RULES OF ORDER

- 1. At every setting, business shall be opened and concluded by prayer, by the moderator or whosoever he may call on.
- 2. Visiting ministers present are invited to seat in council and allowed to take part in debates on all subjects, but are not allowed to vote.
- 3. Those who speak shall arise and address the moderator personally, reflections shall be avoided in all debates.
 - 4. No motion shall be discussed without being seconded.
- 5. When a motion has been made and seconded and a member opposes its discussion, the moderator shall put question: shall it be discussed.
- 6. If any proposition or motion under debate contains two or more points, it shall be divided at the request of any member and a vote taken.
 - 7. A motion made and lost shall not be recorded.
- 8. No one shall speak more than twice on any subject without special permission of the Moderator.
- 9. The Moderator shall have the authority to object to any discussion not carried on in a Christian spirit.
- 10. All questions shall be decided by a majority of the members present.
- 11. No member shall absent himself or herself without special leave of the Moderator.
- 12. Minutes shall be leisurely read and corrected before the close of the Association.
- 14. The Rules of Order shall be distinctly read from the Chair immediately after organization of the Association.
- 14. Alterations shall be made in these rules at any regular session of this Association.

CONSTITUTION

From the long experience, we the members of the Free Will Baptist Church of God, being regularly baptized upon a profession of our faith in Jesus Christ, and being convinced of the necessity of a combination of churches to perpetuate a union among us and to preserve and maintain correspondence with each other, we therefore ordain this constitution for better church government.

- ~ 1. This association shall be composed of members chosen by different churches in our union, not exceeding three delegates from each church and on producing letters shall be entitled to seats.
- 2. Letters from different churches are to express the number in fellowship, the number received by experience of grace, number by letter of recommendation, the number dismissed, excluded, restored, and those who have died since the association.
- 3. The members thus chosen and convened to be denomonated the Eureka Association of Free Will Baptist, being composed of sundry churches in the Eureka Association the association having no power to lord it over God's heritage nor to have any ecclesiastical power over any church becoming disorderly.

4. The association to have a Moderator, Clerk and Treasurer who are to be chosen by the sufferage of the members present.

- 5. Newly constituted churches may be admitted to the association, they are found to be orthodox and orderly they may be received into the association, the moderator giving the right hand of fellowship.
- 6. No question from any church shall come under consideration of the association unless it has first been discussed in its own church.
- 7. Every motion made and seconded shall come under the consideration of the association, except when it is withdrawn by the member who made it.
- 8. The association is to endeavor to furnish the church with minutes of the association in proportion to the number of members in each church, distribution being at discretion of the association.

9. It shall be the duty of the clerk to keep a regular file of

the minutes of the association for that purpose.

10. The minutes of the association shall be read and corrected if needed and signed by the moderator and clerk before the close of the association.

11. Amendments to the constitution may be made when it is

necessary, by a majority of the members present.

Amendments Adopted To Constitution —1959

- 12. Be it resolved that an ordaining counsel for ministers be composed of three (3) ordained ministers in good standing in association.
- 13. Be it resolved that all money be sent to the clerk of the association.
- 14. Money other than allocated funds shall be divided, 75% to Co-op Plan and 25% kept in association.
- 15. Be it resolved that five (\$5.00) dollars accompany each letter to the fifth Sunday meetings, which shall go into the treasure of the association.
- 16. The Examining Committee of the association shall examine ministers for license at the request of the church of which candidate is a member.
- 17. The examining committee shall examine at the end of one year, licensed ministers for ordination at the request of the church of which the minister is a member. Request shall be made to association or the 5th Sunday meeting.

18. The voting power of the association shall be ministers, their wives, deacon and their wives, church clerk and duly elected delegates from each church. The above shall be in good standing

with the association.

19. Be it resolved that all resolutions adopted by the Eureka association, be printed in conclusion with our constitution and be carried in print from year to year as a part of our Rules and Laws.

ARTICLES OF FAITH

1. We believe in one true and living God, Father, Son and Höly Ghost and these three are one in divine essence, power and glory. Romans 1-2; 1st John 1-7; John 17-21.

2. We believe that the Scripture of the Old and New Testament is the inspired Word of God and the only infallible rule of

faith and practice. Second Timothy 3-16; Matthew 5-18.

3. We believe that God created man good, and gave his holy commandments whereby we should live holy, but man voluntarily fell under the just condemnation of the same, whereby all mankind are sinners, not by constrait, but by choice, being partakers of the sinful nature attained by the fall and that man is unable to save himself with his own power, but we see Jesus for suffering of death crowned with glory. That He by the grace of God should taste death for every man. Gen. 3:17; Heb. 2:9.

- 4. We believe that Christ by His death, suffering and resurrection purchased our pardon and offered it freely to all mankind upon principles of repentance toward God and faith in the Lord Jesus Christ. He now commands all men everywhere to repent therefore he sayeth, "Look unto Me and be saved, all ye ends of the earth, for I am God and there is none else." Matt. 4:17; Isaiah 45:22; Acts 20:20.
- 5. We believe that adult persons must be regenerated and born of the Spirit of God, to inherit eternal life. John 3:3; 1st Peter 1:23.
- 6. We believe that infants and idiots are saved upon the merit of the Son of God. John 4:11; Mark 10:14; Deut. 1:39.
- 7. We believe that all Christians must preserve in grace and be faithful to the end if they may have right to the tree of life and enter through the gate into the city. Rev. 22:14; Matt. 24:13.
- 8. The Terms of Salvation: The conditions of salvation are:
 1. Repentance or sincere sorrow for sin and hearty renunciation of it. 2. Faith or the unreserved committal of one's self to Christ as Savior and Lord with purpose to love and obey Him in all things. In the exercise of saving faith the soul is renewed by the Holy Spirit, freed from the domain of sin and becomes a child of God.
 3. Continuance in faith and obedience unto death.
- 9. We believe that God in His goodness displays His power of grace in great degree in calling and qualifying His servants by teaching of the Holy Ghost and by instruction of his word to go forth and nothing prevents the salvation of any but their stubborn rebellion and sinful refusal to come. I Cor. 12:13; Eph. 3:7; Rev. 22:17.
- 10. We believe that baptism and the Lord's Supper and washing the Saint's feet are divine ordinances and should be observed by all His children. Mar. 14:22; John 13:4-14; Matt. 28:19-20; I Tim. 5:10.
- 11. We believe that none have a right to baptism only those who have a living hope in the Lord Jesus Christ, and none have the right to administer the same only those who have come under the hands of the presbytery of orders, and each church ought to have a pastor, deacon, and clerk chosen by the church, ought to have office during the good pleasure of same dealing with disorderly members, reference should be had to the 18th chapter of Matthew and other Scriptures relative to dealing with disorderly members, and then it must be unanimous. Titus 1:5; Acts 14:23; II Corinthians 6:6.
- 12. We believe it is the duty of each church to assemble themselves together once a month and that it is the duty of the pastor of the church in the setting forth of the Lord's Supper and washing the Saint's feet or let as many examine himself and so let him eat. I Cor. 11:28; John 13:14.

13. We believe that sanctification and holiness is a Bible doctrine that immortality is God dwelling in the lives so when this corruptible shall have put on corruption and this mortal shall have put on immortality then shall be brought to pass the saying that is written: "Death is swallowed up in victory." That it is our duty to be tender and affectionate to one another and to study the happiness of the people of God in general and to singly engage to promote the honor and glory of God. Gal. 6:10; I John 2:9.

14. We believe in the resurrection of the dead, of both the just and unjust; the just to glory and immortality in the presence of God; the unjust to everlasting shame and banishment from the presence of God. Matt. 24-31; Cor. 16:42; Thes. 1:10; Rev. 20:12-13.

CHURCH COVENANT

Having been brought, as humbly trust by divine grace to embrace the Lord Jesus Christ as our Savior and having thus obtained justification by faith in His name, we as members of several churches that constitute the Eureka Association of Free Will Baptist adopt the following as our covenant.

- 1. To watch over each other in love, to pray for each other as members of a common faith ever striving to keep the unit of spirit in the bond of peace.
- 2. We will not speak evil of each other nor will we persecute or expose the faults of the weak members of our churches; but we will endeavor to be governed by Paul's instruction to Timothy. "That we will reprove, rebuke and exhort" each other as members of a common brotherhood.
- 3. We are commanded to do good unto all men, especially to those of the household of faith. But we should remember that our relations to each other are closer and the obligations more binding than that of a common hand of Christian charity. In adopting this covenant, we become as a family and assume in a Christian sense the care and responsibility that the members of a family shall feel for each other.
- 4. We will attend the stated meetings of our churches unless we are providentially hindered, or uncontrollable circumstances prevent us. And we will contribute of our means as the Lord has prospered us for the support of our pastor and other necessary expenses of our own church to that of any other and we will pray for our pastor while he is preaching the word of God to us.
- 5. We will not neglect secret and public prayers and those of us who are heads of families will strive to dedicate our households to the service of God by teaching our children the great necessity of the Christian religion as the only hope of happiness after death. We will adopt the Covenant of Joshua, the servant of the Lord, and say, "But as for me and my house, we will serve the Lord."

Rev. Charles Hanna is now in charge to bring the evening message. Prayer by Rev. Norman Woodruff. A good sermon was delivered. Dismissed in prayer by Bro. Otho Williams.

FRIDAY MORNING SESSION

The moderator, Rev. Norman Woodruff, called the body to order and declared it in conference to continue business.

Opened by singing "Revive Us Again," and "I Love My Savior Too." Devotional reading by Rev. C.E. Kennedy, from Saint Matthew, chapter 4, verses 3 through 14. United prayer.

Call for letters. Motion moved and second to receive letters

and seat the delegates.
