## **RULES OF ORDER**

1. At every setting, business shall be opened and concluded by prayer, by the moderator or whosoever he may call on.
2. Visiting ministers present are invited to seat in council and allowed to take part in debates on all subjects, but are not allowed to vote.
3. Those who speak shall arise and address the moderator personally, reflections shall be avoided in all debates.
4. No motion shall be discussed without being seconded.
5. When a motion has been made and seconded and a member opposes its discussion, the moderator shall put question: shall it be discussed.
6. If any proposition or motion under debate contains two or more points, it shall be divided at the request of any member and a vote taken.
7. A motion made and lost shall not be recorded.
8. No one shall speak more than twice on any subject without special permission of the Moderator.
9. The Moderator shall have the authority to object to any discussion not carried on in a Christian spirit.
10. All questions shall be decided by a majority of the members present.
11. No member shall absent himself or herself without special leave of the Moderator.
12. Minutes shall be leisurely read and corrected before the close of the Association.
14. The Rules of Order shall be distinctly read from the Chair immediately after organization of the Association.
15. Alterations shall be made in these rules at any regular session of this Association.

## WEDNESDAY NIGHT SERVICE

The fifty-second setting of the Eureka Association opened by congregational singing led by Bro. Snowden Robinson, Sis. Beulah Williams and Sis. Dessie Menenhall.

Devotional and testimony service was conducted by Bro. Ray Alkes of Wasco, Calif. Special by Ray and Alta. Then another song, "Jesus Saves". Had united prayer, preceding the opening sermon, of which was delivered by Rev. Harold Shuler of Fort Smith, Ark. Subject: "Growing In Christ", reading scripture from the 4th chapter of Ephesians. A good message was delivered, after which the clerk conducted two congregational numbers. The service was dismissed in prayer by Bro. Otho Williams, until 10:00 o'clock Thursday morning.

## THURSDAY MORNING SESSION

The Moderator, Rev. Norman Woodruff, called the body to order. Session opened by singing "I'm Glad That Jesus Came", also "Beyond The Sunset", conducted by Sis. Ruby LaFave, accompanied by Sis. Williams at the piano. Devotional scripture reading by Rev. C. J. Stump, from 12th chapter, verses 1 through 8 of Ecclesiastes. Had united altar prayer.

Letters were called for, read, received, and delegates seated during an ole-time hand-shake and singing, "It Won't Be Very Long."

Motion was made and second to enter in conference and proceed with the business. First portion being election of officers. Motion was moved and second to retain Rev. Norman Wooruff, moderator; Fred Duncan, clerk and treasurer and Lessie Bailes, assistant clerk, and proceed to elect by acclamation. Rev. Charles Hanna was nominated and elected as assistant moderator. The Rules of Order was read by Rev. Hanna.

Motion moved and second to seat all delegates present at reading of letters, also other delegates, thereafter, as long as letter had been previously read.

Motion moved and second to recess conference in favor of the Eleven o'clock sermon, to continue business at 1:30 p.m.

The Introductory Message bearer was Rev. C. J. Stump, the scripture reading from Isaiah, 55th chapter, first verse: "Ho, every one that thirsteth, come ye to the waters, and he that has no money: come ye, buy and eat; yea, come, buy wine and milk without money and without price." Also through verse seven. Good message was delivered. Bro. Riley Wallace gave the benediction.

#### **THURSDAY AFTERNOON SESSION**

Declared back in conference by the moderator. Song: "A Home Up In Heaven" and "I've Got To Cross That Lonely River", led by Ruby LaFave. Devotional from Hebrews 12th chapter, verses 1 through 14, by Rev. Major Followwill. Prayer by Sis. Bertha Roberson.

Appointment of Committees. (See Committees.)

Bro. Snowden Roberson was nominated and elected as member of Yard Committee to succeed Bro. Will LaFave who was elected honorary member of committee.

Motion moved and second to table Query and Request report until Friday. (See report.)

Ministers' Reports read. (See Reports.)

Motion moved and second to receive report of Resolution Committee for discussion.

Motion moved and second to recess conference until Friday morning at 10:00 a.m.

Dismissed in prayer by Rev. Charles Hanna.

#### **THURSDAY NIGHT SERVICE**

Songs: "We Never Will Part", and "When We Sing Around The Throne Eternl." Prayer by Rev. Hubert Brown. More singing conducted by Bro. Lon Mabray. Had united prayer around altar.

Testimony service was conducted by Sis. Lora Tabor.

Special: Quartette arranged by Iron Bridge, "You Can Always Lean On Jesus."

Rev. Charles Hanna to bring the message, reading scripture from 15th chapter of Corinthians. Good message was delivered. Song: "Don't Put Off Salvation Too Long", while the invitation was given. Dismissed by Bro. Rufus Harp.

#### **FRIDAY MORNING SESSION**

Sister Ruby LaFave conducted the opening song, "Way Down Deep In My Soul". Devotional scripture from 1st chapter and 1st verse of St. John, read by Bro. Pete Butler. Prayer by Bro. Moon. Song: "When He Blessed My Soul."

The moderator declared the body back in conference, and made another call for letters. Eight received, read, approved and delegates seated. The Moderator and Assistant extended the Right Hand of Fellowship.

Ministers Reports of Rev. C. J. Stump and Rev. Norman Woodruff read and received.

Moderator Woodruff granted Rev. C. E. Kennedy, state secretary and Rev. Wade Jernigan, state moderator, time to expound upon some of our Denominational State Business.

Reading of Reports: Motion was moved and second to receive reports and retain the committees. Motion carried.

Motion was moved and second to recess conference until 1:30 p.m., in favor of the 11:00 o'clock sermon.

#### 11:00 O'CLOCK SERVICE

Service opened with Sis. Ruby LaFave conducting the singing. Prayer by Rev. Beck.

Assistant Moderator Charles Hanna requested a special. A duet, "One Touch of His Gentle Hand," was rendered by Fred and Bessie Duncan.

Rev. Wade Jernigan to bring the message, reading scripture from 6th chapter Hebrews, verses 4, 5, and 6; also 4th chapter, also 11th chapter, 1st Corinthians. Subject: Falling from Grace and Eternal Security.

A wonderful message was delivered, proving from the word of God, that Man, through his own free will, can fall from Grace and be eternally lost.

Dismissed in prayer by Rev. C. E. Kennedy until 1:30 p.m.

#### FRIDAY EVENING SESSION

Opened by singing "A Home Up In Heaven", led by Sis. Zelma Brigrance. Devotional scripture from 15th chapter of 1st Corinthians, verses 1 through 4, read by Rev. Curtis Maxwell.

Back to conference. Report of Query and Request. Report on Item No. 15 in the constitution to be discussed. After discussion a vote of 36 to strike Item 15 and 23 not to strike. Also placing Executive Board as head of Youth Encampment. Vote 30 for and 29 against.

Motion moved and second to recess conference until 10:00 a.m. Saturday morning. All in favor to stand and sing "Amazing Grace." Dismissed by Rev. Edgar Cole.

#### FRIDAY NIGHT SERMON

Service opened with congregational singing, conducted by: Sister Ruby LaFave, Bro. Ode Long. Prayer by Rev. T. H. Dixon. Song: "It's An Unfriendly World", led by Lon Mabray.

A good testimony service was conducted by Bro. Mack Kinsey. Specials, "Mansions Awaiting Yonder", and "High and Holy Way", arranged by the Haskell Youth Quartette.

Rev. Oren Estes to bring the message. Scripture taken from 16th chapter of St. John, beginning with the 7th verse. Song: "Jesus Is Calling", while the altar call was extended. Dismissed by Rev. Wayne Wagoner.

### **SATURDAY MORNING SESSION**

Session opened by singing, "Remember Me", led by Sister Ruby LaFave. Devotional by Rev. Bart Clark, reading from 116th Psalms, verses 1 through 5. Prayer by Bro. Will LaFave.

Business transaction got underway by the moderator, Rev. Norman Woorduff, declaring the body in session.

Letters were called for; 3 received and delegates seated by extending the Right Hand of Fellowship.

Ministers' Reports were read. (See Reports.)

Motion was moved and second to replace Rev. U. C. Purdom on the Executive Committee by appointing Rev. C. E. Kennedy to serve on the committee. A request by Rev. Purdom was made at the 1959 Association, not to place him on the committee, as he could not serve. The request was granted by removing his name. Also the clerk was requested to notify Bro. Purdom.

Motion was moved and second to place Rev. Kirk Suttles' name on the Association Minister's list.

Dismissed in prayer by Bro. Charles Roye in favor of the

Rev. Leonard Crowder bringing the message on Memorial. Had moment of silent prayer, followed by a spoken prayer by Rev. T. H. Dixon.

Special: "I'll Meet You In the Morning", sung by Rev. Leonard Crowder, Rev. Roy Roberts, Rev. Otho Williams, Rev. Carl Pugh.

Scripture: 26th chapter, verses 21 through 28 of the Book of Acts. Text: For this thing was not done in a corner.

Song: "I Am Bound For the Promised Land", and "Shake Hands With Mother Again". Invitation and handshake. Dismissed in prayer by Rev. Carl Pugh.

### **CONSTITUTION**

From the long experience, we the members of the Free Will Baptist Church of God, being regularly baptized upon a profession of our faith in Jesus Christ, and being convinced of the necessity of a combination of churches to perpetuate a union among us and to preserve and maintain correspondance with each other, we therefore ordain this constitution for better church government.

1. This association shall be composed of members chosen by different churches in our union, not exceeding three delegates from each church and on producing letters shall be entitled to seats.

2. Letters from different churches are to express the number in fellowship, the number received by experience of grace, number by letter of recommendation, the number dismissed, excluded, restored, and those who have died since the association.

3. The members thus chosen and convened to be denominated the Eureka Association of Free Will Baptist, being composed of sundry churches in the Eureka Association—the association having no power to lord it over God's heritage nor to have any ecclesiastical power over any church becoming disorderly.

4. The association to have a Moderator, Clerk and Treasurer who are to be chosen by the suffrage of the members present.

5. Newly constituted churches may be admitted to the association, they are found to be orthodox and orderly they may be received into the association, the moderator giving the right hand of fellowship.

6. No question from any church shall come under consideration of the association unless it has first been discussed in its own church.

7. Every motion made and seconded shall come under the consideration of the association, except when it is withdrawn by the member who made it.

8. The association is to endeavor to furnish the church with minutes of the association in proportion to the number of members in each church, distribution being at discretion of the association.

9. It shall be the duty of the clerk to keep a regular file of the minutes of the association for that purpose.

10. The minutes of the association shall be read and corrected if needed and signed by the moderator and clerk before the close of the association.

1. Amendments to the constitution may be made when it is necessary, by a majority of the members present.

#### **Amendments Adopted to Constitution — 1959**

12. Be it resolved that an ordaining counsel for ministers be composed of three (3) ordained ministers in good standing in association.

13. Be it resolved that all money be sent to the clerk of the association.

14. Money other than allocated funds shall be divided, 75% to Co-op Plan and 25% kept in association.

16. The Examining Committee of the association shall examine ministers for license at the request of the church of which candidate is a member.

17. The examining committee shall examine at the end of one year, licensed ministers for ordination at the request of the church of which the minister is a member. Request shall be made to association or the 5th Sunday meeting.

18. The voting power of the association shall be ministers, their wives, deacons and their wives, church clerk and duly elected delegates from each church. The above shall be in good standing with the association.

19. Be it resolved that all resolutions adopted by the Eureka association, be printed in conclusion with our constitution and be carried in print from year to year as a part of our Rules and Laws.

### ARTICLES OF FAITH

1. We believe in one true and living God, Father, Son and Holy Ghost and these three are one in divine essence, power and glory. Romans 1-2; 1st John 1-7; John 17-21.

2. We believe that the Scripture of the Old and New Testament is the inspired Word of God and the only infallible rule of faith and practice. Second Timothy 3-16; Matthew 5-18.

3. We believe that God created man good, and gave his holy commandment whereby we should live holy, but man voluntarily fell under the just condemnation of the same, whereby all mankind are sinners, not by constraint, but by choice, being partakers of the sinful nature attained by the fall and that man is unable to save himself with his own power, but we see Jesus for suffering of death crowned with glory. That He by the grace of God should taste death for every man. Gen. 3:17; Heb. 2:9.

4. We believe that Christ by His death, suffering and resurrection purchased our pardon and offered it freely to all mankind upon principles of repentance toward God and faith in the Lord Jesus Christ. He now commands all men everywhere to repent therefore he sayeth, "Look unto Me and be saved, all ye ends of the earth, for I am God and there is none else." Matt. 4:17; Isaiah 45:22; Acts 20:20.

5. We believe that adult persons must be regenerated and born of the Spirit of God, to inherit eternal life. John 3:3; 1st Peter 1:23.

6. We believe that infants and idiots are saved upon the merit of the Son of God. John 4:11; Mark 10:14; Deut. 1:39.

7. We believe that all Christians must preserve in grace and be faithful to the end if they may have right to the tree of life and enter through the gate into the city. Rev. 22:14; Matt. 24:13.

8. The Terms of Salvation: The conditions of salvation are: 1. Repentance or sincere sorrow for sin and hearty renunciation of it. 2. Faith or the unreserved committal of one's self to Christ as Savior and Lord with purpose to love and obey Him in all things. In the exercise of saving faith the Soul is renewed by the Holy Spirit, freed from the domain of sin and becomes a child of God. 3. Continuance in faith and obedience unto death.

9. We believe that God in His goodness displays His power of grace in great degree in calling and qualifying His servants by teaching of the Holy Ghost and by instructing of His word to go forth and nothing prevents the salvation of any but their stubborn rebellion and sinful refusal to come. I Cor. 12:13; Eph. 3:7; Rev. 22:17.

10. We believe that baptism and the Lord's Supper and washing the Saint's feet are divine ordinances and should be observed by all His children. Mar. 14:22; John 13:4-14; Matt. 28:19-20; I Tim. 5:10.

1. We believe that none have a right to baptism only those who have a living hope in the Lord Jesus Christ, and none have the right to administer the same only those who have come under the hands of the presbytery of elders, and each church ought to have a pastor, deacon, and clerk chosen by the church, ought to have office during the good pleasure of same dealing with disorderly members, reference should be had to the 18th chapter of Matthew and other Scriptures relative to dealing with disorderly members, and then it must be unanimous. Titus 1:5; Acts 14:23; II Corinthians 6:6.

12. We believe it is the duty of each church to assemble themselves together once a month and that it is the duty of the pastor of the church in the setting forth of the Lord's Supper and washing the Saint's feet or let as many examine himself and so let him eat. I Cor. 11:28; John 13:14.

13. We believe that sanctification and holiness is a Bible doctrine that immortality is God dwelling in the lives so when this corruptible shall have put on corruption and this mortal shall have put on immortality then shall be brought to pass the saying that is written: "Death is swallowed up in victory." That it is our duty to be tender and affectionate to one another and to study the happiness of the people of God in general and to singly engage to promote the honor and glory of God. Gal. 6:10; I John 2:9.

14. We believe in the resurrection of the dead, of both the just and unjust; the just to glory and immortality in the presence of God; the unjust to everlasting shame and banishment from the presence of God. Matt. 24:31; Cor. 16:42; Thes. 1:10; Rev. 20:12-13.

## CHURCH COVENANT

Having been brought, as humbly trust by divine grace to embrace the Lord Jesus Christ as our Savior and having thus obtained justification by faith in His name, we as members of several churches that constitute the Eureka Association of Free Will Baptist adopt the following as our covenant.

1. To watch over each other in love, to pray for each other as members of a common faith ever striving to keep the unit of spirit in the bond of peace.

2. We will not speak evil of each other nor will we persecute or expose the faults of the weak members of our churches; but we will endeavor to be governed by Pauls instructions to Timothy. "That we will reprove, rebuke and exhort" each other as members of a common brotherhood.

3. We are commanded to do good unto all men, especially to those of the household of faith. But we should remember that our relations to each other are closer and the obligations more binding than that of a common hand of Christian charity. In adopting this covenant, we become as a family and assume in a Christian sense the care and responsibility that the members of a family shall feel for each other.

4. We will attend the stated meetings of our churches unless we are providentially hindered, or uncontrollable circumstances prevent us. And we will contribute of our means as the Lord has prospered us for the support of our pastor and other necessary expenses of our own church to that of any other and we will pray for our pastor while he is preaching the word of God to us.

5. We will not neglect secret and public prayers and those of us who are heads of families will strive to dedicate our households to the service of God by teaching our children the great necessity of the Christian religion as the only hope of happiness after death. We will adopt the Covenant of Joshua, the servant of the Lord, and say, "But as for me and my house, we will serve the Lord."
