RULES OF ORDER

1. At every setting, business shall be opened and concluded by prayer, by the moderator or whosoever he may call on.

2. Visiting ministers present are invited to seat in council and allowed to take part in debates on all subjects, but are not allowed to vote.

3. Those who speak shall arise and address the moderator personally, reflections shall be avoided in all debates.

4. No motion shall be discussed without being seconded.

5. When a motion has been made and seconded and a member opposes its discussion, the moderator shall put question; shall it be discussed.

6. If any proposition or motion under debate contains two or more points, it shall be divided at the request of any member and a vote taken.

7. A motion made and lost shall not be recorded.

8. No one shall speak more than twice on any subject without special permission of the Moderator.

9. The Moderator shall have the authority to object to any discussion not carried on in a Christian spirit.

10. All questions shall be decided by a majority of the members present.

11. No member shall absent himself or herself without special leave of the Moderator.

12. Minutes shall be leisurely read and corrected before the close of the Association.

14. The Rules of Order shall be distinctly read from the Chair immediately after organization of the Association.

15. Alterations shall be made in these rules at any regular session of this Association.

OPENING MESSAGE

The Eureka Association's 53rd Annual Session opened on Wednesday evening, August 30th when convened at the Association tabernacle four miles east of Stigler on Highway No. 9. The opening message follows:

WEDNESDAY NIGHT SERVICE

Opened by congregational singing led by Bro. Lon Mabray. Sis. Beulah Williams at the piano. Devotional and testimony services were conducted by Bro. Norman Woodruff. Songs rendered were: "I've Got to Cross That Lonely River," "I'm Glad That Jesus Came," Prayer by Bro. Oma Viles. Another song: "I'd Rather Have Jesus," led by Bro. Oscar Wilson. Another song: "I Carry the Lead."

Had united prayer. After prayer we sang two more songs. Then Bro. Hercel Hickman took charge to preach in place of his Dad, who was sick. Bro. Wade Jernigan called to say he would be unable to be here on Wednesday night, as the message bearer, as was voted at 1960 session. Motion made and seconded we adjourn until Thursday morning at 10 A.M.

Dismissed in prayer by Bro. Major Followwill.

THURSDAY MORNING SESSION

The body came to order by singing No. 103, "Can He Depend on You," also No. 61, "Tis so Sweet to Trust In Jesus," directed by Bro. Oscar Wilson, with Sister Williams at the piano. Devotional by Bro. C. E. Kennedy, reading scripture from Second Corinthians, Chapter 5, Verses 14 through 21. Prayer offered by Bro. Curtis Suttles.

The Moderator, Bro. Norman Woodruff in charge makes statement that neither of the Introductory Message bearers being present, nomination is in order to select minister to bring the message. Bro. C. E. Kennedy was selected.

By a motion and seconded, the body entered conference to transact any and all business for the association.

First: Letters were called for of churches representing, and 12 were received at first call.

Letters received and delegates seated during an old-time hand shake, while singing No. 116, "We Never Will Part," led by Bro. Lon Mabray.

ELECTION OF OFFICERS

The Moderator declared the body in order for nomination of the candidate to serve as Moderator through this association year. Bro. Norman Woodruff and Bro. Bailey Thompson were nominated and elected as follows: Bro. Norman Woodruff as moderator and Bro. Thompson as assistant. Also nomination and election of clerk and assistant clerk. The present clerk, Fred Duncan, with Les-sie Bailes as assistant, were re-elected for the ensuing year.

The assistant moderator, Bro. Thompson, read the Rules of Order, and at this time a motion was entertained to adjourn conference until 1:30 o'clock, in favor of the 11:00 o'clock Worship service.

THE 11:00 O'CLOCK SERVICE

Opened by singing No. 68, "Some Day." Prayer offered by Bro. Pete Butler, and another song: No. 172, "Some Day We Know," led by Bro. Lon Mabray. Bro. C. E. Kennedy was introduced to bring the message. Scripture reading from 2nd Corinthians, 5th Chapter, with the 20th verse as key verse for text: "Now then we are ambassadors for Christ, as though God did beseech you by us: We pray you in Christ's stead, be ye reconciled to God." Also other scripture: Colossians, Ch. 6, V. 6 and Mat., Ch. 5, V. 13-14-15 and 16. A good message was delivered and well received by the entire congregation. Dismissed through prayer by Bro. Woodruff until 1:30 P.M.

THURSDAY AFTERNOON SESSION

Opened by singing No. 56, "I'll Be Satisfied," and No. 55, "Is Your All Upon the Altar," led by Bro. Oscar Wilson. Devotional reading by Bro. Curtis Suttles from Psalms, 23rd Ch. Prayer by Bro. Major Followwill.

Then the body was declared back in conference by the Moderator, and again letters were called for. None were received at this time.

RECOMMENDATIONS FROM ASSOCIATION

Bro. Wayne Wagoner gave in a request for a letter of Recommendation from the Eureka Association to the church in California of which he is pastor. The request was granted and the letter written.

A motion was moved and seconded that the association reimburse Bro. Norman Woodruff for the hiring of teachers during Youth Encampment and insurance premium for insurance on the youths while attending Youth Encampment and authorize the treasurer to issue check in the amount of \$130.00 to cover the total expense. Also a motion was moved and seconded to purchase cooking utensils to be used at Youth Encampment. Also the treasurer's report was read, and a motion moved and seconded to pay the clerk and assistant the regular fee of \$25.00 and \$15.00. The Report follows:

A motion was moved and seconded to give the Moderator or assistant Moderator of the Eureka Association the power to appoint delegates from this association to represent us at the State Association after the State Association has convened, therefore appointing delegates who are present.

Motion moved and seconded to adjourn conference until 10:00 A.M. Friday morning. Dismissed in prayer.

THURSDAY NIGHT SERVICE

Opened by singing No. 103, "Can He Depend on You," No. 102, "Don't You Want to be Ready." Prayer by Bro. A. A. Holdridge. Song No. 65, "Home of the Soul." Prayer by Bro. Riley Wallace. Song No. 56, "I'll Be Satisfied."

Special: "You've Gotta Keep Walking," by Bro. Raymond Qualls and sons, with Sister Qualls at the piano. Special: "That's Why I Love Him So," by Lon, Oscar, Ruby and Herschel.

Sister Roland Smith called for a united prayer as she conducted Devotional service, after which Bro. Bailey Thompson proceeded to bring the message. Subject: "The New Look," reading from St. Matthew, 28 Chapter, Verses 1 through 5. A good message was delivered. Had song and hand-shake. Dismissed through prayer by Bro. Otho Williams.

FRIDAY MORNING SESSION

Opened by singing No. 53, "I've Got to Cross That Lonely River." Prayer by Bro. Beene of Wetumka. Another song, "We Never Will Part." Devotional by Bro. Raymond Qualls, reading from 4th Ch., First Timothy. Prayer by Bro. Thomas Dixon of Muskogee.

Moderator Woodruff declared the body back in conference.

Letters called for, 8 received. Motion moved and seconded to receive letters and seat the delegates. Seated during song and hand-shake. Song, "Beyond the Sunset," led by Bro. O. D. Wickham.

Had talk by Bro. E. M. Kennedy, State Secretary, on the "Co-Op Plan," and where and how it is used to carry the Gospel. Also a talk by Bro. Dan Parker concerning Oklahoma Free Will Baptist Bible College.

A motion was moved and seconded to adjourn conference until 1:30 in favor of the 11:00 o'clock service. Dismissed by Bro. O. D. Wickham.

11:00 O'CLOCK SERVICE

Song: "Some Day We Know," led by Bro. Lon Mabray, got the 11:00 service underway. Bro. C. E. Kennedy led in prayer. Another song: "Just Over In the Glory Land."

The message by Bro. Glen Dipboye was very efficiently delivered, and the very youngest child in Christ should not have been hindered in understanding the sermon.

Scripture for discussion was read from the 26th book of Acts. Subject: Vision. The theme: "Power of God to overcome the work of satan." Living examples of men mentioned in Holy Bible were as follows: Paul, Isaiah, and Job, but the greatest example of all was the vision of "Jesus Christ," the Savior of the world. Let us visualize a soul at the Judgement without knowing Christ as our Redeemer.

FRIDAY AFTERNOON SESSION

A motion was moved and seconded to adjourn conference until 10:00 A.M. Saturday morning.

FRIDAY NIGHT SERVICE

Opened with singing: "I'll Be A Friend To Jesus"; "Home of The Soul", and "I'll Be Satisfied". A special, "I'll Have a Mansion There", presented by Iron Bridge Quartette: Bro. and Sis. Redman Brigance and Bro. and Sis. Otho Williams. Song: "When We Sing Around The Throne Eternal". Special: "I Know I'm Unworthy", by Panama quartette. Song, "Beautiful," by Bro. Jim Cook. Special, "Maybe It's You, and Maybe It's Me", by Bro. and Sis. Watie Buttram and Sis. Geneva Brazil. Song, "He Whispers Sweet Peace To Me".

Had united prayer. Sister Violet Oliver led the Devotional and Testimony service, after which Sister Linda Hartwick soloed, "What A Day That Will Be."

The evening message now to begin. Bro. Norman Woodruff in the pulpit, reading scripture from Revelation 20th chapter, verse 6, and also from the 21st chapter. Subject: "The Lake of Fire." Theme: "Repentance". Song and invitation, "Don't Put Off Salvation Too Long". United prayer. Song, "Everybody Will Be Happy Over There." Dismissed in prayer by Bro. Lon Mabray, until 10:00 A.M. Saturday morning.

SATURDAY MORNING SESSION

Moderator in charge. Song, "I Must Tell Jesus". Prayer by Bro. Clark Cariker. Song, "Some Day We Know". Devotional reading St. John, 12 chapter, verses 23 through 27. Prayer by Sister Lemley of McCurtain.

The moderator declared the body in conference, and extended the call for letters. Two were received, and by a motion moved and seconded the delegates were seated through right hand of fellowship.

Reading of Minister's reports. A motion was moved and seconded to receive reports and print in our Association Minutes. Motion moved and seconded to adjourn conference in favor of the 11:00 o'clock service, to meet back at 1:30 P.M. to continue conference.

11:00 O'CLOCK MEMORIAL SERVICE

Service opened by singing, "There Is A Fountain". Prayer by Bro. Roy Bryant. Another song: "I Would Not Be Denied", conducted by Bro. Lon Mabray.

Bro. Wade Jernigan, state moderator, was elected to preach the Memorial Service. Bro. Jernigan's scripture reading was from the Book of Hebrews: chapter 11, verses 13, 14, 15, 16, 39 & 40. The theme of the message was derived at, especially from the 13th verse. Names of deceased of Association members were read before the message was so fittingly presented, after which Bro. Jernigan offered a prayer of consolation to the bereaved.

Singing, "Victory In Jesus", and "When We All Get To Heaven", while enjoying an ole-time hand shake. Dismissal in prayer by Bro. Curtis Maxwell,, until 1:30 P.M., when conference will be resumed.

SATURDAY AFTERNOON SESSION

The closing session of the 53rd setting of the Eureka Association came to order by singing "I Know Somebody's Listening", led by Bro. James Williams. Devotional reading by Bro. C. J. Stump of Muskogee. Prayer by Bro. Otho Williams.

Reading of Reports: Minister's Character, Deacon's Character and Examining Council. See Reports.

Motion was moved and seconded to adjourn conference until the next setting of the Eureka Association, which convenes on Wednesday night before the First Sunday in September, 1962. Dismissed in prayer by Bro. Clifford Meyers for the afternoon sermon.

Song: "He's The True Shepherd". Bro. Major Followwill to deliver the afternoon message. Scripture chosen to speak from: St. Luke, Chapter 12, verses 8 and 34. Bro. Clifford Meyers followed with some interesting thoughts, after which Bro. Norman Woodruff offered some remarks worthy of remembering and storing within our hearts. Dismissed in prayer by Bro. Carl Pugh. The message was very good, and certainly fitting for the occasion.

SATURDAY NIGHT YOUTH SERVICE

The Youth Service opened by singing, "I'm Glad That Jesus Came", and "We Never Will Part", led by Sis. Bell Viles.

The young folk gathered around the altar for united prayer. Also another song: "Let Me Live Close To Thee", led by Sis. Viles.

CONSTITUTION

From the long experience, we the members of the Free Will Baptist Church of God, being regularly baptized upon a profession of our faith in Jesus Christ, and being convinced of the necessity of a combination of churches to perpetuate a union among us and to preserve and maintain correspondence with each other, we therefore ordain this constitution for better church government.

1 This association shall be composed of members chosen by different churches in our union, not exceeding three delegates from each church and on producing letters shall be entitled to seats.

2. Letters from different churches are to express the num-

ber in fellowship, the number received by experience of grace, number by letter of recommendation, the number dismissed, excluded, restored, and those who have died since the association.

3. The members thus chosen and convened to be denominated the Eureka Association of Free Will Baptist, being composed of sundry churches in the Eureka Association — the Association having no power to lord it over God's heritage nor to have any ecclesiastical power over any church becoming disorderly.

4. The association to have a Moderator, Clerk and Treasurer who are to be chosen by the suffrage of the members present.

5. Newly constituted churches may be admitted to the association, they are found to be orthodox and orderly they may be received into the association, the moderator giving the right hand of fellowship.

6. No question from any church shall come under consideration of the association unless it has first been discussed in its own church.

7. Every motion made and seconded shall come under the consideration of the association, except when it is withdrawn by the member who made it.

8. The association is to endeavor to furnish the church with minutes of the association in proportion to the number of members in each church, distribution being at discretion of the association.

9. It shall be the duty of the clerk to keep a regular file of the minutes of the association for that purpose.

10. The minutes of the association shall be read and corrected if needed and signed by the moderator and clerk before the close of the association.

11. Amendments to the constitution may be made when it is necessary, by a majority of the members present.

12. Be it resolved that an ordaining counsel for ministers be composed of three (3) ordained ministers in good standing in association.

13. Be it resolved that all money be sent to the clerk of the association.

14. Money other than allocated funds shall be divided, 75% to Co-op Plan and 25% kept in association.

16. The Examining Committee of the association shall examine ministers for license at the request of the church of which candidate is a member.

17. The examining committee shall examine at the end of one year, licensed ministers for ordination at the request of the church of which the minister is a member. Request shall be made to association or the 5th Sunday meeting.

18. The voting power of the association shall be ministers, their wives, deacons and their wives, church clerk and duly elected delegates from each church. The above shall be in good standing with the association.

19. Be it resolved that all resolutions adopted by the Eureka association be printed in conclusion with our constitution and be carried in print from year to year as a part of our Rules and Laws.

20. Be it resolved that we, starting next Association, 1960, placing every preacher's yearly report in the Minutes. 1959 Resolutions and Amendments of Constitution and By Laws. Bro. C. E. Kennedy, Bro. Otho Williams, Bro. Charles Hanna.

21. Be it resolved that we adopted the rule that when a church selects deacons, that they be set aside on trial for 12 months, before being ordained. The deacon acting during the 12 months. But not ordained before the 12 months are up.

22. Be it resolved that the Constitution be amended giving the Executive Board control over the Youth Camp. This resolution was adopted, 1961. Rev. C. E. Kennedy, Rev. Major Followwill, Bro. Leamon Harrell, Bro. Vanis King, Bro. Abb Wallen, Committee.

23. Motion made and seconded, That the Eureka Association go on record in its 53rd session as adopting the national Association, Free Will Baptist treatise, officially and that the association go on record as reaffirming our unalterable stand, and our belief in Congregational Church Government.

The resolution committee recommended a committee be appointed to investigate the buying or trade of piano, and that the committee report to the first Fifth Sunday meeting. Committee was appointed by Moderator. They are as follows: Bro. Riley Wallace, Sis. Ruby LaFave, Bro Oscar Wilson.

ARTICLES OF FAITH

1. We believe in one true and living God, Father, Son and Holy Ghost and these three are one in divine essence, power and glory. Romans 1-2; 1st John 1:7; John 17:21.

2. We believe that the Scripture of the Old and New Testament is the inspired Word of God and the only infallible rule of faith and practice. Second Timothy 3-16; Matthew 5-18.

3. We believe that God created man good, and gave his holy commandments whereby he should live holy, but man voluntarily fell under the just condemnation of the same, whereby all mankind are sinners, not by constraint, but by choice, being partakers of the sinful nature attained by the fall and that man is unable to save himself with his own power, but we see Jesus for suffering of death crowned with glory. That He by the grace of God should taste death for every man. Gen. 3:17; Heb. 2:9.

4. We believe that Christ by His death, suffering and resurrection purchased our pardon and offered it freely to all mankind upon principles of repentance toward God and faith in the Lord Jesus Christ. He now commands all men everywhere to repent therefore he sayeth, "Look unto Me and be saved, all ye ends of the earth, for I am God and there is none else." Matt. 4:17; Isaiah 45:22; Acts 20:20.

5. We believe that adult persons must be regenerated and born of the Spirit of God, to inherit eternal life. John 3:3; 1st Peter 1:23.

6. We believe that infants and idiots are saved upon the merit of the Son of God. Jonah 4:11; Mark 10:14; Deut. 1:39.

7. We believe that all Christians must preserve in grace and be faithful to the end if they may have right to the tree of life and enter through the gate into the city. Rev. 22:14; Mat. 24:13.

8. The Terms of Salvation: The conditions of salvation are: 1. Repentance or sincere sorrow for sin and hearty renunciation of it. 2. Faith or the unreserved committal of one's self to Christ as Savior and Lord with purpose to love and obey Him in all things. In the exercise of saving faith the soul is renewed by the Holy Spirit, freed from the dominion of sin and becomes a child of God, 3. Continuance in faith and obedience unto death.

9. We believe that God in His goodness displays His power of grace in great degree in calling and qualifying His servants by teaching of the Holy Ghost and by instruction of His word to go forth and nothing prevents the salvation of any but their stubborn rebellion and sinful refusal to come. 1 Cor. 12:13; Eph. 3:7; Rev. 22:17.

10. We believe that baptism and the Lord's Supper and washing the Saint's feet are divine ordinances and should be observed by all His children. Mar. 14:22; John 13:4-14; Math. 28:19-20; I Tim. 5:10.

11. We believe that none have a right to baptism only those who have a living hope in the Lord Jesus Christ, and none have the right to administer the same only those who have come under the hands of the presbytery of orders, and each church ought to have a pastor, deacon and clerk chosen by the church, ought to have office during the good pleasure of same dealing with disorderly members, reference should be had to the 18th chapter of Matthew and other Scriptures relative to dealing with disorderly members, and then it must be unanimous. Titus 1:5; Acts 14:23; II Corinthians 6:6.

12. We believe it is the duty of each church to assemble themselves together once a month and that it is the duty of the pastor of the church in the setting forth of the Lord's Supper and wash-

ing the Saint's feet or let as many examine himself and so let him eat. I Cor. 11:28; John 13:14.

13. We believe that sanctification and holiness is a Bible doctrine that immortality is God dwelling in the lives so when this corruptible shall have put on corruption and this mortal shall have put on immortality then shall be brought to pass the saying that is written: "Death is swallowed up in victory". That it is our duty to be tender and affectionate to one another and to study the happiness of the people of God in general and to singly engage to promote the honor and glory of God. Gal. 6:10; I John 2:9.

14. We believe in the resurrection of the dead, of both the just and unjust; the just to glory and immortality in the presence of God; the unjust to everlasting shame and banishment from the presence of God. Matt. 24:31; Cor. 16:42; Thes. 1:10; Rev. 20:12-13.

CHURCH COVENANT

Having been brought, as humbly trust, by divine grace to embrace the Lord Jesus Christ as our Savior and having thus obtained justification by faith in His name, we as members of several churches that constitute the Eureka Association of Free Will Baptist adopt the following as our covenant.

1. To watch over each other in love, to pray for each other as members of a common faith ever striving to keep the unit of spirit in the bond of peace.

2. We will not speak evil of each other nor will we persecute or expose the faults of the weak members of our churches; but we will endeavor to be governed by Paul's instruction to Timothy, "That we will reprove, rebuke and exhort" each other as members of a common brotherhood.

3. We are commanded to do good unto all men, especially to those of the household of faith. But we should remember that our relations to each other are closer and the obligations more binding than that of a common hand of Christian charity. 5. We will not neglect secret and public prayers and those of us who are heads of families will strive to dedicate our households to the service of God by teaching our children the great necessity of the Christian religion as the only hope of happiness after death. We will adopt the Covenant of Joshua, the servant of the Lord, and say, "But as for me and my house, we will serve the Lord."
