- 8. No one shall speak more than twice on any subject without special permission of the Moderator.
  - 9. The Moderator shall have the authority to object to any

discussion not carried on in a Christian spirit.

- 10. All questions shall be decided by a majority of the members present.
- 11. No member shall absent himself or herself without special leave of the Moderator.
- 12. Minutes shall be leisurely read and corrected before the close of the Association.
- 13. The Rules of Order shall be distinctly read from the Chair immediately after organization of the Association.
- 14. Alterations shall be made in these rules at any regular session of this Association.

### CHURCH ORDER OF BUSINESS

- Called to order by Moderator.
   Called into conference, or vote, to go into conference.
- .ciiio .c**.**70 Call for peace of the Church, (all who are at peace with God and with each other, hold up your right hand).
  - 4. Visiting brethren invited to seat in Council (Visiting members from other Free Will Baptist Churches).
  - 5. Reading of minutes of last conference.
  - Reading of Treasurer's report.
  - 7. Unfinished business.
  - 8. New business.

### CONSTITUTION

From the long experience, we the members of the Free Will Baptist Church of God, being regularly baptized upon a profession of our faith in Jesus Christ, and being convinced of the necessity of a combination of churches to perpetuate a union among us and to preserve and maintain correspondence with each other, we therefore ordain this constitution for better church government.

- 1. This association shall be composed of members chosen by different churches in our union, not exceeding three delegates from each church and on producing letters shall be entitled to seats.
- 2. Letters from different churches are to express the number in fellowship, the number received by experience of grace, number by letter of recommendation, the number dismissed, excluded, restored, and those who have died since the association.
- The members thus chosen and convened, to be denominated the Eureka Association of Free Will Baptist, being composed of. sundry churches in the Eureka Association—the Association having no power to lord it over God's heritage nor to have any ecclesiastical power over any church becoming disorderly.
- 4. The association to have a Moderator, Clerk, Assistant Clerk and Treasurer who are to be chosen by the sufferage of the members present.
- 5. Newly constituted churches may be admitted to the association if they are found to be orthodox and orderly they may be received into the association, the moderator giving the right hand of fellowship.
- 6. No question from any church shall come under consideration of the association unless it has first been discussed in its own church.
- 7. Every motion made and seconded shall come under the consideration of the association, except when it is withdrawn by the member who made it.

- 8. The association is to endeavor to furnish the church with minutes of the association in proportion to the number of members in each church, distribution being at discretion of the association.
- 9. It shall be the duty of the clerk to keep a regular file of the minutes of the association for that purpose.
- 10. The minutes of the association shall be read and corrected if needed and signed by the moderator and clerk before the close of the association.
  - 11. Amendments to the constitution may be made when it is

necessary, by a majority of the members present.

- 12. Be it resolved that an ordaining council for ministers be composed of three (3) ordained ministers in good standing in association.
- 13. Be it resolved that all money be sent to the treasurer of the association.
- . 14. Money other than allocated funds shall be divided, 75 percent to the Co-op Plan and 25 percent kept in the association.
- 15. The Examining Committee of the association shall examine ministers for license at the request of the church of which candidate is a member.
