MINUTES OF THE FIRST KANSAS QUARTERLY MEETING CONVENING AT FIRST FREE WILL BAPTIST CHURCH HUTCHINSON, KANSAS JANUARY 15 - 16, 1993

Friday Evening, January 15, 1993

Bro. Nick Hollis, acting moderator, welcomed everyone. MM&S to enter into conference. Motion carried. The body stood as Bro. Hollis opened the meeting with prayer. Bro. James Barlow (host pastor) welcomed everyone to Hutchinson, and asked the host church members to stand. Bro. Hollis read Psalm 119:25-32. Sis. Terry Luman led congregational singing with "Standing on the Promises". The evening offering was taken. Bro. Cliff Smith led the offertory prayer as the congregation stood. Sis. Special prayer requests were taken. Bro. Barlow led the prayer.

Bro. Barlow brought the evening message, entitled "Christian Courage". He encouraged us with passages from Hebrews 11:1, Proverbs 28:1, 1 Corinthians 15:13 and II Tim. 1:7 as he preached on our need to be servants of God who will work for the Kingdom of God. He spoke on faith, and how faith must be accompanied by courage. We can build our courage by 1) Prayer, 2) Reading the Bible daily, 3) Following God's will, and 4) Loving everyone. Bro. Barlow closed with an altar call, and Sis. Luman led the invitation hymn, "Have Thine Own Way".

quarters. The host church also announced that refreshments were being served after evening services, and coffee and donuts would be served in the morning before the meeting. There was no Women's Auxiliary meeting.

MM&S to adjourn until 9 am, January 16, 1993. Motion carried by a standing vote. Bro. Ray Hubbard closed the evening meeting with prayer.

<u>Saturday Morning, January 16, 1993</u> Bro. Nick Hollis opened the meeting. Bro. Ray Hubbard led in prayer. Another roll call was taken, and the following <u>additional</u> representatives were recognized;

Bro. James Barlow led singing, accompanied by Sis. Jeannie Dinwiddie on piano. The congregation sang "Victory in Jesus".

A devotion was given by Sis. Jalayne Martens (Missionary to the Ivory Coast). Using text from Hebrews 4:12, II Timothy 3:16-17, Ps. 37:3-6 and Philippians 3:8-11, Sis. Martens compared God's method of molding us as Christians to painting a picture. Both God and the painter start with a rough canvas, and work with it until a "picture" appears. She closed by saying that we should allow God to finish painting our lives, as He makes a masterpiece.

The clerk stood and read the church letters. The delegates stood. MM&S to seat delegates. Motion carried. Copies of the minutes from the last meeting were distributed. MM&S to accept the minutes as printed. Motion carried.

Old Business - None

New Business - The Report of the Business Committee was read by Bro. Barlow. MM&S to accept the report as read and vote on it item by item. Motion carried.

REPORT OF THE BUSINESS COMMITTEE

We, the Business Committee, make the following recommendations to the voting body;

1. That we approve the request of \$1,200 be given to the First Church, Wellington from the Emergency fund, so that they can move their pastor to Wellington. Of this amount, \$1,000 would be for the move and \$200 would pay 1/2 of the first month's rent for his home.

MM&S to accept the first recommendation of the Business Committee. Motion Carried.

2. That the Quarterly meetings for the following year be hosted by the Faith FWB Church, Salina (April), First FWB Church, Wichita (October), and the First FWB Church, Hutchinson (January, 1994). MM&S to accept the second recommendation of the Business Committee. Motion carried.

3. That a rising vote of thanks be given to the host church for their gracious hospitality.

Recommendation tabled.

Other new business - A recommendation was made that the Emergency Fund be increased from the current \$1,000 ceiling to \$2,000, and that when \$2,000 is reached, the surplus funds in excess of \$2,000 be diverted to the Scholarship Fund. When the amount in the Emergency Fund drops below \$1,000, funds would then be kicked back into the Emergency Fund until the \$2,000 ceiling is reached. MM&S to accept the recommendation. After discussion, motion carried.

Sis. Glennda Leatherbury gave an update on the work in the Ivory Coast, and how plans to return to the mission field were progressing.

Bro. Ray Hubbard introduced Bro. Mark Dinwiddie, a Free Will Baptist who is an independent missionary to Russia.

A short break was given. Bro. James Barlow dismissed with prayer.

The conference reconvened at 10:48 am. Bro. Jack Dinwiddie led in prayer. The moderator also asked Bro. Dinwiddie (who formerly pastored in Kansas) to introduce himself and tell the congregation

about himself, his family, and his current ministry.

Sis. Terry Luman led the congregation in singing "I Must Tell Jesus" and "Rescue the Perishing", accompanied by Sis. Jeannie Dinwiddie on the piano. The morning offering was taken. Bro. Bud Nugen led the offertory prayer.

Special music was performed by Bro. Ray Hubbard, ("Somebody's Prayin'") and Sis. Terry Luman, ("Your Arms of Love").

Bro. Jack Dinwiddie introduced his son, Bro. Mark Dinwiddie, for the morning message. Bro.
