A. B. Talbert, M. M. McKee, J. M. Roberts, W. L. Bean, J. L. Waltman Melvin Bingham, W. M. Bingham and Bro. O. E. Stairs acted as ordaining council.

J. L. Waltman and W. L. Bean were elected as associt-

tional Sunday School Superintendents.

Motion carried to send next association to Drumright, to begin on Wednesday night before the fourth Sunday in August, 1929. Rev. W. M. Bingham was elected to preach the Introductory Sermon and Rev. W. J. Pierce as Alternate.

Motion carried to hold first quarterly meeting with New

Home Church.

Motion carried for the Moderator to express our thanks to the people for their kindness toward us during our stay with them. Adjourned to meet as stated.

REPORT OF COMMITTEES

Missions:

We, your committe on Missions, report as follows:

Whereas the Mission Work has proven such a help to our churches, and we believe that we ca nreach souls through the Mission that would not be reached any other way; we ask that every possible effort be made to advance the Mission Work. We also ask that a committee be appointed to meet at Drumright at the State Association to decide on a uniform for the Mission Workers.

Temperance:

We, your Committe on Temperance submit the following: Realizing that intoxicating drink is one of the greatest evils of our land; that it destroys homes, starves children, wrecks human life; makes prostitutes of our girls and human brutes of our boys: Therefore we condemn its use, and as abody we stand on the 18th Ammendment; Also that we staind with our officers in enforcing all Laws against Intemperance.

Committee.

We, your committe on finance make report as follows: Receiving for printing minutes: Drumright Church, \$5.00 Cushing, \$4.00, Tulsa \$5.30, Garden City, \$2.50, New Home \$3.30, Collection \$1.61. Total \$21.71.

Committee.

Resolutions:

No. 1. No minister shall be entitled to a seat in this association until credentials have been approved by the association or Executive board, and the Association or Executive board may withdraw from any minister walking disorderly.

No. 2. The Pastor of the church where the Association

is held act as Chairman of Pulpit Committee.

No. 3. Resolved that the churches abide by the ruling of the Association one year then, should any ruling be found not to be best for the churches it may be changed at next Association.

4. Whereas all officers for churches should be christians be it resolved that all churches select their officers from the members of the respective churches.

No. 5 Resolved that we allow churches near our boundary line to represent in the Association of their preference.

- No. 6. No one shall be granted license to preach until they have been examined by a committee appointed by the Association, or Quarterly Meeting, at the request of their church.
- 7. Resolved that this Association will not license or ordain any minister or Deacon that believes in either a sec-

ond work of Grace, or a thousand years to repent in after death.

No. 8. Resolved that we will not ordain any minister that does not teach and practice feet washing.

No. 9-10-11. Lost.

No. 12. Resolved that we recommend that each church poy into the Associational Treasure 25cts. per member, for Evangelistic and other Associational work.

No. 13. We recommend that the Pastor instruct their members to pay "as the Lord has prospered" also that they keep a record of ammount paid and have the report read at least twice each year.

No. 14. Resoived that the Manuscript for our minutes be approved by at least 3 members of the Executive Board

before being printed.

No. 15. Resolved that we will not allow our ministers to debate unless such a debate be approved by the Executive Board.

----000 CONSTITUTION

From long experience we are convinced of the necessity of a combination of churches to perpetuate our union and to maintain a correspondence among our churches.

Therefore we have adopted the following constitution and by laws for ous government.

1

This Association shall be called the First Mission Association.

2

This Association shall be composed of such well regulated Free Will Bapist Churches Maintaining Gospel order, agreeing with the denomination in Doctrine and practices, favoring the enterprises that have been endorsed by this Association.

3.

The acting members of this Association shall be the Ministers, Deacons, and Church Clerks belonging to any church composing this body, also 3 delegates from each church chosen by the members of their respective churches.

4

The officers of this Association shall be a Moderator, Ass't. Moderator, a Clerk and Ass't. Clerk and an executive board composed of 5 members. The board members to be elected so as to require one to be elected for one year. All officers shall hold office until their successors are elected.

5

The property of any church in this Association that should go down until they could not transact business because they were disorganized, shall become the property of this Association and the executive board his power to execute legal papers for the property.

3.

This Association shall meet annually at such time and place as shall be decided upon by the Association at such quarterly meetings. Any business of the Association may be transacted.

7

This Association may be called together by the Moderator, by giving the churches 10 days notice of such called meeting.

R

This Constitution may be changed at any yearly meeting by a two-thirds majority of members voting.



BL-LAWS

1

The Moderator or Ass't. Moderator or in their absence the oldest minister present shall call the Association unto conference.

2.

Each session shall be opened and closed by prayer.

3.

Five members from two or more churches shall constitute a quorum a less number may adjourn until such quorum is present.

4.

Visiting brethren are invited to seats as advisory membors.

5.

Those who speak shall arise and address the Moderator. Personal reflections shall be avoided in all decates.

6.

If any proposition or motion under debate contains two or more points, it shall be divided at the request o fany member and a vote taken.

7.

Motion made and lost shall not be recorded.

R

No one shall speak more han twice on the same subject without special leave of the moderator.

Q

The Moderator shall not allow discussions when not carried on in a christiain spirit.

The ruling of the moderator may be over ruled by a two-thirds majority of members voting.

11:

Any minister opposed to any of the enterprises endorsed by this Association will not be entitled to a seat in Conference.

12.

No question from any church shall come under the consideration of the Association unless it has first been discussed in its own church.

13.

At each Association arrangements shall be made to insure two or more sermons or other equivalent devotional exercises each day.

ORGANIZATION OF ASSOCIATION

On May 9th, 1928 th eCommittees and delegates that had been elected to organize a new Association met at the Berry Hill School house, west of Red Fork.

Those present were: Rev. A. B. Talbert, State Supt. of Missions, Rev. J. L. Waltman, State Supt. of Sunday Schools. Also elected by the First Oklahoma Association to help organize the new association.

Rev. W. M. Bingham, Pastor of the Tulsa Church, Rev. Melvin Bingham, Pastor of New Home Church, Rev. C. W. Thompson, Pastor of the Garden City Church, Rev. W. C. Wilson, Rev. A. W. Freer, Rev. O. J. White, Rev. W. J. Pierce, Liva Waltman, Mae Waltman, Violet Waltman, Rosa Cook, Bro. and Sister Parker, Bro. and Sister Pruitt, Bro. and Sister Edwards, Sister White, Sister Lierly, Wm. C. Thrasher, Charles Petty, L. L. Collins, D. F. Hayes, Sister Baken, Sister Martin, Sister Sales.

House called toorder by Rev. A. B. Talbert. Rev. W. M. Bingham was elected Moderator, Rev. J. L. Waltman Ass't. Moderator. Sister J. R. Pruitt, Clerk, Brother Petty Ass't Clerk.

The Constitution, Bl-laws and Church Covenant were read and adopted.

The hand of fellowship was given and prayer offered for God's guidance.

Rev. W. C. Wilson was elected Sunday School Sipt. for the Association, Rev. Melvin Bingham Ass't Supt.

Motion carried that we recommend that the churches of

this Association do not call pastors who are not in sympathy with the Mission Work, and other enterprises that have been endorsed by this Association.

Motion carried that we meet on Wednesday night be-

fore the 4th Sunday in August.

Adjournment to meet with Tulsa Church Thursday night. 7:30 P. M. met with Tulsa Church. Called to order by Moderator.

Minutes read and approved. Order of business read and

adopted.

Adjournment to meet on Wednesday night before the 4th Sunday in August with Tulsa Church.

On July 11th the Association met in a called meeting with the Tulsa Church to elect Delegates to the Co-operative Association.

Motion carried to change date of Association for this year to Sept. 26th.

CHURCH COVENANT

We will not forget the assembling of ourselves together for church conference, public worship, and the observence of the ordinance of the Gospel, nor fail to pay according to our ability for the support of the church, of it spoor, and all its benevelant work. We agree to accept Christian admonition and reproof with meekness, and to watch over one another in love, endeavoring to "keep the unity of the Spirit" in the bond of peace, to be careful of one another's happiness and reputation, and seek to strengthen the weak, encourage the afflicted, admonished the erring, and as far as we are able promote the success of the church and of the Gospel. We will every where hold Christian principles sacred and Christian obligations and enterprises supreme; counting it our chief business in life to extend the influence of Christ in society; constantly praying and toiling that the Kingdom of God will come, and His will be done on earth as it is in Heaven.

To this end we agree to labor for the promotion of educational and denominational enterprises, the support of missions, the success of Sabbath schools, and evangelistic egorts for the salvation of souls and the conversion of the world.
