- No. 5—Resolved: That each minister should give a written or verbal report of their work to this Association so that their names may appear in our minutes.
- No. 6.—Resolved: That we hold our quarterly meetings so as to divide the Associational year equally.

Whereas we find that our Sunday Schools are doing a great good we ask that we have a Sunday School rally at each quarterly meeting and the school having the largest attendance be given a banner: banner to be furnished by the Association.

MISSIONS

We, your Committee on Missions, ask that the Resolution regarding uniforms be abided by and that a superintendent be elected for this Association.

We also ask that one day during our Association be set apart as "Mission day" for talks on the mission work. And in order to make the mission what it was organized for we ask that each one cooperate with their president to help do this greatest good possible.

CONSTITUTION

Fromlong experience we are convinced of the necessity of a combination of churches to perpetuate our union and to maintain a correspondence among our churches.

Therefore we have adopted the following constitution and by laws for our government.

1.

This Association shall be called the First Mission Association.

2

This Association shall be composed of such well regulated Free Will Baptist Churches maintaining Gospel order, agreeing with the denomination in doctrine and practices, favoring the enterprises that have been endorsed by this Association.

3.

The acting members of this Association shall be the Ministers, Deacons, and the Church Clerks belonging to any church composing this body, also three delegates from each church chosen by the members of their respective churches.

4.

The officers of this Association shall be a Moderator, assistant Moderator, a clerk and assistant Clerk and an executive board composed of five members. The board members to be elected so as to require one to be elected each year. All officers shall hold office until their successors are elected.

The property of any church in this Association that should go down until they could not transact business because they were disorganized, shall be-

come the property of this Association and the exe-

cutive board has power to execute legal papers for the property.

6.

This Association shall meet annually at such time and place as shall be decided upon by the Association at quarterly meetings. Business of the Association may be transacted.

7.

This: Association may be called together by the Moderator, by giving the churches ten days notice of such meeting.

2

This Constitution may be changed at any yearly meeting by a two-thirds majority of members voting.

BY-LAWS

1.

The Moderator or assistant Moderator or in their absence the oldest minister present shall call the Association into conference.

2.

Each session shall be opened and closed by prayer.

3.

Five members from two or more churches shall constitute a quorum. A less number may adjourn until such quorum is present.

4.

Visiting brethern are invited to seats as advisory members.

5.

Those who speak shall arise and address the

Moderator. Personal reflection shall be avoided in all debates.

6.

If any proposition or motion under debate contains two or more points, it shall be divided at the request of any member and a vote taken.

7

Motion made and lost shall not be recorded.

8.

No one shall speak more than twice on the same subject without special leave of the Moderator.

9.

The Moderator shall not allow discussions when not carried on in a Christian spirit.

10.

The ruling of the Moderator may be overruled by a two-thirds majority of members voting.

11.

Any minister opposed to any of the enterprises endorsed by this Association will not be entitled to a seat in Conference.

12.

No question from any church shall come under the consideration of the Association unless it has first been discussed in its own church.

13.

At each Association arrangements shall be made to insure two or more sermons or their equivalent devotional exercises each day.
