BY-LAWS

- 1. The moderator or assistant moderator, or in their absence, the oldest minister present shall call the Association into conference.
 - 2. Each session shall be opened and closed with prayer.
- 3. Five members from two or more churches shall constitute a quorum. A less number may adjourn until such quorum is present.
 - 4. Visiting brethren are invited to seats as advisory members.
- 5. Those who speak shall arise and address the moderator. Personal reflections shall be avoided in all debates.
- 6. If any proposition or motion under debate contain two or more points, it shall be divided at the request of any member and a vote taken separately.
 - 7. Motions made and lost shall not be recorded.
- 8. No one shall speak more than twice on the same subject without special leave of the moderator.
- 9. The moderator shall not allow discussion when not carried on in a Christian spirit.
- 10. The ruling of the moderator may be overruled by a two-thirds vote of the members voting.
- 11. Any minister opposed to any of the enterprises endorsed by the Association will not be entitled to a seat in conference, and we will not seat any minister in this Association that teaches the baptism of the Holy Ghost separate from regeneration or the birth of the Spirit.
- 12. No question from any church shall come under the consideration of the Association unless it has first been discussed in its own church.
- 13. At each Association arrangements shall be made to insure two or more sermons or their equivalent devotional exercises each day.

Having given ourselves to God by faith in Christ, and adopted the Word of God as our rule of faith and practice, we now give ourselves to one another by the will of God in this solemn covenant. We promise by His grace to love and obey Him in all things, to avoid the appearance of evil, to abstain from all sinful amusements and unholy conformity to the world; from all sanction of the use and sale of intoxicating beverages, and to "provide things honest in the sight of all men."

We agree to accept Christian admonition and reproof with meekness, and to watch over one another in love, endeavoring to "keep the unity of the Spirit," in the bonds of peace, to be careful of one another's happiness and reputation, and seek to strengthen the weak, encourage the afflicted, admonish the erring, and as far as we are able, promote the success of the church and of the Gospel.

We will everywhere hold Christian principle sacred and Christian obligations and enterprises supreme; counting it our chief business in life to extend the influence of Christ in society; constantly praying and toiling that the kingdom of God may come, and His will be done on earth as it is in heaven.

We agree faithfully to discharge our obligations in reference to the study of the Scriptures, secret prayer, family devotions, and social worship; and by self-denial, faith, and good works endeavor to "grow in grace and the knowledge of our Lord and Savior Jesus Christ." We will not forget the assembling of ourselves together for church conferences, public worship, and the observance of the ordinances of the Gospel, nor fail to pay according to our ability for the support of the church, of its poor, and all its benevolent work.

To this end we agree to labor for the promotion of educational and denominational enterprises, the support of missions, the success of Sunday schools, and evangelistic efforts for the salvation of souls, and the conversion of the world. And may the God of peace sanctify us wholly, and preserve us blameless unto the coming of our Lord Jesus Christ.

PROCEEDINGS

The Sixth Annual Session of the First Mission Association met with the Zion Hill church, Wednesday morning, August 23, 1933. The session opened with singing and proper devotions. After which soul-stirring messages were delivered by Sister Pruitt and Eld. Boyd Williams. Old time shoutings were heard throughout the service.

COMMITTEE REPORTS

Missions—We, the Committee on Missions, wish to adopt the resolution as if reads in the minutes:

"Be it Resolved, That the old missions get the Juniors on their hearts and stop so much criticising and encourage them more, and each mission send in a written report at each annual meeting without fail.—Committee.

Temperance—We, your Committee on Temperance, beg to report as follows:

We believe in being temperate in all things, as the Bible teaches. We believe intoxicating drinks to be one of the worst curses of our nation. It does not only rob people of temporal things of this life, but also robs them of their souls. It causes many to spend eternity in hell. May we, as God's people, do all we can to encourage others to be temperate in this life, and that it begin in our homes.—Committee.

Obituary—Whereas the Supreme Ruler in His wisdom has seen fit to remove from our midst the following:

Sister P. L. Dunn, Sister R. H. Miller, Sister Zona Payne, Sister Holder, Bro. W. A. Taylor, Sister Thomas' baby, Sister Gibhart's baby, also Sister Mellion's baby.

Sunday School—We find that each church reports a good Sunday school; and we urge that this work be carried on. Each member should attend and urge that others do so. A church without a Sunday school is on the downward road and sooner or later is gone.

We urge also the use of Free Will Baptist literature. Sunday schools should be encouraged by pastors and deacons. All teachers and officers should be Christians, and of the Free Will Baptist faith.—Committee.

Resolutions: No.1—Be it Resolved, That any of our churches, wishing to call another pastor, must notify said callee at least thirty days before election, and he shall consult the present pastor at least ten days before election as to his desires, whether or not he wishes to stay and in the event that said church will not retain the present pastor and said church shall call the callee, and in that event said callee shall be privileged to pastor said church.

- No. 2—We Recommend, That all churches coming to the Association advise their people to come prepared to camp, corresponding delegates and messengers exempted from the above rule.
- No. 3—Be it Resolved, That we meet on Wednesday night and begin the organization Thursday morning at 9:00 o'clock, and adjourn Saturday as soon as all business is finished.
- No. 4—Be it Resolved, That each church pay tithes of what they take in through their church treasury, and that said tithes shall be paid annually into the treasury of the Association, sent by delegates with letter, and out of said funds shall minutes be published, and of said amount remaining, 50% shall go to Old Ministers' Home fund and 50% to Extention fund.

- No. 5—Whereas God has so wonderfully blessed us in the First Mission Association, and as we feel it our duty to progress as God directs; we suggest that we take steps to organize a Western Conference: also that we lay plans for our dependent Ministers' Home.
- No. 6—To the State Assocition when convened with the Dibble church, beginning on Tuesday night before the fourth Sunday in October, 1933: We, the First Mission Association of Free Will Baptist, are in favor of disbanding the Co-operative General Association and consumate a union with the Eastern Conference.
- No. 7—Be it Resolved, That all discussions be preached and not debated.
- No. 8—We Recommend, That no preacher be called to pastor any church in this Association unless he is a member of this Association, or will be a member of it, and is a Mission worker, and has been proved.
- No. 9—Be it Resolved, That no more Junior missions be organized with sinners in them; as we don't take sinners into the church, and the Mission is a part of the church.
- No. 10—Be it Resolved, That each Mission in our Association take it up and instruct the workers to pledge one-tenth of fruit and vegetables canned to Old Ministers' Home.
- No. 11—Do we have a right to turn anyone out of the church? Voted, We do.
- No. 12—Be it Resolved, That any minister of this Association, talking about another minister of the Association, be reported to the Executive Board, and said board will ask that said minister turn his or her credetials in.

Report of Clerk—Received for minutes: Tulsa church \$5.00, Cushing \$3.00, Jenning \$1.50, Allen \$2.50, Blue Bell \$1.50, Zion Hill \$3.00, Bixby \$1.75, New Home \$2.50, Drumright \$3.00, Oglesby \$1.00, Mt. Zion \$1.50, Vance Chapel \$2.00, Total \$28.25.—Bert F. Rogers, Clerk.

Report of Executive Board—Met at Sand Springs, Oklahoma, June, 1933, and voted to use the money from Old Ministers' Home funds for deposit on lights and on gas for Mission Point. Board received \$23.00 from clerk of Association. Less \$10.00 for lights and \$10.00 for gas leaves a balance of \$3.00 due the Association. The total amount is to be turned back into fund.—Committee.

Reports of Missions

Blue Bell Mission—Average number of members 16. We have made one quilt for the Old Ministers' Home. We are making another quilt to sell. Have visited many who were sick, and given clothes to the needy.

New Home—Junior Mission. We have a good attendance. Sick calls 259, chapters read 1014, made and sold two quilts, 25 print hats, also bought our pastor a new suit. —Velma Woolsey, Secretary.

Tulsa Mission—Sick calls 750, cottage prayer meetings 50, several grocery showers, chapters read 1979, money paid out \$77.89, made three quilts, one name quilt bringing \$15.00. Pastor's wife given one quilt, as birthday present by Junior Mission. We have one quilt and \$3.00 for Old Ministers' Home.

Zion Hill Mission—We have met thirty-one times, sick calls 50, given five baby showers, two bridal showers, one fruit shower, made three quilts, gave one to pastor, made and sold-thirty-three hats and bonnets for \$6.10, have sold two quilts for \$5.00.—Mrs. F. S. Castleberry, See'y.

Allen Mission—Number of meetings 42, cottage prayer meetings 45, sick calls 222, money paid in collections \$34.18, money raised otherwise \$71.85, gave 40 garments to sick and needy, quilted eight quilts, gave six grocery showers, paid out \$105.43.—Mrs. Bryan, Secretary.

Cushing Mission—Average number 18 to 20, quilted 16 quilts, made many sick calls, money raised and grocery showers are turned in to the church for mission work is the church at work.—Sister Walker, President.

Jennings Mission, reported from Cushing—We are doing a good work, meet every Friday night, and cottage prayer meeting Tuesday nights. We have had several conversions. We also visit the sick and are doing good in many ways.—Opal Rogers, President.

New Home Mission—Sick calls 663, chapters read 1707, cottage prayer meetings 10, money taken in \$56.30, paid out \$50.94, amount in treasury \$5.36, 24 grocery showers to pastor and seven to needy people, quilted 12 quilts, four to complete at present. We have raised \$50.00 for new parsonage. —Sister Bacon, President.
