CHURCH COVENANT

We agree to accept Christian admonition and reproof with meekness, and to watch over one another in love, endeavoring to "keep the unity of the Spirit," in the bonds of peace, to be careful of one another's happiness and reputation, and seek to strengthen the weak, encourage the afflicted, admonish the erring, and as far as we are able, promote the success of the church and of the Gospel.

We will everywhere hold Christian principle sacred and Christian obligations and enterprises supreme; counting it our chief business in life to extend the influence of Christ in society; constantly praying and toiling that the kingdom of God may come, and His will be done on earth as it is in heaven.

To this end we agree to labor for the promotion of educational and denominational enterprises, the support of missions, the success of Sunday schools, and evangelistic efforts for the salvation of souls, and the conversion of the world. And may the God of peace sanctify us wholly, and preserve us blameless unto the coming of our Lord Jesus Christ.

ARTICLES OF FAITH

- 1. We believe the Scriptures of the Old and New Testaments are the infallible Word of God, and the only safe rule of faith and practice.—2 Tim. 3:16,17; 2 Peter 1:20, 21.
- 2: That there is but one true and living God, and in the God-Head or Divine Essence, Father, Son and Holy Ghost.—Gen. 17:1: 1 John 5:7.

- 3. That we are fallen and depraved creatures, and cannot extricate ourselves from our fallen situation by any ability we possess by nature.—Eph. 5:1, 19.
- 4. That Salvation, Regeneration, Sanctification, Justification and Redemption are by the Life, Death, Resurrection, Ascension and Intercession of our Lord and Savior Jesus Christ.—Acts 4:12; Titus 3:5.
- 5. That he that shall endure to the end, the same shall be saved.—Matt. 24:13; 2:10.

BY-LAWS

- 1. The moderator or assistant moderator, or in their absence, the oldest minister present shall call the Association into conference.
 - 2. Each session shall be opened and closed with prayer.
- 3. Five members from two or more churches shall constitute a quorum. A less number may adjourn until such quorum is present.
 - 4. Visiting brethren are invited to seats as advisory members.
- 5. Those who speak shall arise and address the moderator. Personal reflection shall be avoided in all debates.
- 6. If any proposition or motion under debate contains two or more points, it shall be divided at the request of any member and a vote taken separately.
 - 7.. Motions made and lost shall not be recorded.
- 8. No one shall speak more than twice on the same subject without leave of the moderator.
- 9. The moderator shall not allow discussion when not carried on in a Christian spirit.
- 10. The ruling of the moderator may be overruled by a twothirds vote of the members present.
- 11. Any minister opposed to any of the enterprises endorsed by the Association will not be entitled to a seat in conference and we will not seat any minister in this Association that teaches the baptism of the Holy Ghost separate from regeneration or the birth of the Spirit.
- 12. No question from any church shall come under the consideration of the Association unless it has first been discussed in its own church.
- 13. At each Association arrangements shall be made to insure two or more sermons or their equivalent devotional exercises each day.
