

The Twelveth Annual Session of the First Mission Association of Free Will Baptist was held at Old Minister's Home and Camp Ground Site, August 22 to 25, 1939.

FREE WILL BAPTIST CHURCH COVENANT

Having given ourselves to God by faith in Christ, and adopted the Word of God as our rule of faith and practice, we now give ourselves to one another by the will of God in this solemn covenant. We promise by His grace to love and obey Him in all things, to avoid the appearance of evil, to abstain from all sinful amusements and unholy conformity to the world; from all sanction of the use and sale of intoxicating beverages, and to "provide things honest in the sight of all men."

We agree to accept Christian admonition and reproof with meekness, and to watch over one another in love, endeavoring to "keep the unity of the Spirit," in the bonds of peace, to be careful of one another's happiness and reputation, and seek to strengthen the weak, encourage the afflicted, admonish the erring, and as far as we are able, promote the success of the church and of the Gospel.

We will everywhere hold Christian principle sacred and Christian obligations and enterprises supreme; counting it our chief business in life to extend the influence of Christ in society; constantly praying and toiling that the kingdom of God may come, and His will be done on earth as it is in heaven.

We agree faithfully to discharge our obligations in reference to the study of the Scriptures, secret prayer, family devotions, and social worship; and by self-denial, faith, and good works endeavor to "grow in grace and the knowledge of our Lord and Savior Jesus Christ." We will not forget the assembling of ourselves together for church conferences, public worship, and the observance of the ordinances of the Gospel, nor fail to pay according to our ability for the support of the church, of its poor, and all its benevolent work.

To this end we agree to labor for the promotion of educational and denominational enterprises, the support of missions, the success of Sunday schools, and evangelistic efforts for the salvation of souls, and the conversion of the world. And may the God of peace sanctify us wholly, and preserve us blameless unto the coming of our Lord Jesus Christ.

ARTICLES OF FAITH

- 1. We believe the Scriptures of the Old and New Tesatments are the infallible Word of God, and the only safe rule of faith and practice—2 Tim. 3:16, 17; 2 Peter 1:20,21.
- 2. That there is but one true and living God, and in the God-Head or Divine Essence, Father, Son, and Holy Ghost.—Gen. 17:1: 1 John 5:7.
- 3. That we are fallen and depraved creatures, and cannot extricate ourselves from our fallen situation by any ability we possess by nature.— Eph. 5:1, 19.
- 4. That Salvation, Regeneration, Sanctification, Justification and Redemption are by the Life, Death, Resurrection, Ascension and Intercession of our Lord and Savior Jesus Christ.—Acts 4:12; Titus 3:5.
- 5. That he that shall endure to the end, the same shall be saved. Matt. 24:13; Rev. 2:10.
- 6. That the joys of the righteous, and the punishment of the wicked shall be eternal.—Matt. 25:46.
- 7. That Baptism and the Lord's Supper, and the washing of the saints' feet are the ordinances of Jesus Christ, appointed in the church, and none but true believers are proper subjects, and the only proper mode of Baptism is Immersion.— Mark 1:4,9,10; Luke 23:30; John 13:14.
- 8. We believe in the sanctity of the first day of the week or the Lord's day, and that it ought to be observed and spent in the public or private worship of God, and that on it we should abstrain from our wordly concerns except in cases of necessity and mercy.—Ex. 31:15; Deut. 5:12; Matt. 12:12.
- 9. We believe in the resurrection of the body, both of the just and the unjust, but every one in his own order; those who have done evil to the resurrection of damnation, and that God has appointed a day in which He will judge the world in righteousness by Jesus Christ.—1 Cor. 15:34; John 5:28; 1 Thes. 4:16.
- 10. That it is our duty to be tender and affectionate to one another, and to study the happiness of the people of God in general, and to be singly engaged to promote the honor of God.

 John 13:35; Gal. 6:10.
- 11. We believe that Jesus Christ by the grace of God tasted death for every man; yet none can partake of his divine benefit only by his repentance towards God and faith in the Lord Jesus Christ, infants and idiots excepted.—Acts 20:21; 1 Tim. 2:5,6; John 3:14-16; 1Cor. 15:20,22; Romans 5:15.
- 12. We believe that the Lord Jesus Christ is the door into the church, that Baptism is a duty in answer to a good conscience.—John 10:7; 1 Peter 3:21.
- 13. We believe that the Lord's people are one in Him, and therefore should be one at His table.—1 Cor. 1:1, 11, 27, 28; Jchn 17:11.

BY-LAWS

- 1. The moderator or assistant moderator, or in their absence, the oldest minister present shall call the Association into conference.
 - 2. Each session shall be opened and closed with prayer.
- 3. Five members from two or more churches shall constitute a quorum. A less number may adjourn until such quorum is present.
 - 4. Visiting brethren are invited to seats as advisory members.
- 5. Those who speak shall arise and address the moderator. Personal reflection shall be avoided in all debates.
- 6. If any proposition or motion under debate contains two or more points, it shall be devided at the request of any member and a vote taken separately.
 - 7. Motions made and lost shall not be recorded.
- 8. No one shall speak more than twice on the same subject without leave of the moderator.
- 9. The moderator shall not allow discussion when not carried on in a Christian spirit.
- 10. The ruling of the moderator may be overruled by a two-thirds vote of the members present.
- 11. Any minister opposed to any of the enterprises endorsed by the Association will not be entitled to a seat in conference and we will not seat any minister in this Association that teaches the baptism of the Holy Ghost separate from regeneration or the birth of the Spirit.
- 12. No question from any church shall come under the consideration of the Association unless it has been first discussed in its own church.
- 13. At each Association arrangements shall be made to insure two or more sermons or their equivalent devotional exercises each day.
