On March 21, 1949 the board had their second meeting and employed Bro. E. S. Hill as caretaker and allowed him to move bus body on the ground for a chicken house, and to paper the caretaker's house.

Bro. Hill began work April 1, 1949.

On April 8, 1949 we met the third time and agreed to have the Camp Ground surveyed.

Motion carried to give Rev. Harry Staries authority

to arrange for building showers.

We find the Association is in debt to Bro. L.-Y. King \$64.14 for building material for caretaker's house and repair on lawn mower. —Signed, Board.

Resolution Committee-

Resolution No. 1. Rules for Trustees. The Board of Trustees shall be elected by and be subject to the Association. They shall act as custodians of all legal papers when authorized by the Association to do so.

Resolution No. 3. Be it resolved that deacons serving

our churches be elected each year by their church.

Resolution No. 4. Resolved that we run a concrete floor in the Tabernacle.

Resolution No. 5. Be it resolved that this Association demand our ministers to adhere strictly to the Free Will

Baptist doctrine, and that we replace the latter clause of paragraph 11 in our minutes.

Credential Committee-

We, the Credential Committee have reached an agreement between Rev. Bert F. Rogers and the Turley Free Will Baptist Church:

We, the Turley Church agree that we have acted illegally against Rev. Bert F. Rogers, and we agree to accept his resignation effective September 6, 1949.—Signed Turley Church.

I hereby tender my resignation as pastor of the Turley Free Will Baptist Church of Turley, Oklahoma effective September 6, 1949 —Bert F. Rogers.

We, the Temperance Committee recommend that we accept the resolution as passed and adopted by the National Association. We also urge all our people to vote no on Repeal September 27, 1949.

1. That we pledge ourselves as followers of Christ to patronize no place of business that sells strong drinks.

2. That we use our influence and votes against the election of representatives and senators to our state and national legislative bodies and any other public officials who advocate the use or sale of strong drink.

3. That we do not subscribe to any magazine that advertises strong drink, and that we protest such advertising to the editors. Futhermore, that we protest the advertising of strong drink over the radio.

And whereas we are conscious of other characterdestroying evils of our country, we also recommend

4. That we seek to lift the morals of our people by strongly disapproving indecency of dress in public, that is, wearing shorts, mixed public swimming of both sexes, etc:

5. That we protest the use of popular gambling devices, that is, slot machines, pin ball machines, carnival games, card games:

6. That we take a positive stand against our youth at-

tending Hollywood inspired and Hollywood made movies that are destructive to their character; that we discourage reading of comic books, and attending the dance;

7. We further recommend that our state and national papers be more emphatic in crying out continually

against these evils.

CONSTITUTION

From long experience, we are convinced of the necessity of a combination of churches to perpetuate our union and to maintain a correspondence among our churches.

Therefore we have adopted the following Constitution

and By-Laws for our government.

1. This shall be called the First Mission Association.

2. This Association shall be composed of such well regulated Free Will Baptist Churches, maintaining Gospel order, agreeing with the denomination in doctrine and practices, favoring the enterprises that have been endorsed by this Association.

3. The acting members of this Association shall be the ministers, deacons, and the church clerks belonging to any church composing this body, also three delegates from each church chosen by the members of their re-

spective churches.

4. The officers of this Association shall be a Moderator, an Assistant, a Clerk, an Assistant Clerk, and an Executive Board composed of five members. The board members to be elected so as to require one to be elected each year. A Board of Trustees consisting of five members. The Trustees shall be elected by and be subject to

the Association. They shall act as custodians of all property belonging to the Association, and shall sign all legal papers when authorized by the Association to do so. All officers shall hold office until their successors are elected.

5. The property of any church in this Association that should go down until they can not transact business because they are disorganized, shall become the property of this Association and the Executive Board has power

to execute legal papers for the property.

6. This Association shall meet annually at such time and place as shall be decided upon by the Association, also meet in regular quarterly meetings and at such quarterly meetings shall have power to transact all business of the Association except to change the Constitution.

7. This Association may be called together by the Moderator, by giving the churches ten day's notice of

such meetings.

8. This Constitution may be changed at any yearly meeting by a two-thirds majority of members voting.

BY-LAWS

1. The Moderator or Assistant Moderator, or in their absence, the oldest minister present shall call the Association into conference.

2. Each session shall be opened and closed with prayer...

3. Five members from two or more churches shall constitute a quorum. A less number may adjourn until such quorum is present.

4. Visiting brethren are invited to seat as advisory

members.

- 5. Those who speak shall arise and address the Moderator. Personal reflections shall be avoided in all debates.
- 6. If any proposition or motion under debate contains two or more points, it shall be divided at the request of any member and a vote taken.

8. Motions made and lost shall not be recorded.

8. No one shall speak more than twice on the same subject without special leave of the Moderator.

9. The Moderator shall not allow discussions when

not carried on in a Christian spirit.

10. The ruling of the Moderator may be overruled by a two-thirds majority of the members voting.

- 11. Any minister opposed to any of the enterprises endorsed by this Association will not be entitled to a seat in Conference, and we will not seat any minister in this Association that teaches the Baptism of the Holy Ghost separate from regeneration or the birth of the Spirit.
- 12. No question from any church shall come under the consideraation of the Association unless it has first been discussed in its own church.
- 13. At each Association arrangements shall be made to ensure two or more sermons or their equivalent devotional exercises each day:
