The second meeting of the Executive Board was at the Turley Free Will Baptist Church, at the request of the Church, on Saturday night, January 12, 1952. The Board conducted a business meeting for the church. Great progress was made in the meeting.

The Third Board meeting was at the Bristow Church,

which was in joint session with the League Board. The care of the cafe for the youth camp meeting and camp meeting was turned over to the League Board, and all money from the cafe was to go to the League. This meet-

ing was March 13, 1952.

The Fourth Executive Board meeting was held at the camp grounds March 20, 1952. Motion carried to drill well deeper and that supervision be left to Rev. Lonnie Hall. Motion carried to turn the placing of the foundation under the small boys dormitory to the League Board.

The drilling of the well deeper cost a total amount of

- 8. ANY PERSON OR PERSONS FOUND DESTROYING PROPERTY WILL BE SENT HOME IMMEDIATELY.
- 9. BREAKFAST WILL BE SERVED AT 7:00 A.M.; LUNCH AT 12:00 NOON; AND SUPPER AT 5:30.
- 10. MEAL TICKETS WILL BE ISSUED ONLY TO ENROLL-ED LEAGUERS, DORMITORY SPONSORS, TEACHERS, AND LEAGUE BOARD MEMBERS.

CONSTITUTION

From long experience, we are convinced of the necessity of a combination of churches to perpetuate our union and to maintain a correspondence among our churches.

Therefore we have adopted the following Constitution

and By-Laws for our government.

1. This shall be called The First Mission Association.

2. This Association shall be composed of such well regulated Free Will Baptist Churches, maintaining Gospel Order, agreeing with the denomination in doctrine and practices, favoring the enterprises that have been endorsed by this Association.

3. The acting members of this Association shall be the ministers, ministers' wives, deacons, and the church clerks belonging to any church composing this body, also three delegates from each church chosen by the members of

their respective churches.

- 4. The officers of this Association shall be a Moderator, an Assistant Moderator, a Clerk, an Assistant Clerk, and an Executive Board composed of five members. The board members to be elected each year. A Board of Trustees to be elected so as to require one to be elected each year. The Trustees shall be elected by and be subject to the Association. They shall act as custodians of all property belonging to the Association, and shall sign all legal papers when authorized by the Association to do so. All officers shall hold office until their successors are elected.
- 5. The property of any church in this Association that should go down until they cannot transact business because they are disorganized, shall become the property of the Association and the Executive Board has power to execute legal papers for the property.

6. This Association shall meet annually at such time and place as shall be decided upon by the Association, also meet in regular quarterly meetings and at such quarterly

meetings shall have power to transact all business of the Association except to change the Constitution.

7. This Association may be called together by the Moderator by giving the churches ten days' notice of such

meetings.

8. This Constitution may be changed at any yearly meeting by a two-thirds majority of members voting.

BY-LAWS

- 1. The Moderator or Assistant Moderator, or in their absence, the oldest minister present shall call the Association into conference.
 - 2. Each session shall be opened and closed with prayer.
- 3. Five members from two or more churches shall constitute a quorum. A less number may adjourn until such quorum is present.
- 4. Visiting brethren are invited to sit as advisory members.
- 5. Those who speak shall arise and address the Moderator. Personal reflections shall be avoided in all debates.
- 6. If any proposition or motion under debate contains two or more points, it shall be divided at the request of any member and a vote taken.
 - 7. Motions made and lost shall not be recorded.
- 8. No one shall speak more than twice on the same subject without special leave of the Moderator.
- 9. The Moderator shall not allow discussion when not carried on in a Christian spirit.
- 10. The ruling of the Moderator may be overruled by a two-thirds majority of the members voting.
- 11. Any minister opposed to any of the enterprises endorsed by this Association will not be entitled to a seat in Conference, and we will not seat any minister in this Association that teaches the Baptism of the Holy Ghost separate from Regeneration or the birth of the Spirit.
- 12. No question from any church shall come under the consideration of the Association unless it has first been discussed in its own church.
- 13. At each Association arrangements shall be made to ensure two or more sermons or their equivalent devotional exercises each day.
