ASSOCIATIONAL PROCEEDINGS

The twenty-eighth annual session of First Mission Association of Free Will Baptists met August 23, 1955 at the Old Ministers' Home and Camp Grounds for the Introductory service. The meeting was called to order at 7:45 p. m. by the moderator, Rev. Harry E. Staires. Singing was led by Rev. Ernest M. Kennedy. The planist was Rev. Cleo Purcell. The congregation was led in prayer by Rev Ernest Harrison. Special recognition was given Rev. and Mrs. W. H. Carter, with Rev. Carter stating he had spent 46 years in the Gospel ministry. Visiting brethren were also recognized as follows: Rev. and Mrs. Alonzo Florence of California, and Rev. and Mrs. Gene Womack of First Oklahoma Association. A solo, "No One Ever Cared for Me Like Jesus," was sung by Sister Martha Biggs, with Rev. Ernest M. Kennedy, pianist. A quartet composed of Rev. and Mrs. James Christian, Rev. Woodrow Matthews and Rev. Conn Saddler sang "I'm Free Again," after which Rev. and Mrs. Kennedy sang "He Lifted Me Up," with Rev. Cleo Purcell, pianist.

The introductory message was delivered by Rev. L. A. Yandell who read 1 Cor. 3:1-11, and used for a title, "Laborers together." Following the sermon a prayer of benediction was led by Rev. Alonzo Florence.

WEDNESDAY MORNING SESSION

Services were opened by the moderator. Singing was led by Rev. Ernest M. Kennedy, pianist, Sister Kay Harris. Prayer was led by Rev. Carl Hembree. The moderator read a few verses of scripture from the 6th chapter of Proverbs after which prayer was led by Rev. Melvin Bingham. Letters were called for and read from 24 churches. Motion carried to receive the letters and seat the delegates. Motion carried the moderator and assistant moderator appoint a pulpit committee to serve throughout the

entire session of the association.

Election of officers was called for and the following were elected: Moderator, Rev. Melvin Bingham; Assistant Moderator, Rev. Ernest M. Kennedy; Clerk, Rev. Ben Scott; Assistant Clerk, Sister Cherry Fipps.

THE STATE OF THE PARTY OF

Report of pulpit committee: Rev. C. C. Hood was selected to bring the eleven o'clock message followed by Rev. Ernest Harrison.

Motion carried to adjourn until 1:15 p. m. Prayer of benediction was led by Rev. Earnie Deeds.

The eleven o'clock worship service was opened by congregational singing led by Rev. Ernest M. Kennedy; pianist, Miss Mary Alice Young. Songs, "Take the Name of Jesus With You" and "Glory To His Name" were sung, after which prayer was led by Rev. Paul Purcell. Rev. Paul Inbody sang "Follow Me" with Rev. Ernest M. Kennedy, pianist.

The assistant moderator introduced the messengers of the hour. Rev. Hood took the stand, reading for a scripture lesson, Matt. 16:17-20; he used for a title "The Church." Rev. Harrison followed reading from John 3:1-14, after which he led in prayer. He then spoke on "The New Birth in Relationship to the Church." An invitation song was sung, "I'll Live For Him." Prayer of Blessing on the noon meal and benediction was led by Rev. F. E. Crane.

WEDNESDAY AFTERNOON SESSION

The services were opened with the congregation singing "Amazing Grace" led by Rev. Ernest M. Kennedy; pianist Sister Kay Harris. The moderator read the 24th Psalm after which Rev. D. B. Hellard led in prayer. The moderator called for election to fill vacancies on the Credentials Board. Rev. Paul Purcell was elected to fill the unexpired term of Rev. Dale Munkus. Rev. Carl Hembree was elected for a five year term. The assistant moderator read the By-laws of the association.

Visiting brethren were recognized, Rev. Alonzo Florence from Palmdale, California, a member of the Southern Association of California.

Motion carried that the moderator and assistant moderator appoint all committees. Note: See list of committee elsewhere.

Report of the Executive Board was read by the clerk. Motion carried to accept report and adopt it item by item. All recommendations were adopted.

League rally report was read and motion carried to accept report to be adopted item by item. The following were elected to fill League Rally offices: Sponsor of Youth Camp, Rev. Paul Inbody; League Board members, Rev. Ben Scott, Rev. L. A. Yandell, Rev. Bob Duck, Rev. Paul Purcell, and Brother Ralph Horton; Dormitory Sponsors, Senior boys, Rev. Ernest Harrison and Rev. Woodrow Matthews; Junior boys, Rev. Ben Scott and Rev. Doyle Dipboye; Senior girls, Sister Harrison and Sister Genell Scott; Junior Girls, Sister Joy Lou Yandell and Sister Lela Dipboye.

Woman's Auxiliary report was read and adopted.

Treasurer's report was read and adopted.

Motion carried to add Woman's Auxiliary Treasurer's report to the general report.

Election of board members was as follows: Rev. Ernest Harrison to executive board for five year term. Rev. W. E. Warner was elected to trustee board replacing Rev. Richard Shade, term to expire in 1957. Rev. Melvin Bingham was elected to trustee board for five year term.

Sunday School board report was read and adopted. Rev. Woodrow Matthews was elected to Sunday School board for five year term.

Rev. Ernest M. Kennedy was elected to serve unexpired term of Rev. Dale Munkus on Home Mission Board; term to expire in 1956.

Rev. Harry E. Staires was elected to three year term on Home Mission Board.

The pulpit committee reported Rev. Carl Hembree and Rev. W. H. Carter had been chosen to preach for the evening service.

The trustee board gave as information the title to Camp Ground has been granted in favor of Free Will Baptists.

Staires took charge of the services and introduced the special singers: Duet, "Jesus Spoke to Me" and by the Purcell family, pianist, Rev. Ernest M. Kennedy. Solo, "Oh, What a Saviour" by Sister Martha Biggs. Pianist, Miss Mary Alice Young; Solo, "Keys to the Kingdom" by Sister Georgia Harris, Pianist, Rev. Ernest M. Kennedy. Speakers for the evening were introduced and Rev. W. H. Carter took the stand singing an old hymn and using for a sermon title, "Does a Sinner Have to Pray in Order to Be Saved?" His text was John 9:30.

Rev. Carl Hembree followed Bro. Carter and used the same subject with a portion of Acts, Chapter 8, enlarging on Christian Standard. Prayer of benediction was led by Rev. L. A. Yandell.

Ernest Harrison, sang "Precious Memories," with Rev. Cleo Purcell, Pianist.

The moderator introduced the speaker for the Memorial message. Rev. Ernest M. Kennedy took the stand and read the 23rd Psalm, after which prayer was led by Rev. Jess Stepp. Text for the message was Psalm 23:1. At the close of the message the moderator read the 24 names on the obituary list and the congregation stood for prayer led by Rev. George H. Johnson. Rev. Paul Inbody prayed the prayer of benediction and blessing on the noon meal.

Executive board report: We have met seven times this year for the purpose of transacting business. Two new churches have been organized, one at Stroud and one at Skiatook. We have had one work day at the Camp Grounds and finished the sheds used for study. We made trips to Miami, Stroud, and Skiatook in an advisory capacity. Rev. Paul Purcell has been elected to fill the unexpired term of Rev. Harry Beatty, who resigned and left the district. We have met and recommended the following:

1. That the budget of \$12,000.00 that was set last year be retained for the coming year, with the allocations for each church remaining the same, or more if the church can raise it.

2. We recommend that 80 percent of the budget raised be

sent through the State co-operative program and 20 percent remain in the District for operating purposes.

3. We recommend a loan of \$10,000.00 be negotiated on the Camp Ground property to be used for improvement of same.

RESOLUTIONS

No. 1—Be it resolved that we have an adult class in the encampment and camp meeting.

No. 2—Be it resolved that the elected League board serve terms as follows: Rev. Paul Purcell, 5 years; Rev. Ben Scott, 4 years; Rev. L. A. Yandell, 3 years; Rev. Bob Duck, 2 years; Bro. Ralph Horton, 1 year.

No 3—Be it resolved that we disolve the resoultion pertaining to the three months waiting period for ministers, as has been required in the past by the association.

No. 4—Be it resolved that we recommend that when the association is in the worship service all on the grounds be asked to attend the service unless providentially hindered.

No. 5—Be it resolved that we write a new blanket insurance

and that our cabins be insured \$200,00 per cabin if possible.

No. 6—Be it resolved that the credential board be urged to act as quickly as possible on candidates for license or ordination. Be it further resolved that if the board cannot reach a decision at the Quarterly Meeting or Association they be allowed to wait three months.

CREDENTIALS BOARD REPORT

- No. 1—We, have examined Rev. Ernest Harrison and found him sound in doctrine. We recommend that this body accept him into full fellowship, and extend to him a hearty welcome.
- No. 2—We find that Bro. Homer Pilgram has not served his trial time and we recommend that he serve this time before examination.
- No. 3—We have examined and found sound in doctrine Bro. Claude M. Robinson of Oilton and we recommend him for ordination as a deacon.
- No. 4—We have examined Bro. Willis Walker and found him sound in doctrine and we recommend him to be licensed to preach for one year.
- No. 5—We have examined and found Bro. Carrol Reynolds sound in doctrine and we recommend that he be given license to preach for one year.
- No. 6—We have examined and found Bro. Conn Saddler unsound in doctrine of the Free Will Baptist Denomination; therefore we cannot recommend his ordination as a minister of the Free Will Baptist Denomination.
- No. 7—We have searched the Treatise, and find no place where we are authorized to examine the deacons for ordination. Therefore, we refer this matter back to this body.—Tabled for 3 months.

We will not forsake the assembling of ourselves together for church conferences, public worship, and the observance of the ordinances of the Gospel, nor fail to pay according to our ability for the support of the church, of its poor, and all its benevolent work.

We agree to accept Christian admonition and reproof with

meekness, and to watch over one another in love, endeavoring to "keep the unity of the Spirit" in the bonds of peace, to be careful of one another's happiness and reputation, and seek to strengthen the weak, encourage the afflicted, admonish the erring, and as far as we are able promote the success of the church and of the Gospel.

We will everywhere hold Christian principle sacred and Christian obligation, and enterprises supreme; counting it our chief business in life to extend the influence of Christ in society; constantly praying and toiling that the Kingdom of God may come, and His will be done on earth as it is in Heaven.

To this end we agree to labor for the promotion of educational and denominational enterprises, the support of missions, the success of Sunday school and evangelistic efforts for the salvation of the world. And may the God of peace sanctify us wholly, and preserve us blameless unto the coming of our Lord Jesus Christ.

ARTICLES OF FAITH

- 1. We believe the Scriptures of the Old and New Testament are the infallible Word of God, and the only safe rule of faith and practice. 2 Tim. 3:16; 2 Peter 1:20-21.
- 2. That there is but one true and living God, and in the God Head or Divine Essence, Father, Son, and Holy Ghost. Gen. 17:1: 1 John 5:7.
- 3. That we are fallen and depraved creatures, and cannot extricate ourselves from our fallen situation by any ability we possess by nature. Eph. 5:1-19.
- 4. That Salvation, Regeneration, Sanctification, Justification, and Redemption are the Life, Death, Resurrection, Ascension, and Intercession of our Lord and Saviour Jesus Christ. Acts 4:12; Titus 3:5.
- 5. That he that shall endure to the end, the same shall be saved. Matt. 22:13; Rev. 2:10.
- 6. That the joys of the righteous and the punishment of the wicked shall be eternal. Matt. 25:46.
- 7. The Baptism and the Lord's Supper and the washing of the saint's feet are the ordinances of Jesus Christ, appointed in the Church, and none but true believers are proper subjects, and the only proper mode of baptism is immersion. Mark 1:4, 9, 10; Luke 23:30; John 13:14.
- 8. We believe in the sancity of the first day of the week or the Lord's Day, and that it ought to be observed and spent in public or private worship of God, and that on it we should abstain from our worldly concerns except in cases of necessity and mercy. Ex. 31:15; Deut. 5:12; Matt. 12:12.
- 9. We believe in the resurrection of the body, both of the just and unjust, but everyone in his own order, those who have

done evil to the resurrection of damnation, and that God has appointed a day in which He will judge the world in righteousness by Jesus Christ. 1 Cor. 15:12; Matt. 12:12.

- 10. That it is our duty to be tender and affectionate to one another, and to study the happiness of the people of God in general, and to be singly engaged to promote the honor of God. John 13:35; Gal. 6:10.
- 11. We believe that Jesus Christ by the grace of God tasted death for every man; yet none can partake of this divine benefit only by his repentance toward God and faith in the Lord Jesus Christ, infants and idiots excepted. Acts 20:21; 1 Tim. 2:5-6; John 3:14, 16; 1 Cor. 15:20-22; Romans 5:15.
- 12. We believe that the Lord Jesus Christ is the door into the church, that baptism is a duty in answer to a good conscience. John 10:7: 1 Pet. 3:21.
- 13. We believe that the Lord's people are one in Him, and, therefore, should be one at His Table. 1 Cor. 1:1, 11, 27, 28.

CONSTITUTION

From long experience, we are convinced of the necessity of a combination of churches to perpetuate our union and to maintain a correspondence among our churches.

Therefore we have adopted the following Constitution and By-laws for our government.

- 1. This shall be called the First Mission Association.
- 2. This Association shall be composed of such well regulated Free Will Baptist Churches, maintaining Gospel order, agreeing with the denomination in doctrine and practices, favoring the enterprises that have been endorsed by this association.
- 3. The acting members of this association shall be the ministers, minister's wives, deacons, and the church clerks belonging to any church, composing this body, also three delegates from each church chosen by the members of their respective churches.
- 4. The officers of this Association shall be a Moderator, and Assistant Moderator, a Clerk, and Assistant Clerk, and an Executive Board composed of five members. The Board members to be elected so as to require one to be elected each year. A board of Trustees to be elected so as to require one to be elected each year. The Trustees shall be elected by and be subject to the Association. They shall act as custodians of all property belonging to the Association, and shall sign legal papers when authorized by the Association to do so. All officers shall hold office until their successors are elected.
- 5. The property of any church in this Association that should go down until they cannot transact business because they are disorganized, shall become the property of the Association and the Executive board has power to execute legal papers for the property.

- 6. This association shall meet annually at such time and place as shall be decided upon by the association, also meet in regular quarterly meetings, and at such quarterly meetings shall have power to transact business of the association except to change the Constitution.
- 7. This Association may be called together by the moderator by giving the churches ten days' notice of such meeting.
- 8. This Association shall not license or ordain any person to the ministry or as a deacon who has more than one living companion.
- 9. This Constitution may be changed at any yearly meeting by a two-thirds majority of members voting.

BY-LAWS

- The moderator or assistant moderator, or in their absence, the oldest minister present shall call the association into conference.
 - 2. Each session shall be opened and closed with prayer.
- 3. Five members from two or more churches shall constitute a quorum. A less number may adjourn until such quorum is present.
 - 4. Visiting brethren are invited to sit as advisory members.
- 5. Those who speak shall arise and address the moderator. Personal reflections shall be avoided in all debates.
- 6. If any proposition or motion under debate contains two or more points, it shall be divided at the request of any member and a vote taken.
 - 7. Motions made and lost shall not be recorded.
- 8. No one shall speak more than twice on the same subject without special leave of the moderator.
- 9. The moderator shall not allow discussion when not carried on in a Christian spirit.
- 10. The ruling of the moderator may be overruled by a two-thirds majority of the members voting.
- 11. Any minister opposed to any of the enterprises endorsed by this association will not be entitled to a seat in conference, and we will not seat any minister in this association that teaches the baptism of the Holy Ghost separate from Regeneration or the Birth of the Spirit.
- 12. No questions from any church shall come under the consideration of the association unless it has first been discussed in its own church.
- 13. At each assocation arrangements shall be made to ensure two or more sermons or their equivalent devotional exercises. each day.
