The twenty-ninth annual session of The First Mission Association of Free Will Baptists met August 21, 1956 at the Old Minister's Home and Camp Grounds for the Introductory Service. The meeting was called to order by the Moderator, Rev. Melvin Bingham. Singing was led by Raymond Lee with Lavern Lee as pianist. The congregation was led in prayer by Rev. F. E. Crain. Devotional service was conduced by Moderator, and a Trio composed of Elda Foster, Ed Mayfield and Don Campbell sang, "It is no Secret." Lavern Lee was pianist.

The Moderator recognized eight present who attended the first session of the First Mission Association 29 years ago. Robert and June Duck of Oilton sang, "Jesus Passed By."

Rev. Ralph Brown was introduced by the Moderator to bring the Introductory message. He used Luke 11:38-42 for the scripture reading, and for his subject, "What We Need." After this most timely message the benediction was led by Rev. Willard C. Day.

EXECUTIVE BOARD REPORT: From the minutes of the Executive Board Clerk; We find they met ten times this year for the purpose of transacting business.

Revival was sponsored by the Executive Board; which was responsible for the organization of the Coffeyville, Kansas, church.

The organization took place October 7, 1955.

Several trips were made to and from Coffeyville in establishing this new work and settling business transactions toward a loan to the Coffeyville Church from the First Mission Association of one thousand five hundred eighty six and 30-100 dollars. (\$1,586.30).

A number of items of business were transacted in the care of our Camp Ground, including: the hiring of a care taker, getting new piano, hiring carpenters, and sponsoring a work day at the camp, and the drilling of a new water well. A new sign also was placed at the ertrance of the grounds.

Organization of another Free Will Baptist church was held at Sapulpa, Oklahoma, May 18, 1956. It was named the South Side Church and Rev. W. E. Warner was elected pastor.

Upon the request of the Pretty Water Free Will Baptist Church the Board met with them for the purpose of conducting their business conference for the election of church officers.

BALANCE ON HAND

AUDITING COMMITTEE REPORT: We, the auditing committee have audited the books of the First Mission Association Treasurer, and find them in order. Myrl Wilson, Virginia Johns and Mable Wooldridge, members.

LEAGUE RALLY REPORT: To The First Mission Association when convened at the Camp Grounds on August 22, 1956. We wish to report the results of our business meeting on Saturday, August 18, 1956. Officers elected for the following year are: President, Everett Ray Keiffer; Vice President, Ronnie Jones; Recording Secretary, Barbara Staires; Corresponding Secretary, Retha Keiffer; Treasurer, Peggy Cox; Song Leader, Charles Biggs; Pianist, Mary Alice Young.

We recommend to the Association: Camp Director, Charlie Smith; second choice for camp director, Rev. Robert Duck. Motion made and carried that we elect our sponsors of dormitories at the last quarterly meeting. Resolutions made by League Convention: Be it resolved that the youth encampment be extended to a ten (10) day period; with the yearly league convention day being conducted the first Friday of Youth Encampment. Resolved that the boys rest room facilities be either repaired or replaced. Resolved that a planned recreation program and better recreation facilities be provided. Motion made and carried that a committee of five (5) be elected. They were as follows: Rev. L. A. Yandell, chairman, June Duck, Bob Duck, Rev. Paul Pursell, Rev. Doyle Dipboye. Be it resolved that if the fee of enrollment is raised we then recommend that the local church pay a certain percentage toward the expense.

Motion made and carried to turn all youth encampment receipts to the First Mission Association, and let them pay all youth encampment expenses. The remaining amount, if there be any, be contributed to the First Mission Association Treasurer as a gift from the First Mission League Convention.

SUNDAY SCHOOL BOARD REPORT: The board met a total of eight times. Recommendations, action, and result as follows: That two Sunday School Clinics be established, one on the east side, and one on the west side of the Association. Recommended subjects were: 1. Sunday School Administration. 2. Visitation. 3. Records. 4. Duties of the teacher. 5. Duties of the superintendent.

The first school was held January 23-27 at the New Home Church. Teachers were Ralph Horton, Bessie Staires, Robert Duck, John West and Harry Staires. It was agreed that one must attend four out of the five scheduled nights to receive a certificate. A total of 106 were enrolled, plus 34 in the nursery department. There were 59 cert ficates awarded.

The second school was held at Drumright, February 13-17.

Teachers were L. A. Yandell, Jim Christian, Cleo Pursell and Ernest Harrison. This second school had an enrollment of 91 with 54 receiving certificates. Total enrollment for the two schools was 197. Total certificates given was 113. Total expense incurred for the schools was \$32.12. Free Will offerings at school was \$37.47. Leaving a balance of \$5.35.

Program outline for the Sunday School Day was prepared and necessary arrangements made. Theme for the day was "Winning the lost thru the Sunday School." Teachers were Lynn Hamilton, L. A. Yandell, Cleo Purcell, Ralph Horton, Bessie Staires, and Harry Staires. Fifteen churches submitted annual reports to the Sunday School Day Convention.

- 10. That it is our duty to be tender and affectionate to one another, and to study the happiness of the people of God in general, and to be singly engaged to promote the honor of God. John 13:35; Gal. 6:10.
- 11. We believe that Jesus Christ by the grace of God tasted death for every man; yet none can partake of this divine benefit only by his repentance toward God and faith in the Lord Jesus Christ, infants and idiots excepted. Acts 20:21; 1 Tim. 2:5-6; John 3:14-16; 1 Cor. 15:20-22; Romans 5:15.
- 12. We believe that the Lord Jesus Christ is the door into the Church, that baptism is a duty in answer to a good conscience. John 10:7; 1 Peter 3:21.
- 13. We believe that the Lord's people are one in Him, and, therefore, should be one at His table. 1 Cor. 1:1, 11, 27, 28.

### CONSTITUTION

From long experience, we are convinced of the necessity of a combination of churches to perpetuate our union and to maintain a correspondence among our churches.

Therefore we have adopted the following Constitution and By-laws for our government.

- 1. This shall be called the First Mission Association.
- 2. This Association shall be composed of such well regulated Free Will Baptist Churches, maintaining Gospel order, agreeing with the denomination in doctrine and practices, favoring the enterprises that have been endorsed by this association.
- 3. The acting members of this association shall be the Ministers, Ministers Wives, Deacons, and the Church Clerks belonging to any church, composing this body, also three delegates from each church chosen by the members of their respective churches.
- 4. The officers of this Association shall be a Moderator, and Assistant Moderator, a Clerk, and Assistant Clerk, and an Executive Board composed of five members. The Board members to be elected so as to require one to be elected each year. A board of Trustees to be elected so as to require one to be elected each year. The Trustees shall be elected by and be subject to the Association. They shall act as custodians of all property belonging to the Association, and shall sign legal papers when authorized by the Association to do so. All officers shall

hold office until their successors are elected. There is a little of

- 5. The property of any church in this Association that should go down until they cannot transact business because they are disorganized, shall become the property of the Association and the Executive Board has power to execute legal papers for the property.
- 6. This Association shall meet annually at such time and place as shall be decided upon by the Association, also meet in regular Quarterly Meetings, and at such quarterly meetings shall have power to transact business of the Association except to change the Constitution.
- 7. This Association may be called together by the Moderator by giving the churches ten days notice of such meeting.
- 8. This Association shall not license or ordain any person to the Ministery or as a Deacon who has more than one living companion.
- 9. This Constitution may be changed at any Yearly Meeting by a two-thirds majority of members voting.



# BY-LAWS

- 1. The Moderator or Assistant Moderator, or in their absence, the oldest minister present shall call the Association into conference.
  - 2. Each session shall be opened and closed with prayer.
- 3. Five members from two or more churches shall constitute a quorum. A less number may adjourn until such quorum is present.
  - 4. Visiting brethren are invited to sit as advisory members.
- 5. Those who speak shall arise and address the moderator. Personal reflections shall be avoided in all debates.
- 6. If any proposition or motion under debate contains two or more points, it shall be divided at the request of any member and a vote taken.
  - 7. Motions made and lost shall not be recorded.
- 8. No one shall speak more than twice on the same subject without special leave of the Moderator.
- 9. The Moderator shall not allow discussion when not carried on in a Christian Spirit.
- 10. The ruling of the Moderator may be overruled by a twothirds majority of the members voting.
- 11. Any Minister opposed to any of the enterprises endorsed by this Association will not be entitled to a seat in conference, and we will not seat any Minister in this Association that teaches the baptism of the Holy Ghost separate from Regeneration of the Birth of the Spirit.
- 12. No questions from any church shall come under the consideration of the Association unless it has first been discussed in

its own church.

13. At each Association arrangements shall be made to ensure two or more sermons or their equivalent devotional exercises each day.

# ALL RESOLUTIONS OF THIS ASSOCIATION WHICH ARE NOW IN EFFECT

- 1. BE IT RESOLVED that all our By-Laws and Resolutions which are now in effect, be printed in our minutes.
- 2. That the traveling expenses of the Credential Board "While on business for the Association," be paid.
- 3. That hereafter the November quarterly meeting begin Thursday night before the third Sunday, because of the Thanksgiving holidays.
- 4. That our Churches not send any minister up for ordination until he has been licensed for one year from date of examination.
- 5. Churches sending delegates to State Association must send \$5 for this delegate's fee.
- 6. That in the examination of candidates for ordination and license, each question and answer be recorded and filed with the clerk of the Association.
- 7. That we the First Mission Association, let it be known to all churches, new members of our Association, and all churches coming in hereafter, that their property is the property of this Association until dismissed by letter from this Association.
- 8. That since we have grown to such proportion, we seat our delegates from the chair, without the usual line up and hand shake.
- 9. That from this time on there will be no one licensed or ordained to the ministry or as a deacon who has more than one living companion, and that such a law become a part of our constitution.
- 10. That no person can be an active deacon or minister in this Association who does not pay and teach tithes.
- 11. That the letters of all churches be in the hands of the Associational Clerk at least one week before Conference convenes.
- 12. That the Sunday School Board be placed on a permanent basis, with a five member board, holding office for five years, and one member going off each year.
- 13. That the Association give the Mission Board the power to establish churches wherever they find it possible.
- 14. That this body purchase or supply a typewriter for Associational use.
- 15. That we recommend that when the Association is in the worship service all on the grounds be asked to attend the service unless providentially hindered.
- 16. That we write a new blanket insurance, and that our cabins be insured "Two Hundred Dollars" per cabin.

- 17. That the credent al board be urged to act as quickly as possible on candidates for license or ordination. Be it further resolved that if the board cannot reach a decision at the Quarterly meeting or Association, that they be allowed to wait three months.
- 18. That churches having candidates for ordination or license send request to quarterly conference in session prior to examination. Examination date to be set at a date between sessions of the Quarterly Conference by the Credential Committee.

19. That all of our Churches use the letter forms furnished by our Clerk.
