MINUTES OF THE FORTY-SECOND ANNUAL FIRST MISSION ASSOCIATION MEETING

Friday Morning — August 15, 1969

The introductory service of the Forty-Second Annual Session of the First Mission Association of Free Will Baptist convened at the Old Minister's Home and Campground on Friday morning, August 15, 1969. Theme for the Association Meeting was "Ministry of Unity" taken from Ephesians 4:4-6. Rev. Jim Christian, Moderator, was in charge with Rev. and Mrs. Bob Ketchum in charge of the music. The service was opened with singing "Stand Up Stand Up for Jesus", then led in prayer by Bro. Wood from the Bristow Free Will Baptist Church. Congregational singing consisted of "Jesus Saves" and "When I See the Blood." The Moderator's message was taken from Ephesians 4:4a; theme being "One Body". Prayer by Rev. Melvin Bingham.

1. Session called into conference by moderator, motion made, seconded, and carried. Nomination for assistant moderator: Rev. Bob Ketchum was elected. Motion made and seconded that we adopt the Association Program as guide for this session — motion carried.
2. Motion made, seconded, and carried to accept the reading of the church letters and to seat the delegates.
3. Recognized the visiting brethren, Rev. James Franklin from Missouri.
4. Reading of the Constitution and By-Laws of the First Mission Association by the Moderator.
5. Motion made, seconded, and carried to receive the Report of the General Board.
6. Committees appointed: **Resolution Committee**, consisting of Rev. Retus Hunsucker, Rev. Charles Brazeal, Rev. J. B. Chism, Jr., Rev. Ray Price, and Rev. Lamar Kindall. **Obituary Committee**, consisting of Sis. Colleen Matherly, Sis. Marguerite Hinesley, and Sis. Mary Keiffer.
7. Associational Treasurer's Report was given by Rev. Everett Keiffer and adopted.
8. Meeting was then adjourned until 1:00 o'clock.

FRIDAY MORNING WORSHIP HOUR

Worship service opened with congregational singing "Blessed Assurance" led by Rev. Bob Ketchum with Sis. Ketchum as pianist. Special music was presented by the Rev. Jim Christian Family sing-

ing "Love Is Why", followed by congregational singing "Brethren We Have Met Together". Special song was then presented by Bro. and Sis. Charles Hinseley from New Home singing "He Touched Me". Message title "The One Spirit" was presented by the Rev. Willard C. Day reading from I Corinthians 12:11-13.

FRIDAY AFTERNOON BUSINESS

Service opened with congregation singing "Leaning On The Everlasting Arms" followed by prayer by Rev. Melvin Bingham. Devotion was given by Rev. Retus Hunsucker on "One Lord" taken from Ephesians 4:5a.

9. The Budget Committee Report was given by Rev. Everett Keiffer. The report was adopted.
10. Report of Oklahoma Bible College was given by Dr. J. D. O'Donnell, President of Oklahoma Bible College.
11. Motion was made that we receive the Resolution Committee and adopted items one by one. The motion was seconded and carried.
12. The Campground Committee Report was given; motion made, seconded, and carried that we accept the report. Rev. Harry Staires was elected as five year member on the Youth Camp Committee.
13. The Trustee Board Report was given; motion made, seconded, and carried that we accept the report. Rev. Retus Hunsucker was elected as the five year member on the Trustee Board.
14. Motion made, seconded, and carried that we receive the Women's Auxiliary Yearly Report and that they be entered into our minutes.
15. Rev. Willard C. Day was elected as Evangelist for next year's Old Time Camp Meeting. Rev. Everett Ray Keiffer was elected as the assistant to the evangelist of next year's Camp Meeting.
16. Rev. Harry Staires, Rev. Sam Gober, and Rev. Roma Stewart were elected as the Camp Meeting Committee.
17. Motion made, seconded, and carried that we adjourn for the Evening Service.

FRIDAY EVENING SERVICE

The service was opened at 7:30 p.m. with prayer led by Rev. Willard Day. Congregational singing opened with "Send The Light". Music Director was Rev. Bob Ketchum. Theme for the evening was "One Faith" with Don Robirds, Missionary from Brazil, bringing the message. At the close of the service an offering was taken for Bro. Don Robirds.

SATURDAY MORNING SESSION, AUGUST 16, 1969

Session opened with singing "Heavenly Sunlight" followed with prayer by Bro. Clarence Johnson. Congregation sang "Leaning on the Everlasting Arms". Devotion was given by Rev. Damon Cariker with his topic being "One Baptism". Scripture reading from Romans 6:1-5. The session was called into conference by Rev. Jim Christian, Moderator.

18. Motion made, seconded, and carried to receive the Obituary Committee's Report.
19. Our State Executive Secretary, Rev. Homer Young, spoke to the Assembly concerning our part in the State and world-wide work for our Lord Jesus Christ.
20. Nominations for State General Board Member. Motion made, seconded, and carried that we elected Rev. Willard Day to represent the First Mission Association on the State Board.
21. Resolution Committee Report: Resolution No. 1 — Motion made, seconded, and carried that we have the Annual Association meeting the first Thursday, Friday and Saturday following the Youth Camp.
22. Motion made, seconded, and carried that we be dismissed until 1:00 o'clock.

SATURDAY MORNING WORSHIP HOUR

Service opened by congregation singing "I'm Bound for the Promised Land" and "Are You Washed In The Blood." The singing was conducted by Rev. and Sis. Bob Ketchum. Special music by Bro. Kenneth Beatty singing "His Eye On The Sparrow". The morning message was then presented by Rev. Bob Duncan. The theme of his message being, "One Hope" taken from Scripture Ephesians 4:4. Dismissed in prayer by Bro. Tipton for the noon meal.

SATURDAY AFTERNOON BUSINESS

Meeting opened with congregation singing "Amazing Grace" led by Rev. Bob Ketchum. Congregation also sang "When We All Get To Heaven". The devotion was given by Rev. Edmon Hollie on "One God". Prayer by Bro. Charles Hinesley.

23. Motion made, seconded, and carried to receive Rev. Harry Staires resignation from Camp Meeting Committee. Rev. Willard Day was then elected to serve on the Camp Meeting Committee.
24. Motion made, seconded, and carried to place item concerning ordination of ministers as permanent resolution.
25. Motion made, seconded and carried to allow the General Board to seek for an Associational Treasurer. Nominations for the First Mission Association officers were as follows:

3. Motion made and carried to delegate the investigation and pricing of the lake on the campground to the campground's Trustee Board, with a report to be submitted to the Associated Meeting in December.
4. Motion made and carried to allow Rev. E. R. Keiffer to examine the Minutes prior to publishing.
5. Motion made and carried to buy a typewriter for the Associational Treasurer.

The meeting adjourned; dismissed in prayer by Rev. Jerry Rhoades.

A special meeting of the General Board was called to discuss the painting of the Youth Camp. The question was whether or not to allow the paint contractor to continue painting or to cease due to inadequate funds. 1. The motion was made and carried to pay the man up to that time and to have him discontinue painting. Dismissed in prayer.

A meeting of the General Board was called by the Moderator on Friday, July 25, 1969. This meeting was called to discuss the Associational Program and the Camp Meeting Program.

Meeting was called to order by Rev. Jim Christian, Moderator. Opened in prayer by Rev. Jerry Rhoades. Seven Members present. Business was: 1. Motion made, second, and carried to move the Introductory Message to Friday Morning and give Thursday evening to the evangelist of the Camp Meeting. Dismissed by prayer led by Rev. Millard McGuire.

YOUTH CAMP COMMITTEE REPORT: We the youth camp committee, would like to express our appreciation to the youth that attended our camp this year. Also, we would like to express our appreciation to the directors, sponsors, teachers, and ministers who gave of their time and ability to help in this youth camp. We would like, also, to express our appreciation to the ones who prepared the meals each day and to the women of our churches who helped in the kitchen each day.

We feel that we had a good and profitable camp this year with a total of 125 enrolled the first week and 111 enrolled the second week in which we are thankful for this good number that attended our camp this year.

PERMANENT RESOLUTIONS

1. Be it resolved that all our By-Laws and Resolutions which are now in effect, be printed in our Minutes.
2. That our Churches not send any Minister up for Ordination until he has been licensed for one year from date of examination.
3. That the examination of candidates for Ordination and License question and answer be recorded and filed with the Associational Clerk.
4. That no person can be an active Deacon or Minister in the Association who does not pay and teach tithes.
5. That the letter of all Quarterly Meetings be in the hands of the Associational Clerk at least one week before conference convenes.
6. The Churches having candidates for ordination or license or ratification send request to Quarterly Conference in session prior to examination.
7. That all of our Churches use the letter forms furnished by our Clerk.
8. That since we have grown to such proportions, and the demands of service are heavy, that no member of this Association be permitted or required to serve on more than two boards at any time.
9. That no Minister be received into the Association from another Denomination or Association unless accompanied by a letter or recommendation.
10. That the Moderator with his Assistant appoint all committees.
11. That the Treasurer be in charge of all insurance business.
12. That the Associational Moderator be Chairman of the General Board.
13. That no ordained Minister or Deacon be recognized as active in the Association until they have appeared before the Credential Board.
14. That the First Mission Association have a printed program.
15. That the Associational Officers serve as the Associational Program Planning Committee.

16. That no one be licensed nor ordained by First Mission Association who uses tobacco and no one will be accepted as a Deacon or Minister into this Association who uses tobacco.
17. That no Minister shall be ordained into this Association unless he is in full-time pastoral, evangelistic, or Christian Education work.

CHURCH COVENANT

Having given ourselves to God, by faith in Christ, and adopted the Word of God as our rule of faith and practice, we now give ourselves to one another by the will of God in this solemn covenant.

We promise by his Grace to Love and obey Him in all things, to avoid all appearances of evil, to abstain from all sinful amusements and unholy conformity to the world, from all sanction of the use and sale of intoxicating beverages, and to provide things honest in the sight of all men.

We agree faithfully to discharge our obligations in reference to the study of the scriptures, secret prayer, family devotions, and social worship, and by self-denial, faith, and good works endeavor to "grow in grace and the knowledge of our Lord and Savior, Jesus Christ."

We will not forsake the assembling of ourselves together for church conference, public worship, and the observance of the ordinances of the Gospel, nor fail to pay according to our ability for the support of the church, of its poor, and all its benevolent work.

We agree to accept Christian admonition and reproof with meekness and to watch over one another in love, endeavoring to "keep the unity" of the spirit" in the bonds of peace, to be careful of one another's happiness and reputation, and seek to strengthen the weak, encourage the afflicted, admonish the erring, and as far as we are able to promote the success of the church and of the gospel.

We will everywhere hold Christian principle sacred and Christian obligation, and enterprises supreme; counting it our chief business in life to extend the influence of Christ in society; constantly praying and toiling that the Kingdom of God may come, and His will be done on earth as it is in Heaven.

To this end we agree to labor for the promotion of educational and denominational enterprise, the support of missions, the success of Sunday School and evangelistic efforts for the salvation of the world. And may the God of peace sanctify us wholly, and preserve us blameless unto the coming of our Lord Jesus Christ.

ARTICLES OF FAITH

1. We believe the Scriptures of the Old and New Testament are the infalliable Word of God, and the only safe rule of faith and practice. II Timothy 3:16-17; II Peter 1:20-21.

2. That there is but one true and living God and in the God Head of Divine Essence, Father, Son and Holy Ghost. Gen. 17:1, I John 5:7.

3. That we are fallen and depraved creatures and cannot extricate ourselves from our fallen situation by any ability we possess by nature. Eph. 5:1-19.

4. That salvation, regeneration, satisfaction, justification and redemption are by life, death, resurrection, ascension and intercession of our Lord and Savior, Jesus Christ. Acts 4:12; Titus 3:5.

5. That the joys of the righteous, and the punishment of the wicked shall be eternal. Matt. 25:46.

6. All believers in Christ, who through grace, persevere in holiness to the end of life, have the promise of eternal salvation. Mark 13:13, Rev. 2:10.

7. Baptism (the immersion of believers in water), the Lord's Supper and Feet Washing are ordinances to be perpetuated under the Gospel. The Lord's Supper, which is to be observed by all believers at night, is followed by the ordinance of feet washing, which teaches humility, of universal obligation, to be practiced by all believers. Baptism: Matt. 28:19; Col. 2:12. Lord's Supper: Mark 14:17; Matt. 26:26-28; I Cor. 11:23-26; Feet Washing: John 13:4-5; I Timothy 6:10.

8. We believe in the sanctity of the first day of the week or the Lord's Day, and that it ought to be observed and spent in public worship of God, and that on it, we should abstain from our worldly concerns except in cases Necessity and mercy. Ex. 31:15; Deut. 5:12; Matt. 12:12.

9. We believe in the resurrection of the body, both the just and unjust, but every one in his own order; those who have done evil to the resurrection of damnation, and that God has appointed a day in which He will judge the world in righteousness by Jesus Christ. I Cor. 15:34, John 5:28, I Thes. 3:16.

10. That it is our duty to be tender and affectionate to one another, and to study the happiness of the people of God in general and to singly engage to promote the honor of God. John 13:35; Gal. 6:10.

11. We believe that Jesus Christ, by grace of God, tasted death for every man; yet none can partake of His divine benefit only by His repentance toward God and faith in the Lord Jesus Christ, infants and idiots excepted. Acts 20:21; I Tim. 2:5-6; John 3: 14-16; I Peter 3:21.

12. We believe that the Lord's people are one in Him, and therefore should be one at His table. I Cor. 1:1-11, 27-28; John 17:11.

CONSTITUTION FOR FIRST MISSION ASSOCIATION

Article 1. This early meeting or Association shall be called the First Mission Association, and shall be composed of such regularly organized and well-disciplined Free Will Baptist Quarterly Meetings, conveniently located, as may embody themselves under this constitution.

Article 2. The conference of this Yearly Meeting or Association shall consist of all Ordained Ministers, Ministers' wives, Ordained Deacons and Church Clerks, having been duly accepted by the Association, and delegates from the different Quarterly Meetings of which it is composed, each Quarterly Meeting being entitled to one delegate, each Quarterly Meeting containing five hundred members to two delegates, and one additional delegate for every additional five hundred members. Each church may send three delegates which have been approved by the Quarterly Meeting.

Article 3. The officers of this Association or Yearly Meeting shall be: (1) A standing clerk and treasurer and a moderator who shall be chosen at every session of the Association, with assistants as may be found necessary. (2) The Associational General Board shall be composed of the Associational Officers, the Chairman of Each Quarterly Meeting Board, and the Chairman of the Associational Boards. The Association Moderator, Clerk, and three members to be elected from the General Board shall compose the Associational Executive Committee. (3) A Trustee Board so elected as to require one to be elected each year. They shall act as custodians of all property belonging to the Association and shall sign legal papers when authorized by the Association to do so. This board shall consist of not less than five members. This board shall also serve as planning board. (4) All Associational Boards to be paid traveling expense at the rate of five cents per mile.

Article 4. Any well organized and well regulated Free Will Baptist Quarterly Meetings who will conform to the practice, endorse the enterprises, and prove themselves orthodox in doctrine may at any time on application by vote of this body, become a member thereof.

Article 5. This Yearly Meeting or Association shall have power to discipline the Quarterly Meetings of which it is composed and to exclude them for disorderly walk if labor proves unsuccessful, but in no case to reverse their decisions, nor to interfere with any of their internal regulations.

Article 6. The sessions of this Yearly Meeting or Association shall be held annually at such time and place as shall be decided upon by the Association. At which time the Association shall act upon such questions and topics as may be referred to it by its respective Quar-

terly Meetings, and transact such other business not repugnant to this constitution, nor to the practices of the denomination, but such as may in its judgment promote the cause of Christ and the interest of the churches and Quarterly Meetings within the limits of this Yearly Meeting or Association.

Article 7. This Yearly Meeting or Association shall have the power to adopt any regulations or by-laws, not inconsistent with this constitution, which may be deemed essential to the further regulation of its sessions.

Article 8. This Association shall not license, ordain or receive from any other association any person to the ministry or as a deacon who has more than one living companion.

Article 9. This constitution may be altered or amended by a vote of the Yearly Meeting or Association at any regular session: notice of such intended alteration having been given in writing, and recorded at the next previous session.

BY-LAWS

1. The moderator or assistant moderator, or in their absence, the oldest minister present, shall call the Association in to conference.

2. Each session shall be opened and closed with prayer.

3. Five members from two or more churches shall constitute a quorum. A less number may adjourn until such quorum is present.

4. Visiting brethren are invited to seats as advisory members.

5. Those who speak shall arise and address the moderator. Personal reflections shall be avoided in all debates.

6. If any proposition or motion under debate contains two or more points, it shall be divided at the request of any member and a vote taken separately.

7. Motion made and lost shall not be recorded.

8. No one will speak more than twice on the same subject without leave of the moderator.

9. The Moderator shall not allow discussion when not carried on in Christian Spirit.

10. The ruling of the moderator may be overruled by a two-thirds vote of the members present.

11. Any Minister opposed to any of the enterprises, organized Sunday School League, Master's Men, Woman Auxiliary, endorsed

by the Association will not be entitled to a seat in Conference and we will not seat any minister in this association that teaches the Baptism of the Holy Ghost separate from regeneration or the birth of the Spirit.

12. No question from any church shall come under the consideration of the Association unless it has been first discussed in its own church.

13. At each Association, arrangements shall be made to insure two or more sermons or their equivalent devotional exercises each day.
