#### RESOLUTION COMMITTEE REPORT:

Item No. 1. Resolved that we adobt the Melvin Bingham Memorial Fund. (Amended to "recommend our Association support" the Melvin Bingham Memorial Fund.) Carried.

Item No. 2. Resolved that our annual Minutes contain a statistical

page of our churches. (Carried.)

Item No. 3. Resolved that it is unnecessary to examine Ministers and Deacons when they move from one Quarterly Meeting to the other in the First Mission Association, except for questionable cause and that we cease this practice. (Amended by substitute motion to read as follows:) When Ministers and Deacons in good standing as certified by letter from their local church, move from one Quarterly Meeting to the other Quarterly Meeting of First Mission Association, they be exempted from examination by Credential Committee of respective Quarterly Meeting. (Adopted.)

Item No. 4. Resolved that the Executive Board be instructed to set up a Melvin Bingham Memorial Loan fund at Hillsdale Free Will Baptist College with the same rules and regulations that are used at Free Will Baptist Bible College. Also the fund is to be financed by individual contributations. (Defeated.)

Item No. 5. Resolved that the Teen Youth Camp be for the period

of two weeks instead of one week. (Defeated.)

Item No. 6. Resolved that a Historian be elected for First Mission Association to keep our hostory up to date. (Adopted.)

#### YOUTH CAMP BOARD REPORT

Rev. Rick Young, director of the pre-teen camp, reported a total enrollment of 80. A good camp was reported. Sister Wilma Sheppard taught the 11:00 o'clock services. Rev. David Bigger was the Evangelist for the evening services.

Rev. Don Jones, Director of the Teen Camp gave a good report of 75 enrolled, 5 first time decisions, 5 surrendered to full time service and

26 rededications. Rev. Gene Jackson was the camp Evangelist.

The Board met Saturday morning at the camp ground and organized for the coming year. Rev. Harry Staires, the chairman and Rev. David Bigger the clerk. A meeting was set for September 11th to plan a youth retreat at the camp ground around the middle of the moth of October.

#### TRUSTEE BOARD REPORT

The Trustee Board met 5 times this year. We met for organizational meeting at the conclusion of the yearly meeting in 1972. Rev. James Franklin remained as chairman, and Rev. Gene Jackson was elected as clerk.

During the year we have:

1. Hired Doyle Holeman as caretaker.

2. Had the caretaker's house exterminated.

3. Purchased a Ford tractor, Brushog and Blade.

4. Purchased a riding lawnmower.

5. Tore out old stage and poured concrete floor and paneled the front of the stage.

6. Replaced glass in dormitories.

NOTE:

We will refund pond money to those churches who request it. Also the well needs some special allocation for new casing. The Trustee Board requests permission to tear down the old Dorm and use the lumber to build a tool shed for the campgrounds.

- 5. That the letter of all Quarterly Meetings be in the hands of the Associational Clerk at least one week before conference convenes.
- 6. The churches having candidates for ordination or license or ratification send request to Quarterly Conference in session prior to examination:
- 7. That all of our Churches use the letter forms furnished by our Clerk.
- 8. That since we have grown to such proportions, and the demands of service are heavy, that no member of this Association be permitted or required to serve on more than one board at any time.
- Residue9: That no Minister be received into the Association from another

Denomination or Association unless accompanied by a letter or recommendation.

- 10. That the Moderator with his Assistant appoint all committees.

- 12. That the Associational Moderator be Chairman of the General Board.
- 13. That no ordained Minister or Deacon be recognized as active in the Association until they have appeared before the Credential Board.

# CHURCH COVENANT

To this end we agree to labor for the promotion of educational and denominational enterprise, the support of missions, the sucess of Sunday School and evangelistic efforts for the salvation of the world. And may the God of peace sanctify us wholly, and preserve us blameless unto the coming of our Lord Jesus Christ.

#### ARTICLES OF FAITH

- 1. We believe the Scriptures of the Old and New Testament are the infalliable Word of God, and the only safe rule of faith and practice. II Timothy 3:16-17; II Peter 1:20-21.
- 2. That there is but one true and living God and in the God Head of Divine Essence, Father, Son and Holy Ghost. Gen. 17:1, I John 5:7.
- 3. That we are fallen and deprayed creatures and cannot extricate ourselves from our fallen situation by any ability we possess by nature. Eph. 5:1-19.
- 4. That salvation, regeneration, satisfaction, justification and redemption are by life, death, resurrection, ascension and intercession of our Lord and Savior, Jesus Christ. Acts 4:12; Titus 3:5.
- 5. That the joys of the righteous, and the punishment of the wicked shall be eternal. Matt. 25:46.
- 6. All believers in Christ, who through grace, persevere in holiness to the end of life, have the promise of eternal salvation. Mark 13:13, Rev. 2:10.
- 7. Baptism (the immersion of believers in water), the Lord's Supper and Feet Washing are ordinances to be perpetuated under the Gospel. The Lord's Supper, which is to be observed by all believers at night, is followed by the ordinance of feet washing, which teaches humility, of universal obligation, to be practiced by all believers. Baptism: Matt. 28:19; Col. 2:12. Lord's Supper: Mark 14:17; Matt. 36:34; I Cor. 11:23,34; Feet Washing: John 13:4,5; I Timothy 6:10.
- 8. We believe in the sanctity of the first day of the week or the Lord's Day, and that it ought to be observed and spent in public worship of God, and that on it, we should abstain from our worldly concerns except in cases of Necessity and mercy. Ex. 31:15; Deut. 5:12; Matt. 12:12.
- 9. We believe in the resurrection of the body, both the just and unjust, but every one in his own order; those who have done evil to the resurrection of damnation, and that God has appointed a day in which He will judge the world in righteousness by Jesus Christ. I Cor. 15:34, John 5:28; I Thes. 3:16.
- 10. That it is our duty to be tender and affectionate to one another, and to study the happiness of the people of God in general and to singly engage to promote the honor of God. John 13:35; Gal. 6:10.
- 11. We believe that Jesus Christ, by grace of God, tasted death for every man; yet none can partake of His divine benefit only by His repentance toward God and faith in the Lord Jesus Christ, infants and idiots excepted. Acts 20:21; I Tim. 2:5-6; John 3:14-16; I Peter 3:21.
- 12. We believe that the Lord's people are one in Him, and therefore should be one at His table. I Cor. 1:1-11, 27-28; John 17:11.

#### SOME CONSTITUTION: FOR FIRST MISSION ASSOCIATION

Article 1. This yearly meeting or Association shall be called the First Mission Association, and shall be composed of such regularly organized and well-disciplined Free Will Baptist Quarterly Meetings, conveniently located, as may embody themselves under this constitution.

Article 2. The Conference of this yearly meeting of association shall consist of all Ordained Ministers, Ministers wives, Ordained Deacons, Church Clerks and three elected delegates from all duly organized Free Will Baptist's Churches from each Quarterly Meeting of the First Mission Association. Each church shall represent by letter.

Article 3. The officers of this Association or Yearly Meeting shall be: (1) A standing clerk and treasurer and a moderator who shall be chosen at every session of the Association, with assistants as may be found necessary. (2) The Associational General Board shall be composed of the Associational Officers, the Chairman of Each Quarterly Meeting Board, and the Chairman of the Associational Boards. The Association Moderator, Clerk, and three members to be elected from the General Board shall compose the Associational Executive Committee. (3) A Trustee Board so elected as to require one to be elected each year. They shall act as custodians of all property belonging to the Association and shall sign legal papers when authorized by the Association to do so. This board shall consist of not less than five members. This Board shall also serve as planning board. (4) All Associational Boards to be paid traveling expense at the rate of five cents per mile.

Article 4. Any well organized and well regulated Free Will Baptist Quarterly Meetings who will conform to the practice, endorse the enterprises, and prove themselves orthodox in doctrine may at any time on application by vote of this body, become a member thereof. Article 5. This Yearly Meeting or Association shall have power to discipline the Quarterly Meetings of which it is composed and to exclude them for disorderly walk if labor proves unsuccessful, but in no case to reverse their decisions, nor to interfere with any of their internal regulations.

Article 6. The sessions of this Yearly Meeting or Association shall be held annually at such time and place as shall be decided upon by the Association. At which time the Association shall act upon such questions and topics as may be referred to it by its respective Quarterly Meetings or churches and transact such other business not repugnant to this constitution, nor to the practices of the demonination, but such as may in their judgment promote the cause of Christ and the interest of the churches and quarterly meetings within the limits of this yearly meeting or association.

Article 7. This Yearly Meeting or Association shall have the power to adopt any regulations or by-laws, not inconsistent with this constitution, which may be deemed essential to the further regulation of its sessions.

Article 8. This Association shall not license, ordain or receive from any other association any person to the ministry or as a deacon who has more than one living companion.

Article 9. This constitution may be altered or amended by a vote of the Yearly Meeting or Association at any regular session: notice of such intended alteration having been given in writing, and recorded at the next previous session.

# BY-LAWS

- 1. The moderator or assistant moderator, or in their absence, the oldest minister present, shall call the Association in to conference.
  - 2. Each session shall be opened and closed with prayer.
- 3. Five members from two or more churches shall constitute a quorum. A less number may adjourn until such quorum is present.
  - 4. Visiting brethren are invited to seats as advisory members.
- 5. Those who speak shall arise and address the moderator. Personal reflections shall be avoided in all debates.
- 6. If any proposition or motion under debate contains two or more points, it shall be divided at the request of any member and a vote taken separately.
  - 7. Motion made and lost shall not be recorded.
- 8. No one will speak more than twice on the same subject without leave of the moderator.
- 9. The Moderator shall not allow discussion when not carried on in Christian Spirit.
- 10. The ruling of the moderator may be overruled by a two-thirds vote of the members present.
- 11. Any Minister opposed to any of the enterprises, organized Sunday School League, Master's Men, Woman's Auxiliary, endorsed by the Association will not be entitled to a seat in Conference and we will not seat any minister in this association that teaches the Baptism of the Holy Ghost separate from regeneration or the birth of the Spirit.
- 12. No question from any church shall come under the consideration of the Association unless it has been first discussed in its own church.
- 13. At each Association, arrangements shall be made to insure two or more sermons or their equivalent devotional exercises each day.
  - 14. Deacons will be elected to serve each year by the local church.
