Minutes of the Thiry Seventh Annual Session of the First Oklahoma Association which convened with the Earlsboro Church at Earlsboro, Okla., Sept. 20, 1934.

THURSDAY EVENING SESSION

There being a quorum present. Association declared in conference. Letters were called for and read as follows: North View, Tecumseh, Oak Grove, First Freewill Baptist of Okla. City, Box, Earlsboro, Pleasant Hill, Spring Hill, Olive, and New Bethlehem The delegates were seated and right hand of fellowship given. Call for "Freewill Baptist Church Number Two" to be organized at Oklahoma City. Same approved by delegates from Church No. 1. Motion carried that church no. 2 be organized.

Letter read requesting that Liberty church be granted a letter to First Mission Association. Motion carried.

Request that B. D. Edmondsons' credentials be recalled. Carried. Clerk of Association instucted to notify County Clerk of Oklahoma Co. that B. D. Edmondsons' credentials have been revoked. Carried. Recess for thirty minutes. Called together by singing.

COMMITTEE REPORTS

Prayer Meeting—We the prayer meeting committee beg to report that we believe nothing will help more to build up a community in christian work and right living than weekly prayer

meetings. A good service: during the week in the church or the homes will help encourage one who may be cold. Let us urge also that we not fail to teach them to pray both publicly and secretly. We also urge that our young people be taught and trained to support the cause financially.

Called to order by singing. Prayer by Sister Tanner. Devotional services conducted by Joy Dearmore. Scripture First Psalm, prayer by Bro. Bingham. Declared in conference by moderator. Motion and second to take question from table Resolution No. 2 reread; motion and second, adopted

Resolution No. 2 — Resolved that this association adopt tithing as Gods foundation plan for the support of the church. Signed: W. L. Bean, W. L. Waddle, chairman.

Resolution No. 3- Be it resolved that we adopt the following:

rules with reference to ordaining preachers and deacons. That no preacher or deacon be ordained to the work until they have be longed to the church (Freewill Baptist) and tried at least one year and found to be unquestionably sound in doctrine and practice and that it become the indispensible duty of the executive board to file charges in the association against any church or preacher or deacon who violates these rules. Resolution adopted.

Resolution No 4Be it resolved that as an Associa ion we take a definite stand against the doctrine of a thousand year's personal reign on earth beginning at Christ's second coming, and that we brand it as dangerous heresy and request our preachers and deacons to take a firm stand against it Signed: W. Called together by singing, followed by talk by Bro. Will Bean, prayer by Bro. Wade, after which a collection of \$7.36 was taken to be sent to Bro. I. W. Yandell, who is in failing health. This amount was mailed to Bro. Ed Morris on Sep. 24 by clerk, as instructed by Associaton. Bro. Bingham gave an interesting account of his work. Talk by Bro. John Bean.

Business session resumed. By motion Bro. Clarence Plumlee was granted license for one year to preach and the clerk was instructed to write the letter. It was sent in care of Bro. Bean Sat. Sept. 24, 1934. At this time Bro. Clyde Argo and Sister Mattie Epperson were ordained to the ministry and Bros. Bashaw, Stevens, and R. Hagar were ordained deacons.

The next annual session of this Association was elected to meet

with Pleasant Hill church; the introductory sermon to be preach ed by Bro. Clyde Argo; J. E Bean, alternate.

Fifth Sunday meetings will be held at the following places and times, beginning on Friday night before the fifth Sunday: Ist North View; 2nd, Spring Hill; and 3rd, at Box, the first introductory sermon to be preached by Bro O.D. Wade, altenate Bro. O'Donnell. Motion carried that a program committee be appointed. Motion carried that one-tenth of minute money paid in at this As sociation be sent to the State Association as minute money, this amounting to \$1.94. Pleasant Hill and Earlsboro churches each pledged \$1.00 for minutes to the State Association. Delegates to State Association: Sisters Perrin, J.Bean, Dearmore, Hagar and Stevens, and Bro. Quinn. Resolution of gratitude: Be it known to all present, to the church and community at large that we the ministers and delegates are grateful for the hospitality shown us while in your midst Adjourned to meet with North View on Friday night before the fifth Sunday in December 1934.

Pastors' Reports—I have pastored one church, preached eighty-six sermons, recived \$11.82 from church, \$7.20 outside the church, and witnessed seven conversions.

RULES OF ORDER

1. At every sitting the meeting shall be opened and closed with prayer by the moderator, or whomsoever he may request.

- 2. All ordained or licensed ministers and ordained deacons in good standing in this Ass'n shall be invited to seats in the annual association.
- 3. Those who speak shall rise and address the moderator. Personal reflections shall be avoided in all debates.
 - 4. No motion shall be discussed without first being seconded.
- 5. When a motion has been made and seconded, the moderator shall ask, "Any discussion or remarks?" If none, the question shall be disposed of as usual.
- 6. If any propositon or motion under debate contains two or more points, it shall be divided at the request of any member and the vote taken separately.
- 7. Motions made and lost shall not be recorded in the minutes unless ordered by the party making the motion.
- 8. No one shall speak more than twice on the same subject without special leave of the moderator.
- 9. All questions shall be decided by the majority of members present
- 10. No member shall be absent while in session without leave of the moderator, and if so, his name shall be left off the minutes.
- 11 Minutes shall be leisurely read and corrected, if necessary, before the close of the association.
- 12 Arrangements shall be made at each session of the Ass'n for two or more sermons or equivalent devotional exercises during each day.
- 13. The rules of order shall be distinctly read from the chair immediately after the organization of the body.
- 14. Alterations may be made in these rules at any regular session.

ATICLES OF FAITH

- 1. The Bible, The Scriptures of the Old and New Testaments were given by the inspiration of God, and are our infallible rule of faith and practice.
- 2. God There is one true and living God, revealed in nature as the Creator, Preserver, and Righteous Governor of the universe, and in the Scriptures as Father, Son, and Holy Ghost, yet as one God, infinitely wise and good, whom all intelligent creatures are supremely to love, adore, and obey.
- 3. Christ. Christ is God manifest in the flesh; in his divine nature truly God, in human nature truly man. The mediator between God and man, once crucified, He is now risen and glorified and is our ever present Saviour and Lord.
- 4. The Holy Spirit. The Scriptures assign to the Holy Spirit all attributes of God. He is the reprover, comforter, guide and sanctifier of men.
- 5. The Government of God. God exercises a wise and benevolent providence over all beings and all things by maintaining the constitution and laws of nature. He also performs special acts of grace, not otherwise provided for, as the highest welfare of man requires.
- 6. The Sinfulness of Man Man was created innocent, but by disodedience fell into a state of condemnation. His posterity, therefore inherits a fallen nature of such tendencies that all who come to years of accountability sin, and become guilty before God.
- 7. The Work of Christ. The Son of God, by his incarnation, life, sufferings, death and resurrection effected for all a redemption from sin that is full and free and is the ground of salvation by faith
- 8. The Terms of Salvation. The conditions of salvation are: 1. Repentunce, or sincere sorrow for sin and the hearty renunciation of it. 2. Faith, or the unreserved commital of one's self to Christ as Saviour and Lord with purpose to love and obey Him in all things. In the exercise of saving faith the soul is renewed by the Holy Spirit, freed from the dominion of sin and becomes a child of God. 3.

Continuance in faith and obedience until death.

- 9 Election. God determined from the beginning to save all who should comply with the conditions of salvation. Hence by faith in Christ men become His elect.
- 10- Freedom of the Will. The human will is free and self-controlled, having power to yield to the influence of the truth and the Spirit and live, or to resist them and perish.
- 11. Salvation Free. God desires the salvation of all, the Gospel invites all, the Holy Spirit strives with all, and whosoever will may come and drink of the water of life freely.
- 12. Perseverance. All believers in Christ, who through grace persevere in holiness to the end of life, have promise of eternal salvation.
- 13. Gospel Ordinancs. Baptism, or the immersion of believers in water, and the Lord's Supper are ordinances to be perpetuated.
- 14 The Christian Sabbath. The divine law requires that one day in seven be set apart from secular employment and amusements for rest, worship, holy works and activities and for personal communion with God.
- 15. War. War destroys the lives of the innocent and is contrary to the teaching of the New Testamnt. Therefore we are opposed to war
- 16. Resurrection, Judgmeut, and Final Retribution. The Scriptures teach the resurrection of all men at the last day. They that have done good will come forth to the resurrection of life, and they that have done evil unto the resurrection of damnation; then the wicked will "go away into eternal punishment but the righteous in to eternal life."

CHURCH COVENANT

Having given ourselves to God by faith in Christ, and adopted the Word of God as our rule of faith and practice, we now give ourselves to one another by the will of God in this solemn covenant. We promise by His grace to love and obey Him in all things, to avoid the appearance of evil, to abstain from all sinful amusements and unholy conformity to the world; from all sanction of the use and sale of intoxicating beverages, and to "provide things honest in the sight of all men."

We agree to accept Christian admonition and reproof with meekness, and to watch over one another in love, endeavoring to "keep the unity of the Spirit," in the bonds of peace, to be careful of one another's happiness and reputation, and seek to strengthen the weak, encourage the afflicted, admonish the erring, and as far as we are able, promote the success of the church and of the Gospel.

We agree faithfully to discharge our obligations in reference to the study of the Scriptures, secret prayer, family devotions, and social worship; and by self-denial, faith, good works endeavor to "grow in grace and knowledge of our Lord and Saviour Jesus Christ." We will not forget the assembling of ourselves together for church conference, public worship, and the observance of the ordinances of the the Gospel, nor to pay according to our ability for the support of the church, of its poor, and and all its benevolent work.

To this end we agree to labor for the promotion of the educational and denominational enterprises, the support of missions, the success of Sunday schools, and evangelistic efforts for the salvation of souls, and the conversion of the world. And may the God of peace sanctify us wholly, and preserve us blameless unto the coming of our Lord Jesus Christ.
