Be it futher resolved that it any minister refuses to affiliate, or take membership with a church in regular standing, that we refuse to recognize him, or his work, and that he or she cease to be identified as a Free Will Baptist minister.

No.2 Resolved that we the First Okla. Association of Free Will Baptist go on record as opposed to the doctrine of the modern theory of pre-milinialism as taught by some Free Will Baptist preachers.
