Motion carried that the First Oklahoma Association shall not consolidate their yearly meeting but remain as it is.

Solo, "I Won't Have To Cross Jordan Alone," by Eld. E. E. Morris. He then took the stand, followed by Eld. Harry Staires, using as their subject, "The Wells of Salvation".

Invitation was given and one soul came forward and was saved.

Ordaining Council reported that they had found Bro. Hodum worthy of ordination. Brothers Argo, Waddle, and Maxwell were chosen as presbytery. Bro. Waddle led the prayer and Eld. Dearmore gave the charge.

Previous minutes approved as read.

Brother and Sister Wilson and Bro. Cummins from Canadian Association were welcomed by the Moderator. Report of Eld. W. A. Land for the year was read and accepted.

#### COMMITTEE REPORTS

#### RESOLUTIONS:

No. 1—Be it Resolved, That we, The First Oklahoma Association, have a ten-day Camp Meeting preceding the Assiciation. Also that we elect two ministers to preach at the Camp Meeting.

No. 2—Be it Resolved, That this body appoint the pastor and clerk of each church to act as a committee in their church to promote league work, and that we have a league rally each fifth Sunday.

No. 3 — Be it Resolved that each church of this Association pay fifty cents (50c) per month for expense of Camp Meeting.

No. 4—Be it Resolved that this body give the Earlsboro Church a vote of thanks for the courtesy shown us and the wonderful way they have entertained this Association.

SUNDAY SCHOOL—We find that we have Sunday Schools in all our churches using Free Will Baptist literature. We urge that we put forth an effort to encourage a higher goal of regular attendance for all ages in our churches and that we build interest by faithful teaching of the Scriptures.

LEAGUE — We, your Committee on League work, find that the league is a strong support to the church and do recommend that each church in the Association that does not have a league organize one. Our league is a training school for our young people that they may be able to carry on God's work more effectively than we.

TEMPERANCE — We, your Committee on Temperance, submit the following:

Temperance covers a broad field and should be an individual subject and appeal to all true followers of Christ. We urge our people of the several churches to be temperate in all things. We also urge that they use all the ability they have to prohibit the sale and use of intoxicating liquors.

FINANCE — We, your Committee on Finance, beg leave to report the following:

We find our churches have paid \$1,522.69 for the support of pastors; \$405.10 for evangelists; \$610.00 for building and repairs; and \$45.00 for minute and expense money.

GOOD AND AND

PUBLICATION—We, your Committee on Publication, recommend that we the First Oklahoma Association use our own printing presses. Since we have no state press in operation, we recommend that the clerk use her own judgement in the publishing of our next minutes. We also recommend that we send \$5.00 to the State Association for state minutes.

MUSIC — We, your Committee on Music, think sacred music and singing very helpful to the church. We recommend that every church have a singing school; also try to arrange a special number or two in every service.

OBITUARY—We, your Committee on Obituary, find only two deaths in our Association. Bro. Andy Cline of Earlsboro and an eight-year old daughter of Sister Pierce of Wolfe church.

CREDENTIAL — We, your Committee on Credentials, find all our preachers and deacons working together in harmony for the glory of God.

## RULES OF ORDER

the the series

- -14(0)(1)(1)(1) 1. At every sitting of the Association, business shall be opened and concluded by prayer by the Moderator or whomsoever he may request.
- 2. Ministers and deacons present are invited to seats, allowed to take part in debates on all subjects, and to vote.
- Those who speak shall arise and address the Moderator. Personal reflections shall be avoided in all debates.
  - 4. No motion shall be discussed without a second.
- 5. When a motion has made and seconded, and a member opposes its discussion, the Moderator shall put the question, "Shall it be discussed?" If negative, the question shall be dismissed.
- 6. If any proposition or motion under debate contains two or more points, it shall be divided at the request of any member, and the vote taken separately.
  - 7. Motions made and lost shall not be recorded.
- 8. No one shal speak more than twice on the same subject without special leave of the Moderator.
- 9. All questions shall be decided by a majority vote of all members present.
- 10. No member shall absent himself without special leave of the Moderator.
- 11. Minutes shall be leisurely read and corrected if necessary pefore the close of the Association.
- ...12. At all future sessions of the Association, arrangements shall be made to insure two sermons, or other devotinal exercises equivalent thereto, during each day of the session, and the chair shall announce just before adjournment who shall
- 13. These Rules of Order shall be distinctly read from the chair immediately after organization of the Association.
- 14. Alternations may be made in these rules at any regular session of the Association.

#### FREE WILL BAPTIST CHURCH COVENANT

Having given ourselves to God by faith in Christ, and adopted the Word of God as our rule of faith and practice, we now give ourselves to one another by the will of God in this solemn covenant. We agree to accept Christian admonition and reproof with meekness, and to watch over one another in love, endeavoring to "keep the unity of the Spirit," in the bonds of peace, to be careful of one another's happiness and reputation, and seek to strengthen the weak, encourage the afflicted, admonish the erring, and as far as we are able, promote the success of the church and of the Gospel.

We will everywhere hold Christian principle sacred and Christian obligations and enterprises supreme; counting it our chief business in life to extend the influence of Christ in society; constantly praying and toiling that the kingdom of God may come, and His will be done on earth as it is in heaven.

We agree faithfully to discharge our obligations in reference to the study of the Scriptures, secret prayer, family devotions, and social worship; and by self-denial, faith, and good works endeavor to "grow in grace and the knowledge of our Lord and Savior Jesus Christ." We will not forget the assembling of ourselves together for church conferences, public worship, and the observance of the ordinances of the Gospel, nor fail to pay according to our ability for the support of the church, of its poor, and all its benevolent work.

To this end we agree to labor for the promotion of educational and denominational enterprises, the support of missions, the success of Sunday schools, and evangelistic efforts for the salvation of souls, and the conversion of the world.
