#### PROCEEDINGS

#### WEDNESDAY NIGHT SERVICE

Testimony service led by Eld. Evert Brown. Special song was sung by Sister Naomi Pitts. Prayer by Eld. A. B. Epperson.

The introductory message was brought by Eld. W. A. Land; text, Matt. 5:14, "Ye are the light of the world." Prayer by Eld. J. W. Thompson.

#### THURSDAY MORNING SESSION

Welcome address given by Rev. Paul Osman, pastor of the Methodist Church, in behalf of the Ministerial Alliance of Tecumseh.

#### COMMITTEE REPORTS

#### RESCLUTIONS -

No. 1—Be it Resolved, That our associational year end July 31 and begin August 1, and that our ministers accepting new churches make the changes on that date.

No. 2-Be it Resolved, That this association pay ten dollars (\$10.00) per month into the National Unified Budget program.

No. 3 — Be it Resolved, That this association convene Thursday morning before the third Sunday in August.

No. 4—Be it Resolved, That the introductory message be brought at 11:00 a. m. Thursday.

. No. 5 — Be it Resolved, That deacons serve one year before ordination.

No. 6—Be it Resolved, That each church take a special offering and send to the associational clerk each month for the National Unified Budget Program.

No. 7—Be it Resolved, That the clerk of this association be paid five dollars (\$5.00) and the assistant clerk two dollars and lifty cents (\$2.50).

SUNDAY SCHOOL—We find that we have Sinday Schools using Free Will Baptist literature in all our churches. We urge that we put forth an effort to encourage a higher goal of regular attendance for all ages in our churches and that we build interest by faithful teaching of the scripture.

FINANCE — We, your Committee on Finance, report the following paid in:

\$35.00 for minutes and expense money; \$36.00 for evangelists; \$5.70 for old ministers' fund.

PUBLICATION — We, your committee, recommend that the clerk use her own judgment in numbers of minutes to be printed and that they be printed by a Free Will Baptist Press.

MUSIC — We, your Committee on Music, recommend that each of our churches participate in community singings. We find that special numbers aid spiritually is the cause for Christ. we recommend that teaching of singing schools and especially for the children of our denomination. We believe that in the training of our younger folk now, we will have made advancement that we will be proud of in later years

OBITUARY—We, your Committee on Obituary, find seven deaths in our association:

Bro. Hoarce Graham, Sister Mollie Hulsey, and an infant of Bro. and Sister Parker Mangham of Oklahoma City Church.

CREDENTIAL — We, your Committee on Credential, find all our preachers and deacons in good standing and working for the glory of God.

PRAYER MEETING — We your Committee on Prayer Meeting find that most of the churches have mid-week prayer meeting and we recommend that each church maintain at least one prayer meeting a week. We also recommend cottage prayer meeting in neighborhoods where there are no churches.

LEAGUE — We, your committee on League work, find that the leagues are a strong support to the church and do recommend that each church in the association that does not have a league organize one. Our league is a training school for our young people that they may be able to carry on God's work more effectively than we.

TEMPERANCE — We, your committee on Temperance, submit the following:

Temperance covers a broad field and should be an individual subject and appeal to all true followers of Christ. We urge our people of the several churches to be temperate in all things. We also urge that they use all the ability they have to prohibit the sale and use of intoxicating liquors.

HOME MISSION—We, your Committee on Home Mission, recommend that our churches adopt the National work of the Woman's Auxiliary and that we elect our associational officers at this session.

CENTRAL LOCATION — We, the Committee on Central Location for the association, report as follows:

We are unable to find a suitable location for the Central Location of the Association; but we recommend that we grant the request of the North View Church that we meet there for the year 1943.

ORDAINING COUNCIL—We, the Ordaining Council recommend that Bro Roy Trice be given license to preach the gospel for one year. We also recommend that Bro. Floyd Northam's ordination as a deacon be deferred for at least six months.

INVESTIGATION OF MINNEHA SCHOOL—We, your committee on investigation of Minneha school property, report as follows:

We find that the property was given by the school board

to the community for a church and gathering place and they were not interested in giving the property to any one organization.

#### RULES OF ORDER

- 1. At every sitting of the Association, business shall be opened and concluded by prayer by the Moderator or whomsoever he may request.
- 2. Ministers and deacons present are invited to seats, allowed to take part in debates on all subjects, and to vote.
- 3. Those who speak shall arise and address the Moderator. Personal reflections shall be avoided in all debates.
  - 4. No motion shall be discussed without a second.
- 5. When a motion has made and seconded, and a mem ber opposes its discussion, the Moderator shall put the question, "Shall it be discussed?" If negative, the question shall be dismissed.
- 6. If any proposition or motion under debate contains two or more points, it shall be divided at the request of any member, and the vote taken separately.
  - 7. Motions made and lost shall not be recorded.
- 8. No one shal speak more than twice on the same subject without special leave of the Moderator.
  - 9. All questions shall be decided by a majority vote of all members present.
  - 10. No member shall absent himself without special leave of the Moderator.
  - 11. Minutes shall be leisurely read and corrected if necessary pefore the close of the Association.
  - 12. At all future sessions of the Association, arrangements shall be made to insure two sermons, or other devotinal exercises equivalent thereto, during each day of the session, and the chair shall announce just before adjournment who shall
  - 13. These Rules of Order shall be distinctly read from the chair immediately after organization of the Association.
  - 14. Alternations may be made in these rules at any regular session of the Association.

#### FREE WILL BAPTIST CHURCH COVENANT

We agree to accept Christian admonition and reproof with meekness, and to watch over one another in love endeavoring to "keep the unity of the Spirit," in the bonds of peace, to be careful of one another's happiness and reputation, and seek to strengthen the weak, encourage the afflicted, admonish the erring, and as far as we are able, promote the success of the church and of the Gospel.

We will everywhere hold Christian principle sacred and Christian obligations and enterprises supreme; counting it our chief business in life to extend the influence of Christ in society; constantly praying and toiling that the kingdom of God may come, and His will be done on earth as it is in heaven.

We agree faithfully to discharge our obligations in reference to the study of the Scriptures, secret prayer, family devotions, and social worship; and by self-denial, faith, and good works endeavor to "grow in grace and the knowledge of our Lord and Savior Jesus Christ." We will not forget the assembling of ourselves together for church conferences, public worship, and the observance of the ordinances of the Gospel, nor fail to pay according to our ability for the support of the church of its poor, and all its benevolent work.

To this end we agree to labor for the promotion of educational and denominational enterprises, the support of missions, the success of Sunday schools, and evangelistic efforts for the salvation of souls, and the conversion of the world. And may the God of peace sanctify us wholly, and preserve us blameless unto the coming of our Lord Jesus Christ.
