PROCEEDINGS

Following a ten-day camp meeting conducted by Evangelist Eld Harry Staires of Oklahoma City and Elder Orbin Doss of Shawnee, Oklahoma in which 16 souls were saved, with the greatest spirit of co-operation ever shown in the Association.

On Thursday morning the 47th Annual Session of the First Oklahoma Association was opened by singing "I Love Jesus." Prayer by Elder A. B. Epperson from Tecumseh. Scripture reading by Elder W. E. Dearmore, from Wolf church. Scripture used first division of Psalms.

Eleven o'clock Service—Opening song led by Bro. Burley Wilson from Spring Hill Church. Pianist Ruth Followill. Prayer by Eld. B. C. Munkus from Pleasant Hill Church. Special song "Keep a Little Sunshine in your Sky," was sung by Eld. Clay Richey, Bro. William Rush, and Bro. and Sister Arthur and Opal Hearron.

Devotional was conducted by Bro. Arthur Downs from Earlsboro Church, and a fine spiritual meeting was enjoyed by all present. A special song was arranged by Bro. Tulane Mooneyham, "Just a Closer Walk with Thee."

The Introductory sermon was preached by Eld. A. B. Epperson

from Tecumseh Church, Subject "Leadership." Concluded by Eld. Harry Staires from the Oklahoma City Church. This was an inspiring message to our ministers.
