Motion made and seconded we give the outgoing officers a vote of thanks. Carried.

C. Ketchem elected by acclaration. Due to resignation of Reford Wilson from executive board, Rev. D. H. O'Donnell was elected to fill same.

Motion made and seconded to receive Sister Trula Thompson's resignation as clerk.

Motion to accept Barbara Thompson's resignation as assistant clerk. Sister Tressie Smith elected.

A partial report of finance committee. As to auditing of treasurer's book, that boooks are in order.

Service at 11 o'clock opened by singing "Some Day" led by Rev. Delbert Akin, pianist, Cora Bruce; prayer by Sister Nettie Barnette. Song, "I'll Make It My Home." Moderator introduced Rev. Weatherman as the speaker of the hour, reading third chapter of Ephesians. An inspiring message on the Spirit of Christ. Song, "How Beautiful Heaven Must Be," led by Brother Delbert Akin. Old-fashioned hand shake given Rev. Weatherman. Dismissed in prayer by Brother B. J. Peters.

Service at 1 o'clock opened by singing "He's a Wonderful Savior," led by Brother Delbert Akin, Sister Cora Bruce, pianist. Scripture lesson, Amos 6:1 read by Brother E. C. Ketchem. Prayer by Brother Delbert Akin.

Nominations declared in order for delegates to state association; Brothers Clarence Bruce, Blair, E. C. Ketchem, and Sister Mildred Cash elected. Alternates, Sisters Tipton, Cora Bruce, Pierce, Wynn and Ray elected. Delegate to national meeting elected. Sister Mildred Cash elected by acclamation.

#### ARTICLES OF FAITH

- 1. We believe the Scriptures of the Old and New Testament are the infaliable Word of God, and the only safe rule of faith and practice. II Tim. 3:16-17; II Peter 1:20-21.
- 2. That there is but one true and living God, and in the God Head of Divine Essence, Father, Son and Holy Ghost. Gen. 17:1; I John 5:7.
- 3. That we are fallen and depraved creatures and cannot extricate ourselves from our fallen situation by any ability we possess by nature. Ph. 5:1-19.
- 4. That salvation, regeneration, sanctification, justification and redemption are by life, death, resurrection, ascension, and intercession of our Lord and Savior, Jesus Christ. Acts 4:12; Titus 3:5.
- 5. That the joys of the righteous, and the punishment of the wicked shall be eternal. Matt. 25:46.
- 6. That He that shall endure to the end the same shall be saved. Matt. 24:13; Rev. 2:10.
- 7. That baptism and the Lord's Supper, and the washing of the Saint's feet are the ordinances of Jesus Christ, appointed in the church, and none but true believers are proper subjects, and the only prope rmode of baptism is immersion. Mark 1:4-9-10; Luke 23:30; John 13:14.
- 8. We believe in the sanctity of the first day of the week or the Lord's day, and that it ought to be observed and spent in the public worship of God, and that on it, we should abstain from our worldly concerns except in cases of necessity and mercy. Ex. 31:15; Deut. 5:12; Matt. 12:12.
- 9. We believe in the resurrection of the body, both the just and the unjust, but every one in his own order; those who have done evil to the resurrection of damnation, and that God has appointed a day in which He will judge the world in righteousness by Jesus Christ. I Cor. 15:34; John 5:28; I Thes. 3:16.
  - 10. That it is our duty to be tender and affectionate to

one another, and to study the happiness of the people of God in general and to singly engage to promote the honor of God. John 13:35: Gal. 6:10.

- 11. We believe that Jesus Christ by the grace of God tasted death for every man; yet none can partake of His divine benefit only by his repentance towards God and faith in the Lord Jesus Christ, infants and idiots excepted. Acts 20:21; Tim. 2:5-6; John 3:14-16; I Peter 3:21.
- 12. We believe that the Lord's people are one in Him, and therefore should be one at His table. I Cor. 1:1-11, 27-28; John 17:11.

#### BY-LAWS

- 1. The moderator or assistant moderator, or in their absence, the oldest minister present, shall call the Association into conference.
  - 2. Each session shall be opened and closed with prayer.
- 3. Five members from two or more churches shall constitute a quorum. A less number may adjourn until such quorum is present.
- 4. Visiting brethren are invited to seats as advisory members.
- 5. Those who speak shall arise and address the moderator. Personal reflections shall be avoided in all debates.
- 6. If any proposition or motion under debate contains two or more points, it shall be divided at the request of any member and a vote taken separately.
  - 7. Motion made and lost shall notherecorded.
- 8. No one shall speak more than twice on the same subject without leave of the moderator.
- 9. The moderator shall not allow discussion when not carried on in a Christian spirit.
- 10. The ruling of the moderator may be overruled by a two-thirds vote of the members present.
- 11. Any minister opposed to any of the enterprises endorsed by the Association will not be entitled to a seat in Conference and we will not seat any minister in this Association that teaches the Baptist of the Holy Ghost separate from regeneration or the birth of the Spirit.
- 12. No question from any church shall come under the consideration of the Association unless it has been first discussed in its own church.
- 13. At each Association arrangements shall be made to insure two or more sermons or their equivalent devotional

exercises each day.

- 14. When a church has died (had no pastor for two years) the Association has the power to take possession of that church property to protect the welfare of the denomination.
- 15. The voting body of First Oklahoma Association of Free Will Baptist, shall be ordained ministers, ordained deacons, regularly elected delegates, ministers' wives, and church clerks, who are members of the Free Will Baptist Churches, of said Association in good standing.
