First Quarterly Meeting May 6, 1995

The first Oklahoma Association of Free Will Baptists met on Saturday, May 6 at Southern Oaks Free Will Baptist Church for its regular quarterly business meeting. The meeting was opened with Rick Pope leading the congregation in "Wonderful Words of Life," accompanied by Waldo Young at the piano. Host pastor Kent Hubbard extended the welcome and also brought the morning devotional, using 1 Corinthians 1 as his text. Bro. Hubbard also led the group in prayer.

Moderator Mike Wade declared the business meeting open and assistant clerk Waldo Young read the letters from the following churches who were represented: Harrah, Choctaw, Windwood (formerly Midwest City), Southwest, Sunnylane, Trinity, Moore, Southern Oaks, Westgate, OKC First, Shawnee Northeast, Tecumseh, Trinity, Calvary, Spring Hill, Skyridge, Newcastle.

MSC to seat the delegates and refer requests to proper committees. Prayer by Bro. Edwin Wade.

Moderator accepted written request from Blackwell Free Will Baptist Church, asking for affiliation with First Oklahoma District Association. MSC to accept application and refer requests to proper boards. Moderator and executive committee will visit church and meet with officials to examine status of application and make recommendation at next quarterly meeting.

Mission Board report given by Frank Wiley showing balance of \$8,478 in treasury. MSC to accept report. Other items included in report given for information included:

- a. Report on First Oklahoma mission work at Mustang by Buddy Drake;
- b. Report on State Mission Board work at El Reno by Homer Young;
- c. Report from Dr. Thomas Marberry on trip to FWB Institute in Mexico. District advanced Dr. Marberry \$450 to help with finances. He returned \$218.38 that was not used.

Treasurer's report given by Garry Richey, showing a balance of \$2,743 at the end of the quarterly report. MSC to approve report.

Upon request of the membership at the previous meeting, the executive committee met on Thursday, May 4 at Calvary Free Will Baptist Church to consider a constitutional change concerning active status. The following persons were present: Moderator Mike Wade, Clerk John Martin and executive board members Kent Hubbard, Stan Konopinski and Dan Farmer.

The group unanimously recommended the following proposed constitutional change to be considered by the group. If approved, it will become Article III. Section 5:

To be considered an active member of First Oklahoma District Association, a church must send in its annual dues and annual report to the annual meeting of the association on the second Saturday in February. A church that fails to do so would be considered Inactive, but state and national dues would still be paid by the association. After the second consecutive year of Inactivity, the district will not pay the national and state dues for the church and will place the church on a non-participation basis. A church is automatically placed on the roster of active churches in the association upon receipt of the annual dues and the annual report.

Moderator also explained that two additional steps would be taken before a church is declared inactive the first year: A written notification by the clerk and a personal communication from the moderator.

MSC to table discussion and vote on proposed change in constitution until after break.

Credentials board report given by Shelby Greeson. MSC to approve the following recommendations from the board:

- 1. Gary Shuey, Sunnylane, ordained as deacon;
- 2. Charles Smith, Skyridge, license to preach;
- 3. Darrell Mosely, Pleasant Hill, ordained as deacon.

Garry Richey led group in prayer for victims and families of Oklahoma City bombing.

Christian Education Board report given by John Martin, showing a balance in treasury of \$814.33. MSC to accept report.

Other reports given for information included:

- A. Tim Eaton presented Hillsdale report and Garry Richey make announcement of Hillsdale Golf Tournament;
 - B. Jack Richey presented report from the State Office.

C. Bro. Delbert Akin revealed that Wolf church has joined Progressive Association .

Business Committee appointed for this meeting and also for the August 12 meeting at Yukon includes Richard Terry, Chairman; Dan Harper, Delbert Akin. Business meeting was dismissed in prayer by Stan Konopinski.

Following break, Garry Richey led singing of "At the Cross" with Waldo Young at the piano. Tom Drake led in prayer followed by special music by Rick Pope and the Ministers Quartet. Jack Richey brought the message using Acts 6 as his text.

To conclude the business of the association: MSC to approve recommendations of business committee, (a) balance of funds allocated to Dr. Marberry (\$218.38) be designated for the Bible Institute in Mexico; (b) \$500 to Havea-Heart for Hillsdale; (c) \$500 to state office disaster relief fund; (d) \$300 to Dr. Marberry for his summer mission trip.

Assistant Moderator Edwin Wade presided as Moderator Mike Wade presented the proposed constitutional change. MSC by group to approve the change.

Richard Terry dismissed in prayer.

Second Quarterly Meeting Calvary Free Will Baptist Church—Norman August 12, 1995

Moderator Mike Wade called the meeting to order and also extended the welcome to those in attendance as host pastor for the meeting. Delbert Akin accompanied by Waldo Young on the piano, led the congregation in singing "Higher Ground". Gary Berglan led in prayer.

Bro. Edwin Wade brought the morning devotional.

Assistant Clerk Waldo Young read the letters and other business from those churches in attendance. MSC to accept the following as ordained deacons in our association the following deacons from the Blackwell FWB Church: Jack Bookout, John

Waycaster, Lester Bookout, Richard Moses, Larry Loughlin, Kevin Bookout to remain on trial at the church and come before the credentials board at a later date.

MSC to accept Connell Howeth, Spring Hill, as ordained minister into association.

MSC to accept Jimmy Howell, OKC First, as ordained minister into association.

MSC to re-license Richard Crook, Mustang, as a minister.

3. Executive Board report given by Moderator Mike Wade.

MSC to accept Blackwell Free Will Baptist Church into full fellowship of First Oklahoma District Association.

4. Mission Board report given by Frank Wiley.

Morgan Road Church at Mustang doing well, averaging about 40 with income of \$3,000 per month. Pastor Buddy Drake has resigned to become promotional secretary at Hillsdale. Balance in Mission Board account is \$9,059.74. MSC to accept report. Also, MSC to authorize executive board to deed land at Kingsview over to the church to remove First Oklahoma Association from any financial responsibility to the church, which is now completely self supporting.

- 5. Mike Cousineau, a foreign missionary on furlough from Ivory Coast, gave a report on the work there in the Bible Institute. The institute continues to grow, producing native pastors to take over the churches established there by FWB missionaries. He is a member of the Norman First church.
- 6. Treasurer's report given by Garry Richey. Beginning balance of \$1,759 and ending balance of \$2,335.68. MSC to accept report.
- 7. Lynn Wood made announcement about Great Escape sponsored by State Christian Education Board on Sept. 9 at Hillsdale from 9 a.m. to 3 p.m. with lunch provided. There will separate activities for grades 1-6 and teens. Churches are urged to support this work.
- 8. Christian Education Board report given by John Martin. Balance in treasury \$1,241.32 with several youth activities scheduled for fall, including party for grades 1-6 and Rally Round the Flag for Teens. MSC to accept report.
- 9. Hillsdale Report given by Tim Eaton. Classes to begin Aug. 17 with largest freshman enrollment since 1970 expected. President Jim Shepherd is battling blood pressure problems but is improving. State accreditation has been extended and national evaluation team visited during the summer which allows Hillsdale to continue on five year cycle of providing federal financial aid.

- b. The following recommendation was tabled to be studied by executive board with recommendation to come back to association in November. If approved, it would be put to a vote (constitutional change) at yearly meeting in February: "Be it resolved that the First Oklahoma District Association meet for two business meetings per year in February and August and that the other two meetings be a mission rally in the spring and a Singspiration in November."
- 11. MSC to meet at Straight Street FWB Church for the yearly meeting in February.

Worship service opened with special music from Steve Mayhue, who played trumpet solo, "Till the Storm Passes By" accompanied by Waldo Young. Following congregational singing of "Since Jesus Came Into My Heart," Mike Wade presented a vocal solo, "Touch Through Me."

Morning message was brought by Bro. Ed Bane, pastor of Victory FWB Church, Moore, using Luke 10:2 as his text.

Meeting adjourned at 11:40 a.m.

Third Quarterly Meeting First United Free Will Baptist Church—Choctaw November 11, 1995

The regular quarterly district business meeting of the First Oklahoma Association of Free Will Baptists met on Saturday, November 11 at First United Free Will Baptist Church of Choctaw. CONSTITUTION

PREAMBLE: From long experience, we, the members of the Free Will Baptist denomination, realizingthe necessity of a bond of union and fellowship among us as a group of churches, do hereby ordain this constitution for our progress and to perpetuate better association government.

ARTICLE I

NAME: This Association shall be known as the First Oklahoma District Association of Free Will Baptists of the State of Oklahoma.

ARTICLE II

OBJECT: The purpose of this Association shall be to coordinate and unify the works of the member churches, to devise and execute measures for the extension of the Kingdom of God, and examine for license and ordination prospective ministers and deacons.

ARTICLE III

MEMBERSHIP: Section 1—This Association shall be composed of area Free Will Baptist Churches that adopt the constitution and are accepted by the body.

Section 2—The voting body shall consist of: a) standing delegates composed of officers of the Association, ordained ministers, deacons actively serving on the deacon board of the local church, and ordained ministers ad deacons actively serving in district mission works members of all standing boards, church clerks, full-time associates of churches serving as pastoral assistants and b) no more than three lay delegates selected by each local church who shall be seated upon presentation of proper credentials.

Section 3—Any area church wishing to unite with this Association upon presentation of a petitionary letter and examination by the Executive and Credential Board shall be accepted by a majority vote of this body. Churches coming from other Associations are expected to present a letter of recommendation.

Section 4—Each of the Association is to send \$90.00 to the annual session of this association. This will be divided in this manner: \$25.00 for the District Association, \$30.00 for the State Association, \$15.00 for the National Association, and \$20.00 for the Wilford Lee Scholarship Fund.

Section 5—To be considered an active member of First Oklahoma District Association, a church must send in their annual dues and annual report to the annual meeting of the association on the second Saturday in March. A church that fails to do so would be considered inactive, but state and national dues would still be paid by the association.

After the second consecutive year of inactivity, the district will not pay the national and state dues for the church and will place the church on a non-participation basis.

A church is automatically placed on the roster of active churches in the association upon receipt of the annual dues and the annual report.

ARTICLE IV

NEW CHURCHES: Any group of believers desiring to be organized, may present a petitionary letter and upon majority vote of the association, the Executive Board shall be instructed to examine for organization. Upon examination by the Executive Board, and a two-thirds majority vote of said board, a group may be organized into a local Free Will Baptist church. This church may then become affiliated with the First Oklahoma District Association by petitionary letter and majority vote of the body.

ARTICLE V

OFFICERS: The officers of this Association shall be a moderator, assistant moderator, clerk, assistant clerk, treasurer, and an assistant treasurer, all of whom shall be elected at the annual session.

Moderator, shall preside at all sessions of the Association and shall have power to appoint special committees.

Assistant Moderator, shall preside in the moderator's absence or at his

request.

Clerk, shall keep careful records of all business sessions and handle other correspondence as directed.

Assistant Clerk, functions at the discretion of the clerk or in his absence shall do the work of the clerk.

Treasurer, shall receive, and record all monies and distribute and make regular financial reports of such. The Association books are to be closed on the 15th of each month.

Assistant Treasurer, functions at the discretion of the treasurer or in his absence shall do the work of the treasurer.

The terms of the officers shall begin at the close of the annual session.

ARTICLE VI

MEETINGS: This Association shall meet the second Saturday of March and second Saturday of September for business sessions. Meetings for fellowship or missions emphasis shall also be planned for two other dates, possibly late spring and late fall. Pressing business may be conducted at these fellowship meetings when determined necessary by the executive board.

ARTICLE VII

EXECUTIVE BOARD: Section 1—Composition: The Executive Board of this Association shall be five members, elected to terms of 5, 4, 3, 2, 1 years with one term expiring each year, plus the Moderator, Clerk and Treasurer of the Association.

Section 2—Duties: The Executive Board shall have general supervision of the affairs of the Association between sessions. The Board shall be subject to the recommendations of the Association and none of its acts shall conflict with the action taken by this Association.

Section 3—Meetings: Meetings of the Board can be called by the Moderator who serves as its chairman. The Board shall have the power to collect funds as the means on hand my warrant. It shall as directed by this association have power to convey or mortgage any real estate or Associational property. This Executive Board shall keep a record of all work done, monies raised, meetings held, and make a full report to the next regular meeting of this Association and shall further receive, hold, manage, use, control, and convey any property entrusted to said Association for the purpose in accordance with the purpose of the donors, and in no case divert from its original object.

Section 4—Powers: The Chairman and Clerk of said Executive Board shall sign all deeds and bonds, notes, etc.; and any other papers by which the First Oklahoma District Association is to become legally responsible. It shall be the duty of this Board to meet as often as may be necessary. No member of the Executive Board shall delegate authority to any other member of said Board to cast his vote for him in anything. The Executive Board shall have the power to call the Association into conference by notifying each church ten (10) days prior to the conference; and, they shall have the authority to change quarterly meetings or association if the place where said quarterly

meetings or association is to meet is not able to care for the meetings; and, their decisions shall be final. This must be done in time to notify each church. No meeting of the Executive Board shall be legal unless at least five members are present.

ARTICLE VIII

BOARDS: The following standing boards shall be elected at the annual session. Each board shall consist of five (5) members, elected as to have one member retiring each year. Vacancies may be filled at any regular meeting.

Credentials Board: It shall be the duty of the Credentials Board to examine the church letters and recommend the seating of such delegates as are properly certified; to examine for license and ordination prospective deacons and ministers at the request of their respective churches and make recommendations to the Association; to examine deacons and ministers coming into this body from other associations and make appropriate recommendations to this body.

Church Training Service: The Church Training Service Board shall plan Church Training Rallies and youth activities of the Association. This Board shall also plan the annual Youth Encampment with the authority to appoint and employ necessary personnel. This Board shall provide the churches of the district updated information regarding trends and materials in Christian education, to sponsor training sessions for the district, to assist individual churches in their training programs, and to seek ways to evaluate and enhance the educational ministries of the various churches of the district.

Mission Board: The Mission Board shall be empowered to assist any worthy mission work within the bounds of the Association and supervise missionary activities of the Association.

COMMITTEES: Section 1—Finance Committee: A finance committee composed of the treasurer and two other members shall be appointed by the moderator. It shall be the duty of this committee to prepare a budget for the calendar year and submit it to the Association at its semi-annual meeting. The Finance Committee can from time to time submit supplements to the budget for the current calendar year.

Section 2—Audit Committee: An audit committee of three members shall be selected by the Association at the regular semi-annual meeting whose duty is shall be to audit the treasurer's account at the close of the calendar year and to report to the annual meeting.

ARTICLE IX

PARLIAMENTARY: The rules contained in the current edition of Robert's Rules of Order Newly Revised shall govern the Association in all cases to which they are applicable and in which they are not inconsistent with this constitution and any special rules or order the Association may adopt.

ARTICLE X

AMENDMENTS: This constitution can be amended at any regular meeting of the Association by a two-thirds vote of the body, provided the

amendment is presented in writing and laid on the table from the first session until the second session.

ARTICLE XI

DISSOLUTION: Should this Association cease to function, all properties and holdings shall go to the Oklahoma State Association of Free Will Baptists after all creditors are satisfied and indebtedness cleared.

BY-LAWS

- 1. The moderator or assistant, or in their absence, the oldest minister present shall call the association into conference.
- 2. Each session shall be opened and closed with prayer.
- 3. A majority of the churches shall constitute a quorum.
- 4. Visiting brethren are invited to seat as advisory members without voting privileges.
- 5. Those who speak, shall rise and address the moderator. Personal reflections shall be avoided in all debates.
- If any proposition or motion under debate contains two or more points, it shall be divided at the request of any member and a vote taken separately.
- No one shall speak more than twice on the same subject without leave of the moderator, or more than ten minutes at a time.
- 8. The moderator shall not allow discussion when not carried on in a Christian spirit.
- 9. No question from any church shall come under the consideration of the association unless it has been first discussed in its own church.
- 10. These by-laws may be amended at any meeting of the association by a two-thirds vote of the body.

ARTICLES OF FAITH

- 1. The Scriptures are the Old and the New Testaments, inspired by the Holy Spirit and are the only infallible rule of faith and practice.
- 2. There is only one true and living Triune God, the Father, the Son and the Holy Spirit, three in one personality, one in essence.
- 3. Man is a fallen creature and cannot save himself.
- 4. Jesus Christ, by the grace of God, tasted death for every man and all who repent and trust Christ as Savior will be saved.
- 5. All believers in Christ, who through grace, persevere in holiness to the end of life, have the promise of eternal salvation.
- 6. It is the duty of every Christian to unite with a visible church where through association with others he may share in the observances of the ordinances and the perpetuation of the gospel. The Lord's day is the first day of the week, commemorating the resurrection of Christ and should be spent in public and private worship and rest from secular activities. Upon this day Christians should bring their tithes and offerings into the Lord's house.
- 7. The Gospel Ordinances: Baptism is the immersion of believers in water by an ordained minister, in the name of the Father, the Son, and the Holy Spirit; the Lord's Supper is a commemoration of the death of Christ and is open to all believers and should be observed at night; feet washing, which teaches humility, follows the Lord's Supper and is the duty and happy prerogative of every believer.
- 8. There will be the resurrection both of the just and the unjust, every one in his own order, "they that have done good, unto the resurrection of life; they that have done evil, unto the resurrection of damnation." The Lord Jesus, who ascended on high, sits at the right hand of God and will come again to close the gospel dispensation, glorify His saints and judge the world. Then the wicked shall go away into everlasting punishment but the righteous into life eternal.
- 9. The definition and condition of the backslider:
 A backslider is a regenerated person who has degenerated to a state of living in unconfessed an unforgiven sin. Such a person is rebellious to the principles of the Kingdom of God and His righteousness, and cannot enter into sinless Heaven in such a backslidden condition. The following scriptures explain: Jeremiah 2:21; Jeremiah 2:32; II Peter 1:9; James 1:13-16; James 5:19-20; Romans 6:12; Matthew 6:24; Hebrews 10:38-39; Hebrews 3:12-14; Ezekial 18:24; I John 1:9; Revelation 21:27.

- (a) We believe that salvation is a present possession by faith in the Lord Jesus Christ as Savior and that a person's eternal destiny depends on whether he has this possession. This we hold in distinction from those who teach that salvation depends on human works or merit.
- (b) We believe that a saved individual may, in freedom of will, cease to trust Christ for salvation and once again be lost. This we hold in distinction from those who teach that a believer may not again be lost.
- (c) We believe that any regenerated person who has sinned (again, whether he be called "backslider" or "sinner"), must be judged by that evidence to be lost should he so die in his sins. this we hold in distinction from those who suggest the pernicious doctrine that man may live in sin as he pleases and still claim heaven as his eternal home.
- (d) We believe that any regenerated person who has sinned (again, whether he be called "backslider" or "sinner"), and in whose heart a desire arises to repent, may do so and be restored to favor and fellowship with God. This we hold in distinction from those whoteach that when a Christian sins he cannot repent and be restored to favor and fellowship with God.

"Whereby are given unto us exceeding great and precious promises: that be these ye might be partakers of the divine nature, having escaped the corruption that is in the world through lust. And beside this, giving all diligence, add to your faith virtue; and to virtue knowledge; and to knowledge temperance; and to temperance patience; and to patience godliness; and to godliness brotherly kindness and to brotherly kindness charity. For if these things be in you and abound, they make you that ye shall neither be barren nor unfruitful in the knowledge of our Lord Jesus Christ. But he that lacketh these things is blind, and cannot see afar off, and hath forgotten that he was purged from his old sins. Wherefore the rather, brethren, give diligence to make your calling and election sure: for if ye do these things, ye shall never fail." II Peter 1:4-10.
