PROCEEDINGS

Proceedings of the Seventh Annual Session of the Florida Free Will Baptist State Association.

The Seventh Annual Session Florida Free Will Baptist State Association convened with Hickory Grove Church, Nov. 2-3, 1951, near Malone, in Jackson County, Florida, with Miss Miranda Ditty leading the song service at 9:45 A.M. Two songs were rendered by Congregation, "Standing on The Promises" and "Showers of Blessing" and a scripture reading.

Prayer by Rev. D. F. Pelt, pastor of host church.

Address of Welcome given by Miss Miranda Ditty. Response by Rev. Rufus Hyman.

At this time the Moderator, Rev. D. F. Pelt, appointed the following as Credentials and Finance Committee: Mrs. Ernest Owen, Chairman; Rev. I. O. Cook, and brother of H. A. Hicks. This Committee was assigned a Sunday School room to meet in session with delegates, ministers and deacons and register them and their fees for Associational expense.

At 10:20 by motion and second, Rev. W. H. Ryland, Superintendent of the Free Will Baptist Children's Home, Eldridge, Ala., was presented to the State Association to speak for the Home. Brother Ryland first spoke to our women about the value various coupons that can be turned into cashfo r the Children's Home. The message told of great progress being made from beginning with a large plant, which was almost donated to us. Other denominations began with a small plant, but we have come way up from the top, to where we are now. The home was purchased for \$7,000 that cost over \$100,000 spent to build when things were low. We have around 50 children in the home.

Motion and second we adjourn for Credentials Committee to compile report.

At 11:15 Rev. K. V. Shutes led the Congregation in singing, "Master the Tempest is Raging." Rev. Henry Chesnut was absent who was on program and the Moderator presented Rev. C. A. Huckaby as the Alternate for brother Chesnut.

Scripture lesson, Roman 9:15. At this time brother Huckaby had the tract "The Free Will Baptist Church," passed out to the congreation. The speaker brought on inspiring message on "Saving the Lost." After the message we were served lunch in the building as the weather was raining.

FRIDAY AFTERNOON — 1:40

Devotional service with Rev. K. V. Shutes leading the singing. and brother L. C. Granger reading the 100th Psalm and Prayer by Rev. G. W. Jordan.

, At 1:45 the Moderator called for Credentials and Finance Committee report. The Committee made a partial report and it was accepted. The Committee then reported that the State Line Association of Alabama and Florida and Union Hill Association were petetioning for membership. Committee report accepted with ammendment the names of all delegates be included in the report. (See reports.)

Bymotion and second the Moderator extend the right hand of fellowship to the delegates from the State Line and Union Hill Associations. Both of these Associations have churches in Alabama and Florida.

Th Planning Board made their report and by motion it be accepted, and there a motion was made and carried that the report lay on the table until following day (Saturday). (See reports).

At this time Rev. Thos. H. Willey spoke briefly on the Free Will Baptist Forein Mission work in Cuba.

At this time the Moderator recognizedvisitors to our body from other states. Rev. Henry Melvin was present from Nash-Ville, Tenn. and Rev. W. H. Ryland and Rev. J. M. Cobb from Eldridge, Ala. From Georgia, Revs. K. V. Shutes, R. C. Houston, Coy Watson and Mr. and Mrs. Bell. By motion all visitors be seated.

The chair appointed the following on Nominating Committee: F. W. Bolin, C. A. Huckaby, R. L. Williams.

For Program Committee for 1952: The clerk, the Moderator, and pastor of host church, elect.

At 2:35 the Moderator presented Rev. Henry Melvin, (native Floridian) as Business-Manager of Free Will Baptist Bible College. The College is in its 10th year and is getting more firmly established and our Ministry much stronger. We have 135 enrolled in our college, and the college is expanding as fast as possible.

Brother Ernest Owen spoke briefly on the Fla. Budget for support for our denominational program and insisted that each church adopt the budget of the unified programs so our work can be supported more systematically.

At this time the Moderator requested the Committee to read their assinment of delegates, ministers and visitors for the night. Motion and second adjourn until 9:30 Saturday morning.

FRIDAY NIGHT — 6:45—(Missionary Night)

A good song service was led by Rev. J. M. Cobb, Eldridge, Ala., and prayer Rev. R. M. Hughes, of Pensacola.

The Moderator, Rev. D. F. Pelt at this time presented Rev. Thos. H. Willey, of Pinor del Rio, Cuba, who brought a fine missionary message from Luke 12:15-21, on "The Rich Fool" who was a farmer.

This was a fine message -and here is what "The Rich Fool" said: (1) "My Ground." It was not his. It belonged to the Lord. He was only a steward on the ground. (2) "My Fruits.' It was not his fruits. He was a steward and 10 per cent plus a free will was God's rent money. (3) "My Barns.' They were his. They also belonged to God. Again he clamied ownership of all. [4) "My Soul." It was not his soul. It was the Lords by creation and by redemption. He lost his soul because failed to recognize he was not even the owner. (5), "My Time. He said he had much time, but he was mistaken. Time and eternity belong to God and

not to man.

SATURDAY MORNING — 9:45

Song service in charge of Rev. C. A. Huckaby and Rev. Henry Melvin at the piano. Scripture lesson read by Rev. J. M. Rich from Matt. 6:31 on putting "First Things First.' Prayer by Bro. Rich.'

At 10:10 the Credentials and Finance asked to retire and enroll delegates, deacons, and ministers.

Moved and carried that the delegates and ministers names with their address be carried.

At this time the Moderator appointed Miss Ada Holley on Committee in place of Brother F. W. Bolin who was absent.

There was motion and second that The Mission Board make some plans for Church Extension. Motion carried.

There was a motion made and carried that the Educational Board make plans for educational loan fund.

There was a motion made and carried that we elect a temporary Mission Board since some of the members of the Mission

Board are reported absent. (See reports for all above elsewhere in their minute.)

At this time Rev. Henry Melvin to lead us in a song service.

The Vice Moderator, Rev. R. M. Hughes called for reports and the Mission Board made their report and it was accepted. (See reports.)

Bymotion we adjourn business session until 1:15 P.M.

At 11:30 preaching service with Rev. Henry Melvin in charge of service. There was a solo by a Mr. Price "I Belong to Him." After which brother Melvin brought a fine message from Gal. 3:1. "Paul was a great writer of letters to Churches and friends who had just recently been converted from heathenism, or either Judaism who were instructed in Christian tecahing. The Galatians thought they were saved by law and grace.

"The Bewitched or Charmed Galatians were unthinking Christians."

The two main points of the sermon were: The Christian Rebased on (1) The Cruxifixion and (2) The Resurrection of Christ.

We recessed for lunch at 12:15 served in Sunday School rooms by the ladies of the host church.

3. Since we recognize the need of Christian education for our young people we have started building a youth training camp near Cottondale, Fla. This camp consist of ten acres of land upon which we have placed a deep well and one building partically completed. Our present need is money to complete this building so classescan be held there next summer.

4. We suggest this Associational Body appoint a Finance Committee to help raise the necessary funds to complete this building.

CONSTITUTION AND BY-LAWS

We, the Free Will Baptists of Florida, for the sake of power that comes of unity and oneness of purpose; for the advancement of the cause of Christ; for the glory of God and the good of mankind do ordain and establish this constitution and by-laws:

ARTICLE I. NAME OF ASSEMBLY

Section 1. This assembly shall be known as "The Florida State Association of Free Will Baptists."

ARTICLE II. OFFICERS, DELEGATES AND FEES

Section 1. The officers of this Association shall be a moderator, an assistant moderator, secretary, an executive board, a planning board, a board of missions (Home and Foreign), an edu-Section 10. When vacancies occur either by death or removal from office, or by resignation the body shall fill vacancy either by proxy or by election of officer to the vacancy at any regular session of the body and the proxy may be appointed by the body to fill any absentee's place who does not attend the session.

Section 11. Election years shall be odd years. Thus the regular elections shall take the place on odd years of the calendar.

Section 12.

All standing boards shall be composed of one (1) member from each association and their term of office shall be four

years. Two being elected at each election year. The first two named shall be elected fro only a term of two years. Thereafter all shall elected as specified herein.

Section 13. This body shall have and does reserve the right to deal with any officer or board member who does not conduct his or her office in a Christian and business-like manner according to rules of Christian conduct laid down laid down in the teachings of the New Testament. Thus the right to discipline in this body is confined to this body, but a charge against a member of this body and the members of local churches shall constitute a charge against said member in this body and the body shall abide accordingly thereby.

ARTICLE III. DUTIES OF OFFICERS AND BOARDS

Section 1. It shall be the duty of the moderator to preside over all the deliberations of this body while in session.

Section 2. The moderator shall have power to rule measures out of order providing this ruling is sustained by one-third of the delegates present.

Section 3. The Vice-Moderator shall assume the duties, rights and privileges of the moderator in his absence.

Section 4. The Vice-Moderator shall be ex-officio member of all boards and committees.

Section 5. It shall be the duty of the clerk to make and keep records of all the business proceedings and activities of this body.

Section 6. It shall be the duty of the treasurer to receive and all funds, pay all bills and keep records of receipts and disbursements.

à

cational board, and any other officers that the Association, while in session, may decide to add because of changes of nescessity.

Section 2. This Association shall be composed of delegates elected from the local association, belonging to this body, delegates elected by the local churches embraced by the various local associations and all ministers belonging to these local associations and churches. The delegates shall be elected as follows: One delegate from each local church composed of one hundred members or fraction thereof, and one delegate from each additional one hundred members or fraction thereof, and one delegate from each local association composed of fifteen churches or fraction thereof. The additional delegates cannot be used unless the churches are active and are represented in the session in which they are appointed. Fees are \$10.00 for an association and for churches \$2.00 per delegate. All deacons and ministers are standing dele-



gates. Fees are \$1.00 for deacons and ministers.

Section 3. Ministers cannot be appointed as delegates from the local associations or churches. All visitors and ministers who do not belong to or pastor for this body can only be seated as honrary members.

Section 4. All churches and associations representing in this body shall pay entrance fee annually. The amount of this fee shall be determined by the body while in session and may be changed by a two-thirds vote in any session.

Section 5. All funds coming into this body shall be spent under a budget plan. This budket must be approved by the body while in session and no funds may be used in any way except as budgeted.

Section 6. It shall be the duty and power of the delegates of this body to make all laws which shall be necessary for the carrying on of the work of this Association, and all these laws must be in keeping with this constitution and must be kept on records so conflicting regulations may be avoided.

Section 7. Fifty (50) per cent of the delegates elect shall con-

stitute a quorum.

Section 8. All officers except board members shall be elected to serve a term of twoyears.

Section 9. Any officer may be re-elected as the body shall see fit, but the officers, or nominees, must give his consent to serve willingly.

Section 7. All officers and board members must be Free Will Baptists who are in good standing in their respective churches and associations, must belong to this body and must, when elected, live within bounds of the Association. The treasurer must give bond.

Section 8. It shall be the duty of the planning board to provide general plans for this Association, make the budket and regulate fees.

Section 9. The Moderator, Vice-Moderator, Clerk and Treasurer shall act as the Executive Board. This board shall act for the Association when the body is not in session. All action of the Executive Board becomes void when the Association meets unless sustained by two-thirds of the delegates present.

Section 10. It shall be the duty of the Mission Board to make plans for church extension and operate any state mission work and also work in the interest of the foreign mission program of

the National Association. It shall be the duty of Mission Board to help make our people missionary minded.

Section 11. It shall be the duty of the educational board to make plans for operating the Florida Training Camp and Christian education for Christian workers. This board shall keep our National and State educational work before our people. It shall be their duty to create interest in Christian education.

Section 12. It shall be the duty of the supernuation board to make general plans for supernuation for aged ministers, and to cooperate the National Association in providing insurance protection for our younger ministers.

BY-LAWS TO SECTION 12

PURPOSE-

The purpose of the program is to make possible for active Free Will Baptist Ministers and full-time Christian Workers the following benefits:

1. Protection for loved-ones in case of untimely death. (Face

- value of insurance policy with accumulated dividends.)
- 2. A regular income in case of total and permanent disability.
- 3. Income from retirement age to death.
- 4. The above benefits shall be provided through and by the provisions of the State and National Superannuation program.

PLAN-


The National board has a working agreement whereby all Ministers and full time Christian Workers can be insured for the the above benefits. (Insurable ages 21 through 52).

FINANCES-

The National board finances this program with funds sent from the State Superannuation boards. The State Treasurer keeps 75 per cent of these funds for the operation of the State program, and will send 25 per cent to the National Treasurer.

AMOUNTS OF BENEFITS FROM STATE TREASURER—

The amount of monthly benefits shall be governed by the following rules:



1. The amount shall be \$10 per month to the disabled Minister or Christian Worker, and to be increased (not to exceed \$25) if the total amount in the State treasure permits, but in no case shall this be done if it will prevent all payments to be made for the Associational year to all those receiving benefits.

ELIGIBILITY-

The above benefits shall be paid monthly to the following:

- 1. To any Free Will Baptist minister or full-time Christian Worker. Who has a total and permanent disability or upon reaching the ae of 70.
- 2. The titles given above Free Will Baptist Minister or fulltime Christian Worker shall be as follows to Free Will Baptist Ministers who have either pastored or done full time Avangerlistic or Teaching work for 10 years. Christian Workers shall be Free Will Baptists although not Ministers, but shall have done full time Christian work as teachers or Missionaries (Home and Foreign) or Evanerlistic work for 10 years for the Free Will Baptist Church.
- 3. Applications must be made to and approved by the Flor-

ida State Superannuation Board, while in private session.

4. That the traveling expense of Board members shall be paid for all Board meetings by the board.

ARTICLE IV. AMENDMENTS

Section 1. Amendments to this constitution must be put before the body while in session one day before voted on, and must be read at least twice and passed by two-thirds of the delegates present. All amendments must be ratified by three of the associations now belonging to the body and by a majority of the associations belonging to same, should other associations join us in the future.

ARTICLE V. RATIFICATION

Section 1. Before this constitution becomes effective it must be ratified by 4 of the 5 associations belonging to this body and by at least 50 of the 82 local churches embraced by the same.
