### Thursday Evening, November 2

The service began with Rev. McFarland leading the congregation in singing "Love Lifted Me". Rev. George led in the opening prayer, and the congregation then sang "Standing on the Promises."

The officers of the Florida State Association of Free Will Baptists was introduced to the congregation, and Wayne Hicks appointed to serve as Clerk in the absence of Robert Owen, Clerk. Then a welcome was extended by Harvey Henderson, Pastor of the Host Church.

The Moderator, Rev. Irvin Hyman, declared The Florida State Association of Free Will Baptists in order for its seventeenth Annual Session. The Moderator then gave his opening address to the Body and read from the Scriptures Zephaniah 3:1-4.

After another song Rev. Owen Ganey, Pastor of Unity Church in Jacksonville, was introduced. Brother Ganey brought the message for the evening. He read Mark 2:1-12, and the title of his message was "Termites from Hell"

The Moderator named the Committee on Committees as Bill Travis, Q. Hansley, and Ernest Owen. The visitors were recognized and welcomed. Then the Credentials Committee was named as follows: Elzie Carroll, Lloyd Carroll, and Floyd Coleman. The congregation sang "Heavenly Sunshine" after which Rev. K. V. Shutes led in the benediction prayer.

#### FRIDAY, NOVEMBER 3

The day started with Rev. Henderson leading the congregational singing, and Rev. Hicks, who read II Samuel 9, led in the morning devotion. The Moderator called the Body to order and a few remarks about parliamentary rules and deliberations.

The Moderator asked for a motion to adopt the Program which had been outlined by the Executive Committee. Rev. D. F. Pelt stated that this was out of order, because the delegates had not been seated.

When the Chair called for a partial report from the Credentials Committee, the Committee was not ready with their report; so the Moderator asked Rev. Carlton Lambert, Superintendent of the Children's Home in Eldridge, Alabama, to give a report of the Children's Home. (see reports).

The Credentials Committee gave a partial report. A motion was carried to accept the report and seat the delegates.

Rev. D. F. Pelt made a motion to seat visiting ministers as visitors, so that they may enter the discussions. Carried.

The Committee on Committees gave their report which was adopted.

The Planning Board made its report, and Rev. McFarland made a motion to table the report. Motion to table carried.

The congregational singing was led by Rev. Henderson for the eleven A.M. Worship Service. We sang "Praise Him, Praise Him", and "At The Cross". Brother E. A. Riggs led in prayer. Rev. Chester A. Huckaby preached the message. His Scripture was taken from Co-

lossians 1:13-19, and his subject was the theme of the Convention. "The Preeminent Christ". After singing "Oh, How I Love Jesus", The Body was dismissed for lunch.

### FRIDAY AFTERNOON

For the devotional period Rev. Travis directed the Body in singing "Send the Light." After Rev. Driggers led in prayer the Congregation sang "Let the Lower Lights be Burning." Rev. George was in charge of the devotion. He read from Col. 1:18 and Proverbs 3:5, 6.

A motion was made by Rev. I. O. Cook to take the planning Board report from the table. Motion was lost.

The Board of Superannuation made their report which was adopted.

League Board report was given and adopted.

Rev. Leon Owens made his report as Treasurer. Report adopted.

Melitino was asked to give information on his work in Miami. He stated that the work was growing, and that about 3 weeks ago they had bought property by the help of the National Home Missions Department. Mrs. Yeley lives in one of the apartments of the building.

The Educational Board made its report, and it was adopted.

The report from the Florida Free Will Baptist Bible Institute was adopted. A motion was made by Rev. Huckaby to give the people an opportunity to give to F. F. W. B. B. I. Motion carried.

A motion, made by Rev. Huckaby, was carried to take from the table the Planning Board report. Report adopted.

Rev. Elro Driggers made a motion that we hear the Executive Committee report. The report was given, and Rev. D. F. Pelt made a motion to table this for this Session. This motion got a second, but it was lost by count of more than 2 to 1. The Executive Committee report was adopted by count of over 13 to 1.

Rev. Driggers moved to hear from Rev. Henderson about the Missionaries coming into our Association with the Primitive Baptist Churches. Brother Huckaby made a motion that our State Mission Board work out some plan on behalf of this work with the National Home Mission Department. Motion carried.

The Motion to adjourn was made by Rev. Ganey.

#### FRIDAY EVENING

The song service for the evening was led by Rev. Henderson, and we sang "Send the Light", "Showers of Blessings", and "I am Thine O Lord". Rev. Elro Driggers presented a challenge to the Body on behalf of Free Will Baptist Bible College.

Brother Henderson sang a solo, "The Love of God". The evening message was given by Rev. Emory R. Corbett of Lake Butler, Florida. Bro. Corbett read from Galatians, Chapter 1, verse 6.

### SATURDAY MORNING

The day was opened with singing led by Rev. McFarland. Rev.

Harrison led in the Devotion, reading Rev. 3:7,8. The prayer was offered by Rev. Owen Ganey.

The Moderator called for a final report from the Credentials Committee. The report was made and adopted.

The Placement Committee report was adopted.

The report of the Resolutions Committee was given with a motion to adopt the report item by item. All items were adopted as given in report except item 5 which was amended to read that the same amount be paid to Vice-Moderator. The Moderator appointed these men to serve on the Revisions Committee; Harrold Harrison, Chester Huckaby and Wayne Hicks.

The report of the Appreciation Committee was adopted.

The report of the Finance Committee was made, and a motion was made to table the report. Motion to table carried.

The Nominating Committee made a report which was accepted and amended.

After Rev. Clyde Owen, who was not present, was elected as State Treasurer; Rev. Hicks was making a statement concerning this action; Rev. D. F. Pelt called a point of order to say that any remarks were out of order. Rev. Elro Driggers offered a motion to let Brother Hicks say what he wishes on the subject. Rev. Hicks made a motion to call Rev. Owen and pay the charges from the General Fund. Motion was Carried. Then Rev. McFarland moved to rescend the action of electing Rev. Owen as Treasurer. This motion was carried. Mr. W. J. Amerson was then elected as Treasurer. A motion was carried to make the change in the report.

A motion was carried to accept the part of the report as a whole which pertained to the assigning of the Boards.

Rev. Huckaby made a motion that we follow the custom in appointing the Credentials Committee. Carried.

A mótion made by Rev. Pelt that the Executive Committee be authorized to appoint the Credentials Committee was carried.

The Moderator appointed a man in each Association to promote

giving through the Cooperative Program. Northeast - Elro Driggers, South Florida - William Travis, North Florida - Wayne Hicks, Liberty -Bill George, Salem - H. D. Shuemake, Central - Fred Bradshew, West Florida - Harvey Henderson.

A report from the Camp Meeting Committee was adopted.

Rev. McFarland made a motion that the moderator of each local association, along with the clerk, compile a complete list of all local churches, plus all local ministers in good standing, along with their present address, and that these lists be sent to the State Association Clerk to be printed in book form. A sufficient amount of these books then be mailed out to each local association. Motion carried.

Mrs. Bertie Baxter made a motion that the new Treasurer give his name and address to the body. Carried.

The Motion for the Moderator to appoint delegates to the National Association was carried. Appointed were: Donald Dingman, Ann Travis, Louise Hicks, Ruby Pelt, W. E. Holley.

This motion by Rev. Huckaby was carried. That in the event that these delegates cannot go, that they send a proxy. Amendment carried: Mrs. Ruby Pelt moved to appoint 3 alternates, and these to be used when the Clerk is notified. Alternates appointed: Mr. G. W. Cloud, Mrs. G. W. Cloud, Mrs. Oceal Finch, Mrs. Grace Huckaby, Mrs. Inez Esther.

A motion was made by Rev. Huckaby to take from the table the Finance Committee report. Motion carried. Report adopted.

Rev. Driggers moved that the same Sunday School Board report be repeated in the minutes. Carried.

Mr. Holley made a motion to take an offering for the Childern's Home. Motion carried.

Rev. Huckaby moved that if we charged any visiting minister a fee, that we refund the money. Carried.

Rev. Huckaby moved that we offer our appreciation to our Moderator for coming all the way from Atlanta, Georgia for the Association. Carried.

Motion offered by Rev. Ganey to adjourn carried.

In closing the Session Brother McFarland sang, "Great is Thy Faithfulness." The Congregation joined in singing the chorus.

### EDUCATIONAL BOARD

1. A one week session of the Florida Free Will Baptist Youth Camp was held June 26-30 with 86 campers enrolled. (Financial report and Details are attached.)

2. The Florida Ministers' and Deacons' Conference met September 11-15 with seven ministers and two deacons present. Rev. Rufus Hyman spoke each morning on the subject, "Ministers' and Deacons' Relationships to each other." Services were held each evening at 7:30 with ministers from four different associations bringing the messages. Some much needed work was completed at the Youth Camp and also at the Florida Free Will Baptist Bible Institute during the week. (Financial report attached.)

3. The following recommendations are submitted by this board:

A. We recommend that the Florida Free Will Baptist Bible Institute receive a portion of the State Cooperative money.

B. We the Board of Education hereby reaffirm our faith in our Free Will Baptist Bible College of Nashville, Tennessee and our Florida Free Will Baptist Bible Institute near Cottondale, Florida. We present this endorsement for the following reasons:

(1) Because of the kind of education involved; that is, the training of Christian men and women to be ministers, missionaries, and other Christian vocations.

(2) Because the Florida Free Will Baptist Bible Institute belongs

to our own Free Will Baptists of Florida and our Bible College belongs to all Free Will Baptists.

(3) Many of our successful pastors in the State are products of our Free Will Bartist Bible College in Nashville.

(4) A number of students from our state are presently enrolled in our Bible College in Nashville and our Institute near Cottondale.

(5) Our Bible Institute of Florida has already benefitted a number of our churches, and will in a period of time reach and Benefit every area of our State.

(6) We therefore encourage the State as a whole to support these two institutions with prayer, finances, and students.

#### FLORIDA FREE WILL BAPTIST BIBLE INSTITUTE

The Board of Directors of the Florida Free Will Baptist Bible

Institute met on December 3, 1960 to formulate plans for the opening of the Bible Institute. In subsequent meetings Rev. H. D. Harrison was named Administrative Dean, Rev. C. A. Huckaby, Chairman of the Board, Rev. Clyde Owen as Treasurer. Rev. Freeman Edwards and Rev. H. D. Harrison were named as instructors. The Board of Directors consists of Mr. Ernest Owen, Rev. C. A. Huckaby, Rev. H. L. Henderson, Rev. Clyde Owen, and Rev. H. D. Harrison.

A kickoff rally was held at the Institute site on February 25, 1961 at which Rev. Charles A. Thigpen, Dean of Free Will Baptist Bible College, was the principal speaker. The Spring semester began on March 7, 1961.

The following one semester hour courses were offered: Bible Survey, Bible Doctrine, Techniques of Teaching, Sunday School Administration, Personal Evangelism, and Daily Vacation Bible School.

The total enrollment for the first semester was twenty-six. Of this number there were eighteen men and eight women. This number was made up of students from the states of Alabama and Florida representing three associations and thirteen churches. Of the twenty-six students there were nine ministers, two deacons, and fifteen laymembers. A total of eighty-one semester hours were enrolled for.

The second semester of the Bible Institute began on September 19, 1961.

The following courses are being offered: Bible Survey II, Bible Doctrine II, Principles of Speech, Preparatory English, Personal Evangelism II, and I Corinthians. The total enrollment for the second semester has been twenty-three. Twelve of this number are returnees from the first semester. This group of students consists of eighteen men and five ladies. They represent the states of Alabama and Florida and come from three different associations and nineteen different churches. The student body is made up of eleven ministers, two deacons, and ten laymembers. A total of fifty-four semester hours have been enrolled for this term. We are presently operating two nights per week, from 6:00 until 9:00 P.M.

Brother Wayne Love, a Free Will Baptist layman, from Cotton-

wood, Alabama, was employed as instructor in Speech and English this semester. Brother Love is a graduate of Troy State Teachers College, Troy, Alabama.

Out of our enrollment this semester, we have seven students with previous college training ranging from two years to one semester; ten who are High School graduates; four who have finished the ninth grade; and two who have finished the eighth grade. This gives us an average grade 1 level attainment of 11.3.

Initial efforts have been made in the building of a good theological library. Presently we have seventy-two selected volumes.

We feel that God has greatly blessed the Florida Free Will Bible Institute and that it is worthy of your prayer and financial support.

Our financial report for the past year is attached.

CONSTITUTION AND BY-LAWS of the FLORIDA STATE ASSOCIATION OF FREE WILL BAPTISTS Constitution Preamble

Preamble:

We, the Free Will Baptists of Florida, for the sake of power that comes of unity and oneness of purpose; for the advancement of the cause of Christ; for the glory of God and the good of mankind do ordain and establish this Constitution and By-Laws.

### ARTICLE I - NAME OF ASSEMBLY

Section 1. This assembly shall be known as "The Florida State Association of Free Will Baptists".

## ARTICLE II - OFFICERS AND BOARDS

Boards, delegates and fees and time of meeting

Section 1. The officers of this Asociation shall be: A Moderator, Assistant Moderator, a Secretary, a Treasurer, an Executive Board, Planning Board, Board of Missions (home and foreign), and Educational Board, Board of Superannuation, Sunday School Board, League Board and Board of Trustees and any other officer and boards that this Association may decide while in session to add because of changes of Necessity. This Association shall convene annually on Friday and Saturday before the first Sunday in November.

Section 2. This Association shall be composed of delegates elected from the local associations, belonging to this body, delegates elected from the local churches embraced by the various associations and churches.

The delegates shall be elected as follows: One delegate from each local church composed of one hundred members or fraction thereof, and one delegate for each additional hundred members, or fraction, thereof; five delegates from each local association composed of fifteen churches, or a fraction thereof, and one additional delegate for each additional four churches or fraction thereof. The additional delegates cannot be used unless the churches are active and are represented in the session in which they are appointed.

Fees are \$10.00 for an association with five (5) churches. Associations with more than (5) churches, fees are \$20.00 and for churches \$4.00 per delegate. All deacons and ministers are standing delegates. Fees are \$2.00 for deacons and ministers.

Section 3. Ministers cannot be appointed as delegates from the local associations or churches. All visitors and ministers who do not belong to or pastor for this body can only be seated as honorary members.

Section 4. All churches and associations represented in this body shall pay entrance fee annually. The amount of this fee shall be determined by the body while in session and may be changed by a twothirds vote in any session.

Section 5. All funds coming into this body shall be spent under a budget plan. This budget must be approved by the body while in session and no funds may be used in any way except as budgeted.

Section 6. It shall be the duty and power of the delegates of this body to make all laws which shall be necessary for the carrying on of the work of this association, and these laws must be in keeping with

this Constitution and must be keep on records so conflicting regulations may be avoided.

Section 7. Fifty (50) percent of the delegates shall constitute a quorum.

Section 8. All officers except board members shall be elected to serve a term of two years.

Section 9. Any officer may be re-elected as the body shall see fit, but officers, or nominee, must give his consent to serve willingly.

Section 10. When vacancies occur either by death or removal from office, or by resignation the body shall fill vacancy either by proxy or by election of officer to the vacancy at any regular session of the body and the proxy may be appointed by the body to fill any absentee's place who does not attend the session.

Section 11. Election years shall be odd years. Thus the regular elections shall take place on odd years of the calendar.

Section 12. Each standing Board shall be composed of 5 mem

bers from one local Association, with the exception of the Board of Trustees and said members shall be elected by the Local Association or its Executive Committee. The State Association shall alternate the Boards to the local Associations annually. These Boards are hereby asked to make their report to their local Associations before they are presented to the State Association.

The Board of Trustees shall be composed of one (1) member from each Association and their term of office shall be four (4) years. Two being elected at the first for only a term of two years. Thereafter all shall be elected as specified herein.

Sction 13. This body shall have and does reserve the right to deal with any officers or board member who does not conduct his or her office in a Christian and business-like manner according to the rules of Christian conduct laid down in the teachings of the new Testament. Thus the right to discipline in this body is confined to this body, but a charge against a member of this body and the members of local churches shall constitute a charge against said member in this body and the body shall abide accordingly thereby.

ARTICLE III — DUTIES OF OFFICERS AND BOARDS

Section 1. It shall be the duty of the Moderator to preside over all the deliberations of this body while in session.

Section 2. The Moderator shall have the power to rule measures out of order providing this ruling is sustained by one third of the delegates present.

Section 3. The Vice-Moderator shall assume the duties, rights and privileges of the Moderator in his absence.

Section 4. The Vice-Moderator shall be ex-officio members of all boards and committees.

Section 5. It shall be the duty of the Clerk to make and keep records of all the business proceedings and activities of this body.

Section 6. It shall be the duty of the Treasurer to receive all funds, pay all bills and keep records or receipts and disbursements.

Section 7. All officers and board members must be Free Will

Baptists who are in good standing in their respective churches and associations, must belong to this body and must, when elected, live within bounds of the Association. The Treasurer must give bond.

Section 8. It shall be the duty of the Planning Board to provide general plans for this Association, make the budget and regulate fees.

Section 9. The Moderator, Vice-Moderator, Clerk and Treasurer shall act as the Executive Board. This Board shall have full authority to do all acts for and in the name of the Association when the Association is not in session.

Section 10. It shall be the duty of the Mission Board to make plans for church extension and operate any state mission work and also work in the interest of the foreign mission program of the National Association. It shall be the duty of Mission Board to help make our people missionary minded.

Section 11. It shall be the duty of the Educational Board to make plans for operating the Florida Youth Camp and Christian Workers. This Board shall keep our National and State educational work before our people. It shall be their duty to create interest in Christian ed-

ucation.

Section 12. Board of Trustees shall be 5 in number, to be elected by the Association. Their duties shall be to take and hold all real property of the Association.

They shall further have full charge and responsibility for the maintenance of the Youth Camp.

Section 13. It shall be the duty of the Superannuation Board to make general plans for Superannuation for aged ministers, and to cooperate with the National Association in providing insurance protection for our younger ministers.

### BY-LAWS TO SECTION 13

Purpose—

The purpose of the program is to make possible for active Free Will Baptist ministers and full time Christian workers the following benefits: 1. Protection for loved ones in case of untimely death. (Face value of insurance policy with accumulated dividends).

2. A regular income in case of total and permanent disability.

3. Income from retirement age to death.

· .

4. The above benefits shall be provided through and by the provisions of the state and national superannuation program.

Plan\_

The National Board finances this program with funds sent from the State Superannuation Boards. The State Treasurer keeps 75 per cent of these funds for the operation of the state program, and will send 25 per cent of the National Treasurer.

#### AMOUNTS OF BENEFITS FROM STATE TREASURER

The amount of the monthly benefits shall be governed by the following rules:

1. The amount shall be \$10 per month to the disabled minister or Christian worker, and to be increased (not to exceed \$25) if the total amount in the state treasurer permits, but in no case shall this be done if it will prevent all payments to be made for the associational year to all those receiving benefits.

#### ELIGIBILITY-

The above benefits shall be paid monthly to the following:

1. To any Free Will Baptist minister or full-time Christian worker who is a member in good standing of a church in the Florida State Association who has a total or permanent disability or upon reaching the age of 70 years.

2. The titles given above Free Will Baptist minister or full-time Christian worker shall be as follows to Free Will Baptist ministers who have either pastored or done full-time evangelistic or teaching work for 10 years. Christian workers shall have done full-time Christian work as teachers or missionaries (home and foreign) or evangelistic work for 10 years for the Free Will Baptist Church. 3. Application must be made to and approved by the Florida State Superannuation Board, while in private session.

4. That the traveling expense of board members shall be paid for all board meetings by the Board.

### ARTICLE IV - AMENDMENTS

Section 1. Amendments to this Constitution must be put before the body while in session one day before voted on, and must be read at least twice and passed by two thirds of the delegates present. All amendments must be ratified by three of the associations now belonging to the body and by a majority of the associations belonging to same, should associations join us in the future.
