A partial report of the Credentials Committee was accepted. Brother Woodruff made the motion.

The Report of Committee on Committees was received after the name Franky Chatwood was substituted for James Cloud.

The Sunday School Board did not report.

Rev. D. W. Poole made a motion to adopt the League Board report from the Salem Association. Motion carried.

Rev. Harrold Harrison presented the literature program and pointed out some of the many improvements from the National Sunday School Board.

The Moderator then called for the Treasurer's report. Brother Amerson made a motion to adopt report. Carried.

A motion was made by Rev. Freeman Edwards to recess for 10 minutes was carried..

After the recess the congregation was led in some singing and Rev. Walter Eldridge preached the morning message. His Scripture was Luke 22:31-62.

The Woman's Auxiliary and churches of the Salem Association served lunch.

Thursday Afternoon, October 31

Brother Cook led the singing and Rev. Dan Gaskins led in the Devotion. The Scripture was Acts 1:8.

The Moderator called for the Pianning Board report. Rev. Burden made the motion which was carried to adopt the report.

Rev. Edwards moved to adopt the Missions Board report. Carried.

Rev. Henderson moved to adopt the Board of Education report. Carried.

Rev. Messex moved to adopt the report of the Youth Camp Board of Trustees. Carried.

Rev. Bill George gave a report from the Childrens Home, and made a motion to receive it and print in our minutes.

Rev. Henderson made a motion to adopt the Welcome Committee report. Carried.

Mrs. R. Q. Adison moved to adopt the Appreciation Committee report. Carried.

The Revisions Committee report was given, and a motion was made and carried to the table.

Delegates to the National Association were appointed: Mr. G. W. Cloud, Mr. W. J. Amerson, Mrs. Esther, Mrs. Messex, Mrs. Ed. Cook.

The State Woman's Auxiliary made a report to the body.

Rev. Burden made a motion that the Committee to see about getting the National Association be given the cost of a Booth plus \$25 for promotion at the National Association in 1964. Motion carried

# Thursday Evening, October 31

Rev. Elro Driggers brought the evening message. He read Acts 2:42-47. After the message the Holy Spirit manifested Himself in the wonderful testimonial and praise service. An offering was received.

The only items of business for the evening service were two: The Revisions Committee made a report, Brother Messex moved to receive Section 6 of Article 3, and Rev. Burden moved to table. Motion to table carried. The Board of Trustees of the Bible Institute gave a report. The motion made of Rev. Henderson to adopt was carried.

Rev. Henry Melvin led in the benediction prayer.

# Friday Morning, November 1

Brother Woodruff led the congregation in the opening hymn, "Standing On the Promises." Mrs. Eva Mae Owen led the morning prayer. Then the congregation sang, "I Love To Tell the Story."

Rev. Dale Burden brought the devotion from Luke 16:10-13.

The Moderator welcomed those who were just getting here for the session.

The Superannuation Board's report was adopted.

The Placement Committee's Report was adopted.

The Resolutions Committee was heard. Rev. I. O. Cook moved to receive report and adopt item by item, and both items were adopted.

Rev. John M. Rich made a motion that we buy 100 song books from the National Association for the Youth Camp Fund. Brother Ernest Owen made a motion that if the books were purchased that they be bought with offerings from local churches. Carried as amended. Brother G. W. Cloud agreed and pledged \$50.00, which he gave along with other donations. I. O. Cook \$5, Frank Willis \$5, J. W. Lamb \$5, Mrs. Sexton \$1, Mrs. Clark \$1, Mrs. Cook 25c, James Calladay \$1.50, Hipps Road Mission \$5, Mrs. Miller \$1, E. T. Taylor \$1, Woodrow Messex \$1, J. W. D. Stephens \$1, G. W. Hatcher \$1, Henry Melvin \$5. This list is not complete, but these are the only names the Clerk got. (see Finance Comm. report for total).

Rev. Messex made a motion to take from the table the Revisions Committee report. Rev. Burden moved to adopt item by item. Item 1 was adopted. Item 2 which stated that the Moderator, Asst. Moderator, Clerk, and Treasurer would receive \$25 each yearly, was amended by a motion from Brother Cook to pay Clerk and Treasurer \$50 each. A motion was then made to kill the motion to adopt this item. The motion to kill was carried. Other items of the report were adopted.

Our Moderator recognized Rev. Billy Melvin, Executive Secretary of

the National Association of Free Will Baptists. Brother Melvin pointed out that Cooperative giving in Florida was down. From January 1 through September 31. 1962 Florida gave \$4,903.18. For the same period in 1963 we had only given \$2,612.45.

The Moderator called for the Treasurer's report of the Bible Institute. Brother Ernest Owen's motion to accept the report was carried.

MSC. Credentials Committee final report.

The Moderator asked the Clerk to write to the Clerk of the North Florida Association to let them know that we missed their report and delegates.

A motion was made by Rev. Burden to take from the table and adopt the other portion of the Revisions Committee report. Motion carried. Report adopted.

Rev. Harvy Hill moved to pay clerk and treasurer \$25 each. Carried.

The Moderator called for nominations for a State Reporter for CON-TACT. Rev. Elro Driggers was elected. His address is 5163 Pennate Drive, Jacksonville 10, Fla.

The Moderator then recognized the chairman of the Nominating Committee for its report. The motion to receive by Rev. Hill was carried. The Moderator gave time to Rev. Henry Melvin, Chairman of the National League Board. Brother Melvin spoke to us about this work and from Heb. 9:26.

Brother Harrison yielded to the new Moderator, Rev. Driggers, to bring this session to a close.

Rev. Burden made a motion to adjourn and give a rising vote of appreciation to the outgoing officers. Motion was carried.

The new Moderator appointed the Committee to get a promotional man for our work in Florida. Committee: Wayne Hicks, Woodrow Messex, I. O. Cock. (Resolutions Committee report).

# CONSTITUTION

AND

**BY-LAWS** 

# OF THE

# FLORIDA STATE ASSOCIATION **OF FREE WILL BAPTISTS**

### PREAMBLE

We, the Free Will Baptists of Florida, for the sake of power that comes of unity and oneness of purpose; for the advancement of the cause of Christ; for the glory of God and the good of mankind do ordain and establish this Constitution and By-Laws.

# ARTICLE I - NAME OF ASSEMBLY

Section 1. This assembly shall be known as "THE FLORIDA STATE ASSOCIATION OF FREE WILL BAPTISTS."

# ARTICLE II - REPRESENTATION

Section 1. This Association shall be composed of delegates elected from the local associations belonging to this body and delegates elected from the local churches embraced by the various associations.

Section 2. All deacons and ministers who are members of, and in good standing with, a local church and local association, which are members of this body are standing delegates.

Section 3. The general officers of this body shall be standing delegates.

Section 4. The delegates shall be elected as follows: One (1) delegate from each local church composed of 100 members or fraction thereof and one (1) delegate from each additional 100 members or fraction thereof; five (5) delegates from each local association composed of 15 churches or fraction thereof and one (1) additional delegate for each additional four (4) churches or fraction thereof. The additional delegates can not be used unless the churches are active and are represented in the session in which they are appointed.

# ARTICLE III - OFFICERS, BOARDS AND COMMITTEES

Section 1. Officers: The officers of this association shall be a moderator, assistant moderator, secretary and a treasurer.

Section 2. Boards: The standing boards of this Association shall be Planning, Missions, Education, Superannuation, Youth Camp Trustees, and Trustees of Florida Free Will Baptist Bible Institute.

Section 3. The Executive Committee shall be composed of the moderator, assistant moderator, secretary, and treasurer. Other committees may be appointed as needed.

Section 4. When vacancies occur either by death or removal from office, or by resignation, the body shall fill vacancy either by proxy or by election of officer to the vacancy at any regular session of the body and the proxy may be appointed by the body to fill any absentee's place who does not attend the session.

Section 5. The regular election shall take place each year.

Section 6. Each standing board shall be composed of 5 members which shall be elected for 5 year terms on a rotating basis, so that one new member shall be elected yearly.

Section 7. This body shall have and does reserve the right to deal with any officer or board member who does not conduct his or her office in a Christian and business-like manner according to the rules of Christian conduct laid down in the teachings of the New Testament. Thus the right to discipline in this body is confined to this body, but a charge against a member of this body and the members of local churches shall constitute a charge against said member in this body and the body shall abide accordingly thereby.

# ARTICLE IV - MEETINGS

Section 1. Regular: This Association shall convene annually on Wednesday evening, Thursday, and Friday before the first Sunday in November.

Section 2. Special: The executive committee may be called into session by the Moderator, or by a majority of its members.

Section 3. Quorum: Fifty (50) percent of the delegates shall constitute a quorum.

# ARTICLE V — FINANCE

Section 1. All churches and associations represented in this body shall pay entrance fee annually. The amount of this fee shall be determined by the Body while in session and may be changed by a two-thirds vote in any session.

Section 2. Fees are \$10.00 for an association, with five (5) churches. Associations with more than five (5) churches, fees are \$20.00, and for churches \$4.00 per delegate. Fees are \$2.00 for deacons and ministers.

Section 3. All funds coming into this body shall be spent under a budget plan. This budget must be approved by the body while in session and no funds may be used in any way except as budgeted

# BY-LAWS

Section 1. It shall be the duty of the Moderator to preside over all the deliberations of this body while in session.

Section 2. The Moderator shall have the power to rule measures out of order providing this ruling is sustained by two-thirds of the delegates present.

Section 3. The Vice-Moderator shall assume the duties, rights and privileges of the Moderator in his absence.

Section 4. The Vice-Moderator shall be ex-officio member of all standing boards and committees.

Section 5. It shall be the duty of the Clerk to make and keep records of all the business proceedings and activities of this body.

Section 6. It shall be the duty of the treasurer to receive all funds, pay all bills, and keep records of receipts and disbursements and to surrender all records when leaving office.

Section 7. All officers and board members must be Free Will Baptists who are in good standing in their respective churches and associations, must belong to this body and must, when elected, live within bounds of this Association. The Treasurer must give bond.

Section 8. It shall be the duty of the Planning Board to provide general plans for this Association, make the budget and regulate fees.

Section 9. The Executive committee shall have full authority to do all acts for and in the name of the Association when the Association is not in session.

Section 10. It shall be the duty of the Mission Board to make plans for church extension and operate any state mission work and also work in the interest of the foreign mission program of the National Association. It shall be the duty of the Mission Board to help make our people missionary minded.

Section 11. It shall be the duty of the Superannuation Board to make general plans for Superannuation for aged ministers, and to cooperate with the National Association in providing insurance protection for our younger ministers.

Section 12. Amendments to this Constitution must be put before the body while in session one day before voted on ,and must be read at least twice and passed by two-thirds of the delegates present.
