

PROCEEDINGS

Wednesday Evening, October 28

After the hymn "Amazing Grace", and an old fashioned hand shaking, we were dismissed in prayer.

Thursday Morning, October 29

The service began with Brother Milton Gann leading the congregation in several songs. Brother John Edwards led in prayer. The devotion was brought by Brother Millard Sasser, on Redeeming the Time.

The Moderator recognized the standing delegates. A partial report of the Credential Committee was given. MSC.

Brother Milton Gann was recognized and given a hearty welcome to our state as a new minister.

National officers were recognized. Brother Billy Melvin, Executive Secretary of our National Association, Brother Kenneth Riggs of the Church Training Service, and Brother Harrold Harrison of the Sunday School Department.

A partial report of Committee on Committees was given. Carried. Report of Christian Education Board was given. Motion made to receive report and adopt item by item. Motion carried. After a general discussion all items were adopted except item 4. This item was tabled.

After enjoying a good lunch prepared by the Liberty and Salem Association, services began by singing and prayer.

Rev. John M. Rich brought the devotion, on "Sowing in Tears".

Brother Billy Melvin, Executive Secretary of our National Association gave his report. He gave information on our national magazine "Contact" and expressed thanks for the good response of subscribing to this good Christian magazine. He urged all of our churches to take advantage of getting this magazine into our homes. He also gave information on the much needed "National Headquarters Building" that is proposed to be erected in Nashville. This information was received gladly and an offering was taken for this worthy cause. The offering was \$50.65.

The Moderator was given authority to appoint a delegate to work with the Superannuation Board. Three of its members were absent. Brother Gary Whitlash was appointed.

Brother Bill George gave the report on the Children's Home. Move to receive report as information. Carried.

Delegates were chosen for the National Association to be held in Raleigh, North Carolina in July. Ernest Thomley, Okra Mullins, Edna Henderson, Mr. I.O. Cook, Lola Edwards, Mrs. Harvey Hill, Mrs. Elro Driggers. The Moderator was given authority to appoint delegates if chosen delegates were not present.

Brother Milton Gann gave a report from Our Bible College in Nashville. He expressed thanks for our college and its support by the churches. He urged our continual support with prayer, pupils and finance.

We were dismissed in prayer.

Thursday Evening, October 29

Services began by singing. Brother Cloud led in prayer. We enjoyed a very lively testimony service. Brother Kenneth brought a message in song, "The Ninty and Nine".

Brother Harrold Harrison brought the message from Philippians 2. His subject was "To The Glory of The Father". God blessed and challanged our hearts through the message.

The Christian Board of Education report was moved from the table. Motion to amend item 4 to read as "we recommend that necessary expenses involved by this

BOARD OF EDUCATION REPORT

We the Board of Christian Education submit the following:

We have met three (3) times during the year. We met November 1, the closing day of the State Association, at which time we elected officers and made plans for the next meeting. November 19 we met in Auburndale with four (4) of our members present, and on June 26, at the Youth Camp with two (2) members present and our State Moderator.

From our meeting on November 19, we recommend the following to our Associations and churches:

- 1. That each Association purchase a slide-filmstrip projector and make use of the free filmstrips offered by our National Sunday School Department.
- 2. That each association sponsor a Sunday School Teacher Training Workshop during this Associational year.
- 3. That each church or churches close enough to each other have a Church Training Service Workshop using the services of Brother Samuel Johnson, our National (League) Church Training Service Director.
- 4. That each church in Florida use the Sunday School, Church Training Service, or any other literature put out by our National Association, and patronize our Bookstore.

- 5. That every church subscribe to "Contact" on the Family Plan.
- 6. That we recommend and urge young people from out of State to attend Free Will Baptist Bible College in Nashville, Tennessee.
- 7. That our pastors encourage our young people to take advantage of the opportunity offered by the Free Will Baptist College to attend the Bible Conference each year.
- 8. That each church sponsor a Daily Vacation Bible School.

The above recommendations were mailed to each Associational Moderator and Clerk in the State. We asked that they read and take action on these at the next meeting of their Association.

In this letter, we offered our services in helping to arrange for the Sunday School and Church Training Service Workshops in their area. We also offered our help without cost except for expenses necessary such as travel, telephone calls, etc.

We also requested that each clerk send us a list of the churches, pastors, and clerks in his Association. We have received only one list.

There were three weeks of Workshops conducted by our National Sunday School Department. Two of these were sponsored by this Board. These were conducted in the Central and Liberty Association.

There were nine (9) nights of Church Training Service Workshops in three Associations. They were conducted in the Central, Liberty and Northeast Associations.

A Sunday School Convention Rally was held in the Central Association, at which a Board Member of the National Sunday School Department spoke.

In view of the work done last year and the work yet to be done and the expediency of the job before us, we make the following requests:

- 1. That you grant to us and your own work of Christian Education prayer and moral support.
- 2. That you grant to us the opportunity to serve you in a greater capacity through:
 - a. Invitations to meet with you in your District Associations on behalf of our Board..
 - b. Invitations to help you with Sunday School and Church Training Service organizations and problems; Vacation Bible School planning, and any other work that might come under this Board.
 - c. Give to us the names and addresses of every District Association Moderator and Clerk.
 - d. Give to us the name and address of every church, Pastor, and Clerk in the state.

- 3. That any Church Training Service or Sunday School Workshop conducted in our State can be channeled through this Board.
- 4. We recommend that necessary expenses involved by this Board be paid from the Youth Camp Fund, but not to exceed \$250.00



CONSTITUTION

AND

BY-LAWS

OF THE

FLORIDA STATE ASSOCIATION OF FREE WILL BAPTISTS

PREAMBLE

We, the Free Will Baptists of Florida, for the sake of power that comes of unity and oneness of purpose; for the advancement of the cause of Christ; for the glory of God and the good of mankind do ordain and establish this Constitution and By-Laws.

ARTICLE I - NAME OF ASSEMBLY

Section 1. This assembly shall be known as "THE FLORIDA STATE ASSOCIATION OF FREE WILL BAPTISTS."

ARTICLE II - REPRESENTATION

Section 1. This Association shall be composed of delegates elected

from the local associations belonging to this body and delegates elected from the local churches embraced by the various associations.

Section 2. All deacons and ministers who are members of, and in good standing with, a local church and local association, which are members of this body are standing delegates.

Section 3. The general officers of this body shall be standing delegates. Section 4. The delegates shall be elected as follows: One (1) delegate from each local church composed of 100 members or fraction thereof and one (1) delegate from each additional 100 members or fraction thereof; five (5) delegates from each local association composed of 15 churches or fraction thereof and one (1) additional delegate for each additional four (4) churches or fraction thereof. The additional delegates can not be used unless the churches are active and are represented in the session in which they are appointed.

ARTICLE III - OFFICERS, BOARDS AND COMMITTEES

Section 1. Officers: The officers of this association shall be a moderator, assistant moderator, secretary and a treasurer.

Section 2. Boards: The standing boards of this Association shall be Planning, Missions, Education, Superannuation, Youth Camp Trustees, and Trustees of Florida Free Will Baptist Bible Institute.

Section 3. The Executive Committee shall be composed of the moderator, assistant moderator, secretary, and treasurer. Other committees may be appointed as needed.

Section 4. When vacancies occur either by death or removal from office, or by resignation, the body shall fill vacancy either by proxy or by election of officer to the vacancy at any regular session of the body and the proxy may be appointed by the body to fill any absentee's place who does not attend the session.

Section 5. The regular election shall take place each year.

Section 6. Each standing board shall be composed of 5 members which shall be elected for 5 year terms on a rotating basis, so that one new member shall be elected yearly.

Section 7. This body shall have and does reserve the right to deal with any officer or board member who does not conduct his or her office in a Christian and business-like manner according to the rules of Christian conduct laid down in the teachings of the New Testament. Thus the right to discipline in this body is confined to this body, but a charge against a member of this body and the members of local churches shall constitute a charge against said member in this body and the body shall abide accordingly thereby.

ARTICLE IV - MEETINGS

Section 1. Regular: This Association shall convene annually on Wednesday evening, Thursday, and Friday before the first Sunday in November.

Section 2. Special: The executive committee may be called into session by the Moderator, or by a majority of its members.

Section 3. Quorum: Fifty (50) percent of the delegates shall constitute a quorum.

ARTICLE V - FINANCE

Section 1. All churches and associations represented in this body shall pay entrance fee annually. The amount of this fee shall be determined by the Body while in session and may be changed by a two-thirds vote in any session.

Section 2. Fees are \$10.00 for an association, with five (5) churches. Associations with more than five (5) churches, fees are \$20.00, and for churches \$4.00 per delegate. Fees are \$2.00 for deacons and ministers.

Section 3. All funds coming into this body shall be spent under a budget plan. This budget must be approved by the body while in session and no funds may be used in any way except as budgeted

BY-LAWS

Section 1. It shall be the duty of the Moderator to preside over all the deliberations of this body while in session.

Section 2. The Moderator shall have the power to rule measures out of order providing this ruling is sustained by two-thirds of the delegates present.

Section 3. The Vice-Moderator shall assume the duties, rights and privileges of the Moderator in his absence.

Section 4. The Vice-Moderator shall be ex-officio member of all standing boards and committees.

Section 5. It shall be the duty of the Clerk to make and keep records of all the business proceedings and activities of this body.

Section 6. It shall be the duty of the treasurer to receive all funds, pay all bills, and keep records of receipts and disbursements and to surrender all records when leaving office.

Section 7. All officers and board members must be Free Will Baptists who are in good standing in their respective churches and associations, must belong to this body and must, when elected, live within bounds of this Association. The Treasurer must give bond.

Section 8. It shall be the duty of the Planning Board to provide general plans for this Association, make the budget and regulate fees.

Section 9. The Executive committee shall have full authority to do all acts for and in the name of the Association when the Association is not in session.

Section 10. It shall be the duty of the Mission Board to make plans for church extension and operate any state mission work and also work in the interest of the foreign mission program of the National Association. It shall be the duty of the Mission Board to help make our people missionary minded.

Section 11. It shall be the duty of the Superannuation Board to make general plans for Superannuation for aged ministers, and to cooperate with the National Association in providing insurance protection for our younger ministers.

Section 12. Amendments to this Constitution must be put before the body while in session one day before voted on ,and must be read at least twice and passed by two-thirds of the delegates present.
