#### **BOARD OF EDUCATION REPORT**

The Board of Christian Education submit the following report.

This Board met twice during the past year on Dec. 8, 1964 and on Feb. 16, 1965.

We are offering the following recommendations:

- 1. We recommend and urge each Association to sponsor a Sunday School Teachers Workshop during this Associational year using the services of personnel from our National Sunday School Department. It was also recommended that the church nearest the center of the Association act as the host church.
- 2. We recommend and urge each church or churches that are close to each other and who desire to come together for this endeavor to have a church Training Service Workshop using the services of personnel from our National C. T. S. Department.
- 3. We recommend and urge each church in Florida to use Sunday School, C. T. S., or any other literature put out by our National Association and to patronize our bookstore.
- 4. We recommend and urge every church to subscribe to "Contact" on the Family Plan.
- 5. We recommend and urge young people from our state to attend Free Will Baptist Bible College.
- 6. We recommend and urge our pastors to encourage our young people to take advantage of the opportunity offered by the Free Will Baptist Bible College to attend the Bible Conference in April of each year, and the Missionary Conference in October.
- 7. We recommend and urge each church to sponsor a Daily Vacation Bible School.
- 8. We recommend each moderator of the various associations of our state grant time on the program of an associational meeting to promote the work of the Board of Christian Education. It is to be understood that the association would pay the travel expenses of the Board member at the rate of six cents  $(6\phi)$  per mile.
- 9. We recommend a grant of \$250.00 to be used by this Board for promotion and travel in the work of Christian Education. We recommend that necessary expenses involved by the Christian Board of Education be paid from the Youth Camp Fund, but not to exceed \$250.00.

## CONSTITUTION

AND

## BY-LAWS

OF THE

#### FLORIDA STATE ASSOCIATION

#### OF FREE WILL BAPTISTS

#### **PREAMBLE**

We, the Free Will Baptists of Florida, for the sake of power that comes of unity and oneness of purpose; for the advancement of the cause of Christ; for the glory of God and the good of mankind do ordain and establish this Constitution and By-Laws.

#### ARTICLE I — NAME OF ASSEMBLY

Section 1. This assembly shall be known as "THE FLORIDA STATE ASSOCIATION OF FREE WILL BAPTISTS."

#### ARTICLE II — REPRESENTATION

Section 1. This Association shall be composed of delegates elected from the local associations belonging to this body and delegates elected from the local churches embraced by the various associations.

Section 2. All deacons and ministers who are members of, and in good standing with, a local church and local association, which are members of this body are standing delegates.

Section 3. The general officers of this body shall be standing delegates.

Section 4. The delegates shall be elected as follows: One (1) delegate from each local church composed of 100 members or fraction thereof and one (1) delegate from each additional 100 members or fraction thereof; five (5) delegates from each local association composed of 15 churches or fraction thereof and one (1) additional delegate for each additional four (4) churches or fraction thereof. The additional delegates can not be used unless the churches are active and are represented in the session in which they are appointed.

#### ARTICLE III — OFFICERS, BOARDS AND COMMITTEES

Section 1. Officers: The officers of this association shall be a moderator, assistant moderator, secretary and a treasurer.

Section 2. Boards: The standing boards of this Association shall be Planning, Missions, Education, Superannuation, Youth Camp Trustees, and Trustees of Florida Free Will Baptist Bible Institute.

Section 3. The Executive Committee shall be composed of the moderator, assistant moderator, secretary, and treasurer. Other committees may be appointed as needed.

Section 4. When vacancies occur either by death or removal from office, or by resignation, the body shall fill vacancy either by proxy or by election of officer to the vacancy at any regular session of the body and the proxy may be appointed by the body to fill any absentee's place who does not attend the session.

Section 5. The regular election shall take place each year.

Section 6. Each standing board shall be composed of 5 members which shall be elected for 5 year terms on a rotating basis, so, that one new member shall be elected yearly.

Section 7. This body shall have and does reserve the right to deal with any officer or board member who does not conduct his or her office in a Christian and business-like manner according to the rules of Christian conduct laid down in the teachings of the New Testament. Thus the right to discipline in this body is confined to this body, but a charge against a member of this body and the members of local churches shall constitute a charge against said member in this body and the body shall abide accordingly thereby.

#### ARTICLE IV — MEETINGS

Section 1. Regular: This Association shall convene annually on Wednesday evening, Thursday, and Friday before the first Sunday in November.

Section 2. Special: The executive committee may be called into session by the Moderator, or by a majority of its members.

Section 3. Quorum: Fifty (50) percent of the delegates shall constitute a quorum.

#### ARTICLE V — FINANCE

Section 1. All churches and associations represented in this body shall pay entrance fee annually. The amount of this fee shall be determined by the Body while in session and may be changed by a two-thirds vote in any session.

Section 2. Fees are \$10.00 for an association, with five (5) churches. Associations with more than five (5) churches, fees are \$20.00, and for churches \$4.00 per delegate. Fees are \$2.00 for deacons and ministers.

Section 3. All funds coming into this body shall be spent under a budget plan. This budget must be approved by the body while in session and no funds may be used in any way except as budgeted.

#### **BY-LAWS**

Section 1. It shall be the duty of the Moderator to preside over all the deliberations of this body while in session.

Section 2. The Moderator shall have the power to rule measures out of order providing this ruling is sustained by two-thirds of the delegates present.

Section 3. The Vice-Moderator shall assume the duties, rights and privileges of the Moderator in his absence.

Section 4. The Vice-Moderator shall be ex-officio member of all standing boards and committees.

Section 5. It shall be the duty of the Clerk to make and keep records of all the business proceedings and activities of this body.

Section 6. It shall be the duty of the treasurer to receive all funds, pay all bills, and keep records when leaving office.

Section 7. All officers and board members must be Free Will Baptists who are in good standing in their respective churches and associations, must belong to this body and must, when elected, live within bounds of this Association. The Treasurer must give bond.

Section 8. It shall be the duty of the Planning Board to provide general plans for this Association, make the budget and regulate fees.

Section 9. The Executive committee shall have full authority to do all acts for and in the name of the Association when the Association is not in session.

Section 10. It shall be the duty of the Mission Board to make plans for church extension and operate any state mission work and also work in the interest of the foreign mission program of the National Association. It shall be the duty of the Mission Board to help make our people missionary minded.

Section 11. It shall be the duty of the Superannuation Board to make general plans for Superannuation for aged ministers, and to cooperate with the National Association in providing insurance protection for our younger ministers.

Section 12. Amendments to this Constitution must be put before the body while in session one day before voted on, and must be read at least twice and passed by two-thirds of the delegates present.
