Thursday Morning Worship Service

Rev. Harvey Henderson led the congregation in "I Am Thine O Lord". Rev. Roger Reeds led in prayer. The congregation then sang "At the Cross". An offering was received for the State Moderator, Rev. Driggers, who was unable to attend. The amount was \$67.00.

The Thursday afternoon meeting was adjourned and dismissed with prayer.

MSC that all of the above elected men remain on the committee even though some are on the Executive Board.

MSC that we stand in silent memory of the late missionary Tom Wiley, Sr. and Rev. Walter Eldridge.

MSC to accept the report of the Appreciation Committee.

MSC to thank the officers of this session for their work.

MSC that all standing committees meet at the same time the Executive Committee meets previous to the first setting of the 1969 Association. The Executive Committee meets early on the same day the Association begins.

The Moderator delcared the 1968, 24th Annual Session of the Florida State Association adjourned. The congregation sang "Amazing Grace" and was dismissed with prayer.

FLORIDA STATE HOME MISSION BOARD ANNUAL REPORT 1967-1968

Go Ye. Look upon the fields. Come over and help us. Let us send forth laborers. Florida is a mission field. May we accept the challenge. Forgetting the past and looking unto the future we submit our report as a matter of record and approval, pressing toward the mark in Christ Jesus.

The board has met 3 times during the year. The cooperation of all members has been outstanding. Not a single note of discord has been sounded. In a prayerful environment we have met and coordinated the work at hand and planned future undertakings which we believe the Holy Spirit will lead us to see accomplished. A constitution and bylaws has been formulated and will be presented for your consideration. An application form to be used when applying for a loan from the board has been prepared and put into use. We ask the association to join us in expressing our appreciation to our secretary-treasurer, Rev. A. C. Truluck, for the contribution he has made to our board during the past year. We regret his departure from our state and wish him the best in our Lord's service.

Report of Board Meetings:

Nov. 17, 1967. The board met in Chipley, Fla. with all the members present except Robert Owen. In the absence of the chairman A. C. Truluck acted as the chairman. Members of the executive board meeting with us at this time were: Elro Driggers, Ernest Owens and Wingate Hansley. Mrs. Ernest Owens was present in the meeting. The meeting was opened with prayer. Discussion was held in reference to the transfer of funds in project 30 account and the church extension fund account. The following amounts were balanced in the state treasurers books as of the state associational meeting.

Due to the deficient account of the promotional department the total amount in the book balance was not available for transfer at the present time. The board voted to carry as a loan \$3949.86 to the promotional department without interest and payment from the state treasurer to be made quarterly as the money becomes available through the cooperative allocation.

The Titusville church had made application for a loan of \$4,000.00 and had been approved by the executive board prior to the mission board being delegated responsibility for the church extension work by the state association. The board voted to approve the action of the executive board and advised the secretary to notify the Titusville church of the approval. A subcommittee was elected to meet and prepare a constitution and by-laws for the operation of the home mission board. This committee was to prepare this constitution and by-laws and mail copies to each board member and after adequate time for study the chairman is to call another meeting for final action on this document and preparation for submission to the state association for final approval. Members appointed to the committee were: A. C. Truluck and W. T. Jones. Members appointed to represent the executive board were: W. C. Combs and W. A. Hansley.

Feb. 23, 1968. The board met at the Ocala Free Will Baptist Church. All members of the board were present. Others who met with us as visitors were: Wingate Hansley and Ernest Owens. Brother Cathey led in prayer after the chairman read a brief scripture selection.

An appeal from the Davie church was presented in which they were asking assistance in securing a pastor for the church. The board voted to try to secure a pastor for the Davie church through an article in the coordinator and other means of communication and personal contact by the board members. A letter is to be written to Rev. Troy Smith, pastor of the Davie church, informing him of the action of the board. At present no financial assistance can be given this church in support of a pastor. Confirmation of the call by the Winter Haven church of Rev. Harvey Henderson as pastor was made. Motion carried to continue support of Project 30 as follows: 50% for the next six months beginning March 1 and 25% for the remaining six months. Note: This action was taken upon request of the Winter Haven church and is in accord with the original contract agreed upon.

A motion was approved for the secretary to prepare a proposed application form to be used by loan applicants. The proposed form is subject to approval of the chairman of the board. A motion was approved to give the Hollywood Church first consideration for a loan upon availability of funds. A motion was approved that the balance be help in treasury to complete project 30 at Winter Haven.


The proposed constitution and by-laws was considered item by item. The constitution and by-laws was approved with changes to article one and four. Article one changed to include Florida in the name of the board, and article four changed the term of officers from 2 years as proposed to 1 year. The adopted constitution and by-laws will be presented to the next state associational meeting for final approval.

Oct. 1, 1968. The board met at the Ocala Free Will Baptist Church. All members of the board were present except Bill Cathey who had requested to be excused from this meeting. Visitors present were: Elro Driggers, Wingate Hansley, Millard Sasser, and Bro. Lancaster. Bro. Driggers read the 34th Psalm and Bro. Hansley led in prayer.

Minutes of previous meeting and financial report was given. A motion was approved that the treasurer obtain a computation sheet to be furnished each church which has a loan to show the principal and interest of their account thru their loan period. Note: The financial report shows this amount as, \$3939.86 due to a designated gift of \$10.00 from the Malone church being applied to this account.

A motion was approved to authorize the secretary to mimeograph the annual report and loan application form. The application form was changed to include a remarks block and signature block for the chairman and secretary of the mission board. A motion was approved to pay travel expense of Elro Driggers to this meeting inasmuch as he was invited to attend for special reasons. Dismissed in prayer to meet jointly with the executive board October 30 at the Winter Haven church.

CONSTITUTION AND BY-LAWS OF THE FLORIDA STATE HOME MISSION BOARD OF FREE WILL BAPTISTS

CONSTITUTION

Article 1. NAME:

This board shall be known as the Florida State Home Mission Board of Free Will Baptists.

Article 2. PURPOSE:

The purpose of this board shall be that of promoting mission work among Free Will Baptists in the State of Florida.

Article 3. MEMBERSHIP:

This board shall be composed of members elected by the State association and shall serve terms established on a rotational basis: one members term shall expire annually. The number of members of this board shall be determined by the constitution and by-laws of the state association.

Article 4. OFFICERS:

Officers of the Board shall be: A Chairman, a Vice Chairman and a Secretary-Treasurer. These officers shall hold office for one (1) year and may be elected to serve succeeding terms. Members of the board shall elect the officers of the board.

Article 5. MEETINGS:

Meetings shall be held as the need arises. Necessary meetings may be called by the chairman or the secretary-treasurer. Mileage for board members expenses shall be paid from the general fund limited to 10¢ per mile one way.

Article 6. COMMITTEES:

Committees may be appointed by the chairman or elected by the the board as the need arises.

Article 7. REPORTS:

A complete report of the board meetings and activities and a complete financial report must be presented to the annual state associational meeting.

Article 8. FINANCES:

This board shall receive its finances from churches and individuals making special contributions, cooperative program allocations, interest on loans, and special offerings received through promoting missions.

Article 9 MISCELLANEOUS:

Section 1. Missions and churches receiving financial support from this board must be Free Will Baptists which prove themselves sound in doctrine and practices as Free Will Baptists.

Section 2. Missions and churches receiving financial support from this board shall consider this board as an advisory body in such matters as the selection of a pastor and further financial obligations.

Section 3. Any work receiving financial support must agree to support the denominational cooperative program.

Section 4. Any work receiving financial support must accept such as a loan on terms and conditions agreed upon by them and the board as set forth in this constitution and such information shall be made available to them and fully understood by those receiving the support.

Section 5. Proper security must be granted the board for loans received. First mortgage is desired but 2nd mortgage may be accepted; however no loan shall be granted in excess of the appraised value of the property. Interest shall be paid at the rate of 6% per annum. Monthly payments shall be paid at the rate of \$10.00 per \$1000.00 loaned.

Section 6. Missions or churches receiving financial support must be in good standing with an association or quarterly meeting affiliated with the state or national association and must have a pastor who is in good standing with the Free Will Baptists denomination.

Section 7. An agreement must be understood between the borrower and the board that in the event financial obligations cannot be met and rights to the property must be relinquished that said rights shall be turned over to the mission board and the decision of the board in regards to the property shall be final.

Section 8. Contracts shall be considered delinquent when 3 successive payments have not been met. It shall be determined by the board if contracts may be held valid and open for a longer period of time.

Section 9. The board shall have the right by majority vote to purchase property in desirable locations when there is good potential for organizing a Free Will Baptist Church. This action shall of necessity be subject to the availability of funds. In such matters full title must be acquired and no investment shall exceed the appraised value of property. Organizational work under such conditions shall be under complete supervision of the mission board.

Section 10. Nominal grants by the board to worthwhile churches or missions may be made when it is in the interest of the denominational cause in which benefits are certain. Grants of this nature shall be subject to money being immediately available and shall not exceed \$1000.00 without joint approval of the mission board and the state executive committee or association.

BY-LAWS

Article 1. DUTIES OF OFFICERS:

Officers of the board shall hold office according to the terms set forth in the constitution and shall carry out those duties peculiar to their respective offices. The secretary-treasurer shall maintain a permanent record of the boards activities and financial transactions. All records and property mortgages and titles shall be surrendered to the succeeding secretary-treasurer.

Article 2. VOTING AND QUORUM:


A majority membership shall constitute a quorum and be duly authorized to transact business. All items of business must receive a majority vote of board members before it is considered final. All members not present in meetings shall be notified of decisions made by the board.

Article 3. DUTIES OF MEMBERS:

All members shall endeavor to support mission work through cooperative efforts of the board. Any member that fails to cooperate with the board for a period of one year may, upon recommendation of the board, be replaced by the state association.

Article 4. AMENDMENTS:

This constitution and by-laws may be amended by a majority vote of the board members and final approvalof the state association.

We your Superannuation Board wish to submit for your information the following recommendations. That Rev. Jesse Allen Pettis be placed on our superannuation roll as one to receive benefits.

We also recommend that Rev. G. V. Eads be placed on our superannuation roll if the needed information be supplied to our state clerk for the records.



CONSTITUTION

AND

BY-LAWS

OF THE

FLORIDA STATE ASSOCIATION

OF FREE WILL BAPTISTS

PREAMBLE

We, the Free Will Baptists of Florida, for the sake of power that comes of unity and oneness of purpose; for the advancement of the cause of Christ; for the glory of God and the good of mankind do ordain and establish this Constitution and By-Laws.

ARTICLE I --- NAME OF ASSEMBLY

Section 1. This assembly shall be known as "THE FLORIDA STATE ASSOCIATION OF FREE WILL BAPTISTS."

ARTICLE II — REPRESENTATION

Section 1. This Association shall be composed of delegates elected from the local associations belonging to this body and delegates elected from the local churches embraced by the various associations.

Section 2. All deacons and ministers who are members of, and in good standing with, a local church and local association, which are members of this body are standing delegates.

Section 3. The general officers of this body shall be standing delegates.

Section 4. The delegates shall be elected as follows: One (1) delegate from each local church composed of 100 members or fraction thereof and one (1) delegate from each additional 100 members or fraction thereof; five (5) delegates from each local association composed of 15 churches or fraction thereof and one (1) additional delegate for each additional four (4) churches or fraction thereof. The additional delegates can not be used unless the churches are active and are represented in the session in which they are appointed.

ARTICLE III — OFFICERS, BOARDS AND COMMITTEES

Section 1. Officers: The officers of this association shall be a Moderator, Assistant Moderator, Secretary, Treasurer, and Promotional Secretary.

Section 2. Boards: The standing boards of this association shall be Planning, Missions, Education, Superannuation, and Youth Board.

Section 3. The Executive Committee shall be composed of the Moderator, Assistant Moderator, Secretary, Treasurer, Promotional Secretary, and one elected member from each affiliated association. A majority members shall constitute a quorum. Other committees shall be appointed as needed.

Section 4. When vacancies occur either by death or removal from office, or by resignation, the body shall fill vacancy either by proxy or by election of officer to the vacancy at any regular session of the body and the proxy may be appointed by the body to fill any absentee's place who does not attend the session.

Section 5. The regular election shall take place each year.

Section 6. Each standing board shall be composed of 5 members which shall be elected for 5 year terms on a rotating basis, so, that one new member shall be elected yearly.

Section 7. This body shall have and does reserve the right to deal with any officer or board member who does not conduct his or her office in a Christian and business-like manner according to the rules of Christian conduct laid down in the teachings of the New Testament. Thus the right to discipline in this body is confined to this body, but a charge against a member of this body and the members of local churches shall constitute a charge against said member in this body and the body shall abide accordingly thereby.

ARTICLE IV — MEETINGS

Section 1. Regular: This Association shall convene annually on Wednesday evening, Thursday, and Friday before the first Sunday in November.

Section 2. Special: The executive committee may be called into session by the Moderator, or by a majority of its members.

Section 3. Quorum: Fifty (50) percent of the delegates shall constitute a quorum.

ARTICLE V — FINANCE

Section 1. All churches and associations represented in this body shall pay entrance fee annually. The amount of this fee shall be determined by the Body while in session and may be changed by a two-thirds vote in any session.

Section 2. Fees for an association are based on \$2.00 per member church. Fees for churches are \$4.00 per delegate. Fees for ministers and deacons are \$2.00 each.

Section 3. All funds coming into this body shall be spent under a budget plan. This budget must be approved by the body while in session and no funds may be used in any way except as budgeted.

BY-LAWS

- Section 1. It shall be the duty of the Moderator to preside over all the deliberations of this body while in session.
- Section 2. The Moderator shall have the power to rule measures out of order providing this ruling is sustained by two-thirds of the delegates present.
- Section 3. The Vice-Moderator shall assume the duties, rights and privileges of the Moderator in his absence.
- Section 4. The Vice-Moderator shall be ex-officio member of all standing boards and committees.
- Section 5. It shall be the duty of the Clerk to make and keep records of all the business proceedings and activities of this body.
- Section 6. It shall be the duty of the treasurer to receive all funds, pay all bills, and submit records when leaving office.
- Section 7. All officers and board members must be Free Will Baptists who are in good standing in their respective churches and associations, must belong to this body and must, when elected, live within bounds of this Association. The Treasurer must give bond.
- Section 8. It shall be the duty of the Planning Board to provide general plans for this Association, make the budget and regulate fees.
- Section 9. The Executive committee shall have full authority to do all acts for and in the name of the Association when the Association is not in session.
- Section 10. It shall be the duty of the Mission Board to make plans for church extension and operate any state mission work and also work in the interest of the foreign mission program of the National Association. It shall be the duty of the Mission Board to help make our people missionary minded.
- Section 11. It shall be the duty of the Superannuation Board to make general plans for Superannuation for aged ministers, and to cooperate with the National Association in providing insurance protection for our younger ministers.
- Section 12. Amendments to this Constitution must be put before the body while in session one day before voted on, and must be read at least twice and passed by two-thirds of the delegates present.
