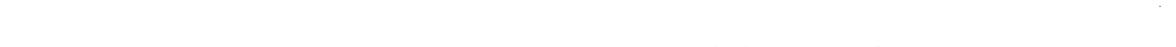
We, your Resolutions Committee, submit the following resolutions:

The board has met two times since the last annual report. Our state mission work is progressing well. We regret that we are not able to meet the requests which we have received from several of our newer churches and mission projects. The work at Orange Park is doing fine under the able leadership of Bro. Neal Thomsen, who was employed as our state missionary January 22, 1969.

BOARD MEETING REPORTS

October 30, 1968 (Minutes)

The Mission Board met jointly with the Executive Board at the Win-

ter Haven Church, October 30, 1968. Bro. W. C. Combs read from the Scriptures, and Bro. W. E. Cathey led in prayer.

The board has been relieved of any obligation to the Hollywood Free Will Baptist Church concerning a previous loan request (attn. prev. minutes). They have decided to borrow through other channels.

The prospect of assisting churches by means of purchasing their bonds with Mission's funds was discussed, and decided against because it would be a violation of the Board's Constitution and By-Laws.

A motion was made and seconded that we recommend to the State another mission project, similar to the Project 30, to be operated from state funds without assistance from the National Association. This undertaking is to be called the Florida State Home Mission Project.

The Grace Free Will Baptist Church of Orange Park has requested, and is under consideration for mission aid at this time. The Board requested that Bro. Hansley contact Grace Church and negotiate a contract with them to be initiated at which time a missionary is available.

Robert Owen was elected as Chairman, and W. E. Cathey was elected as Secretary-Treasurer. Mission Board members present were: Robert Owen, W. T. Jones, W. E. Cathey, and A. C. Truluck.

The Mission Board met at the Grace Free Will Baptist Church near Orange Park Jan. 22, 1969. Bro. Wingate Hansley gave the devotional thoughts from Ps. 15, and Bro. Bill George led in prayer.

REPORT OF THE PROMOTIONAL SECRETARY TO THE TWENTY-FIFTH ANNUAL SESSION OF THE FLORIDA STATE ASSOCIATION OF FREE WILL BAPTISTS CONVENING WITH THE ST. JOHN'S CHURCH, PERRY, FLORIDA

"Unto Him (God) be glory in the church by Christ Jesus throughout all ages, world without end. Amen." Ephesians 3:21.

With joy and thanksgiving to God, we bring this report to you. Our work in Florida has seen another year of progress, causing us to have the greatest year that we have ever experienced.

We continue to see more pastors and churches taking an active interest in our State and National work.

The greatest challenge, that Free Will Baptists in the State of Florida, have ever seen is presently before us. There is a tremendous need for us to "Enlarge the place of thy (our) tent, and let them stretch forth the curtains of thine (our) habitation; spare not, lengthen thy (our) cords, and strengthen thy (our) stakes;" Isaiah 54:2.

How will we meet the challenge that is before us? "In a day of protest, violence, increased crime and lawlessness, what can Free Will Baptists do to become more spiritually influential? Will we drift with the current or sit on the side lines and wring our hands in despair? Or will we seek to counteract the crisis of our time with a vigorous witness for Christ? Another area of progress is the plan of distribution of our State Paper, "THE CO-ORDINATOR". The committee that was appointed to set up guide-lines for the Promotional Secretary, with the approval of the Executive Committee, decided to send the paper on an all family plan, to each church in the state without charge. This has increased the distribution from less than 500 copies to almost 1500 copies per month.

REPORT OF THE EXECUTIVE BOARD

MEETING HELD AT EDGEWOOD PARK FREE WILL BAPTIST CHURCH LEESBURG, FLORIDA - APRIL 25, 1969

The meeting was called to order by the moderator, Rev. Harvey Henderson. We had an opening song: "Standing on the Promises". Rev. W. C. Combs led in the opening prayer.

The rollwas called by the clerk. The following board members were present: Rev. Harvey Henderson, Rev. H. Reedy Saverance, Rev. Millard C. Sasser, Rev. W. A. Hansley, Rev. W. T. Turnbough, Bro. Ernest Owen, and Rev. Wayne Hicks. We had several visitors at the board meeting. They were: Rev. Chastin from Leesburg, Rev. W. C. Combs, Rev. Robert Crawford, and Rev. Glen Hood.

The first item of business discussed was the church at Leesburg. Rev. W. A. Hansley made a statement concerning the church and the church's property. The amount owed on the property at the time was \$5,593.74. The monthly payments are \$60.00 per month.

Rev. Hansley asked that the Executive Board become the trustees of the property. The present trustees were not members of the church and there were no male members to Secome trustees.

M.S. that the Executive Board accept the property as trustees of the property and that Rev. Hansley work with the church a couple of days per week for about four months while we try to help find a pastor for the church. The motion was made by Rev. Millard C. Sasser, seconded by Rev. H. Reedy Saverance. With much discussion on the motion by the members of the Executive Board members and the visiting brethren.

M.S.C. to amend the second part of the previous motion to read two months rather than four months. The motion as amended was carried.

M.S.C. that the State Clerk (Millard C. Sasser) and the Promotional Secretary (W. A. Hansley) act as the trustees of the property.

M.S.C. that the Executive Board ask the Promotional Secretary to ask the churches to receive an offering twice a year for the support of the CO-ORDINATOR. The motion was made by Rev. Wayne Hicks. All present participated in a lengthy discussion before the motion was carried. This is an amendment to the guidelines for the Promotional Secretary: Article No. 3 under Section No. 1 entitled "Duties".

M.S.C. to amend Article No. 1 under Section No. 11 by adding the word "be" after the word "and" and before the word "responsible" and by adding the following sentence at the end of the Article: "The Executive Board's decision must be approved by the State Association.

M.S.C. to accept the proposed guidelines as amended. We then recessed for lunch.

M.S.C. to resume conference.

M.S.C. for the moderator to appoint a committee to prepare a constitution and by-laws for the Board of Christian Education. The committee members appointed were: Rev. W. A. Hansley, Bro. Ernest Owen, Rev. Robert Crawford, Rev. W. C. Combs, and Rev. Harvey Henderson.

M.S.C. to use Rom. 13:11-14 as our theme text, and the theme: "Redeeming the Time" for the 1969 session of the State Association.

The various speakers for the Association were named after a lenghty discussion. They were selected by general consent rather than by formal motion.

The clerk was instructed to contact the proposed speakers and prepare the programs for the association.

M.S.C. to adjourn. We closed the meeting with an altar prayer after having several prayer requests.

CONSTITUTION

AND

BY-LAWS

OF THE FLORIDA STATE ASSOCIATION OF FREE WILL BAPTISTS

PREAMBLE

We, the Free Will Baptists of Florida, for the sake of power that comes of unity and oneness of purpose; for the advancement of the cause of Christ; for the glory of God and the good of mankind do ordain and establish this Constitution and By-Laws.

ARTICLE 1 - NAME OF ASSEMBLY

Section 1. This assembly shall be known as "THE FLORIDA STATE ASSOCIATION OF FREE WILL BAPTISTS".

ARTICLE II - REPRESENTATION

Section 1. This Association shall be composed of delegates elected from the local associations belonging to this body and delegates elected from the local churches embraced by the various associations.

Section 2. All deacons and ministers who are members of, and in good standing with, a local church and local association, which are members of this body are standing delegates.

Section 3. The general officers of this body shall be standing delegates.

Section 4. The delegates shall be elected as follows: One (1) delegate from each local church composed of 100 members or fraction thereof, and one (1) delegate from each additional 100 members or fraction thereof; five (5) delegates from each local association composed of 15 churches or fraction thereof, and one (1) additional delegate for each additional four (4) churches or fraction thereof. The additional delegates cannot be used unless the churches are active and are represented in the session in which they are appointed.

ARTICLE III - OFFICERS, BOARDS AND COMMITTEES

Section 1. Officers: The officers of this association shall be a Moderator, Assistant Moderator, Secretary, Assistant Secretary, Treasurer, and Promotional Secretary.

Section 2. Boards: The standing boards of this association shall be Planning, Missions, Education, Superannuation, and Christian-Youth Board.

Section 3. The Executive Committee shall be composed of the Moderator, Assistant Moderator, Secretary, Treasurer, Promotional



Secretary, and one elected member from each affiliated association. A majority members shall constitute a quorum. Other committees shall be appointed as needed.

Section 4. When vacancies occur either by death or removal from office, or by resignation, the body shall fill vacancy either by proxy or by election of officer to the vacancy at any regular session of the body and the proxy may be appointed by the body to fill any absentee's place who does not attend the session.

Section 5. The regular election shall take place each year.

Section 6. Each standing board shall be composed of 5 members which shall be elected for 5 year terms on a rotating basis, so that one new member shall be elected yearly.

Section 7. This body shall have and does reserve the right to deal with any officer or board member who does not conduct his or her office in a Christian and business-like manner according to the rules of Christian conduct laid down in the teachings of the New Testament. Thus the right to discipline in this body is confined to this body, but a charge against a member of this body and the members of local churches shall constitute a charge against said member in this body and the body shall abide accordingly thereby.

ARTICLE IV - MEETINGS

Section I. Regular: This Association shall convene annually on Wednesday evening, Thursday, and Friday before the first Sunday in November.

Section 2. Special: The Executive Committee may be called

into session by the Moderator, or by a majority of its members.

Section 3. Quorum: Fifty (50) percent of the delegates shall constitute a quorum.

ARTICLE V - FINANCE

Section 1. All churches and associations represented in this body shall pay entrance fee annually. The amount of this fee shall be determined by the body while in session and may be changed by a two-thirds vote in any session.

Section 2. Fees for an association are based on \$2.00 per member church. Fees for churches are \$4.00 per delegate. Fees for ministers and deacons are \$2.00 each.

Section 3. All funds coming into this body shall be spent under a budget plan. This budget must be approved by the body while in session and no funds may be used in any way except as budgeted.

BY-LAWS

Section 1. It shall be the duty of the Moderator to preside over all deliberations of this body while in session.

Section 2. The Moderator shall have the power to rule measures out of order providing this ruling is sustained by two-thirds of the delegates present.

Section 3. The Vice-Moderator shall assume the duties, rights and privileges of the Moderator in his absence.

Section 4. The Vice-Moderator shall be ex-officio member of all standing boards and committees.

Section 5. It shall be the duty of the Clerk to make and keep records of all the business proceedings and activities of this body.

Section 6. It shall be the duty of the Treasurer to receive all funds, pay all bills, and submit records when leaving office.

Section 7. All officers and board members must be Free Will Baptists who are in good standing in their respective churches and associations, must belong to this body and must, when elected, live within bounds of this Association. The Treasurer must give bond. No person shall serve on more than one board at the same time.

Section 8. It shall be the duty of the Planning Board to provide general plans for this Association, make the budget and regulate fees.

Section 9. The Executive Committee shall have full authority to do all acts for and in the name of the Association when the Association is not in session.

Section 10. It shall be the duty of the Mission Board to make plans for church extension and operate any state mission work and also work in the interest of the foreign mission program of the National Association. It shall be the duty of the Mission Board to help make our people missionary minded.

Section 11. It shall be the duty of the Superannuation Board to make general plans for Superannuation for aged ministers, and to cooperate with the National Association in providing insurance protection for our younger ministers.

Section 12. Amendments to this Constitution must be put before the body while in session one day before voted on, and must be read at least twice and passed by two-thirds of the delegates present.

 Constitution

 Article 1.
 NAME:

This board shall be known as the Florida State Home Mission Board of Free Will Baptists.

Article 2. PURPOSE:

The purpose of this board shall be that of promoting mission work among Free Will Baptists in the State of Florida.

Article 3. MEMBERSHIP:

This board shall be composed of members elected by the State association and shall serve terms established on a rotational basis: one members term shall expire annually. The number of members of this board shall be determined by the constitution and by-laws of the state association.

Article 4. OFFICERS:

Officers of the Board shall be: A Chairman, a Vice Chairman and a Secretary-Treasurer. These officers shall hold office for one (1) year and may be elected to serve succeeding terms. Members of the board shall elect the officers of the board.

Article 5. MEETINGS:

Meetings shall be held as the need arises. Necessary meetings may be called by the chairman or the secretary-treasurer. Mileage for board members expenses shall be paid from the general fund limited to 10¢ per mile one way.

Article 6. COMMITTEES:

Committees may be appointed by the chairman or elected by the board as the need arises.

Article 7. REPORTS:

A complete report of the board meetings and activities and a complete financial report must be presented to the annual state associational meeting.

Article 8. FINANCES:

This board shall receive its finances from churches and individuals making special contributions, cooperative program allocations, interest on loans, and special offerings received through promoting missions.

Article 9. MISCELLANEOUS:

Section 1. Missions and churches receiving financial support from this board must be Free Will Baptists which prove themselves sound in doctrine and practices as Free Will Baptists.

Section 2. Missions and churches receiving financial support from this board shall consider this board as an advisory body in such matters as the selection of a pastor and further financial obligations.

Section 3. Any work receiving financial support must agree to support the denominational cooperative program.

Section 4. Any work receiving financial support must accept such as a loan on terms and conditions agreed upon by them and the board as set forth in this constitution and such information shall be made available to them and fully understood by those receiving the support.

Section 5. Proper security must be granted the board for loans received. First mortgage is desired but second mortgage may be accepted; however no loan shall be granted in excess of the appraised value of the property. Interest shall be paid at the rate of 6% per annum. Monthly payments shall be paid at the rate of \$10.00 per \$1000.00 loaned.

Section 6. Missions or churches receiving financial support must be in good standing with an association or quarterly meeting affiliated with the state or national association and must have a pastor who is in good standing with the Free Will Baptists denomination.

Section 7. An agreement must be understood between the borrower and the board that in the event financial obligations cannot be met and rights to the property must be relinquished that said rights shall be turned over to the mission board and the decision of the board in regards to the property shall be final.

Section 8. Contracts shall be considered delinquent when 3 successive payments have not been met. It shall be determined by the board if contracts may be held valid and open for a longer period of time.

Section 9. The board shall have the right by majority vote to purchase property in desirable locations when there is good potential for organizing a Free Will Baptist Church. This action shall of necessity be subject to the availability of funds. In such matters full title must be acquired and no investment shall exceed the appraised value of property. Organizational work under such conditions shall be under complete supervision of the mission board.

Section 10. Nominal grants by the board to worthwhile churches or missions may be made when it is in the interest of the denominational cause in which benefits are certain. Grants of this nature shall be subject to money being immediately available and shall not exceed \$1000.00 without joint approval of the mission board and the state executive committee or association.

Article 1. DUTIES OF OFFICERS:

Officers of the board shallhold office according to the terms set forth in the constitution and shall carry out those duties peculiar to their respective offices. The secretary-treasurer shall maintain a permanent record of the boards activities and financial transactions. All records and property mortgages and titles shall be surrendered to the succeeding secretary-treasurer.

Article 2. VOTING AND QUORUM:

A majority membership shall constitute a quorum and be duly authorized to transact business. All items of business must receive a majority vote of board members before it is considered final. All members not present in meetings shall be notified of decisions made by the board.

Article 3. DUTIES OF MEMBERS:

All members shall endeavor to support mission work through cooperative efforts of the board. Any member that fails to cooperate with the board for a period of one year may, upon recommendation of the board, be replaced by the state association.

Article 4. AMENDMENTS:

This constitution and by-laws may be amended by a majority vote of the board members and final approval of the state association.
