WEDNESDAY EVENING, OCTOBER 31, 1974, 7:30 P.M.

REPORT OF THE STATE HOME MISSION BOARD

The Home Mission Board recommends that \$10,000.00 be returned to Camp Mount Pleasant Youth Camp Board in the Northern Part of the State.

In order to do this \$7,000.00 must be transferred from the general fund to be returned by the church extension money coming in monthly on 1st mortgage payments.

We recommend that we continue with our missionary through 1974 to pay a liveable salary of \$150.00 per week from the general funds and all church money be used on the land in an attempt to pay off the land and get a building on this new property.

In addition, we suggest that all churches try to do even more in the support of the West Palm Beach project. This is a joint mission effort and must have our whole-hearted support.

PARTIAL REPORT

- 2 that we further encourage each Free Will Baptist Church in our state to become and remain a member of and support the state association.
- 3 that we go on record as adopting all resolutions adopted by the National Association and that we encourage each local association to adopt the same and to make them a matter of their common practice.
- 4 that all local churches and associations carefully consider the practice and faith of Free Will Baptists as outlined by the National Treatise and strictly adhere to the same and that after duly laboring if the Quarterly meeting fails to adhere to the same that we withdraw fellowship from that Quarterly Meeting.

NATIONAL ASSOCIATION RESOLUTION COMMITTEE REPORT

TELEVISION

WHEREAS, television is the most effective means of communication today combining the eyes and ears for a double impression, and

WHEREAS, the television networks are using this media to show restricted movies and programs that appeal to the base and prurient nature of mankind and propose to show X-rated movies, and

WHEREAS, murder, rape, stealing, lying, and other such acts of crime are becoming commonplace in regularly aired programs during prime time when children are watching, and

WHEREAS, the Bible describes all such acts of crime, lewdness, filth, and barbarous behaviour as evil and wicked deeds against the God of heaven.

THEREFORE BE IT RESOLVED:

- 1. That the National Association of Free Will Baptists go on record as appealing to the three major networks (NBC, CBS, and ABC) to cease showing such films and programs described above.
- 2. That we appeal to every member of every church of this association to send letters of protest to the three major networks registering their complaint.
- 3. That parents be urged to keep a more thorough screening of programs viewed by their children thus protecting their minds from being bent and twisted by such evil influence.

4. That copies of this resolution be sent by the clerk to the three major networks informing them of our action.

ABORTION

WHEREAS, we recognize that life is a gift from God and that we have a sacred obligation to protect a soul's right to live whether born or unborn, and

WHEREAS, the Supreme Court of the United States has ruled contrary to the laws of God placing abortion and/or the decision to terminate the life of an unborn child in the hands of a doctor, and a woman, and

WHEREAS, very little is said of the root causes of the vast majority of such pregnancies resulting in an abortion which are immorality, promiscuous living defying God's laws of purity of life, and a constant erosion of the sanctity of marriage and the home which are basic units of society, and

WHEREAS, we recognize that frustration is common among Christian people as to what they should or can do about such conditions and rulings that exist,

THEREFORE BE IT RESOLVED:

- 1. That the National Association of Free Will Baptists go on record as opposing abortion-on-demand.
- 2. That the clerk of this association send a letter to the Supreme Court of the United States urging them to reconsider their recent ruling in favor of abortion.
- 3. That we urge the pastors of our churches to keep informed and advise their members of groups and organizations who are working to get laws enacted opposing abortion (presuming such groups are legitimate and worthy of support) and also urge their members to give active support to such campaigns.
- 4. That we urge the members of our churches to write their representatives both in their state and Washington urging them to support legislation to repeal the present laws and rulings on abortion.

PORNOGRAPHY

WHEREAS, the problem of smut, pornography, and obscenity is on the increase in America taking the form of "adult book stores," "peep shows," and radio programs that major on sex-oriented discussions, and

WHEREAS, such pornography, smut, and obscenity leave a trail of perverted minds obsessed and twisted leading to a drastic increase in immorality, rape, and related crimes, and

WHEREAS, The U. S. News and World Report says that this is an \$800 million business which takes that much money from legitimate businesses that seek to build a decent, law-abiding society, and

WHEREAS, the Bible gives clear and unmistakable warning against such literature and pictures that appeal to the base Adamic nature of man making him more deprayed in the sight of God, and

WHEREAS, the Bible teaches that Christians are to use their influence and energy to stop the flow of such literature and obscenity which deteriorates any society,

THEREFORE BE IT RESOLVED:

- 1. That the National Association of Free Will Baptists voice its strong opposition to smut, pornography, and obscenity whether it be on television, radio, bookstores, or places of entertainment.
- 2. That a copy of this resolution be sent by the clerk to the following persons and groups encouraging them to actively use their position, prestige, and influence to stop the production, sale, and display of such base and prurient materials or shows:

The President of the United States

The Supreme Court of the United States.

- 3. That every member of the National Association be urged to actively become involved in opposing this illegitimate business.
- 4. That we encourage every family to subscribe to at least two Christian publications and to suggest that one of these be specifically for youth if there are children in the home.
- 5. That we as Christians voice our disapproval to supermarkets, drug-stores, and other businesses that display pornography.

FREE WILL BAPTISTS AND THE CHARISMATIC MOVEMENT

WHEREAS, the phenomena of "speaking in tongues" is a spreading movement which usually causes confusion, contention and division within the church, and

WHEREAS, speaking in tongues overemphasizes an emotional experience out of proportion to a life of service, soul winning and ethical living, and

WHEREAS, tongues have never made any significant contribution to church growth and there is no evidence that contemporary charismatic movement is any different, and

WHEREAS, advocates of tongues-speaking misinterpret the scriptures in order to justify their position about this supposed gift of grace, and

WHEREAS, there is a need to clarify the position of the National Association of Free Will Baptists,

THEREFORE BE IT RESOLVED:

That this body adopt the following statement as expressing the position of our denomination concerning the charismatic movement:

Free Will Baptists understand that the Bible teaches the following facts:

- A. On the Day of Pentecost believers spoke in distinct foreign languages which were readily understood by the nationalities present (Acts 2:6, 8, 11).
- B. Tongues were given as a special gift to the early church as only one sign which confirmed the witness of the Gospel to unbelievers (I Cor. 14:1-40, Heb. 2:4).
- C. Although practiced by some believers, it was the least significant gift which is not to be sought after (I Cor. 12:7-11).
- D. When the gift was abused it became a source of disturbance in public gatherings. To eliminate confusion and correct the error Paul set specific guidelines for the Corinthian Church to follow (I Cor. 14:18-19, 23, 28, 33).

- E. The gift of tongues is not the evidence of the Baptism of the Spirit and neither does it bring about sanctification (I Cor. 12:13).
- F. Tongues were bestowed by the sovereign will of God in some believers but all did not speak with tongues (I Cor. 12:10, 30).

THEREFORE, the National Association of Free Will Baptists holds the following position on glossolalia.

- A. We reject the doctrine of speaking in tongues as being a valid gift for the church today because the complete revelation of God is given in the Bible.
- B. We reject the erroneous teachings that speaking in tongues is a visible sign of the baptism of the Holy Spirit. Any implication of a "second work of grace" has never been tolerated in our fellowship of churches.
- C. We refuse to embrace this doctrine. Even though some individuals may profess to speak in tongues, this practice is not to be encouraged or promoted in a local church nor do we find any reason to advocate "Neo-Pentecostalism." Churches affiliated with the National Association are not to be considered fertile ground to sow the seed of tongues speaking.
- D. We believe the church, as God's instrument of redemption, has been advanced by the preaching of the Gospel in a "known tongue" rather than magnifying some particular gift.
- E. We encourage all churches to preach the fulness of the Holy Spirit, the whole counsel of God and to take heed to the Scriptural admonition in Eph. 5:18b-20, "But be filled with the Spirit; Speaking to yourselves in psalms and hymns and spiritual songs, singing and making melody in your heart to the Lord; Giving thanks always for all things unto God and the Father in the name of our Lord Jesus Christ."

CONSTITUTION

and *BY-LAWS*

of the

FLORIDA STATE ASSOCIATION OF FREE WILL BAPTISTS

PREAMBLE

We, the Free Will Baptists of Florida, for the sake of power that comes of unity and oneness of purpose; for the advancement of the cause of Christ; for the glory of God and the good of mankind do ordain and establish this Constitution and By-Laws.

ARTICLE I - NAME OF ASSEMBLY

Section 1. This assembly shall be known as "THE FLORIDA STATE ASSOCIATION OF FREE WILL BAPTISTS."

ARTICLE II - REPRESENTATION

Section 1. This Association shall be composed of delegates elected from the local associations belonging to this body and delegates elected from the local churches embraced by the various associations.

Section 2. All deacons and ministers who are members of, and in good standing with, a local church and local association, which are members of this body are standing delegates.

Section 3. The general officers of this body shall be standing delegates.

Section 4. The delegates shall be elected as follows: One (1) delegate from each local church composed of 100 members or fraction thereof, and one (1) delegate from each additional 100 members or fraction thereof; five (5) delegates from each local association composed of 15 churches or fraction thereof, and one, (1) additional delegate for each additional four (4) churches or fraction thereof. The additional delegates cannot be used unless the churches are active and are represented in the session in which they are appointed.

ARTICLE III - OFFICERS, BOARDS AND COMMITTEES

Section 1. Officers: The officers of this association shall be a Moderator, Assistant Moderator, Secretary, Assistant Secretary, Treasurer, and Promotional Secretary.

Section 2. Boards: The standing boards of this association shall be Planning, Missions, and Christian Education-Youth Board.

Section 3. The Executive Committee shall be composed of the Moderator, Assistant Moderator, Secretary, Treasurer, Promotional Secretary, and one elected member from each affiliated association. A majority of members shall constitute a quorum. Other committees shall be appointed as needed.

Section 4. When vacancies occur either by death or removal from office, or by resignation, the body shall fill vacancy either by proxy or by election of officer to the vacancy at any regular session of the body and the proxy may be appointed by the body to fill any absentee's place who does not attend the session.

- Section 5. The regular election shall take place each year.
- Section 6. Each standing board shall be composed of 5 members which shall be elected for 5 year terms on a rotating basis, so that one new member shall be elected yearly.

Section 7. This body shall have and does reserve the right to deal with any officer or board member who does not conduct his or her office in a Christian and business-like manner according to the rules of Christian conduct laid down in the teachings of the New Testament. Thus the right to discipline in this body is confined to this body, but a charge against a member of this body and the members of local churches shall constitute a charge against said member in this body and the body shall abide accordingly thereby.

ARTICLE IV - MEETINGS

- Section 1. Regular: This Association shall convene annually on Wednesday evening, Thursday, and Friday before the first Sunday in November.
- Section 2. Special: The Executive Committee may be called into session by the Moderator, or by a majority of its members.
- Section 3. Quorum: Fifty (50) percent of the delegates shall constitute a quorum.

ARTICLE V - FINANCE

- Section 1. All churches and associations represented in this body shall pay entrance fee annually. The amount of this fee shall be determined by the body while in session and may be changed by a two-thirds vote in any session.
- Section 2. Fees for an association are based on \$3.00 per member church, and fees for churches are \$5.00 per delegate.
- Section 3. All funds coming into this body shall be spent under a budget plan. This budget must be approved by the body while in session and no funds may be used in any way except as budgeted.

BY-LAWS

- Section 1. It shall be the duty of the Moderator to preside over all deliberations of this body while in session.
- Section 2. The Moderator shall have the power to rule measures out of order providing this ruling is sustained by two-thirds of the delegates present.
- Section 3. The Vice-Moderator shall assume the duties, rights and privileges of the Moderator in his absence.
- Section 4. The Vice-Moderator shall be ex-officio member of all standing boards and committees.
- Section 5. It shall be the duty of the Clerk to make and keep records of all the business proceedings and activities of this body.
- Section 6. It shall be the duty of the Treasurer to receive all funds, pay all bills, and submit records when leaving office.
- Section 7. All officers and board members must be Free Will Baptists who are in good standing in their respective churches and associations, must belong to this body and must, when elected, live within bounds of this Association. The Treasurer must give bond. No person shall serve on more than one board at the same time.
- Section 8. It shall be the duty of the Planning Board to provide general plans for this Association, make the budget and regulate fees.

CONSTITUTION

and BY-LAWS

of the

FLORIDA STATE HOME MISSION BOARD OF FREE WILL BAPTISTS

CONSTITUTION

ARTICLE I - NAME

This board shall be known as the Florida State Home Mission Board of Free Will Baptists.

ARTICLE II - PURPOSE

The purpose of this board shall be that of promoting mission work among Free Will Baptists in the State of Florida.

ARTICLE III - MEMBERSHIP

This board shall be composed of members elected by the State association and shall serve terms established on a rotational basis: one member's term shall expire annually. The number of members of this board shall be determined by the constitution and by-laws of the state association.

ARTICLE IV - OFFICERS

Secretary-Treasurer. These officers shall hold office for one (1) year and may be elected to serve succeeding terms. Members of the board shall elect the officers of the board.

ARTICLE V - MEETINGS

Meetings shall be held as the need arises. Necessary meetings may be called by the chairman or the secretary-treasurer. Mileage for board members' expenses shall be paid from the general fund limited to .10¢ per mile one way.

ARTICLE VI — COMMITTEES

Committees may be appointed by the chairman or elected by the board as the need arises.

ARTICLE VII - REPORTS

A complete report of the board meetings and activities and a complete financial report must be presented to the annual state associational meeting.

ARTICLE VIII - FINANCES

This board shall receive its finances from churches and individuals making special contributions, cooperative program allocations, interest on loans, and special offerings received through promoting missions.

ARTICLE IX - MISCELLANEOUS

- Section 1. Missions and churches receiving financial support from this board must be Free Will Baptists which prove themselves sound in doctrine and practices as Free Will Baptists.
- Section 2. Missions and churches receiving financial support from this board shall consider this board as an adivsory body in such matters as the selection of a pastor and further financial obligations.
- Section 3. Any work receiving financial support must agree to support the denominational cooperative program.
- Section 4. Any work receiving financial support must accept such as a loan on terms and conditions agreed upon by them and the board as set forth in this constitution and such information shall be made available to them and fully understood by those receiving the support.
- Section 5. Proper security must be granted the board for loans received. First mortgage is desired but second mortgage may be accepted; however no loan shall be granted in excess of the appraised value of the property. Interest shall be paid at the rate of 6% per annum. Monthly payments shall be paid at the rate of \$10.00 per \$1000.00 loaned.
- Section 6. Missions or churches receiving financial support must be in good standing with an association or quarterly meeting affiliated with the state or national association and must have a pastor who is in good standing with the Free Will Baptists denomination.
- Section 7. An agreement must be understood between the borrower and the board that in the event financial obligations cannot be met and rights to the property must be relinquished that said rights shall be turned over to the mission board and the decision of the board in regards to the property shall be final.
- Section 8. Contracts shall be considered delinquent when 3 successive payments have not been met. It shall be determined by the board if contracts may be held valid and open for a longer period of time.
- Section 9. The board shall have the right by majority vote to purchase property in desirable locations when there is good potential for organizing a Free Will Baptist Church. This action shall of necessity be subject to the availability of funds. In such matters full title must be acquired and no investment shall exceed the appraised value of property. Organizational work under such conditions shall be under complete supervision of the mission board.

Section 10. Nominal grants by the board to worthwhile churches or missions may be made when it is in the interest of the denominational cause in which benefits are certain. Grants of this nature shall be subject to money being immediately available and shall not exceed \$1000.00 without joint approval of the mission board and the state executive committee or association.

BY-LAWS

ARTICLE I - DUTIES OF OFFICERS

Officers of the board shall hold office according to the terms set forth in the constitution and shall carry out those duties peculiar to their respective offices. The secretary-treasurer shall maintain a permanent record of the board's activities and financial transactions. All records and property mortgages and titles shall be surrendered to the succeeding secretary-treasurer.

ARTICLE II - VOTING AND QUORUM

A majority membership shall constitute a quorum and be duly authorized to transact business. All items of business must receive a majority vote of board members before it is considered final. All members not present in meetings shall be notified of decisions made by the board.

ARTICLE III - DUTIES OF MEMBERS

All members shall endeavor to support mission work through cooperative efforts of the board. Any member that fails to cooperate with the board for a period of one year may, upon recommendation of the board, be replaced by the state association.

ARTICLE IV - AMENDMENTS

This constitution and by-laws may be amended by a majority vote of the board members and final approval of the state association.

CONSTITUTION

and

BY-LAWS

of the

CHRISTIAN EDUCATION - YOUTH BOARD

ARTICLE I – NAME

This board shall be known as the Christian Education - Youth Board of the Florida State Association of Free Will Baptists.

ARTICLE II – PURPOSE

The purpose of this board shall be to promote Sunday School, Church Training Service, Free Will Baptist Bible College, Youth Camps, Youth Rallies, Vacation Bible Schools, and Teacher Training Programs, and to be a co-ordinating agency between National, State, and District offices.

ARTICLE III – THE BOARD

- Section 1. Composition This board shall be composed of five members.
- Section 2. Tenure of Office The members of this board shall be elected for a term of five years and arranged whereby that only one member's term expires annually.
- Section 3. Vacancies In the event irregular vacancies occur on this board they will be filled by the Florida State Association.
- Section 4. Time of Meeting This board will meet semi-annually. As need arises called meetings may be held.
 - Section 5. Organization The board shall elect a Chairman and Secretary.

ARTICLE IV – DUTIES OF THE BOARD

- Section 1. To set up and direct CTS competitive activities.
- Section 2. To promote and encourage Teacher Training Courses that have been approved by the National Sunday School Department of the local and district group meetings.
- Section 3. The board shall give a report of its activities at the Florida State Association annual meeting.

ARTICLE V - TRAVEL EXPENSES

Ten cents per mile one way shall be paid board members for all meetings except the board meetings in connection with the State Association.

ARTICLE VI – AMENDMENTS

This Constitution and By-Laws may be amended by a majority vote of the State Association.

CHURCH COVENANT

Having given ourselves to God, by faith in Jesus Christ, and adopted the Word of God as our rule of faith and practice, we now give ourselves to one another by the will of God in this solemn covenant.

We promise by His Grace to love and obey Him in all things, to avoid all appearance of evil, to abstain from all sinful amusements and unholy conformity to the world, from all sanction of the use and sale of intoxicating beverages, and to provide things honest in the sight of all men.

We agree faithfully to discharge our obligations in reference to study of the Scriptures, secret prayer, family devotions, and social worship, and by self-denial, faith, and good works endeavor to grow in grace and in the knowledge of our Lord and Saviour Jesus Christ.

We will not forsake the assembling of ourselves together for church conferences, public worship, and the observance of the ordinances of the Gospel, nor fail to pay according to our ability for the support of the church, of its poor, and all its benevolent work.

We agree to accept Christian admonition and reproof with meekness, and to watch over one another in love, endeavoring to "keep the unity of the Spirit in the bonds of peace," to be careful of one another's happiness and reputation, and seek to strengthen the weak, encourage the afflicted, admonish the erring and as far as we are able, to promote the success of the church and of the Gospel.

We will everywhere hold Christian principles sacred and Christian obligations and enterprises supreme; counting it our chief business in life to extend the influence of Christ in society; constantly praying and toiling that the Kingdom of God may come, and His will be done on earth as it is in Heaven.

To this end we agree to labor for the promotion of educational and denominational enterprises, the support of Missions, the success of Sunday Schools, and evangelistic efforts for the Salvation of the World. And may the God of peace sanctify us wholly, and preserve us blameless unto the coming of our Lord Jesus Christ.
