

MINUTES OF THE 47th ANNUAL SESSION FLORIDA STATE ASSOCIATION OF FREE WILL BAPTISTS OCTOBER 30 - NOVEMBER 1, 1991



THE YOUTH BOARD

Pam Stewart - Oral Communication and registration for State and National


The Board met again on Saturday morning to visit facilities in the Gainesville area that had showed an interest in hosting the State Competition. After discussing with the hotels the cost for conference rooms, sleeping rooms, and available dates, the Board booked the Holiday Inn in downtown Gainesville for the dates of May 24 and 25. This proved to be a good choice since the only expense the Board had to pay to use the facilities was a rental fee on the PA system.

The Youth Board met at the Holiday Inn in Gainesville, May 24, 1991 in conjunction with the State Youth Competition. All Board members were present. Pam Stewart distributed copies of the list of competitors and Randy Hill completed the judging assignments. It was discussed that letters requesting judges were sent to all churches and these were the only people who had volunteered. It was suggested that maybe by having such a limited list of judges this year others will get involved next year.

Issues printed were: Nov/Dec, Jan/Feb, March, April, May/June, July/Aug, Sept/Oct, and Nov/Dec. Printing bi-monthly seems to work out best for the amount of material we receive and for the material to be printed on a timely basis.

Regarding supplies: We have found a good source for supplies. For example, the mailing envelopes are ordered by the thousand and last approximately two years for a cost of about \$75. These will need to be ordered again after the Nov/Dec issue goes out. Consequently, the costs for supplies will vary from year to year, but will average around \$50.00 per year.

Based on 6 issues per year, the average cost per issue is \$418.00.

EXECUTIVE COMMITTEE REPORT

The Executive Committee met on October 30 and brought forth these recommendations:

I. PROMOTION

- Item 1. We recommend that representatives from each Association, elected by their Association, come together for the purpose of being educated in the Co-Operative Plan of Support and then have them go back and instruct their Local Associations as to Co-Operative giving. The Executive Office of the State will be responsible for the expenses of the joint meeting, however, the work within their association will be done voluntarily.
- Item 2. That the Assistant Moderator serve as the Coordinator in arranging the training and the securing of area representatives for the Co-Operative promotion.
- Item 3. We recommend that the Moderator of the State Association serve as the Promotional Secretary temporarily.
- Item 4. We recommend that the State Paper, The Coordinator, be published on a bi-monthly basis.

II. STATE MEETING

- Item 5. We recommend that we have a joint State Meeting with the State Woman's Auxiliary and the Youth Competition.
- Item 6. The State Meeting will have a Wednesday night through Saturday format.
- Item 7. The location of the State Meeting will be the same each year.
- Item 8. The Ocala Hilton will be the location of next year's meeting.
- Item 9. The dates for this meeting will be May 27-30, 1992.
- Item 10. We recommend that a Steering Committee be appointed for the State Meeting consisting of the Moderator, the State Auxiliary President, and the Chairman of the Youth Board.
- Item 11. A Constitutional change be made for Article IV. Meetings, Section 1 Regular. to:

 This Association shall convene annually in a joint meeting with the State Woman's Auxiliary and the Youth Competition on Wednesday evening, Thursday, Friday, and Saturday after the first Sunday in May.

III. FINANCIAL

- Item 12. We recommend that we set this year's budget for State Co-Op at \$70,000,
- Item 13. That the distribution for Co-Op money be as follows: 60% to remain in State, 40% to the National Of State Co-Op money:

Item 14. We give our Treasurer \$50 per month.

REPORT OF THE RESOLUTIONS COMMITTEE

I. Whereas in a local church the pastor's salary is the public knowledge of the Body, and

Whereas in a Baptistic form of government the members of that Body are entitled to complete knowledge of all financial matters, and

Whereas National leaders are the servants of the National Body and employed by boards who represent the churches of the National Association of Free Will Baptists, and

Whereas to protect the reputation of our denominational leadership and boards, Therefore, be it resolved that salaries of all directors of departments and department heads within those departments be specified individually in budget reports recommended to the National Body.

Therefore be it further resolved that this Body recommend this resolution to the General Board of the National Association of Free Will Baptists for adoption and implementation at the National Association of Free Will Baptists beginning in the 1992-93 budget.

II. Whereas there exists a continual need for financial stability with our Christian homes, churches, associational, state and national works, missions, Bible college, etc.,

Whereas this is a spiritual matter that is based upon the teaching and application of the Word of God in the life of the believer,

Whereas this comes about by the maturing of our FWB people and churches, Be it resolved that we encourage our churches, their leadership, and membership to recommit themselves to endeavor to mature our people through sound Bible teaching, training, and especially pastoral preaching from our pulpits.

Be it further resolved that these areas be considered and emphasized especially beginning from the State Association:

- 1. Teacher training for sound Bible teaching in our churches
- 2. Young convert and new member teaching
- 3. Sound stewardship teaching and preaching

- 4. Biblical and rewarding reasons for giving and sharing God's financial blessings
- 5. The potential areas of giving in the church; associational, state and national ministries

Be it further resolved that our churches be encouraged to come to greater financial accountability by budgeting of income and giving and especially be concerned with the area of "pastoral support", trying to get our pastor a full-time servants in the field of service, substantially supported, so that souls can be won to the Kingdom of God..

III. Whereas new residents of the State of Florida are required to pay an extremely high vehicle registration tax, and

Whereas most of our new Pastors come from out of state and are under a financial hardship,

Be it resolved that our churches be encouraged to help pay their Pastor's vehicle registration expense along with the customary moving reimbursement.

There are several objectives and plans that your Board is considering:

- 1) Plans are being considered for a pastor/wife retreat. We want to assist you dear pastors in your local ministry and we feel this would be very beneficial and productive. The program, date and subjects are in the making and we hope that we can forthwith finalize these ideas and start promoting this meeting.
- 2) We still want to encourage each pastor to seriously consider starting a local Bible Institute for the training and edification of our church people.
- 3) We also want to remind you of our tape-lending library that is available FREE of charge to any church wishing to use this avenue of ministry. These tapes range in interest and help from church growth, discipleship, youth ministry, and Sunday School success ideas. These tapes are free for the asking, all we ask is that you underwrite the postage and handling of the tapes.
- 4) We also want to encourage each District Association to consider extending some type of support for those students that are continuing their education from your local churches. This can be accomplished through you local/district Co-Op giving. We do ask that if any pastor has a young man or woman attending first semester in any of our Bible Colleges that they notify the board so we can expedite their scholarship.

If you have any suggestion or comments on how we may better serve, we would appreciate hearing from you.

Report of Committee Reviewing State Co-Operative Plan Structure

On Tuesday, April 14, 1992, a committee authorized by the Florida State Association met in Ocala to discuss ways to improve funding of the state work. Representatives from seven district associations were present: Edd Green (S FL), Odis Whitehead (Gr. St. John), Paul Oppy (N FL), Tim Owen (W FL), Jerry Whitworth (Salem), Jim Christian (Ind River), and David Williford (Liberty).

The committee discussed the present financial picture and the state program of giving. It was reported that state funding is declining at an alarming rate. After much discussion the following proposals were made:

- 1) We recommend a change in the method of Co-Op support. We ask the state to recommend that each local association adopt a local co-op plan of support. churches would be encouraged to give 10% of their undesignated receipts to their local co-op program.
 - 2) Churches that are not currently giving to co-op are encouraged to begin by giving 3% of their receipts to co-op, and to increase their giving by 1% each year until they reach at least 10%.
 - 3) A recommended model of giving for the local co-op program would be for each local association to retain no more than 40% for local ministries

and send at least 60% to the State co-op fund.

- 4) The following suggestions for local ministries that local association might begin:
- a) Local missions
- b) Christian education activities like Bible Institutes, youth activities, scholarship programs, etc.
- c) Local outreach ministries like youth missions trips, radio ministry, etc.
- d) Pastor's retirement fund
- 5) We recommend that the boards receiving co-op funds prepare a financial summary projecting how this increase in funds would enhance the scope of their ministries.

These proposals are based on successful programs from at least four local associations within our state. If adopted, these proposals would allow the state to develop more programs aimed at strengthening the local church. Examples would include state-wide youth retreats, local workshops designed to help the local church, provision of tools for ministry, aid in evangelism, church growth, discipleship, etc.

We recommend that this program be adopted by the state and all local associations for a one-year trial..

EXECUTIVE BOARD REPORT

CONSTITUTION AND BY-LAWS OF THE FLORIDA STATE ASSOCIATION OF FREE WILL BAPTISTS

PREAMBLE

ARTICLE I - NAME OF ASSEMBLY

Section 1. This assembly shall be known as "The Florida State Association of Free Will Baptists".

ARTICLE II - REPRESENTATION

<u>Section 1.</u> This Association shall be composed of delegates elected from the local associations belonging to this body and delegates elected from the local churches embraced by the various associations.

Section 2. All deacons and ministers who are members of, and in good standing with, a local church and local association which are members of this body are standing delegates.

Section 3. The general officers of this body shall be standing delegates.

Section 4. The delegates shall be elected as follows: One (1) delegate for each local church composed of 100 members or fraction thereof, and one(1) delegate for each additional 100 members or fraction thereof; five (5) delegates from each local association composed of fifteen (15) churches or fraction thereof, and one(1) additional delegate for each additional four (4) churches or fraction thereof. These additional delegates cannot be used unless the churches are active and are represented in the session in which they are appointed.

ARTICLE III - OFFICERS, BOARDS AND COMMITTEES

Section 1. Officers: the officers of this association shall be a Moderator, Assistant Moderator, Secretary, Assistant Secretary, and Treasurer.

Section 2. Boards: The standing boards of this association shall be Home Missions, Christian Education, and Youth Boards.

Section 3. The Executive Committee shall be composed of the Moderator, Assistant Moderator, Secretary, Treasurer, the chairman of each standing board, and one elected member from each affiliated district association. District associations shall recommend their representative on the Executive Board annually. A majority of members shall constitute a quorum.

Section 4. When vacancies occur either by death, removal from office, or by resignation, the general officers shall appoint a temporary replacement until the next regular session of this body, at which time the body shall elect a permanent replacement. A proxy may be appointed by the body to fill any absentee's place who does not attend the session.

Section 5 General officers of this Association shall serve for the term of two (2) years.

Section 6. Each standing board shall be composed of five (5) members which shall be elected for five (5) year terms on a rotating basis, so that one new member shall be elected yearly.

Section 7. This body shall have the right to discipline any officer or board member who does not conduct his office in a Christian and business-like manner according to the rules of christian conduct laid down in the New Testament.

ARTICLE IV - MEETINGS

Section 1. Regular: This association shall convene annually in a joint meeting with the State Woman's Auxiliary and the Youth Competition on Wednesday evening, Thursday, Friday and Saturday after the first Sunday in May.

Section 2. Special: The Executive committee may be called into session by the moderator, or by a majority of its members.

Section 3. Quorum: Fifty (50) percent of the delegates shall constitute a quorum.

ARTICLE V - FINANCES

Section 1. All churches and associations in this body shall pay a representation fee annually. The amount of this fee for an association of \$15.00 per member church. The fee for local churches is \$10.00 per delegate.

Section 2. All Cooperative Plan funds coming into this body shall be spent under a budget plan. This budget must be approved by the body while in session, and no funds may be used in any way except as budgeted.

Section 3. Mileage for the Executive Committee members and standing Board members shall be paid at the I.R.S.. rate for that fiscal year. Expenses are to be paid from each Board member's account. If a called meeting requires a member to stay overnight, his room and board will be paid from the General Fund or his Board's account. Mileage and expenses shall be paid for the Moderator to attend the denomination's annual leadership conference.

BY-LAWS

Section 1. It shall be the duty of the Moderator to preside over all deliberations of this body while in session. All meetings shall be governed by Roberts Rules of Order.

Section 2. The Assistant Moderator shall assume the duties, rights and privileges of the Moderator in his absence.

Section 3. It shall be the duty of the Clerk to make and keep records of all the business proceedings and activities of this body.

Section 4. It shall be the duty of the Treasurer to receive all funds, pay all bills, and submit records when leaving office. The Treasurer must give bond while filling this office.

Section 5. Each officer and board member must be a member in good standing of a Free Will Baptist Church which is a member of this body. He must be in good standing with his local association, and must live within the boundaries of this Association. No person shall serve on more than one board at the same time.

Section 6. The Executive Committee shall have full authority to do all acts for and in the name of the Association when the Association is not in session.

<u>Section 7.</u> Amendments to this Constitution and By-Laws must be put before the body while in session one day before voted on, and must be read at least twice and passed by two-thirds of the delegates present.

CONSTITUTION AND BY-LAWS OF THE FLORIDA FREE WILL BAPTIST HOME MISSION BOARD

ARTICLE I-NAME

This Board shall be known as the Florida Free Will Baptist Home Mission Board, Inc.

ARTICLE II - PURPOSE

The purpose of this board shall be that of promoting mission work among Free Will Baptists in the State of Florida.

ARTICLE III - MEMBERSHIP

This board shall be evomposed of members elected by the State Association and shall serve terms established on a retational basis. One member's term shall expire annually. Thenumber of members of this board shall be determined by the Constitution and By-Laws of the State Association.

ARTICLE IV - OFFICERS AND COMMITTEES

Officers of this board shall be Chariman and Secretary/Treasurer. These officers shall hold office for one(1) year and may be elected to serve succeeding terms. Members of the board shall elect the

officers of the board. Committees may be appointed by the chairman elected by the board as the need arises.

ARTICLE V - MEETINGS

Meetings shall be held as the need arises. Necessary meetings may be called by the chairman or the secretary/treasurer.

ARTICLE VI - FINANCES

This board shall receive its finances from churches and individuals making special contributions, cooperative program allocations, interest on loans, and special offerings received through promoting missions. Mileage for board member expenses shall be paid from the general fund at the I.R.S. rate for that fiscal year.

BY-LAWS

Section 1. Officers of the board shall hold office according to the terms set forth in the Constitution and shall carry out those duties peculair to the respective offices. The Secretary/Treasurer shall maintain a permanent record of the Board's activities and financial transactions. All records and property mortgages and titles helal be surrendured to the succeeding Secretary/Treasurer.

Section 2. A majority membership shall constitute a quorum and be duly authorized to transact business. All items of business must receive a majority vote of a quorum before it is considered final. All members not present in meetings shall be notified of decisions made by the Board.

Section 3. All members shall endeavor to support mission work through cooperative efforts of the board. Any member that fails to cooperate with the board for a period of one year may, upon recommendation of the board, be replaced by the State Association.

<u>Section4.</u> A complete report of the board meetings and activities and a complete financial report must be presented to the annual State associational Meeting.

Section 5. Missions and churches receiving financial support from this board must be Free Will Baptists which prove themselves sound in doctrine and practices as Free Will Baptists.

Section 6. Missions and churches receiving financial support from this board shall consider this board as an advisory body in such matters as the selection of a pastor and further financial obligations.

Section 7. Any work receiving financial support must agree to support the denominational cooperative program.

Section 8. Any work receiving financial support as a loan must accept such on terms and conditions agreed upon by them and the board as set forth in this constitution and such information shall be made available to them and fully understood by those receiving the support.

Section 9. Proper security must be granted the board for loans received. First mortgage is desired but second mortgage may be accepted; however, no loan shall be granted in excess of the appraised value of the property. Interest shall be paid at the rate of 6% per annum. Monthly payments shall be paid at the rate of \$10.00 per \$1000.00 loaned.

Section 10. Missions or churches receiving financial support must be in good standing with an association or quarterly meeting affiliated with the state or national association and must have a pastor who is in good standing with the Free Will Baptist denomination.

Section 11. An agreement must be understood between the borrower and the board that in the event financial obligations cannot be met and rights to the property must be relinquished that siad rights shall be turned over to the Mission Baord and the decision of the board in regards to the property shall be final.

Section 12. Contracts heall be considered delinquent when three (3) successive payments have not been met. It shall be determined by teh board if contracts may be held valid and open for a longer period of time.

<u>Section 13</u>. The board shall have the right by majuority vote to purchase property in desirable locations when there is good potential for organizing a Free Will Baptist Church. This action shall of necessity be subject to the availability of funds. In such matters full title must be acquired and no
