

# Minutes of the 49th Annual Session Florida State Association of Free Will Baptists May 5 - 8, 1993

# Executive Committee Report

1. We recommend that we change Article V Section 1 in our Constitution to read: "All churches shall pay a representation fee annually. The amount of this fee for an association is \$30 per member church. The fee for local churches is \$10 per delegate.

- 2. We recommend the adoption of the report from the committee studying the need of a Promotional Secretary.
- 3. We recommend the adoption of the following resolutions:

"Whereas the integrity of our Foreign Missions Department, its General Director, and certain missionaries have been called into question, and

Whereas we affirm our support for them, and

Whereas the accusations are being made against our Department and missionaries by a group known as "Contenders for the

Covenant", and

Whereas Norwood Gibson, the former chairman of the Foreign Missions Board, has unethically revealed to this group actions of Board and Field Council meetings, and

Whereas Rue Dell Smith and Earl Hendrix, who are members of the National Home Missions Board, have chosen to publicly identify and affiliate with the "Contenders for the Covenant" which has publicly and detrimentally criticized and opposed the policy of another National Board, the Foreign Missions Board, and has "sown discord among the brethren" of our denomination, THEREFORE BE IT RESOLVED that we condemn as unethical the conduct of our former Foreign Missions Board Chairman, Norwood Gibson, and hereby call for his resignation from the Foreign Missions Board and that we further condemn as unethical the actions of Home Missions Board Members Rue Dell Smith and Earl Hendrix, and call for an official rebuke for those actions.

BE IT RESOLVED that we submit this resolution to the Executive Committee of the National Association of Free Will Baptists;

BE IT FURTHER RESOLVED that if this resolution is not recommended by the Executive Committee that we direct our General Board Representative to present it to the Body from the floor of the National Association.

5. We recommend the following distribution of undesignated Co-Operative funds 60% to remain in the State and 40% to the National

- Co-Op. The State Co-Op funds after the funding of the Executive Office to be designated as follows: Mission Board 63%, Youth Board 15%, Promotional Fund 10%, C.E. Board 6%, Children's Home 5 1/2 5, Historical Committee 1/2%.
- 6. We recommend the State Treasurer be given \$50 per month.
- 7. We recommend we give the Moderator and Clerk \$250 per year.
- 8. We recommend that money in the Retirement fund be placed back into the Co-Op funds if the State Treasurer does not receive an account number from our Retirement Board by June 15, 1993 for those enrolled.
- 9. We recommend the C.E. Board be granted a \$500 draw toward the expenses of its next seminar. This is to come from the Executive Office.

# Home Mission Board Report

The Home Mission Board presently has the oversight of two state misison works: the Bayshore FWB Mission Church in St. Petersburg, led by home missionaries Curtis and Laverne Alligood, and the Faith Chapel FWB Mission Church in Jacksonville, led by missionaries Odis and Mary Nell Whitehead.

The Mission Board visited both works recently, conducting a service, and meeting with both the mission pastor and the congregations. We were pleased with this personal contact, and feel that both missions have experienced significant growth, strengthening, and development during the past year. You will hear reports from the missionary pastors during this meeting. We appreciate the fine work these men are doing, and pray that God will continue to use them to build strong Free Will Baptist Churches in these two strategic Florida cities. The board is working on a phase-out plan so that these works will become increasingly self-supporting over the next two to three years.

The board has committed \$35,000 of our present funds for the St. Pete work toward debt retirement on the property. We challenge the Florida State Association with a project to provide a matching amount over the

next year, to culminate at the 1994 association meeting. We believe this will reduce the indebtedness to a managable size to enable the church to realistically move toward self-supporting status.

The board has discussed a new Florida mission work in the not too distant future. With the above-mentioned project and our phase-out plan, we hope to be able to announce a new mission project at our 1996 State Association. Join us in praying for God's direction and provision of the right missionary personnel, the financial strength, and the right target city in Florida.

We have been asked about the Gainesville work and its future. The mission board has title to the property which we currently rent to a church group of another denomination. The money from the rental, plus the sale of the old property, covers the bond payments, so we have little expense in Gainesville. Are we planning to attempt another mission work in Gainesville? Probably, but not now. We have invested about 20 years and many thousands of dollars in the Gainesville mission without any lasting success. We believe it is time to give it a rest. We are most reluctant to ask people across the denomination to again invest in Gainesville. To revive this work would be so costly as to prevent or seriously delay our starting a new work in another Florida city. We believe it wise to leave the Gainesville property as is for now, and focus our energies and finances elsewhere. Later, as the Lord directs and provides, we will still have the property in which to make a new start. Again, pray with us about his matter.

We commend Leroy Cutler and express appreciation on behlf of the board and the entire State Association for his faithful service (approximately 14 years) on the Home Mission Board.



# Historical Commission Report



In the year since its formation, the Historical Committee has taken as its major goal the ititial publication of an annual historical bulletin, entitled *The Historical Review*. We are happy to have completed this publication in time for our State Association Meeting. This first issue contains the following articles:

"Our Fathers Have Told Us" - a devotional meditation on the purpose and value of church history.

"The Death of Polycarp" - an early martyr story from the year A.D. 168

"Who Now Will Follow Chirst in Life" - a hymn written in 1527 by George Wagner, a German Anabaptist, before his execution

"The English General Baptists" - a very detailed, scholarly study of the history and theology of the English Baptists of the early 1600's.

"The Standard Confession of 1660" - a reprint verbatim of the early English Baptist confession which was brought to America and used by our Free Will Baptist forefathers in the Carolinas

"Origins of Free Will Baptists in West Florida" a ground-breaking article which shows the connection between Liberty
and Salem Associations and the early nineteenth-century Free Will
Baptists of North Carolina

"A Prince and a Great Man" - the last article by Sister Laura Belle Barnard before her recent death, a biography of our own Dr. E.L. St. Claire.

"What Free Will Baptists Believe and Why" - a sermon preached by Dr. St. Claire about 1890 describing the Biblical basis of our faith and practice.

We published enough for each church to have three copies, but we also had some extra copies printed. They are available for \$2.50 each. The total cost of the publication was \$313.96 (which will be reflected, of course, in the 1993 Treasurer's Report). Our present financial status is as follows:

We thank the Executive Board for the gift of \$500 which it made to us in its meeting in November. These funds will keep us going for one or two more years. We encourage our churches to read *The Historical Review*, to pass around the copies, to use them as the basis of a group study of church

history in general, and our Florida Free Will Baptist history in particular. We encourage all delegates and visitors at the State Association to visit the exhibit table and to look at some of our display of books, minutes, and photographs which pre-date the National Association.

The State Historical Committee thanks you for the opportunity of serving the State Association this year and asks for your prayers and support in their efforts.

# CONSTITUTION AND BY-LAWS OF THE FLORIDA STATE ASSOCIATION OF FREE WILL BAPTISTS

### **PREAMBLE**

### ARTICLE I - NAME OF ASSEMBLY

Section 1. This assembly shall be known as "The Florida State Association of Free Will Baptists".

### **ARTICLE II - REPRESENTATION**

<u>Section 1.</u> This Association shall be composed of delegates elected from the local associations belonging to this body and delegates elected from the local churches embraced by the various associations.

Section 2. All deacons and ministers who are members of, and in good standing with, a local church and local association which are members of this body are standing delegates.

Section 3. The general officers of this body shall be standing delegates.

Section 4. The delegates shall be elected as follows: One (1) delegate for each local church composed of 100 members or fraction thereof, and one(1) delegate for each additional 100 members or fraction thereof; five (5) delegates from each local association composed of fifteen (15) churches or fraction thereof, and one(1) additional delegate for each additional four (4) churches or fraction thereof. These additional delegates cannot be used unless the churches are active and are represented in the session in which they are appointed.

### ARTICLE III - OFFICERS, BOARDS AND COMMITTEES

Section 1. Officers: the officers of this association shall be a Moderator, Assistant Moderator, Secretary, Assistant Secretary, and Treasurer.

Section 2. Boards: The standing boards of this association shall be Home Missions, Christian Education, and Youth Boards.

Section 3. The Executive Committee shall be composed of the Moderator, Assistant Moderator, Secretary, Treasurer, the chairman of each standing board, and one elected member from each affiliated district association. District associations shall recommend their representative on the Executive Board annually. A majority of members shall constitute a quorum.

Section 4. When vacancies occur either by death, removal from office, or by resignation, the general officers shall appoint a temporary replacement until the next regular session of this body, at which time the body shall elect a permanent replacement. A proxy may be appointed by the body to fill any absentee's place who does not attend the session.

Section 5 General officers of this Association shall serve for the term of two (2) years.

Section 6. Each standing board shall be composed of five (5) members which shall be elected for five (5) year terms on a rotating basis, so that one new member shall be elected yearly.

Section 7. This body shall have the right to discipline any officer or board member who does not conduct his office in a Christian and business-like manner according to the rules of christian conduct laid down in the New Testament.

### ARTICLE IV - MEETINGS

<u>Section 1.</u> Regular: This association shall convene annually in a joint meeting with the State Woman's Auxiliary and the Youth Competition on Wednesday evening, Thursday, Friday and Saturday after the first Sunday in May.

Section 2. Special: The Executive committee may be called into session by the moderator, or by a majority of its members.

Section 3. Quorum: Fifty (50) percent of the delegates shall constitute a quorum.

### **ARTICLE V - FINANCES**

Section 1. All churches and associations in this body shall pay a representation fee annually. The amount of this fee for an association of \$30.00 per member church. The fee for local churches is \$10.00 per delegate.

Section 2. All Cooperative Plan funds coming into this body shall be spent under a budget plan. This budget must be approved by the body while in session, and no funds may be used in any way except as budgeted.

Section 3. Mileage for the Executive Committee members and standing Board members shall be paid at the I.R.S.. rate for that fiscal year. Expenses are to be paid from each Board member's account. If a called meeting requires a member to stay overnight, his room and board will be paid from the General Fund or his Board's account. Mileage and expenses shall be paid for the Moderator to attend the denomination's annual leadership conference.

### **BY-LAWS**

Section 1. It shall be the duty of the Moderator to preside over all deliberations of this body while in session. All meetings shall be governed by Roberts Rules of Order.

<u>Section 2.</u> The Assistant Moderator shall assume the duties, rights and privileges of the Moderator in his absence.

Section 3. It shall be the duty of the Clerk to make and keep records of all the business proceedings and activities of this body.

<u>Section 4.</u> It shall be the duty of the Treasurer to receive all funds, pay all bills, and submit records when leaving office. The Treasurer must give bond while filling this office.

<u>Section 5.</u> Each officer and board member must be a member in good standing of a Free Will Baptist Church which is a member of this body. He must be in good standing with his local association, and must live within the boundaries of this Association. No person shall serve on more than one board at the same time.

Section 6. The Executive Committee shall have full authority to do all acts for and in the name of the Association when the Association is not in session.

<u>Section 7.</u> Amendments to this Constitution and By-Laws must be put before the body while in session one day before voted on, and must be read at least twice and passed by two-thirds of the delegates present.

# CONSTITUTION AND BY-LAWS OF THE FLORIDA FREE WILL BAPTIST HOME MISSION BOARD

### ARTICLE I - NAME

This Board shall be known as the Florida Free Will Baptist Home Mission Board, Inc.

### **ARTICLE II - PURPOSE**

The purpose of this board shall be that of promoting mission work among Free Will Baptists in the State of Florida.

### ARTICLE III - MEMBERSHIP

This board shall be evomposed of members elected by the State Association and shall serve terms established on a retational basis. One member's term shall expire annually. Thenumber of members of this board shall be determined by the Constitution and By-Laws of the State Association.

### ARTICLE IV - OFFICERS AND COMMITTEES

Officers of this board shall be Chariman and Secretary/Treasurer. These officers shall hold office for one(1) year and may be elected to serve succeeding terms. Members of the board shall elect the officers of the board. Committees may be appointed by the chairman elected by the board as the need arises.

### ARTICLE V - MEETINGS

Meetings shall be held as the need arises. Necessary meetings may be called by the chairman or the secretary/treasurer.

**ARTICLE VI - FINANCES** 

This board shall receive its finances from churches and individuals making special contributions, cooperative program allocations, interest on loans, and special offerings received through promoting missions. Mileage for board member expenses shall be paid from the general fund at the I.R.S. rate for that fiscal year.

### **BY-LAWS**

Section 1. Officers of the board shall hold office according to the terms set forth in the Constitution and shall carry out those duties peculair to the respective offices. The Secretary/Treasurer shall maintain a permanent record of the Board's activities and financial transactions. All records and property mortgages and titles held be surrendured to the succeeding Secretary/Treasurer.

<u>Section 2.</u> A majority membership shall constitute a quorum and be duly authorized to transact business. All items of business must receive a majority vote of a quorum before it is considered final. All members not present in meetings shall be notified of decisions made by the Board.

<u>Section3.</u> All members shall endeavor to support mission work through cooperative efforts of the board. Any member that fails to cooperate with the board for a period of one year may, upon recommendation of the board, be replaced by the State Association.

<u>Section4.</u> A complete report of the board meetings and activities and a complete financial report must be presented to the annual State associational Meeting.

Section 5. Missions and churches receiving financial support from this board must be Free Will Baptists which prove themselves sound in doctrine and practices as Free Will Baptists.

Section 6. Missions and churches receiving financial support from this board shall consider this board as an advisory body in such matters as the selection of a pastor and further financial obligations.

Section 7. Any work receiving financial support must agree to support the denominational cooperative program.

<u>Section 8.</u> Any work receiving financial support as a loan must accept such on terms and conditions agreed upon by them and the board as set forth in this constitution and such information shall be made available to them and fully understood by those receiving the support.

Section 9. Proper security must be granted the board for loans received. First mortgage is desired but second mortgage may be accepted; however, no loan shall be granted in excess of the appraised value of the property. Interest shall be paid at the rate of 6% per annum. Monthly payments shall be paid at the rate of \$10.00 per \$1000.00 loaned.

Section 10. Missions or churches receiving financial support must be in good standing with an association or quarterly meeting affiliated with the state or national association and must have a pastor who is in good standing with the Free Will Baptist denomination.

Section 11. An agreement must be understood between the borrower and the board that in the event financial obligations cannot be met and rights to the property must be relinquished that siad rights shall be turned over to the Mission Baord and the decision of the board in regards to the property shall be final.

Section 12. Contracts heall be considered delinquent when three (3) successive payments have not been met. It shall be determined by teh board if contracts may be held valid and open for a longer period of time.

. Section 13. The board shall have the right by majuority vote to purchzse property in desirable locations when there is good potential for organizing a Free Will Baptist Church. This action shall of necessity be subject to the availability of funds. In such matters full title must be acquired and no investment shall exceed the appraised value of property. Organizational work under such conditions shall be under complete supervision of the MIssion Board.

Section 14. The board shall have the right by majority vote to sell any personal or real property it deems is not necessary for continued religious use.

Section 15. Nominal grants by the board to worthwhile churches ormissions may be made when it is in the interest of hte denominational cause in which benefits are certain. Grants of this nature shall be subject to money being immediately available and shall not exceed \$1000.00 without joint approval of themission board anbd the state executive committee or association.

# CONSTITUTION AND BY-LAWS OF THE FLORIDA STATE YOUTH BOARD

### **ARTICLE I - NAME**

This board shall be known as the Youth Board of the Florida State Association of Free Will Baptists.

### ARTICLE II - DUTIES OF THE BOARD

<u>Section 1.</u> The duties of this board shall be to promote Youth Camps, Youth Rallies, and to be a coordinating agency between District, State, and National offices.

Section 2. To set up and direct CTS competitive activities.

Section 3. This board shall give a report of its activities to the Florida State Association's annual meeting.

### **ARTICLE III - MEMBERSHIP**

Section 1. This board shall consist of five members

Section 2. Tenure of office - the members of this board shall be elected for a term of five years and arranged whereby only one member's term expires annually.

Section 3. Vacancies - In the event irregular vacancies occur on this board, they will be filled by the Florida State Association.

Section 5. Organization - the board shall elect a chairman and a secretary.

### **ARTICLE IV - TRAVEL EXPENSES**

Mileage shall be paid at the current IRS rate for that fiscal year for all meetings except the board meeting in connection with the State Association. Any called meeting that requires a member to stay overnight - his room and board shall be paid from the Youth Fund account.

### ARTICLE V

This constitution and by-laws may be ammended by a majority vote of the State Association.

### CONSTITUTION OF THE CHRISTIAN EDUCATION BOARD

### ARTICLE 1 - NAME

This board shall be known as the Christian education Board of the Florida State Association of Free Will Baptists.

### ARTICLE II - PURPOSE

The purpose of this board shall be to promote the educational aims of the Florida State Association of Free Will Baptists among these: statewide Bible Institutes, Teacher training programs, Sunday School, CTS, Free Will Baptist Colleges and any other training methods that will help in the growth of our churches.

### ARTICLE III - THE BOARD

Section 1. Composition - This Board shall be composed of five members.

Section 2. Tenure of Office - The members of this board shall be elected for a term of five years and arranged whereby that only one member's term expires annually.

Section 3. The Board shall elect a Chairman, Assistant Chairman, and Secretary/Treasurer, which shall be elected annually.

Section 4. Vacancies - In the event irregular vacancies occur on this board, they will be filled by the Florida State Association.

Section 5. The Board shall meet at least once a year and/or whenever a meeting is deemed necessary.

### ARTICLE IV - DUTIES OF THE BOARD

Section 1. To create a statewide Bible Institute program that will assist and encourage the development of regional extensions in each local association.

<u>Section 2.</u> To assist and encourage the growth of Sunday Schools through Sunday School conventions, workshops, etc.

Section 3. To p[romote the organizing of new CTS groups and to assist in the training portion of existing CTS groups.

<u>Section 4.</u> To encourage the young people of our churches to further their education in our denomination's institutions.

### ARTICLE V - TRAVEL EXPENSES

Mileage shall be paid at the current IRS rate for the fiscal year for all meetings except the board meeting in connection with the State Association. If a called meeting requires memebers to stay overnight the room and board of each member will be paid.

### **ARTICLE VI - COMMITTEES**

Committees may be appointed by the chairman or elected by the board as the need arises.

### **ARTICLE VII - REPORTS**

A complete report of the board meetings and activities, and a complete financial report must be presented to the annual State Asociation meeting.

### **ARTICLE VII - AMENDMENTS**

This constitution may be amended by a majority vote of the board members and final approval of the State Association.
