




Minutes of the 52nd Annual Session Florida State Association of Free Will Baptists May 8 - 11, 1996



The 52nd Annual Session of the Florida State Association of Free Will Baptists convened at the Ocala Hilton in Ocala, Florida on May 8 - 11, 1996. This was a joint meeting of the State Association, the State Youth Convention, and the Florida Women Active for Christ. The theme for the State Association was "Boldly To The Throne".

A Year in Review

Competition

Youth Competition continues to be a major emphasis of our State Meeting thanks to the diligence of our youth, the Christian spiritedness of our coaches, the encouragement of parents, the excellent work of our competition Judges, and the coordinating efforts of our Youth Board. Last year, approximately 400 parents, kids, coaches and friends gathered for Competition events.

Youth competition is an excellent program offering our youth training in the Scriptures, music, oral communication, and more. Mentoring relationships are established between kids and coaches. Young people are able to discover their strengths and strengthen their

Executive Secretary's Report

"Praise God from Whom all blessing flow." God has indeed blessed Florida Free Will Baptists. Overall, our churches have grown, souls have been saved, many of our people seem to be growing in the likeness of our Savior, and our finances continue to improve. Opportunities abound for Florida Free Will Baptists. Yes, there have been difficulties along the way. But those difficulties have provided opportunities for personal, denominational, and spiritual growth.

Looking Back

You have been gracious and thoughtful toward me during these past months. You have allowed me to be in your churches, quarterly meetings, youth camps, and camp meetings. You have given me the privilege of presenting the state ministries to your people. Many of you have responded by supporting Florida State Association ministries. Thank you.

■Together Way■

We praise the Lord for a greater involvement of our churches in the "Together Way" support of our state and national ministreis. According to the 1995 Treasurer's report, 44 of our 70 Floida Churches supported Co-op. This is an increase from 36 in 1994. Thank you for catching the vision of what can happen when we work together.

It is Biblical to call the Florida State Association of Free Will Baptists a "body" or "family". A body in which all its members do not function in cooperation with the rest of the body will be a sick and weak body. A family in which there are members that fail to respond to other family members' needs will become a dysfunctional family. There are too many souls at stake, too little time, and too much to lose for Chrsit's sake for Florida Free Will Baptist to splinter themselves, be sick and weak, or become dysfunctional. God is calling Florida Free Will Baptists to a much larger task than just what happens within the four walls of any one of our local churches. Together we can accomplish God's will for us.

A special thank you goes out to those local churches, associations, and the individuals who have placed the Executive Office in

your budgets and have given special offerings or gifts for the upkeep of the office.

■Randall House

A good percentage of our Florida churches purchase Sunday School, CTS, VBS, and other church supplies through the Executive Office. In doing this, you have given additional support to the State Association. This comes about through the generosity of Randall House Publications. Dr. Loveless and Randall House have graciously entered into an arrangemnt allowing us to handle their materials. In the beginning it has cost Randall House money. If Randall House allows us to continue with this arrangement, our goal is to make it a worthwhile venture for them, as well as for Florida Free Will Baptists. Thank you, pastors and churches, for casting your lot with us with a vision to build a strong state program in Florida.

Some of you use material for Sunday School, Church Training, VBS, and other church supplies that are not Randall House publications. Please let me urge you to purchase those materials through the State Executive Office. By doing this you will help your state ministry and you will help Randall House recover some of the loss it has sustained through its generosity to Florida Free Will Baptists.

■LifeLine Long Distance Service ■

LifeLine Long Distance Telephone Service continues to be a source of income to help fund our state ministries. The income has leveled out at around \$300.00 per month. This income varies month by month depending on how much those who suubscribe to LifeLine "reach out and touch" others. It will increase or decrease depending on the number of subscribers to LifeLine who designate Florida State Association of Free Will Baptists as the recipient of their contribution.

Thank you for your generosity in allowing a percentage of the income from Randall House and LifeLine to be added to my income this year. If the State Association adopts the 1997 budget, or the principles of the budget recommended by the Budget Committee, these incomes will go into the general fund and be disbursed along with the other State Association income. No portion of it will be designated as supplemental salary for the Executive Secretary.

■The Present Look■

Recently, a group of people in Sebring committed themselves to begin a new Free Will Baptist Church. They bought property, incorporated, and then on March 31, 1996, held their first service in their own building. Pray for this new church. They are now seeking an energetic pastor to serve with them on a permanent basis. Retired minister, Rev. James Klingensmith, serves as interim. Others in different sections of the state have expressed an interest in similar enndeavors.

Other opportunities for ministry continue to open to us. With e-mail capabilities available to us, we have opportunity to advertise our state association churches, make Bible Studies available to many who were closed to us previously, stay in touch with our missionaries, and become missionaries individually and as a state body.

I have personally gone on the Internet. Included with my monthly rate I have been able to establish a web page for the Florida State Association of Free Will Baptists. On this I plan to advertise state activities, local churches that want to be advertised on the Internet, provide Bible Studies and sermons prepared by Florida Free Will Baptist pastors, correspond with our missionaries and unsaved people I will never see, and promote Randall House. If you are interested in being a part of this ministry, tell me. Even though this is my personal project, it also becomes a state ministry for those who wish to be involved.

■Looking Ahead■

Doors of opportunity continue to open. We need to prepare to step through as many as our Lord may desire that we enter. I share the following concerns as we look to the future until Jesus comes for us:

- 1. We desperately need to pray that God will call dedicated, disciplined, determined, and developed men to the ministry to pastor our churches.
- 2. We need to examine some alternative approaches to solving some of our pastoral needs. To be precise, we have smaller churches across the state unable to pay pastors a sufficient salary for them to devote their full time to the church ministry. However, with a little shuffling of service schedules, churches that are in proximity of each other could share the same pastor, pay him a full-time salary, and both would have a pastor who would be devoting his full time to them. More capable churches could share their pastors with the smaller struggling ones. After all, we are all in His minstry.


- 3. It will be to our profit to begin an annual all-boards meeting. This will provide opportunity for all of our boards to meet, make cooperative plans, pray together, and in general learn each others needs and hopes. Since each board meets at least once during the year, this approach should not increase expenses, we will only need to arrange our meeting times so that we all meet at the same time.
- 4. We are approaching a senior adult population in Florida, along with the rest of our nation. Florida Free Will Baptists can seize the opportunity. We should consider a state-wide senior adult ministry program. The responsibility for this program could come under the Executive Office temporarily to cut down on cost, or a Commission for Senior Adults could be created. The results of such a ministry is no doubt beyond our fondest dreams.

Conclusion

Thank you for your generous acceptance of my wife, Margie, and myself. We join you because we want to serve our Lord and help build His Kingdom and Free Will Baptists in Florida, our native state. In this report I have attempted to be factual and upbeat. I have desired to share some concerns and dreams. I have asked you to join together in the eternal work of Christ as Florida Free Will Baptists. The future is bright "til He comes.



Home Mission Board Report



1995 was a good year for Florida Home Missions. Speaking for the Mission Board and our missionaries, we are grateful for the support that you have given us over the past year. We are keenly aware that without your prayer and financial support we could not have a mission outreach to the state of Florida.

When Bro. Curtis Alligood went to the Bayshore FWB Mission in St. Petersburgh, he inherited a \$185,000 debt. The church was paying \$25,000 per year *in interest*. A major goal of Bro. Curtis has been to erase the mortgage. Due to his good stewardship, the generosity of his people at Bayshore, and your gifts over the years, the church now needs only \$8,000 to be debt free. A "snow bird" in the congegation offered to match, dollar for dollar, contributions on the final \$30,000 of indebtedness. The church has raised \$7,000 and now needs to raise only the remaining \$8,000 in order to be free of the debt. We would encourage Free Will Baptists across the state to help the Bayshore Church retire this debt. Bro. Curtis and Mrs. Laverne Alligood are to be commended for their good leadership in this church.

The Faith Chapel Church in Jacksonville has experienced some of the growing pains that come with a new work. Bro. Odis Whitehead has labored faithfully in Jacksonville, and has guided th church through some difficult problems. Bro. Whitehead and Sister Mary Nell Whitehead are to be commended for their faithfulness and hard work as they and the people work to build a self-supporting Free Will Baptist Church in Jacksonville. the church continues to see people saved on a regular basis, and is faithfully seeking ways to minister to their community. This church, like Bayshore a few years ago, labors under a heavy mortgage. Our state will need to consider some special project to help ease the debt burden on this young church in the near future.

Our newest work, the Renacer FWB Mission in Miami, continues to do well. Under the leadership of mission pastor Jose Rodriguez, he Renacer Church is having a good ministry among the Cuban population of Miami. the church has worked very hard at renovating their building, the old Ebenezer FWB Church, and has a very beautiful building that serves as a base for their ministry. The church operates a day care

center, is doing well finanacially, but most importantly, is seeing people saved on a regular basis. Bro. Rodriguez and his new wife are to be commended for the work they are doing in Miami.

Our board has been deeded possession of the Friendship Church in Jacksonville after the church closed. After renting this property for some time, we have sold it to the Bible Believer's Baptist Church of Jacksonville for \$116,000. The proceeds from this sale will provide us with a monthly income to help our mission churches in Florida.

Again, we are grateful for the faithful support of our people in Florida. Without your prayers and finanacial support, mission work in our state would be only a dream. We encourage our churches to "adopt" at least one of our mission works. Put them in your budget, pray for them, and correspond with them on a regular basis. Let them know that, having sent them, we have not forgotten them. Assure them of your continued prayer and financial support.



Audit Committee Report

We, the Audit Committee, examined the treasurer's report and accounting procedures for the Christian Education Board, Youth Board, Mission Board, and State Treasurer for this year.

In our opinion, the financial statements of the above mentioned boards present fairly in all material respects the financial positions of these boards, their operations, and cash flow, in conformity with general accounting principles and procedures.

Also, for the purpose of conformity and to put each board treasurer on line with the same general practices, we recommend the following:

- 1. That all cash received through offerings from individuals or churches, or money that is sent directly or given directly to each board treasurer, should be verified by a cash voucher form and signed by the individual or organization that is presenting the offering.
- 2. That there be a meeting of all board treasurers and the audit committee to determine standard forms for accounting procedures so that all funds will be handled in a consistent and orderly manner. This will also make the job of this committee easier to regulate and determine accounting procedures.

Executive Committee Report



Having met on May 8, 1996, the Executive Committee would like to present the following items:

- 1. We recommend the adoption of the budget for the calendar year, 1997, and that the Treasurer have the authority to transfer budget allocations between the following account numbers: Accounts 759 through 766 and Accounts 804 through 885, and that the Executive Committee, if necessary be authorized to prorate a percentage reduction of all budget items.
- 2. We recommend that the Planning Committee, along with Bro. Sasser, be alloted up to \$12,000 to purchase a vehicle for the Executive Secretary to use in the fulfillment of the duties of the Executive Office.
- 3. We recommend that the cost of the automobile be amortized over four years, through the Executive Secretary's auto expense budget.
- 4. We recommend that the funds designated for "The Promotional Fund", "The Executive Baord", and "The Executive Secretary" should be reflected on the financial statements as categories of the General Fund.
- 5. In order to facilitate the accounting of our expenditures, we recommend that a corporate credit card be secured for the Executive Secretary's use.
- 6. We recommend the adoption of the following "Mission Statement":
 Definition: Who we are as Florida Free Will Baptists
 Purpose: Why we exist as a body in Florida
 Mission: What God is calling us to do

Definition:

The Florida State Association of Free Will Baptists is a fellowship of Christian believers, united to extend the witness of christ and the building of His Church in the State of Florida and throughout the world.

Purpose:

The purpose of the Florida State Association of Free Will Baptists is to promote fellowship among Florida Free Will Baptists and to provide opportunity for our churches to accomplish cooperatively what they cannot do individually.

Mission:

God is calling the Florida State Association of Free Will Baptists to obey His Great Commandment (Luke 10:27) and to fulfill His Great Commission (Matthew 28:18-20) through:

- The Exaltation of the Lord Jesus Christ (John 4:24, I Corinthians 10:31)
- *The Evangelization of the Lost (Mark 16:15, Acts 1:8)
- The Establishment of Biblical churches (Acts 2:42-47, 16:5)
- *The Equipping of the Saints
 (Ephesians 4:11-13, II Timothy 2:2)

- 9. We recommend that Bro. Sasser be placed on the State's checking account in order to fulfill the Treasurer's responsibilities in case of an emergency.
- 10. We recommend that the Moderator be authorized to appoint two District Association sponsored representatives to the Alabama Children's Home Board.

- 11. We recommend that we give the Treasurer \$75.00 per month.
- 12. We recommend that we give the Moderator and Clerk \$300 each as honorariums.
- 13. We recommend that we give a \$100 honorarium to each of this year's speakers.




Resolutions Committee Report





CONSTITUTION AND BY-LAWS OF THE

FLORIDA STATE ASSOCIATION OF FREE WILL BAPTISTS

PREAMBLE

ARTICLE I - NAME OF ASSEMBLY

Section 1. This assembly shall be known as "The Florida State Association of Free Will Baptists.

ARTICLE II - REPRESENTATION

<u>Section 1.</u> This Association shall be composed of delegates elected from the local associations belonging to this body and delegates elected from the local churches embraced by the various associations.

Section 2. All deacons and ministers who are members of, and in good standing with, a local church and local association which are members of this body are standing delegates.

Section 3. The general officers of this body shall be standing delegates.

Section 4. The delegates shall be elected as follows: one (1) delegate for each local church composed of 100 members or fraction thereof, and one (1) delegate for each additional 100 members or fraction thereof; five (5) delegates from each local association composed of fifteen (15) churches or fraction thereof, and one (1) additional delegate for each additional four (4) churches or fraction thereof. These additional delegates cannot be used unless the churches are active and are represented in the session in which they are appointed.

ARTICLE III - OFFICERS, BOARDS, AND COMMITTEES

Section 1. Officers: the officers of this association shall be a Moderator, Assistant Moderator, Secretary, Assistant Secretary, and Treasurer, to be elected by this body while in regular session.

Section 2. Boards: The standing boards of this association shall be Home Missions, Christian Education, and Youth Boards.

Section 3. When the State Association deems it wise, committees or commissions may be established to perform a specific service in a restricted area on a more or less permanent basis. The number of members and their terms of office of any committee or commission shall be decided by vote of the State Association, and the members shall be elected by the Association.

<u>Section 4.</u> The Executive Committee shall be composed of the Moderator, Assistant Moderator, Secretary, Assistant Secretary, Treasurer, the chairman of each standing board, and one elected member from each affiliated District Association. District Association shall recommend their representatives on the Executive Board annually. A majority of members shall constitute a quorum.

Section 5. When vacancies occur either by death, removal from office, or by resignation, the general officers shall appoint a temporary replacement until the next regular session of this body, at which time the body shall elect a permanent replacement. A proxy may be appointed by the body to fill any absentee's place who does not attend the session.

Session 6, General officers of the Association shall serve for the term of two (2) years.

Section 7. Each standing board and the Historical Commission shall be composed of five members which shall be elected for five year terms on a rotating basis, so that one new member shall be elected annually.

The auditing committee shall be composed of three members which shall be elected for three year terms on a rotating basis, so that one new member shall be elected annually. Members of the auditing committee may not be members of any standing board or committee.

The Budget Committee shall be composed of the Executive Secretary, Moderator, and chairman of each standing board.

Section 8. This body shall have the right to discipline any officer or board member who does not conduct his office in a Christian and business-like manner according to the rules of Christian conduct laid down in the New Testament.

Section 9. The Executive Committee is to hire an Executive Secretary and to direct his office. The Executive Secretary is to be a non-voting member of all boards and committees.

ARTICLE IV - MEETINGS

Section 1. Regular: This association shall convene annually in a joint meeting with the State Woman's Auxiliary and the youth Competition on Wednesday evening, Thursday, Friday and Saturday after the first Sunday in May.

<u>Section 2.</u> Special: The Executive Committee may be called into session by the Moderator, or by a majority of its members.

Section 3. Quorum: Fifty (50) percent of the delegates shall constitute a quorum.

ARTICLE V - FINANCES

Section 1. All churches and associations in this body shall pay a representation fee annually. The amount of this fee for an association is \$30.00 per member church. The fee for local churches is \$10.00 per delegate. Section 2. All Cooperative Plan funds coming into this body shall be spent under a budget plan. This budget must be approved by the body while in session, and no funds may be used in any way except as budgeted. Section 3. Mileage for the Executive Committee members and standing Board members shall be paid at the IRS. rate for that fiscal year. Expenses are to be paid from each Board member's account. If a called meeting requires a a member to stay overnight, his room and board will be paid from the General Fund or his Board's account. Mileage and expenses shall be paid for the Moderator to attend the denomination's annual leadership conference.

BY-LAWS

Section 1.. It shall be the duty of the Moderator to preside over all deliberations of this body while in session. All meetings shall be governed by Roberts Rules of Order.

Section 2. The Assistant Moderator shall assume the duties, rights and privileges of the Moderator in his absence.

Section 3. It shall be the duty of the Clerk to make and keep records of all the business proceedings and activities of the body.

Section 4. (1) It shall be the duty of the State Association treasurer, or someone designated by the State body, to receive all funds, pay all appropriate bills, disburse co-operative and designated funds in a timely manner according to the State Association's budget. (2) It shall be the duty of each State Board treasurer to receive all funds for the board he serves, pay all appropriate bills, and disburse appropriate funds in a timely manner. (3) The State Association treasurer and all State Board treasurers shall use the same accounting system. (4) Each treasurer of the State Association shall submit his/her records to the State Association's Audit Committee annually for audit.

Section 5. It shall be the duty of the audit committee to conduct a financial audit of each treasurer's books annually. The audit shall take place after the fiscal year and before the State Association convenes. The date for the audit will be agreed upon by the audit committee and the various treasurers who shall be present at the time their books are audited.

<u>Section 6.</u> It shall be the duty of the Budget Committee to make recommendations to the State Association concerning the total State Association Budget and the allocations of State Cooperative receipts.

Section 7. Each officer, board member, and standing committee or commission member must be in good standing with a Free Will Baptist Church which is a member of this Body. He must be in good standing with his local association, and must live within the boundaries of this Association. No person shall serve on more than one board at the same time.

Section 8. The Executive Committee shall have full authority to do all acts for and in the name of the Association when the Association is not in session and shall make a general report of all their actions to this body annually.

Section 9. Amendments to this Constitution and By-Laws must be put before the body while in session one day before voted on, and must be read at least twice and passed by two-thirds of the delegates present.

CONSTITUTION AND BY-LAWS OF THE FLORIDA FREE WILL BAPTIST HOME MISSION BOARD

ARTICLE I - NAME

This Board shall be known as the Florida Free Will Baptist Home Mission Board, Inc.

ARTICLE II - PURPOSE

The purpose of this board shall be that of promoting mission work among Free Will Baptists in the State of Florida.

ARTICLE III - MEMBERSHIP

This board shall be composed of members elected by the State Association and shall serve terms established on a rotational basis. One member's term shall expire annually. The number of members of this board shall be determined by the Constitution and By-Laws of the State Association.

ARTICLE IV - OFFICERS AND COMMITTEES

Officers of this board shall be Chairman and Secretary/Treasurer. These officers shall hold office for one (1) year and may be elected to serve succeeding terms. Members of the board shall elect the officers of the board. Committees may be appointed by the chairman elected by the board as the need arises.

ARTICLE V - MEETINGS

Meetings shall be held as the need arises. Necessary meetings may be called by the chairman or the secretary/treasurer.

ARTICLE VI - FINANCES

This board shall receive its finances from churches and individuals making special contributions, cooperative program allocations, interest on loans, and special offerings received through promoting missions. Mileage for board member expenses shall be paid from the general fund at the IRS rate for that fiscal year.

BY - LAWS

Section 1. Officers of the board shall hold office according to the terms set forth in the Constitution and shall carry out those duties peculiar to the respective offices. The Secretary/Treasurer shall maintain a permanent record of the Board's activities and financial transactions. All records and property mortgages and titles shall be surrendered to the succeeding Secretary/Treasurer.

Section 2. A majority membership shall constitute a quorum and be duly authorized to transact business. All items of business must receive a majority vote of a quorum before it is considered final. All members not present in meetings shall be notified of decisions made by the Board.

Section 3. All members shall endeavor to support mission work through cooperative efforts of the Board. Any member that fails to cooperate with the board for a period of one year may, upon recommendation of the Board, be replaced by the State Association.

Section 4. A complete report of the Board meetings and activities and a complete financial report must be presented to the annual State Association Meeting.

Section 5. Missions and Churches receiving financial support from this Board must be Free Will Baptists which prove themselves sound in doctrine and practices as Free Will Baptists.

Section 6. Missions and Churches receiving financial support from this Board shall consider this Board as an advisory body in such matters as the selection of a pastor and further financial obligations.

Section 7. Any work receiving financial support must agree to support the denominational cooperative program.

<u>Section 8.</u> Any work receiving financial support as a loan must accept such on terms and conditions agreed upon by them and the Board as set forth in this constitution and such information shall be made available to them and fully understood by those receiving the support.

Section 9. Proper security must be granted the Board for loans received. First mortgage is desired but second mortgage may be accepted; however, no loan shall be granted in excess of the appraised value of the property. Interest shall be paid at the rate of 6% per annum. Monthly payments shall be paid at the rate of \$10.00 per \$1000.00 loaned.

Section 10. Missions or churches receiving financial support must be in good standing with an association or quarterly meeting affiliated with the state or national association and must have a pastor who is in good standing with the Free Will Baptist denomination.

Section 11. An agreement must be understood between the borrower and the Board that in the event financial obligations cannot be met and rights to the property must be relinquished that said rights shall be turned over to the Mission Board and the decision of the Board in regards to the property shall be final.

Section 12. Contracts shall be considered delinquent when three (3) successive payments have not been made. It shall be determined by the Board if contracts may be held valid and open for a longer period of time.

Section 13. The Board shall have the right by majority vote to purchase property in desirable locations when there is good potential for organizing a Free Will Baptist Church. This action shall of necessity be subject to the availability of funds. In such matters full title must be acquired and no investment shall exceed the appraised value of property. Organizational work under such conditions shall be under complete supervision of the Mission Board.

Section 14. The Board shall have the right by majority vote to sell any personal or real property it deems is not necessary for continued religious use.

Section 15. Nominal grants by the board to worthwhile churches or missions may be made when it is in the interest of the denominational cause in which benefits are certain. Grants of this nature shall be subject to money being immediately available and shall not exceed \$1000.00 without joint approval of the Mission Board and the State Executive Committee or Association.

CONSTITUTION OF THE FLORIDA STATE YOUTH BOARD

ARTICLE 1 - NAME

The Board shall be known as the Youth Board of the Florida State Association of Free Will Baptists, Inc.

ARTICLE II - DUTIES OF THE BOARD

Section 1. The duties of this board shall be to: (1) Promote youth camps, youth rallies, and to be a coordinating agency between District, State, and National officers (2) Coordinate and direct CTS competitive activities (3) Encourage and equip church leaders in their ministry to youth

Section 2. This board shall give a report of its activities, board meetings and financial status to the Florida State

Section 2. This board shall give a report of its activities, board meetings and financial status to the Florida State Association at its annual meeting.

ARTICLE III - MEMBERSHIP

Section 1. This board shall be composed of five members who shall be elected for a term of five years and arranged whereby that only one member's term expires annually. In the event irregular vacancies occur on this board, they will be filled by the Florida State Association.

Section 2. Officers of this board shall be a Chairman, Secretary, and Treasurer. These officers shall hold office for one year and may be elected to serve succeeding terms. Members of the board shall elect the officers of the Board. Committees may be appointed by the Chairman as the need arises. The Secretary shall maintain a permanent record of all the Board's activities. The Treasurer shall keep a complete record of all financial activities of this board. All records and financial transactions are property of the Youth Board and shall be surrendered to new officers.

ARTICLE IV - MEETINGS

This board will meet semi-annually. Meetings may be called by the Chairman or the Secretary as the need arises.

ARTICLE V - FINANCES

This board shall receive its finances from churches and individuals making special contributions, cooperative program allocations, and special offerings received through promoting youth. Mileage, room and board shall be paid from the general fund of the Youth Board for all meetings. Mileage shall be paid at the current IRS rate.

ARTICLE VI - AMENDMENTS

This constitution and by-laws may be amended by a majority vote of the state.

CONSTITUTION OF THE CHRISTIAN EDUCATION BOARD OF THE FLORIDA STATE ASSOCIATION OF FREE WILL BAPTISTS

ARTICLE I - NAME

This board shall be known as the Christian Education Board of the Florida State Association of Free Will Baptists.

ARTICLE II - PURPOSE

The purpose of this board shall be to promote the educational aims of the Florida State Association of Free Will Baptists among these: statewide Bible Institutes, Teacher training programs, Sunday School, CTS, Free Will Baptist Bible Colleges and any other training methods that will help in the growth of our churches.

ARTICLE III - THE BOARD

Section 1. Composition - this Board shall be composed of five members.

Section 2. Tenure of Office - The members of this board shall be elected for a term of five years and arranged whereby that only one member's term expires annually.

Section 3. The Board shall elect a Chairman, Assistant Chairman, and Secretary/Treasurer, which shall be elected annually.

Section 4. Vacancies - In the event irregular vacancies occur on this board, they will be filled by the Florida State Association.

Section 5. The Board shall meet at least once a year and/or whenever a meeting is deemed necessary.

ARTICLE IV - DUTIES OF THE BOARD

Section 1. To create a statewide Bible Institute program that will assist and encourage the development of regional extensions in each local association.

Section 2. To assist and encourage the growth of Sunday Schools through Sunday School conventions, workshops, etc.

<u>Section 3.</u> To promote the organizing of new CTS groups and to assist in the training portion of existing CTS groups.

<u>Section 4.</u> To encourage the young people of our churches to further their education in our denomination's institutions.

ARTICLE V - TRAVEL EXPENSES

Mileage shall be paid at the current IRS rate for the fiscal year for all meetings except the board meeting in connection with the State Association. If a called meeting requires members to stay overnight the room and board of each member will be paid.

ARTICLE VI - COMMITTEES

Committees may be appointed by the chairman or elected by the board as the need arises.

ARTICLE VII - REPORTS

A complete report of the Board meetings and activities, and a complete financial report must be presented to the annual State Association Meeting.

ARTICLE VII - AMENDMENTS

This constitution may be amended by a majority vote of the Board Members and final approval of the State Association.
