



Minutes of the Fifty-sixth Annual Session of the



Florida State Association of Free Will Baptists

The fifty-sixth annual session of the Florida State Association of Free Will Baptists convened at the Holiday Inn Convention Center in Deland, Florida. The meeting was held on May 10-13, 2000 and was a joint meeting of the State Association, the Florida Women Active for Christ, and the Youth Conference. The theme of the State Association was "Two Ministries, One Call" and focused on the ministry of Bi-vocational pastors.

Wednesday, May 10, 7:00 p.m.

The service began with the congregation singing, "To God Be The Glory" and "I Love To Tell The Story". The music for this service was led by Rev. Danny Conn and Norm Hansen served as the presider. Jose Rodriguez led the congregation in prayer.

The fifty-sixth Annual Session was called to order by Clerk, Rev. Randy Bryant, who introduced our Moderator, Rev. Tim Owen. Rev. State Youth Ministries Report

Florida Youth Ministries enjoyed an active year in 1999. The State Youth Conference registered 89 entries which included 109 participants from fifteen churches representing five district associations. Forty-five entries advanced to the National Youth Conference, giving 89 youth from Florida the opportunity to go to Atlanta, GA. Florida youth placed first in 12 events at the NYC.

Bro Charlie Elliott attended the National FWB Youth Workers Retreat as our representative and will be hosting a seminar at the SYC to share insights on Children's Ministries with

our state youth workers. Bro Charlie and Bro Ryan McDougald have also worked together as the directors of the Active Christian Teens, our state version of Truth and Peace.

The first annual State Youth Workers Retreat was a tremendous success. Seventy two youth workers gathered from across the state at the Crystal River Resort to be challenged and equipped for ministry. Dean and Lisa Jones were our keynote speakers. Sam and June McVay will be speaking at the 2000 retreat in Ocala, FL.

The Missions Control project has raised \$10,459.94 toward our goal of \$50,000.00 for Florida Mission Shares by the 2003 National Convention. A youth missions trip is being scheduled for 2001 to help our youth focus on world evangelism.

The Youth Board met during the state meeting, at Pleasant Hill FWB Church on August 17th, and at Crystal River during the retreat. We have also maintained frequent contact by phone and email. We have developed a five-year plan of ministry which seeks to expand the efforts of the board to provide more opportunities for training and ministry for both youth and youth workers.

Thank you for allowing us the opportunity to serve.

Executive Secretary's Report 2000

General Information:

We rejoice that God has called us to be laborers together with Him, having placed us into His ministry. Florida Free Will Baptists have open doors of opportunity. I pray we shall continue stepping through them.

This Association begins the State Office's seventh year of continuous operation and our people are realizing its value. The office was first established in our home where it continues today. Margie and I have recently sold our house in Ocala and presently live in a doublewide mobile home there. The sale of our house in Ocala will enable Margie to retire and become a more active part of this ministry. We plan sometime after this state association to move to my old home place in Washington County. We were waiting until after this meeting to move so major changes in addresses and telephone numbers would not occur before this meeting.

The actual cost of the office operation should be less after the move. There will be additional travel in some areas but less in others. I have made arrangements with some of the leaders of the Central Association to use their facilities at Camp Eagle when my travel in the central and southern areas of the state requires me to stay overnight. This will help continue keeping motel expenses down. I have had the same arrangement with the West Florida Associations and Camp Mt. Pleasant for several years already.

I believe our future dream should include a physical state office in the Central Florida area. Until that dream is realized, it is logical to continue working with the Executive Secretary who maintains the office in his home so that he and the State Association are best served.

During 1999 we continued our pastoral ministry to pastors and local churches. As the pressure of the local church ministry continues to increase, the need for this type of ministry will escalate. In the last part of 1999 we focused a larger portion of time encouraging our people across the state to support Florida Ministries through the Together Way Plan, which includes cooperative giving, special Florida Ministries offerings, and other contributions. As a result, while we did not reach our original 1999 budget we were able to go over the contingency budget. This enabled our state boards and national ministries to regain some of the funds they had given up earlier.

Budget and Finances

The 2000 budget will be difficult to reach. However as we join our hands, our prayers, our goals, and our resources, we can reach it. While we must look at budgets and goals in these meetings lets be careful to not forget their purpose, which is winning the lost and discipling the saved, at home and around the world.

A review of the 1999 giving reveals success as well as areas needing improvement. I am providing you with a summary of income received from associations. These figures are based on the year end report from the State Association Treasurer. You may pick up a complete charted report at the state office booth.

The record shows that 25 Florida Free Will Baptist Churches do not yet tithe of their income to the larger bodies, which are the local, state, and national associations. The record also reveals that 28 of our churches did not support State and World Missions through Florida Shares. These churches are almost identical. One church that gave nothing in the way of tithes (CoOp) or Florida Shares did give \$50.00 to other missions through the state treasurer. While on the one hand the records reveal some progress in these areas, they also point up a tremendous need for training and commitment in total stewardship. Christians who are good stewards do give of their personal income and resources to the work of Christ through their denominational programs. The Executive Office is committed to informing and encouraging churches and church leaders regarding this important area of Christian doctrine and practice.

You will note that based on the number of churches and members in the associations that there is a disparity among the associations. This disparity is not representative of major economic differences among Floridians. It rather reveals that some of our churches and church leaders have not grasped the joy of being committed stewards of Christ's work in this age. I challenge each pastor to catch a vision of the potential God has given him

and his congregation in harmony with the potential Florida Free Will Baptist have as a team.

Suppose

According to the 1999 Digest of Reports the State Association membership totaled 5832. Lets do a little supposing with these figures.

- 1. Suppose that only 1/2 (or 2916) of the total membership received wages.
- 2. Suppose that the average annual income of those receiving wages were only \$20,000 (this is below the average). The annual income of Florida Free Will Baptists would have been \$58,320,000.00
- 3. Suppose that each income receiving person tithed his or her income to his or her local church. (That is Bible Doctrine with promised blessings attached.) The income of Florida Free Will Baptist Churches would have been \$5,832,000.00.
- 4. Suppose each church tithed its income from the tithes of their membership into their local associations. \$583,200.00 would have gone into our local associations.
- 5. Suppose that the State Association received only 60% of the \$583,200.00. that would mean that The State Association would have received \$349,920.00 in tithes alone and the local associations would have received \$233,280.00 for their local ministries and Missions. Let's make one more supposition.
- 6. Suppose we make our theme "The whole body witnessing the Gospel to the whole world as a team through total stewardship of each individual and each local church."

Minister's Retirement

The Florida State Association sets aside 5% of the state's church tithe receipts (CoOp) to be paid into the retirement of the pastors whose churches tithe their general income to the State Association. The 1999 budget called for \$3,600.00 to be paid into the retirement accounts of tithing pastors. Sadly some pastors did not receive their share of the retirement funds because they either do not have a retirement account with the Board of Retirement or because they have not communicated their account numbers to the state treasurer. It is the desire of the State Association to assist our pastors in preparation for retirement. It benefits the pastor to lead his church into becoming a tithing church. The Executive Office urges pastors to take advantage of this opportunity. The office stands anxiously ready to assist in this area.

OASIS

Five years ago the Executive Secretary began introducing the possibility of a Senior Adult Ministry. This year the Executive Committee is proposing to launch such a program through the recommendation to appoint an OASIS (Older Adult Saints In Service) Commission. I trust the State Association will enthusiastically adopt this proposal. Several Florida churches already have senior ministry organizations. Perhaps they could be enlisted to share their experiences as we launch a statewide ministry.

Bible Institutes

Training leadership within our churches must become a priority. The Executive Office and the Christian Education Board have for a number of years been encouraging churches and associations to begin Bible Institute programs. The purpose for such institutes is to train church and Sunday School leaders for leadership roles in our churches and the denomination. This has been a most difficult area to establish.

Two associations now have institute programs in place. The Hispanic Association has been very successful with their institute. The new association that has petitioned the state association at this meeting has included in its basic organization a Bible Institute program that is incorporated into their Quarterly Meetings in addition to other class times. Workshops, seminars, and course training are incorporated into each Quarterly Meeting of the Citrus Association. I encourage each association to follow this example and make your Quarterly Meetings times of training and learning, as well as fellowship and business.

Evangelical Training Association (ETA) materials for developing solid institutes and training programs are available through the State Office. The Christian Education Board and the State Office stand ready to help you develop a training program that will assist you, your association, and your local church grow and become a soul winning body. If as Florida Free Will Baptists we are to meet the needs of our communities we must train our people as Bible teachers, Sunday School workers, and church leaders. The Executive Office urges you to take advantage of these opportunities.

State Office Ministry

The Executive Office ministry continues to increase. The opportunities to minister to our churches and pastor continue to grow. For this we offer thanksgiving to God. As the responsibilities increase so do the demands on the Executive Secretary. We are at a point that we are in need of delegating certain key people in the state work to provide specific assistance. This year we will be asking for key leaders in each association to assist in this work by becoming an Executive Secretary's Partner. These partners will of necessity be people who support the State Association ministries. They will most generally be the moderators of the associations. We also plan to create an Executive Secretary's Prayer Team. We will be looking for one individual in each church who will commit to join this team.

These people will be kept informed as to the needs and progress of the State Association. They will be asked to help keep the Executive Secretary informed about needs of their local churches, pastors, and associations. They will be asked to pray daily for the State Association ministry, the Executive Secretary, and their pastors. These partners will help cut travel costs as they represent the State Association on behalf of the Executive Office.

The potential for Florida Free Will Baptists stretches far beyond our fondest dreams. Under God our possibilities are unlimited. I pray that we shall catch the vision, pursue the dream, and become a State Association of tithing believers and tithing churches, and as one team play a vital role in fulfilling our Lords Commission. This can be accomplished if we catch the total stewardship vision, accept our regal ambassador assignments, teach and train each church member, and join hands in the common mission of the State Association.

Roll Call Sunday Report

Roll Call 2000 was Sunday, March 26. In preparation for Roll Call Sunday the National Home Missions Department made two mailings to each pastor. In addition the Florida State Executive Office made two mailings on the subject to each pastor as well as an announcement in the Coordinator. Roll Call 2000 was well publicized.

The summary of the results of Roll Call 2000 in Florida is as follows:

Total churches including mission churches	72
Total churches reporting for Roll Call	67
Total Attendance reported	4,994
Total reported saved	23

Several rededications and people uniting with churches along with other types of special events were also reported. While the day was an overall success it revealed some disturbing needs among us. Some of the needs are: evangelism, edification, and enthusiasm among many of our churches. Roll Call Sunday is an annual event around which every Free Will Baptist can rally. It gives us an opportunity for a special day of evangelism and revival.

Solid church growth is a long term process. Each church can began now in preparation for Roll Call 2001.

- 1. <u>Dream.</u> What are the realistic potentials for your church? Do not compare your church with either the largest church or the smallest church. Look hard at your community. Who lives there? What are the evangelistic and spiritual needs in your ministering area? Do not dwell on your limitations. Find the needs in your community that you can help meet and focus on what you can do. Dream of your church being a life changing force in the lives of people where you are located.
- 2. Plan. As pastor and church leader plan your strategy for evangelism and church growth. Get your church leaders together and present your plan to them. Get their feedback and incorporate it into your plan. Be practical. Do not plan something you cannot do. Plan

what you can do with what God has placed in your hands. A church of "20" cannot do the same things a church of "500" can do. You're not in competition. Each of us has a commission from our Commander to fill our post where we are.

- 3. <u>Implement.</u> Start reaching into your ministering area now. Start putting your plan into action. Do it step by step, week by week, and part by part until the whole comes together and the miracle of evangelism, edification, and encouragement begins to happen.
- 4. Revise. As you implement your dream to accomplish your dream you may find you need to revise your plan or even your dream. Sometimes we don't dream big enough. Sometimes we don't plan with the right strategies. If something isn't working don't be afraid to try something different. Revise your plan without shame or fear.
- 5. **Be current.** Keep up with your progress. Keep your people informed about and involved with your progress. Keep the dream up front and up to date.

Roll Call 2001 can begin a yearlong revival in your church and in your ministering area. I pray we shall make it so. You can find a full Roll Call 2000 report at the State Office Booth. Pick one up for your reviewing.

THE COORDINATOR

When the Coordinator was first published in the early to mid 60's the Executive Committee chose the name coordinator because of their vision for the publication. The Coordinator had as it purpose, "To coordinate and communicate the ministries of Florida Free Will Baptists." That purpose has not changed through the years. The guiding purpose of the Coordinator may be stated like this:

The ministry purpose of the Coordinator is to provide information about the total ministry of Florida Free Will Baptists, provide encouragement for Florida Free Will Baptists in their ongoing ministries, and provide instruction in the faith and practices of Free Will Baptists.

The Coordinator was published quarterly in 1999. We are presently continuing to publish it quarterly. My dream is for it to become a full-blown monthly news magazine that instructs, informs, and encourages all who read it. I trust it can continue as a complimentary publication. Areas the Coordinator should communicate include materials that enhance and encourage the pulpit ministry; pastoral leadership; music and worship ministry; evangelism and church growth; Sunday School and Christian training; news from Florida's local churches; state boards and leaders; and National Association news. A news magazine that covers all these areas will be better published monthly and have and editor who can assign writers, collect, edit and prepare materials for publication.

The Coordinator was published four times in 1999. The total cost of publication was \$3,048.53. This includes printing, mailing, and some editorial costs. The Coordinator goes to over 2200 addresses at each mailing. The per issue cost of the Coordinator per address was \$.36. We anticipate the cost per address to remain very close to the same for 2000 and 2001 if we continue publishing it as we are presently.

Christian Education Board Report

This past year was an exceptional year for the state's Christian Education Ministries. We have seen so much accomplished in a short period of time. Our vision has been well endorsed by each of you and supported both financially and in attendance. We have seen God use our various venues this past year to reach the very core of the churches in our state. The following is a synopsis of this past year.

Bible Institutes

We have been able to help two groups this past year. I would like to highlight one of these. Our Hispanic Association has begun a Bible Institute that has continued to grow each time they begin a new class. Their success has been the combination of good leadership in the association and an eagerness to learn and take time for such classes. Neither of these traits alone can make a Bible Institute successful, it takes both! There is an interest in another part of the state to begin another institute and we will be talking with them in the coming months as they get ready.

Scholarships

We awarded one scholarship this past year. Stephanie Williford was our scholarship recipient and another congratulations to her. This year we are looking at having it in the Jacksonville area to make it more centrally located for everyone in the state. the topics will be very applicable and we will have various key speakers for these topics. They will be taught in such a way that you can attend the topics you desire and classes will be repeated to allow you to catch those you miss for a conflict with another. Please register early.

This was possible because of the special gifts from associations and churches. These are listed in the financial report and to all of you we say thank you.

Ministers' Retreat

We had a tremendous retreat in Crystal River in which Edwin Hayes was our guest speaker. We had close to 30 in attendance and we heard from Rev. Benito Rodriguez about vision, reflecting upon the past, and what God has done. This is always enjoyed by all the pastors and they are refreshed and renewed. A special thanks to all the churches who sent their pastors to this and provided their way financially. Your reward will be seen in his ministry.



Mission Board Report

Florida continues to be an open mission field for Free Will Baptists. The Mission Board continues to be committed to planting churches across the state. Our prayer is that God will raise up men, who are willing to be used by God, to build churches in key cities of our state. While we are thankful for the successful churches of our state, we are burdened for those cities where the voice of Free Will Baptist is not being heard. Help us pray that God will provide the means that this burden will become a reality.

1999 was a banner year for Florida Home Missions. Brother Odis Whitehead and the people of Faith Free Will Baptist in Jacksonville have reached their goal of being a self-supporting church. Brother Odis and his wife Mary Nell are to be commended for their faithful and dedicated work in accomplishing this goal. On February 13, 2000 our board, along with National Home Missions Director Trymon Messer, was privileged to be with Brother Odis and his people for this momentous occasion.

In addition to the success of Faith Chapel, the Jacksonville area has another new work. Brother Tommy Capps has begun a new work in the Manderin Community (Cornerstone Free Will Baptist Church) and is doing very good. In November the Mission Board interviewed Brother Tommy for tentmaker status and on May 1st of this year he officially became a missionary to Jacksonville under our Mission Shares Plan. Pray for Tommy, his wife Brenda and their family as they labor in God's vineyard.

In Miami Brother Jose Rodriquez and the people of Renacer Free Will Baptist Church have reached their goal of self-supporting status. In July 1999 Brother Jose and the church began a trial of

self-supporting status and in January 2000 it became official. Brother Jose and his wife Maday have done an outstanding job. Our hats are off to him and his people at the Renacer Church. On March 23, 2000 the Mission Board was privileged to be with Brother Jose and his church for their celebration of self-supporting status. Brother Larry Montgomery was the keynote speaker. Larry was the Mission Board Chairman and was instrumental in getting the Renacer project off the ground. In appreciation for their hard work, Brother Trymon Messer presented Brother Jose and Maday a plaque.

Brother Omar Alfaro is doing a great job in Homestead. In September the church moved from Brother Omar's house to a rented facility. The attendance and offerings have more than doubled. In January the church began contributing to Omar's salary, the pastor's retirement, and the state co-operative plan.

Brother Jean Guerrier continues to minister to the Haitian community in the Deerfield Beach area. The facility in which he is meeting is small and inadequate. Brother Jean and our board are presently looking for a better and larger place for him to meet.

Over the last several months the board has been working on a policy manual. It has now been completed and is available for anyone that would like to have one. Our board is recommending several changes to our Constitution and By-Laws. It is felt that this up-date is needed in order to bring them more in line with the responsibilities that are given to the board by the state.

Our board thanks you for the privilege of serving you in the area of missions. We urge your continued prayer and support as we seek God's direction for Free Will Baptist Missions in the State of Florida.

Item 1 Upon the request from the Citrus association and the Examination of the Association, the Executive Committee recommends the acceptance of the Citrus Association into our State Association.

- Item 2 The Committee has received the following reports and recommend their acceptance: Executive Secretary, State Treasurer, Christian Education, Mission Board, and the Steering Committee.
- Item 3 We recommend the changes to the Mission Board's Constitution and By-Laws.
- Item 4 We recommend that we adopt the budget of the 2001 Mission Shares.
- Item 5 We recommend changing our Constitution in Article IV, Section 1 to read, "This Association shall convene annually in a joint meeting with the Florida Women Active for Christ and the Youth Conference on a Wednesday evening, Thursday, Friday and Saturday as close to the first Sunday in May as possible."
- Item 6 We recommend an amendment of Article III, Section 2 by substituting the word "Home" with "Florida".
- Item 7 We recommend the adoption of policies and procedures for the Planning, Steering, Budget, and Auditing Committees.
- Item 8 We are interested in a Seniors' Ministry throughout the State and are actively seeking those who would be interested in heading up such a ministry.
- Item 9 We have accepted Millard Sasser's resignation effective June 30, 2000.
- Item 10 We recommend the Promotional Team Concept to assume the responsibilities of the Executive Office. This team should begin June 1 and work with Bro. Sasser in

the transition. The individuals will be evaluated on an annual basis.

- Item 11 We recommend that our Moderator sit as our proxy in the General Board at this year's National.
- Item 12 We recommend the adoption of the 2001 General Fund budget.
- Item 13 We recommend the adoption of the Total State Ministries Budget for 2001 of \$438,706.
- Item 14 Article V, Section 1 We recommend changing the representation fee from \$75.00 to \$100.00 per church.

Planning Meeting Notes

Planning Committee: consists of the Moderator, Treasurer, and Chairman of each Board, it reports to the Executive Committee. The responsibilities of the Planning Committee are to make intermediate and long-range plans for State ministries; coordinate the efforts of the Missions, Youth, and Christian Education ministries; to plan the State Association theme and speakers; and to handle any items of review given by the Executive committee or the State Body.

Steering Committee: consists of the Moderator, Clerk, Chairman of the Youth Board, and the President of Florida Women Active for Christ. Others may be appointed by the Moderator on a special need basis. It exists for the purpose of coordinating our annual State Meeting. The responsibilities for this committee shall be: to negotiate with the various locations concerning rates and arrangements and to recommend locations to the State body; to

work with the various Convention Bureaus to secure sites; to make site inspections when necessary; to set and approve the catering contracts for meeting rooms and meal functions with the host hotel; to coordinate the meeting times and room specifications for each session; to set the schedule for the State Meeting; to coordinate the registration process for the State Meeting; and to be the on-site liason for hotel staff.

Budget Committee: consists of three members of the Executive Committee appointed by the Moderator, one year in advance. The State Treasurer serves as an ex-officio member. The responsibility of this committe is to analyze and compile the State's General Fund budget. Budget requests will be submitted in writing. A representative will be available from Florida standing boards and commissions to provide information to the committee. The Executive Secretary will present his operating expenses and the Coordinator expense. Direction from the State Moderator concerning administrative items will be provided. The Budget Committee has the authority to request additional information in compiling the budget. This budget will be presented to the Executive Committee for approval and recommendation to the State Body for final approval.

Auditing Committee: composed of three members which shall be elected for three year terms on a rotating basis, so that one new member shall be elected annually. Members of the auditing committee may not be members of any standing board or committee. They are to review financial documents to determine that the Treasusrer's reports of each board and the State Association clearly reflects the financial activity for the year.

Promotional Team Concept

The transition we have before us is vital in light of the fact that our state has seen a plateau in co-op giving. At this crossroads we

stand and yet we must not take the wrong turn. We have the opportunity, we have the possibilities, and we all have vision. Now we must unify the vision and proceed with wisdom and passion.

The office is a great task, one that not many men are qualified in every aspect to handle. We may find someone who is creative and visonary, but in most cases they are not administrative giants. The administrative giants may not be adept in layout and design of newsletters or newspapers. Then there is the all important people skills in representing the state and its ministries. The fact is that the office may very well be bigger than one individual and yet the finances are not there to accommodate a staff nor is it necessary to proceed in that vein at any point in the near future.

The following may very well be entertained as a trial basis for as short as two years or as long as deemed worthy. It seeks to find the right personalities and spiritial gifts for the right task. It is a promotional team concept. We offer the following:

The Executive Secretary - He is tasked with being the point man, representing the state ministries, not necessarily the office, to our associations and churches. He also co-ordinates the other two positions. This part time position requiring two dates a month to be traveling.

The Bookstore Manager - He is tasked with maintaining and promoting the state library and promoting and handling Sunday School orders and relating items.

The Editor of the Coordinator - He is tasked with delegating articles to be written and compiling the content of the state newsletter in whatever time period and manner published. He may or may not be tasked with actual layout and printing which

could lead to a fourth area in which becomes the media coordinator for all three of these positions (To handle their perspective promotions and graphic design and printing) or you may consider delegating this to the Media Commission.

CONSTITUTION OF THE CHRISTIAN EDUCATION BOARD OF THE FLORIDA STATE ASSOCIATION OF FREE WILL BAPTISTS

ARTICLE I - NAME

This board shall be known as the Christian Education Board of the Florida State Association of Free Will Baptists.

ARTICLE II - PURPOSE

The purpose of this board shall be to promote the educational aims of the Florida State Association of Free Will Baptists among these: statewide Bible Institutes, Teacher training programs, Sunday School, CTS, Free Will Baptist Bible Colleges and any other training methods that will help in the growth of our churches.

ARTICLE III - THE BOARD

Section 1. Composition - this Board shall be composed of five members.

Section 2. Tenure of Office - The members of this board shall be elected for a term of five years and arranged whereby that only one member's term expires annually.

<u>Section 3.</u> The Board shall elect a Chairman, Assistant Chairman, and Secretary/Treasurer, which shall be elected annually.

Section 4. Vacancies - In the event irregular vacancies occur on this board, they will be filled by the Florida State Association.

Section 5. The Board shall meet at least once a year and/or whenever a meeting is deemed necessary.

ARTICLE IV - DUTIES OF THE BOARD

Section 1. To create a statewide Bible Institute program that will assist and encourage the development of regional extensions in each local association.

<u>Section 2.</u> To assist and encourage the growth of Sunday Schools through Sunday School conventions, workshops, etc.

Section 3. To promote the organizing of new CTS groups and to assist in the training portion of existing CTS groups.

<u>Section 4.</u> To encourage the young people of our churches to further their education in our denomination's institutions.

ARTICLE V - TRAVEL EXPENSES

Mileage shall be paid at the current IRS rate for the fiscal year for all meetings except the board meeting in connection with the State Association. If a called meeting requires members to stay overnight the room and board of each member will be paid.

ARTICLE VI - COMMITTEES

Committees may be appointed by the chairman or elected by the board as the need arises.

ARTICLE VII - REPORTS

A complete report of the Board meetings and activities, and a complete financial report must be presented to the annual State Association Meeting.

ARTICLE VII - AMENDMENTS

This constitution may be amended by a majority vote of the Board Members and final approval of the State Association.

CONSTITUTION AND BY-LAWS OF THE

FLORIDA FREE WILL BAPTIST MISSION BOARD

ARTICLE I - NAME

This Board shall be known as the Florida Free Will Baptist Mission Board, Inc.

ARTICLE II - PURPOSE

The purpose of this board shall be that of promoting mission work among Free Will Baptists in the State of Florida, beginning new mission works in the state of Florida, and overseeing the missionary and the mission work until the mission is able to assume full self supporting status.

ARTICLE III - MEMBERSHIP

This board shall be composed of members elected by the State Association and shall serve terms established on a rotational basis. One member's term shall expire annually. The number of members of this board shall be determined by the Constitution and By-Laws of the State Association.

ARTICLE IV - OFFICERS AND COMMITTEES

Officers of this board shall be Chairman and Vice Chairman, Secretary, and Treasurer. The same person may hold the office of Secretary and Treasurer. These officers shall hold office for one (1) year and may be elected to serve succeeding terms. Members of the board shall elect the officers of the board. Committees may be appointed by the chairman elected by the board as the need arises.

ARTICLE V - MEETINGS

Meetings shall be held as the need arises. Necessary meetings may be called by the chairman or any three members.

ARTICLE VI - FINANCES

This board shall receive its finances from churches and individuals making special contributions, cooperative program allocations, interest on loans, and special offerings received through promoting missions. Mileage for board member expenses shall be paid from the general fund at the IRS rate for that fiscal year. All other Board travel expenses shall be reimbursed at members cost.

BY - LAWS

- Section 1. Officers of the board shall hold office according to the terms set forth in the Constitution and shall carry out those duties peculiar to the respective offices. The Secretary shall maintain a permanent record of the Board's activities. The Treasurer shall maintain a permanent record of the Board's financial transactions. All records and property mortgages and titles shall be surrendered to the succeeding Secretary.
- Section 2. A majority membership shall constitute a quorum and be duly authorized to transact business. All items of business must receive a majority vote of a quorum before it is considered final. All members not present in meetings shall be notified of decisions made by the Board.
- <u>Section 3.</u> All members shall endeavor to support mission work through cooperative efforts of the Board. Any member that fails to cooperate with the board for a period of one year may, upon recommendation of the Board, be replaced by the State Association.
- Section 4. A complete report of the Board meetings and activities and a complete financial report must be presented to the annual State Association Meeting.
- <u>Section 5.</u> Missions and churches receiving financial support must be in good standing with anassociation or quarterly meeting affiliated with the state or national association andmust have a postor who is ingood standing with the Free Will Baptist denomination.
- Section 6. The board shall have the right, by majority vote, to purchase property where there is good possibility for organizing a Free Will Baptist Church. Full title must be acquired, and no investment shall exceed the

appraised value of the real property. Missionaries and mission works receiving funding from the Mission Board will be under the direct supervision of the mission board. Missionaries serve mission works at the discretion of the board. Missions and churches with Pastors employed by the board shall be under the authority of this board for any non ruotine purchases or financial obligations.

Section 7. The mission board will be responsible for administering the Mission Shares Program under the guidelines set by the Florida State Association of Free Will Baptists.

Section 8. Any work receiving financial support must agree to support the donominational cooperative program.

Section 9. The Board shall have the right by majority vote to sell any personal or real property it deems is not necessary for continued religious use.

Section 10. Nominal grants by the Board to worthwhile churches or missions may be made when it is in the interest of the donominational cause in which benefits are certain. Grants of this nature shall be subject to money being immediately available and shall not exceed \$1000 without joint approval of the Mission Board and the State Executive Committee or Association.

Section 11. The Constitution and By-Laws may be amended by majority vote of the Board members with the approval of the State Body.

CONSTITUTION OF THE FLORIDA STATE YOUTH BOARD

ARTICLE 1 - NAME

The Board shall be known as the Youth Board of the Florida State Association of Free Will Baptists, Inc.

ARTICLE II - DUTIES OF THE BOARD

Section 1. The duties of this board shall be to: (1) Promote youth camps, youth rallies, and to be a coordinating agency between District, State, and National officers (2) Coordinate and direct CTS competitive activities (3) Encourage and equip church leaders in their ministry to youth

Section 2. This board shall give a report of its activities, board meetings and financial status to the Florida State Association at its annual meeting.

ARTICLE III - MEMBERSHIP

Section 1. This board shall be composed of five members who shall be elected for a term of five years and arranged whereby that only one member's term expires annually. In the event irregular vacancies occur on this board, they will be filled by the Florida State Association.

Section 2. Officers of this board shall be a Chairman, Secretary, and Treasurer. These officers shall hold office for one year and may be elected to serve succeeding terms. Members of the board shall elect the officers of the Board. Committees may be appointed by the Chairman as the need arises. The Secretary shall maintain a permanent record of all the Board's activities. The Treasurer shall keep a complete record of all financial activities of this board. All records and financial transactions are property of the Youth Board and shall be surrendered to new officers.

ARTICLE IV - MEETINGS

This board will meet semi-annually. Meetings may be called by the Chairman or the Secretary as the need arises.

ARTICLE V - FINANCES

This board shall receive its finances from churches and individuals making special contributions, cooperative program allocations, and special offerings received through promoting youth. Mileage, room and board shall be paid from the general fund of the Youth Board for all meetings. Mileage shall be paid at the current IRS rate.

ARTICLE VI - AMENDMENTS

This constitution and by-laws may be amended by a majority vote of the state.

CONSTITUTION AND BY-LAWS OF THE

FLORIDA STATE ASSOCIATION OF FREE WILL BAPTISTS

PREAMBLE

ARTICLE I - NAME OF ASSEMBLY

Section 1. This assembly shall be known as "The Florida State Association of Free Will Baptists.

ARTICLE II - REPRESENTATION

<u>Section 1.</u> This Association shall be composed of delegates elected from the local associations belonging to this body and delegates elected from the local churches embraced by the various associations.

Section 2. All deacons and ministers who are members of, and in good standing with, a local church and local association which are members of this body are standing delegates.

Section 3. The general officers of this body shall be standing delegates.

Section 4. The delegates shall be elected as follows: one (1) delegate for each local church composed of 100 members or fraction thereof, and one (1) delegate for each additional 100 members or fraction thereof; five (5) delegates from each local association composed of fifteen (15) churches or fraction thereof, and one (1) additional delegate for each additional four (4) churches or fraction thereof. These additional delegates cannot be used unless the churches are active and are represented in the session in which they are appointed.

ARTICLE III - OFFICERS, BOARDS, AND COMMITTEES

Section 1. Officers: the officers of this association shall be a Moderator, Assistant Moderator, Secretary, Assistant Secretary, Treasurer, and Assistant Treasurer, to be elected by this body while in regular session.. Section 2. Boards: The standing boards of this association shall be Florida Missions, Christian Education, and Youth Boards.

Section 3. When the State Association deems it wise, committees or commissions may be established to perform a specific service in a restricted area on a more or less permanent basis. The number of members and their terms of office of any committee or commission shall be decided by vote of the State Association, and the members shall be elected by the Association.

Section 4. The Executive Committee shall be composed of the Moderator, Assistant Moderator, Secretary, Assistant Secretary, Treasurer, Assistant Treasurer, the chairman of each standing board, and one elected member from each affiliated District Association. District Association shall recommend their representatives on the Executive Board annually. A majority of members shall constitute a quorum.

Section 5. When vacancies occur either by death, removal from office, or by resignation, the general officers shall appoint a temporary replacement until the next regular session of this body, at which time the body shall elect a permanent replacement. A proxy may be appointed by the body to fill any absentee's place who does not attend the session.

Session 6, General officers of the Association shall serve for the term of two (2) years.

Section 7. Each standing board and the Historical Commission shall be composed of five members which shall be elected for five year terms on a rotating basis, so that one new member shall be elected annually.

The auditing committee shall be composed of three members which shall be elected for three year terms on a rotating basis, so that one new member shall be elected annually. Members of the auditing committee may not be members of any standing board or committee.

The Budget Committee shall be composed of the Executive Secretary, Moderator, Treasurer, and chairman of each standing board.

<u>Section 8.</u> This body shall have the right to discipline any officer or board member who does not conduct his office in a Christian and business-like manner according to the rules of Christian conduct laid down in the New Testament.

Section 9. The Executive Committee is to hire an Executive Secretary and to direct his office. The Executive Secretary is to be a non-voting member of all boards and committees.

ARTICLE IV - MEETINGS

<u>Section 1.</u> Regular: This association shall convene annually in a joint meeting with the Florida Women Active for Christ and the Youth Conference on a Wednesday evening, Thursday, Friday and Saturday as close to the first Sunday in May as possible.

<u>Section 2.</u> Special: The Executive Committee may be called into session by the Moderator, or by a majority of its members.

Section 3. Quorum: Fifty (50) percent of the delegates shall constitute a quorum.

ARTICLE V - FINANCES

Section 1. All churches and associations in this body shall pay a representation fee annually. The amount of this fee for an association is \$100.00 per member church. The fee for local churches is \$10.00 per delegate. Section 2. All Cooperative Plan funds coming into this body shall be spent under a budget plan. This budget must be approved by the body while in session, and no funds may be used in any way except as budgeted. Section 3. Mileage for the Executive Committee members and standing Board members shall be paid at the IRS. rate for that fiscal year. Expenses are to be paid from each Board member's account. If a called meeting requires a a member to stay overnight, his room and board will be paid from the General Fund or his Board's account. Mileage and expenses shall be paid for the Moderator to attend the denomination's annual leadership conference.

BY-LAWS

Section 1.. It shall be the duty of the Moderator to preside over all deliberations of this body while in session. All meetings shall be governed by Roberts Rules of Order.

Section 2. The Assistant Moderator shall assume the duties, rights and privileges of the Moderator in his absence.

Section 3. It shall be the duty of the Clerk to make and keep records of all the business proceedings and activities of the body.

Section 4. (1) It shall be the duty of the State Association treasurer, or someone designated by the State body, to receive all funds, pay all appropriate bills, disburse co-operative and designated funds in a timely manner according to the State Association's budget. (2) It shall be the duty of each State Board treasurer to receive all funds for the board he serves, pay all appropriate bills, and disburse appropriate funds in a timely manner. (3) The State Association treasurer and all State Board treasurers shall use the same accounting system. (4) Each treasurer of the State Association shall submit his/her records to the State Association's Audit Committee annually for audit.

Section 5. It shall be the duty of the audit committee to conduct a financial audit of each treasurer's books annually. The audit shall take place after the fiscal year and before the State Association convenes. The date for the audit will be agreed upon by the audit committee and the various treasurers who shall be present at the time their books are audited.

Section 6. It shall be the duty of the Budget Committee to make recommendations to the State Association concerning the total State Association Budget and the allocations of State Cooperative receipts.

Section 7. Each officer, board member, and standing committee or commission member must be in good standing with a Free Will Baptist Church which is a member of this Body. He must be in good standing with his local association, and must live within the boundaries of this Association. No person shall serve on more than one board at the same time.

Section 8. The Executive Committee shall have full authority to do all acts for and in the name of the Association when the Association is not in session and shall make a general report of all their actions to this body annually.

Section 9. Amendments to this Constitution and By-Laws must be put before the body while in session one day before voted on, and must be read at least twice and passed by two-thirds of the delegates present.
