Minutes of the Fifty- seventh Annual Session of the

The fifty-seventh annual session of the Florida State Association of Free Will Baptists convened at the Holiday Inn Convention Center in DeLand, Florida. The joint meeting of the State Association, Florida Women Active for Christ, and the Youth Conference met on May 9-12, 2001. The theme of this meeting was "It's Harvest Time".

Executive Committee Report



The State Executive committee met on May 8 and 9, 2001 at the Holiday Inn in DeLand. The Committee would like to present the following items:

- 1. We have heard the reports from the State Treasurer, the the Executive Office, which includes "The Coordinator" and Resource Manager, the Youth Board, the Christian Education Board, the Mission Board, Mission Shares, the Steering Committee, the Planning Committee, the Budget Committee and OASIS. We recommend acceptance of their reports.
- 2. We considered item 10 of the 2000 Executive Committee Report in which we were directed to explore the full-time status of our Executive Secretary. A compensation package was suggested that totals \$62,000. This would be divided as follows: Salary-\$32,000; Housing-\$18,000; Retirement-\$6,000; and Insurance-\$6,000. These additional expenses for the office are expected as well: Auto Expense and Depreciation \$7,800; Travel

Expense - \$4,800; Telephone - \$2,400; National Association Expense - \$1,800; Office Rent - \$20,000; Office Equipment - \$4,000; Office Supplies - \$6,000; Miscellaneous - \$480; Secretarial Help - \$5,280; Promotions - \$4,800. The total expense of a full-time Executive Secretary will be \$119,360.00.

In discussing how to fund a full-time Executive Secretary, the Committee considered a number of possibilities. We offer three possibilities:

- 1. Requiring each church in the Florida State
 Association to Co-op 10% to the State Association.
- 2. Requiring each church in the State Association to contribute to Co-op at \$50 per member in each church.

The Florida Statistics on page 48 of the 2000 Digest of Reports indicate a total membership in Florida Free Will Baptist churches of 5,972. Multiplying the total membership by \$50 per member would generate \$298,600.00

- 3. The Executive Secretary is an essential link in promoting and generating funds for the Mission Shares Plan. Compensation to the Executive Secretary for his work could be built into the Shares budget.
- 3. We recommend that we allow only individuals representing ministries accountable to our State Association to address the Body during our Business Sessions. Accountable should be defined as our State having a board member or voting on its board members.
- 4. Since our State-owned car now has 136,000 miles on it, we recommend that the Executive Secretary get the car inspected by a reputable mechanic and have needed repairs done.

- The Planning Committee is authorized to purchase vehicle.
- 5. We recommend that we pay the expenses of the sound technician and that we give \$150 honorarium to the person in charge of the registration on an on-going basis each year.
- 6. We recommend that we send the "Resolution Concerning One National Magazine" to the National Association for their consideration. (Resolution attached)
- 7. We recommend the adoption of the attached 2002 State Budget and the Total Ministries Budget. (the State Treasurer and Executive Secretary are given the option of moving Item 752 to Item 751.)
- 8. We recommend that we allot \$1,008 for OASIS reimbursements for this year.

Resolution: One National Magazine

Whereas, six Free Will Baptist national agencies (Executive Office, Home Missions Department, Foreign Missions Department, Master's Men Department, Free Will Baptist Bible College, and the Sunday School and Church Training Department) print magazines or newsletters and distribute them to the denominational constituency, and,

Whereas, five of these National magazines/newsletters are mailed free to subscribers (AIM, Heartbeat, Master's Men Newsletter, Bible College Bulletin, and Outreach), while one is mailed to a paid subscription list (Contact), and,

Whereas, the cost of producing, printing and mailing these publications continues to rise each year,

Therefore, to avoid needless duplicating of mailing list, and in the interest of denominational stewardship, departmental cooperation and a spirit of unity,

Be it resolved that the National Association moderator appoint a five-person *Publications Committee* from the ranks of those knowledgeable in the field of publishing, from various states, to study the feasibility of printing one enlarged national monthly magazine with sections in the publication that incorporate material from each national agency, that the publication be mailed complimentary to subscribers, and,

Be It Further Resolved that the national agencies along with their director and editors be instructed to provide the Publications Committee unlimited access to their financial files and editorial schedules, that the directors and editors be instructed to meet with the Publications Committee as needed, and,

Be It Finally Resolved that the Publications Committee report it's findings and recommendations to the delegates at the July 21-25, 2002 session of the National Association of Free Will Baptists which meets in Memphis, Tennessee.

Synopsis of State Executive Committee Meetings

Conference Call, August 22, 2000

Since the "Shares" Program is a State project, the Committee voted to give the Mission Board one-half the cost of promoting the "Shares" program up to \$10,000.

We were also informed of an agreement that was reached to buy-out the lease on the State copier for \$2500.

Conference Call, February 12, 2001

The Executive Committee had a conference call on February 12, 2001. Participating were: David Womack, Randy Jackson, Jim Christian, Sam Lucky, Tom Collins, R.C. Wiggins, Danny Conn, Dave Thomas, David Williford, Tim Owen, Jimmy Aldridge, and Randy Bryant.

The Committee authorized the printing of "The Coordinator" in Spanish on the same scale as the English version.

Executive Committe Meeting, May 8 and 9, 2001 at Holiday Inn, Deland

The State Executive Committee met at the Holiday Inn in Deland on Tuesday, May 8 and Wednesday, May 9, 2001. Present for this meeting was David Womack, James Butcher, Norm Hansen, Tim Owen, Dave Thomas, Jim Christian, David Williford, Sam Lucky, Tom Collins, R.C. Wiggins, Dave Buck, Ed Sweigart, Tommy Capps, Danny Conn, Jose Rodriguez, and Randy Bryant. Bill Whipple set in on the meeting.

The meeting on Tuesday was to discuss the possibility of a full-time Executive Secretary as directed by the State Body last year.

Our meeting on Wednesday had everyone that was present on Tuesday plus Jimmy Aldridge. Gene Cross, Ron Draper, and Jeffrey Barnard also set in.

The Committee heard the reports from our Executive Office, our State Treasurer, Standing Boards and our Committees. We discussed the opportunities associated with our website, a policy to determine what groups can be permitted to speak during our Business sessions, and the status of our State-owned car. The most memorable event of the year 2000 was not the complete meltdown of worldwide computer systems and the end of life as we knew it. The highlights for the Florida Youth Board include a Youth Workers Seminar for the newly formed Citrus Association at the Zion FWB Church in Sanford, FL; Seeing twenty-nine of the forty-six CTS entries advance to the National competition; Participating in the *Operation Saturation* in Jacksonville and Miami; Taking a group photo of 30 Florida youth at the National Convention in Anaheim; and fellowshipping with over 70 youth workers at the Youth Workers' Retreat in Ocala.

The theme for the 2000 State Youth Conference was *Press Toward* the Goal. Bro. Stewart-Allen Clark presented this challenge during

the Youth Rally. Bro. Eddie Payne & Bro. Ryan McDougald presented the opportunity that was available through youth missions programs. Bro. Charlie Elliott shared insights that were gleaned from the National Youth Workers' Conference. This year's SYC theme is **GO**! No Reserves, No Retreats, No Regrets. Bro. Executive Secretary's Report

The last 12 months have been months of transition. The responsibilities for the Executive Office were divided among three individuals, each one being responsible for specific areas of ministry. The approach seems to be working smoothly, and I believe that the ministry of the State Office continues to meet the needs of our churches and people.

Special attention needs to be directed to Danny Conn and Ron Hunter's work with the Coordinator. We have as good a state paper as exists within our ranks. These two men have brought their expertise to this project and have developed a paper that is not only informative, but also attractive and highly readable. They are to be commended.

In addition to the revamping of the Coordinator, we took another unprecedented step forward. Florida became the first state in the history of our movement to publish a version of their state paper in a language other than English. With Mrs. Lucy Hyman serving as translator, we have begun publishing the Coordinator in Spanish as well as English. The members of the Hispanic Association have received this innovation with open arms. This step allows us to minister more effectively to our Hispanic brothers, and opens doors of communication even wider. We continue to seek other ways to work more closely with our Spanish-speaking brothers. There is a great deal they can contribute to our state ministries.

Randy Bryant is doing a good job with the Resource Center. Use Randy's office to order your curriculum and study materials. Purchases made through the Resource Center financially benefit state ministries. He can order not only from Randall House, but also from any major publisher. He is also our state resource person for ETA materials. In addition, he manages the resource library that is available to you on a loan basis. We encourage you to take advantage of the resources your state has to offer.

My primary responsibility has been to travel and promote the ministries of our state. The boards of our state continue to find new and innovative ways to increase their ministries to our people, and my job is to represent them to the people of our state. The response of our people has been gratifying. There is an increased awareness that our state association exists to serve the Free Will Baptist people and Churches of this state, and people are becoming more enthusiastic about what can be accomplished through our combined efforts. A special note of thanks is due to the moderators of our associations who have been so gracious to give me time in their meetings to talk about the ministry opportunities that exist for us.

As I've traveled among us this past year I've been more impressed by our similarities than I have been surprised by our differences. We may have different approaches to ministry, we may sing different types of music, and we may express ourselves differently in worship, but the core values are the same: We want to see the lost saved, and we want to see Christians grow into the likeness of Christ. It is around these common goals that we can unite, and it is for these goals that we can work together.

One question I am frequently asked in my meeting with associations and churches is, "When are we going to have a full time Executive Office?" My answer to that has taken various forms, but the essence of the answer is, "When we decide we want it badly enough to pay for it." The fact is that a full time office and Executive Secretary will require significant funding. The decision about whether or not we will have a full time man in that position will not be made by the Executive Committee, or even by this body, but will ultimately be made by the churches of our state. If the position is to exist, the churches are the ones who will provide the funds for it.

If you are among those who want a full time position, I have two suggestions: (1) Make your feelings known to your Executive Committee member. He is your representative on the group who will make recommendations to this body about this position. (2) Lead your church and association to give to Florida Free Will Baptist Ministries.

Thank you for the opportunity you have given me to work with you. This past year has been one of the most enjoyable of my ministry. I trust that in the years ahead we can see more accomplished for the cause of Christ.

Finally, let me say a word of thanks to the First Free Will Baptist Church of Chipley. They are a kind, gracious, and generous people. They have given me the freedom to pursue this ministry among Florida Free Will Baptists, and I will forever be in their debt for their willingness to allow me the privilege of working with our State. Their commitment to the cause of Christ and strengthening of our state work is real. For their patience and understanding I will be eternally grateful.



that Ron had done previously. I trust that this report will make sense. The following is a synopsis of this past year's activities.

SUNDAY SCHOOL CONFERENCE:

This past year we held our second annual Sunday School Conference. The Sunday School is a vital part of God's work in the local church. Through the Sunday School many souls have been saved, Christians have been trained and taught the Word of God, and believers have established a strong bond with other members of the church family by the fellowship found there.

God's work is worthy of the greatest effort that we can give. Certainly, training seminars will help us in that effort. The purpose of the Sunday School Conference is to instruct; to motivate; and encourage those working in this vital area of our church ministries.

After the meeting the C.E. Board met and after evaluation and discussion concerning the seminar, we realized that much of the instruction could also be related to the Youth Ministry. We decided to talk to the Florida Youth Board and determine if we could combine our seminar with the youth seminar that they hold. This way we would not be crossing over into each other's area. When we presented this matter to them, they were excited also about this project and we jointly met and worked out the details for this joint effort, which will be presented to you at this year's state meeting.

MINISTER'S RETREAT

February 27-28 we met in Crystal River for a valuable time of rest, fun, fellowship, and instruction. There were 14 ministers that joined us, which was fewer than in recent years, but it was a great chance to enjoy one another's company and to gain valuable lessons from the three speakers: Randy Bryant, who spoke of the importance of church government and record keeping; David Williford who spoke on the pastor and his family; and Tom Collins, who spoke on the pastor and his finances. Every pastor who attended expressed the need for such instruction and their thanks for receiving it. I truly wish this information could be available to every pastor in our state.

The pastors in attendance gave suggestions for next year's retreat, which would include the pastor's wife. Please make every effort to attend. We will have some new and exciting events for the next retreat. Every church will benefit greatly by sending their pastor and wife to this retreat. So churches, we urge you to pay their way and send them with your blessing.

Mission Board Report

This past year has been one filled with blessings and disappointments. The annual Home Mission trip, as always, was the highlight of the year. The board was blessed to have as our guest pastors from around the state. The trip began in Ocala where we met and boarded the bus. From there we visited the property in Gainesville where we hope to have a new work in the near future. From there we traveled to Jacksonville and met with Bro. Tommy Capps and the people from Cornerstone Free Will Baptist Church. From Jacksonville it was on to Homestead. There we enjoyed the hospitality and fellowship of Missionary Pastor Omar Alfaro and his congregation. The next day it was on to Lehigh Acres, a suburb of Ft. Myers. We were given a tour of the city, complements of Dennis and Mary Ann Matthews. 

CONSTITUTION AND BY-LAWS OF THE

FLORIDA STATE ASSOCIATION OF FREE WILL BAPTISTS

PREAMBLE

ARTICLE I - NAME OF ASSEMBLY

Section 1. This assembly shall be known as "The Florida State Association of Free Will Baptists.

ARTICLE II - REPRESENTATION

Section 1. This Association shall be composed of delegates elected from the local associations belonging to this body and delegates elected from the local churches embraced by the various associations.

Section 2. All deacons and ministers who are members of, and in good standing with, a local church and local association which are members of this body are standing delegates.

Section 3. The general officers of this body shall be standing delegates.

Section 4. The delegates shall be elected as follows: one (1) delegate for each local church composed of 100 members or fraction thereof, and one (1) delegate for each additional 100 members or fraction thereof; five (5) delegates from each local association composed of fifteen (15) churches or fraction thereof, and one (1) additional delegate for each additional four (4) churches or fraction thereof. These additional delegates cannot be used unless the churches are active and are represented in the session in which they are appointed.

ARTICLE III - OFFICERS, BOARDS, AND COMMITTEES

Section 1. Officers: the officers of this association shall be a Moderator, Assistant Moderator, Secretary, Assistant Secretary, Treasurer, and Assistant Treasurer, to be elected by this body while in regular session.

Section 2. Boards: The standing boards of this association shall be Florida Missions, Christian Education, and Youth Boards.

Section 3. When the State Association deems it wise, committees or commissions may be established to perform a specific service in a restricted area on a more or less permanent basis. The number of members and their terms of office of any committee or commission shall be decided by vote of the State Association, and the members shall be elected by the Association.

Section 4. The Executive Committee shall be composed of the Moderator, Assistant Moderator, Secretary, Assistant Secretary, Treasurer, Assistant Treasurer, the chairman of each standing board, and one elected member from each affiliated District Association. District Association shall recommend their representatives on the Executive Board annually. A majority of members shall constitute a quorum.

Section 5. When vacancies occur either by death, removal from office, or by resignation, the general officers shall appoint a temporary replacement until the next regular session of this body, at which time the body shall elect a permanent replacement. A proxy may be appointed by the body to fill any absentee's place who does not attend the session.

Session 6. General officers of the Association shall serve for the term of two (2) years.

Section 7. Each standing board and the Historical Commission shall be composed of five members which shall be elected for five year terms on a rotating basis, so that one new member shall be elected annually. The auditing committee shall be composed of three members which shall be elected for three year terms on a rotating basis, so that one new member shall be elected annually. Members of the auditing committee may not be members of any standing board or committee. The Budget Committee will be appointed by the Moderator a year in advance. The committee will consist of three members from the Executive Committee and the State Treasurer will serve as an ex-officio member.

<u>Section 8.</u> This body shall have the right to discipline any officer or board member who does not conduct his office in a Christian and business-like manner according to the rules of Christian conduct laid down in the New Testament.

Section 9. The Executive Committee is to hire an Executive Secretary and to direct his office. The Executive Secretary is to be a non-voting member of all boards and committees.

ARTICLE IV - MEETINGS

Section 1. Regular: This association shall convene annually in a joint meeting with the Florida Women Active for Christ and the Youth Conference on a Wednesday evening, Thursday, Friday and Saturday as close to the first Sunday in May as possible.

Section 2. Special: The Executive Committee may be called into session by the Moderator, or by a majority of its members.

Section 3. Quorum: Fifty (50) percent of the delegates shall constitute a quorum.

ARTICLE V - FINANCES

Section 1. All churches and associations in this body shall pay a representation fee annually. The amount of this fee for an association is \$100.00 per member church. The fee for local churches is \$10.00 per delegate. Section 2. All Cooperative Plan funds coming into this body shall be spent under a budget plan. This budget must be approved by the body while in session, and no funds may be used in any way except as budgeted. Section 3. Mileage for the Executive Committee members and standing Board members shall be paid at the IRS rate for that fiscal year. Expenses are to be paid from each Board member's account. If a called meeting requires a member to stay overnight, his room and board will be paid from the General Fund or his Board's account. Mileage and expenses shall be paid for the Moderator to attend the denomination's annual Leadership Conference.

BY-LAWS

Section 1. It shall be the duty of the Moderator to preside over all deliberations of this body while in session. All meetings shall be governed by Roberts Rules of Order.

Section 2. The Assistant Moderator shall assume the duties, rights and privileges of the Moderator in his absence.

Section 3. It shall be the duty of the Clerk to make and keep records of all the business proceedings and activities of the body.

Section 4. (1) It shall be the duty of the State Association treasurer, or someone designated by the State body, to receive all funds, pay all appropriate bills, disburse co-operative and designated funds in a timely manner according to the State Association's budget. (2) It shall be the duty of each State Board treasurer to receive all funds for the board he serves, pay all appropriate bills, and disburse appropriate funds in a timely manner. (3) The State Association treasurer and all State Board treasurers shall use the same accounting system. (4) Each treasurer of the State Association shall submit his/her records to the State Association's Audit Committee annually for audit.

Section 5. It shall be the duty of the auditing committee to conduct a financial audit of each treasurer's books annually. The audit shall take place after the fiscal year and before the State Association convenes. The date for the audit will be agreed upon by the audit committee and the various treasurers who shall be present at the time their books are audited.

Section 6. It shall be the duty of the Budget Committee to make recommendations to the State Association concerning the total State Association Budget and the allocations of State Cooperative receipts.

Section 7. Each officer, board member, and standing committee or commission member must be in good standing with a Free Will Baptist Church which is a member of this Body. He must be in good standing with his local association, and must live within the boundaries of this Association. No person shall serve on more than one board at the same time.

Section 8. The Executive Committee shall have full authority to do all acts for and in the name of the Association when the Association is not in session and shall make a general report of all their actions to this body annually.

Section 9. Amendments to this Constitution and By-Laws must be put before the body while in session one day before voted on, and must be read at least twice and passed by two-thirds of the delegates present.

CONSTITUTION OF THE FLORIDA STATE YOUTH BOARD

ARTICLE 1 - NAME

The Board shall be known as the Youth Board of the Florida State Association of Free Will Baptists, Inc.

ARTICLE II - DUTIES OF THE BOARD

Section 1. The duties of this board shall be to: (1) Promote youth camps, youth rallies, and to be a coordinating agency between District, State, and National officers (2) Coordinate and direct CTS competitive activities (3) Encourage and equip church leaders in their ministry to youth

Section 2. This board shall give a report of its activities, board meetings and financial status to the Florida State Association at its annual meeting.

ARTICLE III - MEMBERSHIP

Section 1. This board shall be composed of five members who shall be elected for a term of five years and arranged whereby that only one member's term expires annually. In the event irregular vacancies occur on this board, they will be filled by the Florida State Association.

Section 2. Officers of this board shall be a Chairman, Secretary, and Treasurer. These officers shall hold office for one year and may be elected to serve succeeding terms. Members of the board shall elect the officers of the Board. Committees may be appointed by the Chairman as the need arises. The Secretary shall maintain a permanent record of all the Board's activities. The Treasurer shall keep a complete record of all financial activities of this board. All records and financial transactions are property of the Youth Board and shall be surrendered to new officers.

ARTICLE IV - MEETINGS

This board will meet semi-annually. Meetings may be called by the Chairman or the Secretary as the need arises.

ARTICLE V - FINANCES

This board shall receive its finances from churches and individuals making special contributions, cooperative program allocations, and special offerings received through promoting youth. Mileage, room and board shall be paid from the general fund of the Youth Board for all meetings. Mileage shall be paid at the current IRS rate.

ARTICLE VI - AMENDMENTS

This constitution and by-laws may be amended by a majority vote of the state.

CONSTITUTION OF THE CHRISTIAN EDUCATION BOARD OF THE FLORIDA STATE ASSOCIATION OF FREE WILL BAPTISTS

ARTICLE I - NAME

This board shall be known as the Christian Education Board of the Florida State Association of Free Will Baptists.

ARTICLE II - PURPOSE

The purpose of this board shall be to promote the educational aims of the Florida State Association of Free Will Baptists among these: statewide Bible Institutes, Teacher training programs, Sunday School, CTS, Free Will Baptist Bible Colleges and any other training methods that will help in the growth of our churches.

ARTICLE III - THE BOARD

Section 1. Composition - this Board shall be composed of five members.

Section 2. Tenure of Office - The members of this board shall be elected for a term of five years and arranged whereby that only one member's term expires annually.

Section 3. The Board shall elect a Chairman, Assistant Chairman, and Secretary/Treasurer, which shall be elected annually.

Section 4. Vacancies - In the event irregular vacancies occur on this board, they will be filled by the Florida State Association.

Section 5. The Board shall meet at least once a year and/or whenever a meeting is deemed necessary.

ARTICLE IV - DUTIES OF THE BOARD

Section 1. To create a statewide Bible Institute program that will assist and encourage the development of regional extensions in each local association.

Section 2. To assist and encourage the growth of Sunday Schools through Sunday School conventions, workshops, etc.

Section 3. To promote the organizing of new CTS groups and to assist in the training portion of existing CTS groups.

<u>Section 4.</u> To encourage the young people of our churches to further their education in our denomination's institutions.

ARTICLE V - TRAVEL EXPENSES

Mileage shall be paid at the current IRS rate for the fiscal year for all meetings except the board meeting in connection with the State Association. If a called meeting requires members to stay overnight the room and board of each member will be paid.

ARTICLE VI - COMMITTEES

Committees may be appointed by the chairman or elected by the board as the need arises.

ARTICLE VII - REPORTS

A complete report of the Board meetings and activities, and a complete financial report must be presented to the annual State Association Meeting.

ARTICLE VII - AMENDMENTS

This constitution may be amended by a majority vote of the Board Members and final approval of the State Association.

CONSTITUTION AND BY-LAWS OF THE

FLORIDA FREE WILL BAPTIST MISSION BOARD

ARTICLE I - NAME

This Board shall be known as the Florida Free Will Baptist Mission Board, Inc.

ARTICLE II - PURPOSE

The purpose of this board shall be that of promoting mission work among Free Will Baptists in the State of Florida, beginning new mission works in the state of Florida, and overseeing the missionary and the mission work until the mission is able to assume full self supporting status.

ARTICLE III - MEMBERSHIP

This board shall be composed of members elected by the State Association and shall serve terms established on a rotational basis. One member's term shall expire annually. The number of members of this board shall be determined by the Constitution and By-Laws of the State Association.

ARTICLE IV - OFFICERS AND COMMITTEES

Officers of this board shall be Chairman and Vice Chairman, Secretary, and Treasurer. The same person may hold the office of Secretary and Treasurer. These officers shall hold office for one (1) year and may be elected to serve succeeding terms. Members of the board shall elect the officers of the board. Committees may be appointed by the chairman elected by the board as the need arises.

ARTICLE V - MEETINGS

Meetings shall be held as the need arises. Necessary meetings may be called by the chairman or any three members.

ARTICLE VI - FINANCES

This board shall receive its finances from churches and individuals making special contributions, cooperative program allocations, interest on loans, and special offerings received through promoting missions. Mileage for board member expenses shall be paid from the general fund at the IRS rate for that fiscal year. All other Board travel expenses shall be reimbursed at members cost.

BY - LAWS

Section 1. Officers of the board shall hold office according to the terms set forth in the Constitution and shall carry out those duties peculiar to the respective offices. The Secretary shall maintain a permanent record of the Board's activities. The Treasurer shall maintain a permanent record of the Board's financial transactions. All records and property mortgages and titles shall be surrendered to the succeeding Secretary.

Section 2. A majority membership shall constitute a quorum and be duly authorized to transact business. All items of business must receive a majority vote of a quorum before it is considered final. All members not present in meetings shall be notified of decisions made by the Board.

Section 3. All members shall endeavor to support mission work through cooperative efforts of the Board. Any member that fails to cooperate with the board for a period of one year may, upon recommendation of the Board, be replaced by the State Association.

Section 4. A complete report of the Board meetings and activities and a complete financial report must be presented to the annual State Association Meeting.

Section 5. Missions and churches receiving financial support must be in good standing with an association or quarterly meeting affiliated with the state or national association and must have a postor who is ingood standing with the Free Will Baptist denomination.

Section 6. The board shall have the right, by majority vote, to purchase property where there is good possibility for organizing a Free Will Baptist Church. Full title must be acquired, and no investment shall exceed the

appraised value of the real property. Missionaries and mission works receiving funding from the Mission Board will be under the direct supervision of the mission board. Missionaries serve mission works at the discretion of the board. Missions and churches with Pastors employed by the board shall be under the authority of this board for any non ruotine purchases or financial obligations.

Section 7. The mission board will be responsible for administering the Mission Shares Program under the guidelines set by the Florida State Association of Free Will Baptists.

Section 8. Any work receiving financial support must agree to support the donominational cooperative program.


Section 9. The Board shall have the right by majority vote to sell any personal or real property it deems is not necessary for continued religious use.

Section 10. Nominal grants by the Board to worthwhile churches or missions may be made when it is in the interest of the donominational cause in which benefits are certain. Grants of this nature shall be subject to money being immediately available and shall not exceed \$1000 without joint approval of the Mission Board and the State Executive Committee or Association.

Section 11. The Constitution and By-Laws may be amended by majority vote of the Board members with the approval of the State Body.
