

Functions of Committees

<u>Planning Committee:</u> The Planning Committee consists of the Moderator, Executive Secretary / Treasurer, and Chairman of each Board and reports to the Executive Committee. The responsibilities of the Planning Committee are to make intermediate and long-ranged plans for State Ministries; coordinate the efforts of the Mission Board and Christian Ministries Board; to plan the State Association theme and speakers; and to handle any items of review by the Executive Committee or the State Body.

Steering Committee: The Steering Committee consists of the Moderator, Clerk, Executive Secretary / Treasurer, the Chairman of the Christian Ministries Board and the President of the Florida Women Active For Christ. Others may be appointed by the Moderator on a special need basis. It exists for the purpose of coordinating our annual State Meeting. The responsibilities for this committee shall be: to negotiate with the various locations concerning rates and arrangements and to recommend locations to the State Body; to work with the various Convention Bureaus to secure sites; to make site inspections when necessary; to set and approve the catering contracts for meeting rooms and meal functions with the host hotel; to coordinate the meeting times and room specifications for each session; to set the schedule for the State Meeting; to coordinate the registration process for the State Meeting; and to be the on-site liaison for hotel staff.

Budget Committee: The Budget Committee consists of three members of the Executive Committee appointed by the Moderator one year in advance. The Executive Secretary / Treasurer serves as an ex-officio member. The responsibility of this committee is to analyze and compile the State's General Fund Budget. Budget requests will be submitted in writing. A representative will be available from Florida standing boards and commissions to provide information to the committee. The Executive Secretary will present his operating

expenses and the Coordinator expense. Direction from the State Moderator concerning administrative items will be provided. The Budget Committee has the authority to request additional information in compiling the budget. This budget will be presented to the Executive Committee for approval and recommendation to the State Body for final approval.

Auditing Committee: The Auditing Committee is composed of three members which shall be elected for three year terms on a rotating basis, so that one new member shall be elected annually. Members of the auditing committee may not be members of any standing board or committee. They are to review financial documents to determine that the Treasurer's report of each board and the State Association clearly reflects the financial activity for the year.

Promotional Team Concept:

The Executive Secretary – He is tasked with being the point man, representing the state ministries, not necessarily the office, to our associations and churches. This is a part-time position requiring two dates a month to be traveling.

The Editor of the Coordinator – He is tasked with delegating articles to be written and compiling the content of the state newsletter in whatever time period and manner published. He may or may not be tasked with actual layout and printing. This could lead to a third area which would become the Media Coordinator for all of these positions (to handle their perspective promotions and graphic design and printing) or he may consider delegating this to the Media Commission.

Minutes of the Sixtieth Annual Session of the

Florida State Association of Free Will Baptists

The Sixtieth Annual Session of the Florida State Association of Free Will Baptists convened at the Jacksonville Marriott in Jacksonville, Florida on May 5 – 8, 2004. This was a combined meeting with the Florida Women Active for Christ and the Florida Youth Conference. The theme for the meeting was "'Til He Comes."

Wednesday, May 5, 2004 ~ Evening Worship Service

The time of worship began with some pre-service singing led by Danny Conn. The songs included "To God Be The Glory", "At The Cross" and "Bring Them In."

Paul Smith welcomed everyone to the Worship Service and called on Leroy Cutler to open our service in prayer. The congregation then sang the hymn "Praise Him, Praise Him."

Clerk, David Baker, welcomed everyone to the Sixtieth Annual Meeting of Florida Free Will Baptists and called the session to order. The congregation then sang "How Firm A Foundation."

Charlie Elliot provided the special music for the service. He sang, "God Can Make A Way." The speaker for the service was Donnie Hussey, pastor of the Salem Free Will Baptist Church. His message title was "How Wealthy We Really Are." His text for the message was Ephesians 1:3-14 and Ephesians 3:13-21.

After the message the State Moderator, Tim Owen, named the "Committee on Committees" and the "Credentials Committee." The Committee on Committees will be made up of Charlie Elliot, John Pinson and Lavon Crawford. The Credentials

Committee will consist of Jimmy Aldridge, Greg Bevan and James Bradley.

Tim Owen made a special presentation to Tom and Lucille Collins for their years of service to Florida Free Will Baptists. After the presentation, announcements were given and Lee Craddick dismissed us in prayer.

There was a seminar presented by Ron Hunter, Director of Randall House Publications on the new "CLEAR" curriculum for the first part of the morning session.

Following a break, the morning worship service began with the singing of "Jesus Saves" and "To God Be The Glory." Ed Hutchinson offered the opening prayer for the service.

Paul Smith presided over the evening service and welcomed everyone to the service. Ed Sweigart opened the service in prayer.

Executive Secretary's Report

It has been my distinct pleasure to serve the Associations, churches, pastors and people that make up the Florida State Association of Free Will Baptists. I have been impressed by the kind and hospitable reception I have received at your Association Meetings, your local churches and in your homes. Your support and prayers kept me encouraged and moving forward in the midst of my travels and in the challenges we have faced. I had the distinct honor to visit each of our Associations except one. Due to scheduling conflicts I was unable to attend the Citrus Association during 2003. I also had the honor of being invited into a number of our churches for services.

In many ways 2003 was challenging for our State Association. We had numerous churches without pastors throughout the year. Several times during the year our State had as many as 10% of our churches seeking pastors. This office has done its best to bring potential pastors and churches together by maintaining lists of available men and churches seeking pastors. We have developed forms for pastors seeking churches to fill out to include their resumes, backgrounds and basic information that should be helpful to churches seeking a good fit for their congregation. These are kept on file and updated as needed. Our State Association also faced the challenge of a significant shortfall in Cooperative funds that were received this year. Although we can trace the reasons for the shortfall, we are still faced with the challenge of operating on less than we have budgeted for our ministries. Of course, our state also faced the challenge of a shortfall in our mission shares program. In spite of the shortfall, it continues to be the best means we have to support missionaries and their ministries.

We do want to extend our thanks to the churches and individuals who have been so faithful to support our Cooperative and Shares programs. Not only do our State ministries depend on your faithful support but so do each of our Florida missionaries.

Our State owes a great deal of gratitude for the team that produces "The Coordinator." We have one of the finest, if

not the finest State publication in our denomination. We commend Dr. Danny Conn for his work as our Editor; Ron Hunter for his expertise in lay-out and Jose Rodriguez and Daniel Perez for their efforts with the Hispanic edition. When you consider the time and effort these men put into this publication, you can see that it is indeed a labor of love for these men.

As you are aware, our agreement with Randall House ended in 2003. We are grateful for the relationship we had with them and with their support of our State Ministries over the years. We do trust you will continue to use them for all your literature needs.

As was discussed last year, we will be offering a Senior Summit in November of this year. This year's Summit will be held on November 8-10 at the Holiday Inn in St. Augustine. Rev. Bill Evans will be the principle speaker for this year's summit. We will be having evening worship services, some morning seminars, and a time to tour the city of St. Augustine. We are looking forward to beginning this ministry for our senior saints.

In closing, let me thank you for the privilege of serving in this capacity. It is always an honor to represent this State and its ministries. I also want to offer a special word of thanks to the Ryanwood Fellowship Free Will Baptist Church of Vero Beach for allowing me to serve in this capacity. They have been more than gracious to allow me to pursue and carry out this ministry. Please allow me to acknowledge the support and encouragement of my wife, Diana. She has spent many nights at home by herself while I am on the road. I appreciate her selfless attitude as I serve our State Association.

Christian Ministries Board Report

In 2003 the Christian Education Board and the Youth Board were combined to form the Christian Ministries Board. This new board assumed all the duties of the two previous boards. The stated purpose of the Christian Ministries Board is to (1) Promote the educational aims of the Florida State Association of Free Will Baptists; (2) Coordinate and direct youth training and competitive activities; (3) Encourage and equip Christian leaders and workers for effective ministry through the local Church.

Toward that goal, this past year the Christian Ministries Board sponsored three Christian Workers' Conferences: one in Ft. Walton, one in Orlando, and a Hispanic CWC in Miami; with the total of over 200 in attendance. Plans are already underway for the 2004 Conferences.

The 2003 State Youth Conference had 103 registered contestants in 81 entries. Forty-five entries advanced to the National Youth Conference in Tampa, where ten groups or individuals were recognized for their top marks. In following the tradition established by the Christian Education Board, over \$5,000 was awarded in scholarships to Free Will Baptist Bible College students, E-Team, and Youth Evangelistic Team members to encourage Florida youth in developing their service to God.

The most ambitious effort of the Christian Ministries Board this past year was the 2004 Ministers' Retreat. In January, fifteen couples boarded Royal Caribbean's, Sovereign of the Seas for a five-day cruise to Nassau, Bahamas. Our goal for the Ministers' Retreat is to provide a time of refreshing and

uplifting fellowship for the minister and his wife. We hope that each church will encourage and enable their pastor and his wife to attend the Ministers' Retreat.

The members of the Christian Ministries Board consider it a privilege to serve God and His people in this ministry. Thank you for the opportunity to be involved in teaching, training and encouraging Florida Free Will Baptists in their ministries

Don Walker, our missionary to Gainesville, is doing a GREAT job. The numbers and finances are growing steadily. In two years the number have grown from Don and his wife Dede to an average in the 50's. In the second anniversary service Don reported an attendance of 103.

We are really excited about this work and believe that its success is providing the board with ways of starting other successful Free Will Baptist churches.

In November the board hired Andres Sancho for a Hispanic work in West Palm Beach. Andres and his wife Nora came from Chili where they served in a variety of ministries. Since arriving, Andres has begun to write a religious column for a local newspaper in exchange for free advertisement. Executive Committee Report

The Executive Committee met on May 5, 2004 at the Jacksonville Marriott in the Mandarin Room. Paul Smith opened the meeting with Scripture Reading and Prayer. The following are recommendations from this meeting:

- 1. We have heard the reports from the Executive Office, the State Treasurer, the Christian Ministries Board, the Florida Mission Board, Mission Shares, the Steering Committee, and the Planning Committee. We recommend the acceptance of the reports and the adoption of the budgets.
- 2. We recommend the Moderator appoint the Resolutions Committee in the Wednesday evening service and no longer use the Committee on Committees format.
- We recommend that we invite the National Association of Free Will Baptist Convention to Florida in the year 2013.
- 4. We recommend that the office of Executive Secretary assume the responsibilities of the State Treasurer.
- 5. We recommend the following changes in our Constitution and By-Laws:
 - Article 3, Section 1 delete the word "Treasurer."

It will read – Officers: the officers of this association shall be Moderator, Assistant Moderator and Clerk to be elected by this body while in regular session.

 Article 3, Section 4 – delete the word "Treasurer."

It will read – The Executive Committee shall be composed of the Moderator, Assistant Moderator, Clerk, the Chairman of each standing board, and one elected member from each affiliated District Association. District Associations shall recommend

their representatives on the Executive Board annually. A majority of members shall constitute a quorum.

 By – Laws Section 4 - delete the phrase, "State Association Treasurer, or someone designated by the State Body" and "State Association Treasurer."

It will read - (1) It shall be the duty of the State Executive Office to receive all funds, pay all appropriate bills, disburse co-operative and designated funds in a timely manner according to the State Association's budget; (2) It shall be the duty of each State Board Treasurer to receive all funds for the board he serves, pay all appropriate bills, and disburse appropriate funds in a timely manner. (3) The State Executive Office and all State Board Treasurers shall use the same accounting system. (4) Each treasurer of the State Association shall submit his / her records to the State Association's Audit Committee annually for audit.

- 6. We recommend the adoption of the Budget Committee Report.
- 7. We heard the report from the "Committee On Assisting Struggling Churches" that was appointed in the 2003 State Meeting. We recommend the extension of the committee's work for one year, that the moderator appoint a replacement for Kevin Flannagin on the committee and that committee be increased by two (2) members. They are instructed to do a survey of "struggling churches" and then meet with the Mission Board concerning the findings. They are to report back to the Executive Committee at the 2005 State Meeting.

Committee On Struggling Churches Report

Our Committee was appointed during the 2003 State Association Meeting to see if there was some way that the State Association could assist struggling churches in our state.

One of the major issues to be addressed was regarding help with the pastor's health insurance. After looking at the issue, we feel that it would be very difficult for the State Association to get involved in that area. The fact that we are so few in numbers and notoriously not in the best of health would make it very difficult to have our own group plan.

The committee would like to offer one recommendation that would help our struggling churches. We would like to recommend that the State Association provide a full-time salary for a bivocational pastor who would meet certain criteria set forth by the State Association. This could be done for a period of one year to enable the church to get on its feet. We feel this could be administered through the State Mission Board.

While the criteria should be set by the State Body or a committee appointed by the state, we feel that a couple of criteria should be: 1) that the church agrees to participate in the state co-op, and 2) that there be a reversionary agreement with the state in the event that the church folds or leaves the State Association.

Constitution and By-Laws of the

Florida State Association of Free Will Baptists

<u>Preamble</u>

Article 1 - Name of Assembly

Section 1: This assembly shall be known as "The Florida State Association of Free Will Baptists".

Article II - Representation

Section 1: This Association shall be composed of delegates elected from the local associations belonging to this body and delegates elected from the local churches embraced by the various associations.

Section 2: All deacons and ministers who are members of, and in good standing with, a local church and local association which are members of this body are standing delegates.

Section 3: The general officers of this body shall be standing delegates.

Section 4: The delegates shall be elected as follows: one (1) delegate for each local church composed of 100 members or fraction thereof, and one (1) delegate for each additional 100 members or fraction thereof; five (5) delegates from each local association composed of fifteen (15) churches or fraction thereof, and one (1) additional delegate for each additional four (4) churches or fraction thereof. These additional delegates cannot be used unless the churches are active and are represented in the session in which they are appointed.

Article III - Officers, Boards and Committees

Section 1: Officers: the officers of this association shall be Moderator, Assistant Moderator, and Clerk to be elected by this Body while in regular session.

Section 2: The standing boards of this Association shall be the Florida Mission Board and the Christian Ministries Board.

Section 3: When the State Association deems it wise, committees or commissions may be established to perform a

specific service in restricted area on more or less permanent basis. The number of members and their terms of office of any committee or commission shall be decided by vote of the State Association and the members shall be elected by the Association.

Section 4: The Executive Committee shall be composed of the Moderator, Assistant Moderator, Clerk, the Chairman of each Standing Board, and one elected member from each affiliated District Association. District Associations shall recommend their representatives on the Executive Board annually. A majority of members shall constitute a quorum.

Section 5: When vacancies occur either by death, removal from office or by resignation, the general officers shall appoint a temporary replacement until the next regular session of this body, at which time the body shall elect a permanent replacement. A proxy may be appointed by the body to fill any absentee's place who does not attend the session.

Section 6: General officers of the Association shall serve for the term of two (2) years.

Section 7: Each standing board and the Historical Commission shall be composed of five members which shall be elected for five year terms on a rotating basis, so that one new member shall be elected annually.

The auditing committee shall be composed of three members which shall be elected for three year terms on a rotating basis, so that one new member shall be elected annually. Members of the auditing committee may not be members of any standing board or committee.

The Budget committee will be appointed by the Moderator a year in advance. The committee will consist of three members from the Executive Committee and the State Treasurer will serve as an ex-officio member.

Section 8: This body shall have the right to discipline any officer or board member who does not conduct his office in a Christian and business-like manner according to the rules of Christian conduct laid down in the New Testament.

Section 9: The executive Committee is to hire an Executive Secretary and to direct his office. The Executive Secretary is to be a non-voting member of all boards and committees.

Article IV - Meetings

Section 1: Regular: This association shall convene annually in a joint meeting with the Florida Women Active for Christ and the Youth Conference on a Wednesday evening, Thursday, Friday and Saturday as close to the first Sunday in May as possible.

Section 2: Special: The Executive Committee may be called into session by the Moderator, or by a majority of its members. Section 3: Quorum: Fifty (50) percent of the delegates shall constitute a quorum.

Article V - Finances

Section 1: All churches and associations in this body shall pay a representation fee annually. The amount of this for an association is \$200.00 per member church. The fee for local churches is \$10.00 per delegate.

Section 2: All Cooperative Plan funds coming into this body shall be spent under a budget plan. This budget must be approved by the body while in session, and no fund may be used in any way except as budgeted.

Section 3: Mileage for the Executive Committee members and standing Board members shall be paid at the IRS rate for that fiscal year. Expenses are to be paid from each Board member's account. If a called meeting requires a member to stay overnight, his room and board will be paid from the General Fund or his Board's account. Mileage and expenses shall be paid for the Moderator to attend the denomination's annual Leadership Conference.

By-Laws

Section 1: It shall be the duty of the Moderator to preside over all deliberations of this body while in session. All meetings shall be governed by Roberts Rules of Order.

Section 2: The Assistant Moderator shall assume the duties, rights and privileges of the Moderator or Clerk in the absence of either.

Section 3: It shall be the duty of the Clerk to make and keep records of all the business proceedings and activities of this body.

Section 4: (1) It shall be the duty of the State Executive Office to receive all funds, pay all appropriate bills, disburse cooperative and designated funds in a timely manner according to the State Association's budget; (2) It shall be the duty of each State Board Treasurer to receive all funds for the board he serves, pay all appropriate bills, and disburse appropriate funds in a timely manner. (3) The State Executive Office and all State Board Treasurers shall use the same accounting system. (4) Each treasurer of the State Association shall submit his / her records to the State Association's Audit Committee annually for audit.

Section 5: It shall be the duty of the auditing committee to conduct a financial audit of each treasurer's books annually. The audit shall take place after the fiscal year and before the State Association convenes. The date for the audit will be agreed upon by the audit committee and the various treasurers who shall be present at the time their books are audited.

<u>Section 6:</u> It shall be the duty of the Budget Committee to make recommendations to the State Association concerning the total State Association Budget and the allocations of State Cooperative receipts.

Section 7: Each officer, board member and standing committee or commission member must be in good standing with a Free Will Baptist Church which is a member of this body. He must be in good standing with his local association and must live within the boundaries of this Association. No person shall serve on more than on board at the same time.

Section 8: The Executive Committee shall have full authority to do all acts for and in the name of the Association when the Association is not in session and shall make a general report of all their actions to the body annually.

Section 9: Amendments to this Constitution and By-Laws must be put before the body while in session one day before voted on, and must be read at least twice and passed by a two-thirds of the delegates present.

Constitution and By-Laws of the

Florida State Free Will Baptist Mission Board

Article I - Name

This Board shall be known as the Florida Free Will Baptist Mission Board, Inc.

Article II - Purpose

This purpose of this board shall be that of promoting mission work among Free Will Baptists in the State of Florida, beginning new mission works in the state of Florida, and overseeing the missionary and the mission work until the mission is able to assume full self-supporting status.

<u>Article III - Membership</u>

This board shall be composed of members elected by the State Association and shall serve terms established on a rotational basis. One member's term shall expire annually. The number of members of this board shall be determined by the Constitution and By-Laws of the State Association

Article IV - Officers and Committees

Officers of this board shall be Chairman and Secretary / Treasurer. These officers shall hold office for one (1) year and may be elected to serve succeeding terms. The board members have the option of hiring a treasurer who is not a board member. Members of the board shall elect the officers and/or hire the treasurer of the board. Committees may be appointed by the chairman elected by the board as the need arises.

Article V - Meetings

Meetings shall be held as the need arises. Necessary meetings may be called by the chairman or any three members.

Article VI – Finances

This board shall receive its finances from churches and individuals making special contributions, cooperative program allocations, interest on loans, and special offerings received through promoting missions. Mileage for board member expenses shall be paid from the general fund at the IRS rate for that fiscal year. All other Board travel expenses shall be reimbursed at members cost.

By-Laws

Section 1: Officers of the board shall hold office according to the terms set forth in the Constitution and shall cary out those duties peculiar to the respective offices. The Secretary shall maintain a permanent record of the Board's activities. The Treasurer shall maintain a permanent record of the Board's financial transactions. All records and property mortgages and titles shall be surrendered to the succeeding Secretary.

Section 2: A majority membership shall constitute a quorum and be duly authorized to transact business. All items of business must receive a majority vote of a quorum before it is considered final. All members not present in meetings shall be notified of decisions made by the Board.

Section 3: All members shall endeavor to support mission work through cooperative efforts of the Board. Any member that fails to cooperate with the board for a period of one year may, upon recommendation of the Board, be replaced by the State Association.

Section 4: A complete report of the Board Meetings and activities and a complete financial report must be presented to the annual State Association Meeing.

Section 5: Missions and Churches receiving financial support must be in good standing with an association or quarterly meeting affiliated with the state or national association and must have a pastor in good standing with the Free Will Baptist denomination.

Section 6: The board shall have the right, by majority vote, to purchase property where there is good possibility for organizing a Free Will Baptist Church. Full title must be acquired, and no investment shall exceed the appraised value

of the real property. Missionaries and mission works receiving funding from the Mission Board will be under the direct supervision of the mission board. Missionaries serve mission works at the discretion of the board. Missions and churches with Pastors employed by the board shall be under the authority of this board shall be under the authority of this board for any no routine purchases or financial obligations.

Section 7: The mission board will be responsible for administering the Mission Shares Program un the guidelines set by the Florida State Association of Free Will Baptists.

Section 8: Any work receiving financial support must agree to support the denominational cooperative program.

Section 9: The Board shall have the right by majority vote to sell any personal or real property it deems is not necessary for continued religious use.

Section 10: Nominal grants by the Board to worthwhile churches or missions may be made when it is in the interest of the denominational cause in which benefits are certain. Grants of this nature shall be subject to money being immediately available and shall not exceed \$1000.00 without joint approval of the Mission Board and the State Executive Committee or Association.

Section 11: The Constitution and By-Laws may be amended by a majority vote of the Board members with the approval of the State Body.

Constitution of the Christian Ministries Board of the Florida State Association of Free Will Baptists

Article I - Name

This board shall be known as the Christian Ministries Board of the Florida State Association of Free Will Baptists.

Article II - Duties

Section 1. The board shall (1) Promote the educational aims of the Florida State Association of Free Will Baptists;

(2) Coordinate & direct youth training and competitive activities; (3) Encourage and equip Christian leaders and workers for effective ministry through the local Church.

Section 2. The board shall give a report of its activities, financial statement, and property inventory, and present a budget request to the Florida State Association of Free Will Baptists at its annual meeting.

Article III - Membership

Section 1. The board shall be composed of five members who shall be elected for a term of five years, arranged whereby only one members term expires annually. Unexpired terms will be filled by the Florida State Association of Free Will Baptists.

Section 2. Officers of this board shall be (1) Chairman, (2) Secretary, (3) Treasurer. Officers shall be elected by the board for one year and may be elected to serve succeeding terms.

Article IV - Meetings

Section 1. Meetings shall be held annually with additional meetings called by the chairman, or by any three members, as necessary.

<u>Article V - Finances</u>

Section 1. This board shall receive its finances from (1) Cooperative program allocation, (2) Fund raising projects, (3) Registration fees, and (4) Designated giving.

Section 2. Appropriate expenses incurred on official board business shall be paid or reimbursed from the general fund of the Christian Ministries Board. Mileage shall be paid at the current IRS rate.

Article VI - Amendments

This constitution may be amended by a majority vote of the Florida State Association of Free Will Baptists.
