Executive Director's Report

April 2020

Every once in a while, it is good for us to step back and look at the basics of our organization. At the very foundational of our existence is the question: Why are we in existence? What is our purpose as a State Association? The Mission Statement of the Florida State Association of Free Will Baptists reminds us. First, we are a "fellowship of Christian believers united to extend the witness of Christ and the building of His church in the State of Florida and throughout the world." Although, we come from churches from as far northwest as Bratt and as far southeast as Miami, we are united in purpose. Our purpose as stated is two-fold: "to promote fellowship among Florida Free Will Baptists and to provide opportunity for our churches to accomplish cooperatively what they cannot do individually." Our mission calls for us as Florida Free Will Baptists to obey His Great Commission. We are challenged to fulfill it through: The Exaltation of Jesus Christ; The Evangelization of the Lost; The Establishment of Biblical Churches; The Equipping of the Saints; and the Edification of the Body of Christ.

As Executive Director of the Florida State Association of Free Will Baptists, I take this mission statement seriously. It is my desire that through the ministry of this office this mission statement will be taken off the paper and implemented in each of our programs and events. For this to happen as laid out in our mission statement, we must work together in a cooperative manner. No one person or church or even district association can accomplish as much by themselves as we can together. For those churches and associations that have joined together with us, we thank you for your faithful support and for your help in accomplishing our mission. We would love to encourage others to join us in this broad effort to fulfill the Great Commission. Since everything begins with the local church, it is important that we see each of our ministries as an extension of that body. When our Florida Mission Shares helps keep mission workers on the field, it is an extension of the local church; when the Christian Ministries Board sponsors conferences to train workers or offers competition for our youth to better themselves, it is an extension of the local church. When the Senior Summit offers fellowship, activities and worship to our seniors, it should be seen as an extension of your local church's senior

ministry. I firmly believe that every church that participates in the ministries of the Florida State Association will be greatly enhanced by its participation.

It has been my distinct privilege to serve the Florida State Association of Free Will Baptists this past year. Financially, this past year has been a mixed bag. Our cooperative giving exceeded our budget while our Missions Shares Plan of Support fell short of its goal. We have seen again that God is faithful and His work is moving forward.
