## **Christian Ministries Board Report FY 2021**

The Christian Ministries Board is thankful for the fruitful year of 2021. Despite continued Covid restrictions and limitations, we were able minister in a variety of ways to the state of Florida Free Will Baptists.

## Executive Director's Report April 2022

What a year 2021 was! That very statement can be taken in a positive light and in a not so positive light! From a personal standpoint, the last third of 2021 was very challenging physically. It was during those months that we witnessed many in our state rise up and provide assistance to my family and myself and take over some of the responsibilities of this office. From the standpoint of our State Association, 2021 was a very positive year.

As a State Association, we were able to share in the beginning of a new project in the area of The Villages with Frank and Debbie Webster. Our State added the Women's Ministries Board to our ministries in 2021, also. This was accomplished by bringing the Florida Women for Christ as a separate ministry and incorporating it as an official board.

For the second year in a row, we exceeded our budget in both our Mission Shares and in cooperative giving in 2021. Our Mission Shares giving exceeded our goal by almost \$12,000 and our Coop giving exceeded its goal by just over \$4000. Thank you so much for your faithfulness giving through these channels. On top of this, our State Association increased its giving to National Ministries from \$320,901.71 in 2020 to \$456.256.11. That was an increase of \$135,354.40 from 2020 to 2021 and that during the pandemic.

On a mixed note, 2021 saw another one of our churches close its doors and sell its property. The Lighthouse FWB Church in St. Petersburg, ceased to function and sold the property. This church was started through our State Mission Board in the mid 1980s and went selfsupporting in 2002. Due to the foresight of our Mission Board and the church leadership, an agreement was placed in the deed to state that if the church ever ceased to be a Free Will Baptist Church in good standing with the State and National, then the proceeds were to go to the State Mission Board. After much work, this took place with just over \$800,000 going to the Mission Board for further projects. Please note: It is our suggestion that each of our churches take such action prior to discussions about closing a church.

Our events for 2021 were successful for the most part:

The 2021 Ministers' Retreat was held on January 18-20 at the Residence Inn in Daytona Beach Shores. Clint and Lynette Morgan shared with the group during the retreat. Several expressed their thoughts that this was one of the best ministers' retreats in recent history.

The Mission Shares Golf Tournament was one that will long be remembered. This is true because we had three of our guys score a "hole in one" during the tournament; we had a significant increase in participation; and we raised nearly \$4000 for Mission Shares. We congratulate Clint Morgan, Todd Raines and Daylon Watson for accomplishing the feat of a "hole in one." We want to congratulate Blake Nance and Michael Kuchera form the Beulah Church in Pensacola, for winning the tournament for the second year in a row.

Thanks to each of the sponsors for making the tournament a success.
