

Why A Full Time Evangelist

DURING THE FIRST few years of my ministry I was convinced that full time evangelists were useless men too lazy to pastor. One Free Will Baptist preacher said they were "preachers who got tired of working, stopped pastoring, and went into evangelism." I'm quite sure my belief on this subject was molded by what I had heard older and more mature ministers say. I had had no experience along this line. I always used pastors as evangelists in my church and God blessed, so I didn't see any sense in changing.

I kept hearing of Bobby Jackson, Wade Jernigan, Jack Paramore and others who were being used successfully in revivals all across the denomination. I decided to call Wade Jernigan for a meeting. God blessed. He blessed not only with conversions but with real church revival as well. John Land had entered evangelistic work, so I called him for a meeting. He came with revival enthusiasm and God used him to excite my church which was in shock after having seven leading church families move out of the city to other towns in a two-month period. Souls were saved and real church revival followed. I next called Evangelist Bobby Jackson, and again the response was great. I was convinced. I now knew that God would bless a church through the ministry of a full time evangelist. I still felt free to use a pastor-evangelist but I also was sure that there were times when it was best to call a full time evangelist.

When God spoke to my heart about doing full time revival work I gladly entered into the most blessed year of my ministry. In twenty-one revivals God blessed with over 425 altar decisions. Most of these were first time decisions. I now have some definite opinions about this matter of full time evangelism that I want to share. Whereas I am now back in pastoral work I don't feel that it is out of order to give my ideas to the "Gem". Why should our churches use full time evangelists when they are available?

- 1. The Bible teaches that they are given to the church by the Lord. If this be true, and there is no question about that, then they should be used.
- 2. They are free men. They are not tied down to a church back home, thus they can concentrate all their effort in your church. During that week he is with you he becomes an associate pastor, sharing with the

pastor and his people their burdens and joys. A pastor-evangelist can never do this. His heart and thoughts are always not far from his church back home. He knows he will have new problems to solve when he gets back. Not so with the full time evangelist. He can become totally involved with your church.

3. The full time evangelist is a professional. He knows what type of sermon is most effective in a church of your nature. He knows the best ways to keep attention, which isn't always easy. The full time evangelist knows how to give an invitation. Most of us are weak in this area. The full time evangelist cannot afford to be weak here, in fact this must be his strong point. Herein lies success or failure in the revival.

There are other reasons but these are sufficient. People have asked me why I returned to pastoring. There are several reasons. Not least among them is that far too few Missouri Churches were interested in using my services. An evangelist must have revivals to survive financially. I simply could not support my family on twenty-five revivals a year. Brother John Land is re-entering the ministry of full time evangelism. If you don't already have your meeting set for this fall or spring, why not call him? He'll bless your church. Missouri needs a full time evangelist. We all know that. If that be true, why don't we support him?

THE WHY OF FOREIGN MIS'SIONS'

Why should many talented young men and women go to foreign countries as missionaries? Is there not enough missionary work to be done in the home land? Will God permit those who have never heard the gospel to be eternally lost? Will not a God of love somehow save the heathen?

These are questions about which many are perplexed today. It is lamentably true that many Christians are not fully persuaded that the heathen are lost and that the gospel should be preached to every creature. This being true, in many Free Will Baptist churches the program of missions is at an optional enterprise. God's program of world evangelization is greatly hindered by churches and individual Christians who have little or no missionary vision or sense of responsibility to the world at large.

The following, among many others, are reasons why the Christian Church should proclaim the gospel of Jesus Christ unto all the world:

I. The lost condition of the heathen. II. The will of God. III. The plain commands of Christ.

I. The Lost Condition of the Heathen

Why are the heathen lost? This is a vital question. It is important that Christians have the right views relative to spiritual truths, especially when to have a false view will result in imperiling the souls of millions. When there is a clear understanding of the Scriptural teaching on the question of the spiritual condition of those in heathendom, there is keen interest in foreign missions.

The Bible says: "...all have sinned and come short of the glory of God." (Romans 3:23) "He that believeth not shall be damned." (Mark 16:15) "Neither is there salvation in any other: for there is none other name under heaven given among men, whereby we must be saved." (Acts 4:12) "I am the way, the truth, and the life; no man cometh unto the Father, but by me." (John 14:6)

In the first chapter of Romans Paul declares the lost state of the heathen

world: "They are without excuse." And why are they without excuse? "Because that which may be known of God is manifest in them; for God hath shewed it unto them. For the invisible things of him from the creation of the world are clearly seen, being understood by the things that are made, even his eternal power and Godhead." In other words, the apostle was saying that though the heathen have not the Bible, they have the book of creation or nature which is equally legible to all.

In the next chapter Paul said, "For when the Gentiles which have not the law (the written law) do by nature the things contained in the law, these, having not the law, are a law unto themselves; which shew the work of the law written in their hearts, their conscience also bearing witness, and their thoughts the meanwhile accusing or else excusing one another." In substance this passage states that conscience is the heathen's light. But the heathen do not live up to the light which they have-Rom. 3:9, "... for we have before proved both Jews and Gentiles, that they are all under sin." This truth is affirmed by the testimony of many missionaries who have lived among the heathen. Hudson Taylor, who for nearly fifty years had contact with the heathen in China, said that he had never met a Chinese who for an instant would claim that he had lived up to the light God had given him.

The heathen who have not heard of the Saviour will be condemned not for disobeying the gospel, but for rejecting the light which is given them in nature and conscience. They feel their guilt, yet know nothing of the remedy for sin. Therefore, they have recourse to self inflicted tortures and all sorts of idol worship which can never bring them peace or salvation. Concerning their destiny, Romans 2:12 declares, "For as many as have sinned without law shall also perish without law: and as many as have sinned in the law shall be judged by the law."

The heathen are lost. What greater motive do we need to compel us to give them the marvelous message of salvation?

To see the pulpit of a drowning man or to see a person perishing in a burning building is incentive enough to urge one to attempt to rescue him. Surely the dreadful condition of the heathen world should constrain every Christian to put into practice the words of Fanny Crosby's song:

Rescue the perishing

Care for the dying

- Snatch them in pity, from the grave, Weep o'er the erring one, lift up the fallen
- Tell them of Jesus the mighty to save.

II. The Will of God

The Bible clearly teaches that God would have all men to be saved. As the Apostle Peter stated, "The Lord is not willing that any should perish, but that all should come to repentance."

Paul, the apostle, in the second chapter of First Timothy, said: "God will have all men to be saved, and to come unto the knowledge of the truth." To prove that God would have all to be saved, reference is made in this chapter to the universal purpose of the atonement: "Jesus Christ gave himself a ransom for all." The atoning death of Christ, which was clearly for all, demonstrates the fact that all men are included in the saving purpose of God.

Further, Paul declares that these truths are "to be testified in due time." Indeed, for that very purpose he was ordained a preacher, and an apostle, a teacher of the Gentiles in faith and verity."

Missions of the present generation need to come unto the "knowledge of the truth" concerning the plan of salvation. This is essential to their salvation. Man is saved by grace through faith, and "faith cometh by hearing and hearing by the word of God," which is truth.

Jesus was motivated to witness to the woman of Samaria by a conviction that He was doing the will of God. On that occasion the disciples were concerned because Jesus had not eaten. Having been urged by His disciples to eat, he said unto them, "My meat is to do the will of him that sent me, and to finish his work." Jesus was saying in effect, the salvation of sinners is the will of

God. This is my opportunity to bring an individual to God and to plant the gospel among the Samaritans. This gave Him a greater satisfaction than eating food would have given.

Jesus is our great example. Since His meat was to do the will of God and to finish His work, the Christian's chief aim in life should be the same. To have this disposition of mind is to be a partner in the world-wide missionary effort.

III. The Plain Commands of Christ

The explicit commands of Christ should motivate every Christian to missionary exertions. He said, "Go ye into all the world and preach the gospel to every creature." (Mark 16:15) Again He said, "Go ye therefore, and teach all nations." (Matt. 28:19) His final recorded message to His disciples was: "Ye shall be witnesses unto me both in Jerusalem, and in all Judea, and in Samaria, and unto the uttermost part of the earth."

To fail to have a part in world evangelization is to be disobedient to the plain commands of our Lord. God's people do well when they apply to the carrying out of the great commission the advice that the mother of Jesus gave in Cana of Galilee—"Whatso ever he saith unto you do it."

On an occasion when Dr. Robert P. Wilder was working as a missionary in India he said: "I went to a place near Poona. On Saturday night, when I entered the hotel dining room, I found seated at the same table with me a naval officer, an infantry major and his wife, and a sergeant major and his wife. When the conversation started, the naval officer said:

"Why don't these missionaries stay at home, and mind their own business? You can get all the converts you want at a rupee a head."

I replied, "Suppose you were ordered to take your battleship to Constantinople tomorrow, and I was to ask you why you didn't stay here and mind your own business; that there was no sense in going to Constantinople:"


The man's eyes flashed fire as he said, "I would tell you to mind your own business. If we were ordered to go, we must go, even if every ship is sunk, and every sailor killed."

I said to him, "Quite right, my friend; and I have marching orders from the Divine Government to go and preach the Gospel to every creature, and the primary question is whether I am going to obey the last command of my Lord."

A large number are needed in this generation who feel the compulsion to obey the commands of Christ relative to global evangelization. Many are needed who will go with the gospel, not counting their lives dear unto themselves. Many more are needed who will make the material support of foreign missions their aim in life. Multitudes are needed who will be daily intercessors on behalf of missionaries and the perishing millions.

Can we, whose souls are lighted, With wisdom from on high, Can we to men benighted, The lamp of life deny? Salvation, oh salvation, That joyful sound proclaim,

Till every tribe and nation, Has heard of Jesus' Name!

- 5. We recommend that our offering for today be given to Dr. L. Miley.
- 6. We recommend that we designate the month of February, 1971, as the State Home Missions month, with the week of prayer that month, and we recommend, as a supplement to the

material provided by WNAC, that our State Officers prepare and distribute materials emphasizing our particular State Home Mission projects.

- 7. We recommend that the proposed Constitution and By-Laws be adopted.
- 8. Motion received that we ask the WNAC give consideration to using more Free Will Baptist women to write the Co-Laborer programs. Adopted.
