

What Will Happen To My Pastor If...?

Have you ever stopped to think—What will happen to my pastor and his family if he becomes seriously ill and requires extended hospitalization; suffers an accident and becomes disabled; or suddenly dies; or (thinking more optimistically) reaches an age where retirement is possible?

Forget the "what its," because it is a fact that ministers are occasionally hospitalized. Some become disabled, others die, and many even live to retire. Actually, unless Jesus comes soon, every pastor will face at least one or more of these possibilities.

In light of that it seems wise that a church be interested in planning for its pastor's future.

As Christians we all recognize our absolute dependence upon God. No preplanning can eliminate the need for His continuous direction and provision. Yet, the Scriptures are clear that God gave us a thinking-planning ability; and He expects us to use it in preparing for our spiritual and physical future. (Examine these passages—Proverbs 6:6-11; 13:22; 20:18; 22:3; 24:3-6; Exodus 18:13-26; 1 Kings 12:6-11; Luke 14:25-33.)

How do we get started? The most obvious place is with the pastor's salary. For instance, What basis does your church use to establish his salary? Is it, Can he "get by" on x number of dollars; or Will this amount allow him to support his family relatively worry free?

Many people compare the pastor's weekly check dollar-for-dollar to their own take-home pay. But can it be compared? Often it cannot. Why? Because in most cases there are a number of benefits that public work offers that are not included in a pastor's salary, such as:

(1) Hospitalization coverage. Almost every employer protects himself and his employee by providing some type of medical coverage. In some cases it even extends to provide coverage for the entire family or offers at a lower group-rate coverage for an additional charge. Do you offer hospitalization for your pastor? If not, have you checked what it costs him to have it? And just as a matter of information, few doctors give discounts to ministers and to my knowledge no hospitals do and rightfully so. After all it isn't their responsibility to maintain the pastor.

(2) Disability insurance is an added feature to many paychecks. It may take the form of workman's compensation or unemployment or be provided in another type of insurance package. Yet, the only protection offered most ministers in this regard is the good will of their people. This is not to demean God's people or their good will, for many pastors have been blessed with folks who genuinely love and appreciate them. Yet, few churches have enough extra income to put one pastor on a long-term disability income and hire another fulltime man. The easiest way to provide for this possibility is to secure a reasonable amount of disability insurance for your pastor and review it at each pastoral change.

(3) Life insurance. (This term is a misnomer for death insurance since one must die to collect it.) Though we are assured that "to be absent from the body is to be present with the Lord," someone must

bury the body. And of course, the cost of funeral arrangements has been affected by inflation. Most employers provide some amount of life insurance. What kind of protection does your pastor have? This is not to say that you need to know all about his financial matters or even how much insurance he has. However, it is important for you to consider providing at least a basic amount of coverage for your own peace of mind.

(4) What about retirement? If your pastor is blessed with long life he most definitely will come face to face with it. Though utopian retirement is the goal of many, for the pastor it can be a real dilemma in many ways—finances, housing, health, and not least, is the need to continue making a meaningful contribution of his life to the Lord's work. Assuring health and happiness is beyond any church's ability, but assisting with finances and housing is not.

Many churches provide a parsonage for the pastor which makes it convenient for him when he comes but does nothing for him when he leaves. Does your church consider the parsonage part of the pastor's salary? If your church does, have you thought about giving him a portion of its value when he leaves? (For example, what about one/thirtieth of its value per year of service?) Remember, he has no choice as to where he lives or how large a portion of his income is "spent" for housing. For comparison, imagine your employer moving you across the state into a house he owns, and then telling you that he will just deduct its value from your pay. Some churches are now giving a housing allowance so the

pastor chooses his home and pays for it during his wage earning years. Where will your pastor live when he retires? This is a question you can help him settle now.

An adequate retirement fund can help take the financial pressure off your pastor's shoulders. Some people can spend more than they could ever earn; but, fortunately, most pastors and their families manage their financial affairs quite well. Yet, even at best most pastor's salaries are not padded with a lot of excess money that can be put back for "those golden years." A moderate amount paid into a retirement program on a regular basis will provide a respectable income. Are you helping your pastor prepare for retirement?

Our Free Will Baptist Board of Retirement and Insurance was established to help local churches meet these needs. It offers a very attractive retirement program and some basic insurance programs. A Teach 'N Train workshop will be held at the Bethel Free Will Baptist Church in Festus, Missouri on March 19, 20, 1976.


Pastors, Sunday school superintendents, teachers, and CTS workers will be benefitted. These "How To" workshops have met with good success in many areas of our denomination.

FLEETING IMPRESSIONS by Wesley Bigelow

Missouri has been blessed with an outcropping of young people. This is obvious as we look at the hundreds that have been saved at youth camp and countless others that have been saved in our churches. This question then comes to our mind, Where is the impact that should have hit our rural areas, towns, and cities. What would have happened if we had sent three or four hundred missionaries to the Ivory Coast last year? The churches would be filled to overflow. Yet, as we survey our churches here, only a few have grown, while many have not.

Where are the young people? Are they hiding under a rock or maybe asleep on the back row? The excitement of camp is over, and that great church service that won many to the Lord happened last week. Where is the action now? What has happened? Some of the young people have become senile! They only have fleeting impressions of God touching their lives. It is like the flashbacks on the old Kung-Fu series. Every once in a while there is a memory that God did something, but eventually that thought fades away.

Ezekiel 33:31 states, "And they come unto thee as the people cometh, and they sit before thee as my people, and they hear thy words, but they will not do them: for with their mouth they shew much love, but their heart goeth after their covetousness." These are the pretenders. There is an old saying that states, "I can't hear what you say for what you are doing."

Matthew 13:20, 21 states, "But he that received the seed into stony places, the same is he that heareth the word, and anon with joy receiveth it; Yet hath he not root in himself, but dureth for a while; for when tribulation or persecution ariseth because of the word, by and by he is offended." He takes the Word of God into his heart and expects it to flourish without doing anything. Also, there is the educated idiot, who is "ever learning and never able to come to the knowledge of the truth." This person reminds us of a nut with stripped threads. There is no gripping power to tighten it down.

Let me encourage everyone to accept 1 John

2:13: "I write unto you, young men, because ye have overcome the wicked one." Let's stand and face the world with Christ, instead of running like cowards. Someone may ask how. By answering the following question truthfully.

Does God have a plan for my life? Yes, He does. He has a definite plan and purpose for the life of each believer. Today many young people are satisfied to be with the "in" group and to fit their patterns into the pattern of the world system. This type of attitude and God's will do not go together. Because the worldly Christian cannot see his faults and failures, the will of God is not clear. He will trip over the object that is not clear. Therefore, the Christian must check his life and make sure he is striving to do God's will.

By yielding our will to God we are placing our future at the disposal of God. We are expressing our confidence in God's faithfulness. It is not enough to see the wisdom of doing something; there must be the will and determination to act upon it. The surrender of one's whole life, soul, and time to the Lord is a personal transaction. It reaches its climax in complete obedience to the will of God. To delay is the loss of irreplaceable time. Remember, God only asks what is reasonable and He will reward for whatever is done for Him.

The key to discovering the will of God is to be utterly and fully surrendered. One may think this is a kind of bondage. But through Christ one comes to realize that it is a bondage of love. The Bible states that His commandments are not grievous. We serve because we love.

In our service to the Lord, it is important that we know His Word. We know His Word by prayer and study. If the Lord is touching your life for a special kind of Christian service, answer Yes. Peace and joy comes by doing His will.







The Perpetual Loan Fund

The Sikeston Free Will Baptist Church and the Oak Hill Free Will Baptist Church are only two of the many new mission churches that have borrowed from the Perpetual Loan Fund. Since this is one of the State Projects for 1976, let's take a look at what had been done.

The Sikeston Free Will Baptist Church is located on a five-acre tract of land on Interstate 51, in Sikeston, Mo. The congregation originally met on April 29, 1973, in the Sikeston Activity Center. The first service held in the new 36 x 80 foot structure was September 14, 1975. The building was mostly constructed by members of the congregation at a cost of \$25,000. This structure represents part of a 3-unit, long-range building plan. The present building will become an educational unit following the completion of a second educational unit and a permanent sanctuary. The brick building contains six class rooms, nursery facilities, and a fiberglass baptistry. The interior has dark pecan paneling and red decor, with the floors completely carpeted. There is central air and heat throughout the entire building.

A loan institution had agreed to lend the money for the construction of the building; but, due to a lot of "red tape," a great delay was caused in its construction. The church contacted the State Home Mission Board, and it was agreed to make a loan of \$10,000 from the Perpetual Loan Fund. This short-term loan thus enabled the church to begin construction of the new building. In four months



the building was completed! The church has since sent \$100.00 to the State Woman's Auxiliary to be used in the State Project of raising \$10,000. The pastor of the Sikeston Church is Rev. Denzil Durbin.

The Oak Hill Free Will Baptist Church is a new mission church. The first service of the new mission had an attendance of 18 and an offering of \$221.67. The service was held in the home of the pastor, Rev. Tom Owens. Five acres of property have been purchased. The church will be located on Highway 47 between Union and St. Clair, Missouri. Brother Owens says: "When a community sees the church is there to stay and is not some fly-by-night group, they will start attending." This is why it is so important that the mission churches secure the money to build a building. Money sent to the Perpetual Loan Fund is only used for loans to the mission churches.

Auxiliaries, if you have not already sent in your money to the State Project for the Perpetual Loan Fund, do so right away.
