EDUCATIONAL PROGRAM REPORT

The Board of Education of The National Association of Original Free Will Baptist in session at Glennville, Ga, on Thursday, June 18, 1936 prepared and submitted to The Eastern General Association, formerly the General Conference, and which was ratified by said body in regular session the following plan, namely:

First, we set a goal of \$150,000.00 to be raised by The Eastern Division of The National Association of Free Will Baptist by the 1941 session, said money to be apportioned upon a per capita basis. Basing our estimate upon the statisticial's report of 68,000 members, the amount per capita is \$2.21 each, or 50c per capita each year for five years.

Second, too, we ask The Western Division of the National Association of Free Will Baptist to raise \$100,000.00 on the same basis as above outlined.

Third, we ask for \$10,000.00 to be raised as follows, namely: 2,500.00 by Sept. 1, 1936; \$2,500.00 by Nov. 1, 1936; \$5,000.00 by Jan. 1, 1937. The amount to be raised is apportioned as follows, namely: North Carolina \$2,000.00; South Carolina \$500.00; Georgia \$300.00; Alabama \$500.00 Florida \$2,00.00; Tennessee \$1,000.00; Texas \$800.00; Ohio \$200.00; Missouri \$1,000.00; Oklahoma \$1,000.00; Arkansas \$1,000.00 Kentucky \$1,000.00; Mississippi \$500.00.

Fourth, the school in its plan will offer High School Work; College courses if warranted; Bible College courses, or Theological courses; courses in instrumental and vocal music. Too, such prepratory courses as the ministerial student may need for his preparation of studies.

Fifth the board will consider applications from teachers who hold degrees from recognized colleges and universities and who are fundamental in our faith and practice of Bible doctrine, as teachers in the designated school. Said school to open in the vicinity of Nashville, Tenn.

FOREIGN MISSION REPORT June 1, 1935 to June 1, 1936

For the past year foreign mission efforts in our church have been greater by far than they have been during any year in the past six years that this great work has been being emphasized with renewed enthusiasm among our people. More money has been raised and more work has been done for the spread of the Gospel, both in the home land and in the foreign fields, than we have been accustomed to doing in the past. Besides supporting Mr. R. Paul, a native missionary in India, through the Ceylon and India General Mission, We have helped in getting Miss Laura Belle Barnard to India where she has been working and studying the language of that section of India since August 15, 1935. Since her arrival on the foreign field, we have been supplementing her small salary for work done in Queens Hill Rest Home with the amount of \$20.00 a month.

Also, since last November Rev. Thomas H. Willey has been working among our people in several states in interest of foreign mission work. Brother Willey has encouraged foreign missions in general, but with special emphasis has he concentrated on South America, where he has had extensive experience as a missionary among the native Indians of Peru. Brother Willey is anxious to return to the South American field for the purpose of beginning independent mission work for the Free Will Baptist Church. Therefore, this great door is open to us and we must accept the

opportunity or reject it. Brother Willey is ready to go to this field as quickly as our people are willing to send him.

Moreover, the Lord has laid the burden for lost souls in the heathen lands on the hearts of quite a few of our young people. This body shall be known henceforth as the Eastern General Association of Free Will Baptists.

It shall be the purpose of this association to cooperate with the National Association in its efforts to elicit, combine, and direct the energies of the Free Will Baptist Church for the promotion of home and foreign missions, Christian education, Sunday School, Free Will Baptist League, and Ladies' Auxiliary work, and for the extension of the Kingdom of God in general.

Section 3. State conventions, associations, and conferences may represent in the Association only when they represent the associations or conferences of which they are composed, in which case they shall represent on the Dasis given in Section 2 of Article III.

This Association shall have an Executive Committee of five members and a Committee on Credentials which shall consist of one member from each state representing in the Association, and as many other committees, boards, and secretaries as it thinks necessary to carry out the program it may determine to promote, which shall be in strict cooperation with the program of the National Association.

The officers of this Association shall be a Moderator and an Assistant Moderator, a Recording Secretary and an Assistant Recording Secretary, a Treasurer and an Assistant Treasurer.

CONSTITUTION AND BY-LAWS of the EASTERN GENERAL ASSOCIATION of

FREE WILL BAPTISTS

CONSTITUTION

Preamble. We the official delegates to the General Conference of Free Will Baptists, while in session at Glennville, Georgia, June 16-19, 1936. in keeping with the requirements of Section 1 of Article III of the Constitution of the National Association of Free Will Baptists, relinquish the name "General Conference" and adopt the rules and principles which, as amended from time to time, are as follows:

ARTICLE I.

ARTICLE II

ARTICLE III

Section 1. This Association shall consist of delegates duly appointed or elected by the organizations they represent, and of ordained Free Will Baptist ministers who are of good repute in the Free Will Baptist Church.

Section 2. Associations and conferences may represent in this Association on the basis of two delegates from each association and conference of one thousand members or less and one additional delegate for each additional thousand members or fraction thereof.

ARTICLE IV.

ARTICLE V.

ARTICLE VI,

All the officers of the Association, all members of its committees and boards, all its secretaries, missionaries and agents appointed by the Assoation, or by any of its boards, shall be members of regular Free Will Baptist organizations cooperating with this Association.

ARTICLE VII.

All missionaries, teachers, and Christian workers approved, appointed, or supported by this Association must be fundamental in their views of the Bible and its teaching and in harmony with the doctrines of the Free Will Baptist Church. Also, they must give evidence of genuine Christian piety, of fervent zeal in the service of Christ, and of ability to do the work for which they are considered.

ARTICLE VIII.

This Association shall hold its meetings annually, each meeting beginning on Tuesday evening and closing on Friday of the week between the first and second Sundays in June. Called meetings may be held at the discretion of the Executive Committee.

ARTICLE IX.

There Articles may be altered at any regular session of the Association by a vote of two-thirds of the members present, providing the change is recommended at least one day before the vote is taken.

BY-LAWS

1. A portion of the Scriptures shall be read and prayer offered at the beginning of each morning and afternoon session of the Association, and prayer shall be offered at the close of each session.

2. The Moderator or the Assistant Moderator shall call the Association to order at the hour designated by the Program Committee. When neither the Moderator nor the Assistant Moderator is present, the Executive Committee shall elect a Moderator pro tem, who shall call the Association to order.

3. It shall be the duty of the Secretary to enroll the delegates to the Association who shall present themselves with proper evidence of their right to seats therein, and those enrolled by the Secretary shall compose the Association.

4. It shall be the duty of each organization representing in the Association to send a letter to the Association, giving as accurately as possible the information requested by the letter forms found in the minutes of each annual session of the Body.

5. Each organization representing in the Association shall send ten dollars (\$10.00) to the Association, and each organization representing with more than two delegates shall send an extra \$2.50 for each additional delegate sent to the Association. This money shall be used to meet the expenses of the Association and to promote the work it undertakes.

6. On the first day of the Association the Moderator shall appoint a Resolutions Committee to consist of three members. All resolutions not connected with the reports of boards and committees shall be referred to the Committee, which shall report on all resolutions referred to it, either with or without recommendations.

7. The officers of the Association, the departmental secretaries the Executive Committee, and all boards shall be elected by the Association. All other committees may be either appointed by the Moderator or elected by the Association. The Association shall vote by secret ballot in the election of its officers, but in other elections the vote may be taken by ballot or by some other method of voting.

8. The members of the Executive Committee shall be elected for a term of five years each, except the first four elected, who shall serve a period of one, two, three, and four years respectively.

9. The duties of the Executive Committee are as follows: (1) To act for the Association in matters that demand its consideration between the regular annual sessions of the Association. (2) To have oversight of arrangements for meetings of the Association with the authority to change, if necessary, the time and place of meeting. (3) To fill vacancies in the Association that may be caused by death, resignation, etc., between the regular sessions of the Association.

10. It shall be required of all members of the Association to remain throughout the entire session, unless they be excused by a majority vote of the Body.

11. Any one desiring to speak shall rise and address the Moderator and shall wait until he is recognized before speaking further.

12. The Moderator shall not allow discussions that are unchristian in spirit and that tend to create envy and strife among the brethren, and any one resenting the ruling of the Moderator in this matter shall be liable to the censure of the Body. 13. No one shall be allowed to speak more than ten minutes or twice

of two years.

15. These By-Laws may be altered at any regular session of the As-^{sociation} by a vote of two-thirds of the members present, providing the ^{change} is recommended at least one day before the vote is taken.

13. No one shall be allowed to speak more than ten minutes or twice In the same subject without permission of the Body.

14. The officers of this Association shall hold their offices for a term

CONSTITUTION

Article I, Name

This organization shall be known as the National Women's Auxiliary Convention of the Free Will Baptist Church.

Article II. Object

The object of this Convention shall be to bring the women of each state together for the purpose of transacting business pertaining to the promotion of the work in general.

Article III. Membership

This convention shall be composed of the officers of said convention together with the presidents and delegates from the state or district conventions which will include one delegate at large and one for each 25 members or major fraction thereof.

Article IV. General Officers

The officers of this convention shall be a president, five vice-presidents, recording secretary, corresponding secretary, treasurer and field worker and these officers shall compose the executive committee, five of which shall constitute a quorum.

This national convention shall meet annually at a time and place selected by the Convention while in session.

This Constitution may be amended at any annual meeting of the Convention by a two-third vote of the members present.

Section 1. President: The president shall preside over all meetings, appoint such committees as may be needed, call the executive committee together when necessary and perform such duties as usually devolve upon such an officer.

Section 2. First Vice-President: The first vice-president shall act as president in her absence or by her request and shall be in charge of the department of publications and literature. Section 3. Second Vice-President: The 2nd vice-president shall act as

Section 3. Second Vice-President: The 2nd vice-president shall act as president in the absence of the president and 1 vice-president and shall have charge of the department of Christian Education.

Section 4. Third Vice-President: The 3rd vice-president shall act as president in the absence of the president and 1 and 2 vice-presidents and shall have charge of the department of Missions.

Section 5. Fourth Vice-President: The 4th vice-president shall act as president in the absence of the president and the first three vice-presidents and shall have charge of the department of Stewardship.

Section 6. Fifth Vice-President: The 5th vice-president shall act as president in the absence of the President and the first four vice-presidents and shall have charge of the department of Benevolences.

Section 7. The Recording Secretary: The Recording Secretary shall keep an accurate record, in a well-bound book provided by the Convention, of all annual meetings of the Convention and of meetings of the Executive Committee; shall notify all officers of their election or appointment and edit the minutes of all meetings held. She shall take care of all papers of value and turn them over to her successor in office.

Section 8. The Corresponding Secretary: The Corresponding Secretary shall conduct all necessary correspondence for the Convention, send out re-Port blanks and award winners for Standard of Excellence.

Section 9. Treasurer: The treasurer shall have charge of all funds belonging to this Convention and shall pay out same only when authorized by the Convention at its annual meetings on order from the secretary signed by the President. She shall keep a correct record of all funds received and disbursed and shall give a detailed, written report at the annual meeting.

Section 10. Field Worker: A national field worker, or organizer, shall be elected annually by the Convention, who shall compile statistics from the

Article I. Duties of Officers

district Conventions and present them to the annual meetings of the national convention.

Section 11. The Executive Committee: The duty of the executive committee shall be to maintain an oversight of the work at large, fill vacancies in the interim of meetings, and act for the Convention, same to be subject to the will of the Convention at its regular meeting.

Article II. Directors of Departments

The Vice Presidents shall originate and direct plans of work for their department in harmony with the plan of work arranged and approved by the Convention, secure reports and compile them for report to the annual meeting and to be printed in the minutes.

Article III. Elections

The General Officers and Field Worker shall be elected by acclamation at the annual meeting of the Convention.

Article IV. Expenses

The expenses of the General Officers and the Field Worker to all official meetings shall be paid from the National treasury. The expense of printing the minutes shall be paid from the treasury and an appropriation of ten dollars be made to secretary for transcribing and superintending printing minutes. Postage and stationery shall be furnished the General Officers and Field Worker. Other appropriations may be decided upon by the Finance Committee and passed on by the Convention.

Article V. Committees

Section 1. Credentials: The National Corresponding Secretary shall be chairman of the Credentials Committee and other members may be appointed by the President.

Section 2. Finance: The National Treasurer shall be chairman of the Finance Committee and four other members may be appointed by the President.

Article VI. Amendments

These By-Laws may be amended by a two-thirds vote of members present at any regular annual meeting of the National Convention.
