# MINUTES

The third annual session of the Georgia State Association of the Original Free Will Baptist met in session with Corinth Church, near Iron City, Ga., Seminole County on Tuesday, Nov. 14, 1939 and continued through Thursday A. M., Nov. 16, 1939.

The devotional and welcome services were conducted by Corinth Church in a well put manner. The welcome address being given by Rev. R. L. Cartrett, and the response was made by Rev. J. F. Ashmore.

The sermon delivered by Rev. F. E. Crosby was followed with a solo sung by Rev. S. T. Shutes and accompanied by Mrs. Edith Cherry.

## AFTERNOON SERVICES AND SESSION

Devotional by Rev. Floyd Cherry—Subject, "The Environment of The Life of Jesus Christ"; prayer by the speaker.

Moderators message was delivered at this point and at which time the Moderator, Bro. K. V. Shutes confined himself to examples of faith and works which were manifested by such men as Rev. Paul Palmer, Benjamin Randal, Elis Gore, and others. His remarks were timely and encouraging, carrying with his message a charge that the church should be missionary minded with an expansive program. The Moderator was followed by Rev. H. A. Drake, who spoke concerning the originality of our church as a denomination, and of the Arminian faith.

The following amendments were offered to the Constitution and By-laws by T. B. Mellette to wait discussion and adoption at next day's session.



Sec. 2., Article 2. That any local church of any recognized body, association, or conference be allowed one delegate for each 100 members, or fraction thereof and shall pay into the treasure a minimum fee of \$1.00 annually, or more. Said delegates shall be from the laity of the church.

Article 3, Sec. 5. The Executive Board shall consist of the Moderator, the Assistant Moderator, The Secretary and Treasure, and the Assistant Secretary, or as otherwise it shall be determined by the body at a regular session, and which Executive Board may be elected from the floor at regular elections of officers, and therupon the Executive Board shall consist of members other than the regular officers:

Section 2. One delegate from each union meeting for each 1000 members or fraction thereof; provided the union meeting represents in the body.

By vote the body recessed until 9 A. M. Thursday morning for evening services.

### REPORT OF THE STATE EVANGELIST, NOV. 15, 1939

Report covers time from Nov. 1938 to November 1939.

I have held twelve meetings all of which were in Georgia.

Conversions as a result of my services total 137.

Members added to churches I have albourne number 31.

Money received as remuneration for services \$301.00.

Sunday Schools organized—Three.

This has been our work outside the pastoral care of three churches, and two of which were half time churches.

We have resigned our pastoral work to give full time to evangelistical work with the exception of one Sunday each month in which time we will pastor one church.

Too, we hope to visit as many churches in Georgia during January, February, and March as possible; also, to conduct a radio broadcast from Thomasville, Ga., for a period of time each day during the winter.

The Lord willing we expect to purchase a tent for evangelistical services and for organizing of new churches during the summer 1940, and before the session in November 1940, God helping us.

I am willing and will put all strength I can gather in this work, and as an humble servant of the Lord I need your help and prayers.

### **FIELD SECRETARY REPORT**

I have a very short report as I have not made any visits to the associations in behalf of the state body, but I have written articles to the paper.

We are glad to see two see two associations, i. e. the Union and the Benjamen Randal, come into this body, and we hope that others will soon follow. We have now eighty churches in five associations connected with this organization and a representative body of 4,560 and in which pastors received during the outgoing year \$6,297.78; missions reported through associations \$206.81.

Further, as your Field Secretary I recommend that such a person as will be able be elected who can get a more full and intelligent report.

I suggest the following, value of church property, value of church buildings and amount spent yearly for building and repairs; also, Sunday school expenditures and incidentals, amount paid to charity, pastors, evangelist, Missions home and foreign, ministerial relief and associations funds, including amount spent for Christian education.



Also, a report of membership, male, female, baptised, ex-communicated, restorations, received by letter and number of deaths, etc.

If the above can be done a complete statistical report can be made and printed in our minutes. Please do this that such a report can be tabulated.

We find only 24 L. A. S. reporting, and we feel that this number should increase and especially the working strength of same.

### **MISSION BOARD'S RECOMMENDATIONS**

#### **Same Were Adopted By The Body**

The Mission Board recommends that we continue to encourage a home mission program among our people, that we ask our pastors who are serving churches connected with this organization to take at least one free will offering for missions during the year and send the same to the treasure of the Home Mission Board.

We want to purchase a tent with which our state evangelist can work in the establishing of new churches and revival work, and expect to do this just as soon as finance will allow us. We also recommend that the board assist the state evangelist all it can in financing meetings in new fields.

Too, we ask that the report of the first session mission committee's report be incorporated in this report, which is, "We the committee on Missions, beg to submit the following:

1. That this association elect a mission board, and that the chairman of the board be the secretary of the same.

2. That the different churches have a committee, as many as will, of three who will canvass their members and get every one who will to give as much as they will each month or yearly, and the said committee send said money to the treasure of the Home Mission Board.

### **REPORT OF BOARD OF RELIGIOUS EDUCATION**

To The Georgia State Free Will Baptist Association convening at Corinth Church, Iron City Ga.

Greetings, We, the board in our last report to this body 1938 carried a request; this request was for each league in the bounds of this body to send \$5.00 to Bro. A. D. Ivey, Jakin, Ga., for educational purposes, so your board will keep recommending this, and urge each pastor to push this move.

Further, we ask the Ladies Aid Society to send an offering, and along with each S. S. to Bro. A. D. Ivey, Jakin, Ga., for religious education purposes.

We stress the idea that all educational activities be sponsored by the board.



We urge that Sunday School courses be outlined and taught in Sunday Schools, or in sections where Sunday Schools can be grouped and the center be the teaching place of the group of churches, such that the work can reach the longest possible group at the least possible cost.

We know that people must be trained in any work to be efficient. Therefore, we urge that the training begin and take on momentum now. We, also, urge that our leaders stress the need of the camp and lend their help from every standpoint. This we believe is one of the greatest ways of getting our churches together and the supporting of a full program.

The teachers for the FWB Encampment are the best type of Christians. Too, we report that Camp Sawyer has been secured for our camp 1940. Our treasure reports amount received \$733.91. Expended \$779.51. Due the treasure to date \$45.60.

# CONSTITUTION & BY-LAWS

Of The Georgia State Association of The Original Free Will Baptist Church of Christ.

## PREAMBLE

We, The Original Free Will Baptist of Georgia, assembled in order to advance, promote and increase the cause of Jesus Christ, do establish and ordain this Constitution and By-Laws.

—o-o-o—

## CONSTITUTION

### ARTICLE I

Section I. This assembly shall be know as the Georgia State Association of the Original Free Will Baptist Church of Jesus Christ.

### ARTICLE II

Section I. The officers of this Association shall be a Moderator, Assistant Moderator, Secretary and Treasure, Assistant Secretary, Field Secretary, Secretary of Foreign Missions and Executive Board.

Section II. This Association shall be composed of all active ministers who are members of an association which is a member of this body, and one delegate for every 500 members, or fraction thereof from each association which is a member of this body; one delegate for every 1000 members of a Union Meeting of an association representing in this body, and one delegate for every 100 members or fraction thereof of any local Free Will Baptist Church representing in this body.

Section III. All delegates from associations, Union Meetings, and local churches shall be elected from the laity of the church.

Section IV. Each association representing in this body shall pay annually into the treasure of this body a minimum fee, or more, of one half of one per cent per capita for all the members of the association. Each union meeting shall pay annually one fourth of one per cent per capita into the treasure of this body; each local church shall pay annually a minimum fee, or more, of one dollar (\$1.00) into the treasure of this body. Note—An association with 1000 members is required to pay \$5.00 and the Union meeting \$2.50, and the local church at least \$1.00. For associations multiply each member by one half per cent per capita, and union meetings one fourth per cent per capita.

### ARTICLE III

Section I. The following named boards shall be elected every two years in the following manner.

Section II. Board of Home Mission. The Board of Home Missions shall be composed of three members from people who are noted for missionary zeal elected by the body at the regular time for election of officers.

Section III. The Chairman of the Board of Home Missions shall be secretary and treasure of the same, or unless otherwise designated by the board.

Section IV. Board of Religious Education. This board shall consist of three members, and shall be elected at the regular time of election of officers. They shall choose their chairman, and formulate their rules, and have the right to sponsor their programs in the fields of religious education.

Section V. The Executive Board shall consist of all regular officers of this body, and as provided for in these Constitution and By-Laws, or as otherwise may be provided for.

### ARTICLE IV

Section I. All officers shall be elected at the regular time of election of officers, and these shall serve for a period of two years.

Section II. Any officer may be re-elected as the body shall see fit but the officer, or nominee must give his consent to serve willingly.

Section III. When vacancies occur either by death, or removal from office, or by resignation the body shall fill the vacancy either by proxy, or by election of officer to the vacancy at any regular session of the body, and a proxy may be appointed by the body to fill any absentee's place who does not attend the sessions.

Section IV. Election years shall be odd years, Thus the regular elections shall take place on odd years of the calander.

Section V. This body shall have and does reserve the right to deal with any officer, or board member who does not conduct his, or her office in a Christian and business like manner according to rules of Christian conduct laid down in the teaching of the New Testament. Thus the right to discipline in this body is confined to this body, but a charge against a member of this body in the members of local churches shall constitute a charge against said member in this body, and the body shall abide accordingly thereby.

### AMENDMENTS

This Constitution and these By-Laws shall not be changed or altered except by two-thirds vote of the members present in a regular session. All amendments shall lie on the table at least from morning session until evening session, or from evening session until morning session prior to adoption and shall during that be read at least twice in open session.

Additions of boards, or officers may be added as there is an occasion for same.
