I was able, by the help of friends and State Mission Board, to carry on Radio Programs from Thomasville, for four and one-half months. There are 100,000 radio homes in reach of this station and we had our part of these listeners. We went into as many churches in as many of the associations as possible, but did not get to contact some of them, because we could not get a date in them.

We ran tent meeting from March till October, organized one church and left four fine prospects for other churches. We also ran a number of church revivals, with some good results.

# *Constitution and By-Laws*

## Of the Georgia State Association of The Original Free Will Baptist Church of Christ

---

### PREAMBLE

We, The Original Free Will Baptist of Georgia, assembled in order to advance, promote and increase the cause of Jesus Christ, do establish and ordain this Constitution and By-Laws.

---

### CONSTITUTION

#### ARTICLE I

Section 1. This assembly shall be known as the Georgia State Association of the Original Free Will Baptist Church of Jesus Christ

#### ARTICLE II

Section 1. The officers of this Association shall be a Moderator, Assistant Moderator, Secretary and Treasurer, Assistant Secretary, Field Secretary, Secretary of Foreign Missions and Executive Board.

Section 11. This Association shall be composed of all active ministers who are members of an association which is a member of this body, and one delegate for every 500 members, or fraction thereof from each association which is a member of this body; one delegate for every 1000 members of a Union Meeting of an association representing in this body, and one delegate for every 100 members or fraction thereof of any local Free Will Baptist Church representing in this body.

Section III. All delegates from associations, Union Meetings, and local churches shall be elected from the laity of the church.

Section IV. Each association representing in this body shall pay annually into the treasury of this body a minimum fee, or more, of one half of one per cent per capita for all the members of the association. Each union meeting shall pay annually one fourth of one per cent per capita into the treasury of this body; each local church shall pay annually a minimum fee, or more, of one dollar (\$1.00) into the treasury of this body. Note—An association with 1000 members is required to pay \$5.00 and the Union meeting \$2.50, and the local church at least \$1.00. For associations multiply each member by one half per cent per capita, and union meeting one fourth per cent per capita.

### ARTICLE III

Section I. The following named boards shall be elected every two years in the following manner.

Section II. Board of Home Missions. The Board of Home Missions shall be composed of three members from people who are noted for missionary zeal elected by the body at the regular time for election of officers.

Section III. The Chairman of the Board of Home Missions shall be secretary and treasurer of the same, or unless otherwise designated by the board.

Section IV. Board of Religious Education. This board shall consist of three members, and shall be elected at the regular time of election of officers. They shall choose their chairman, and formulate their rules, and have the right to sponsor their programs in the fields of religious education.

Section V. The Executive Board shall consist of all regular officers, of this body, and as provided for in these Constitution and By Laws, or as otherwise may be provided for.

### ARTICLE IV

Section I. All officers shall be elected at the regular time of election of officers, and these shall serve for a period of two years.

Section II. Any officer may be re-elected as the body shall see fit but the officer, or nominee must give his consent to serve willingly.

Section III. When vacancies occur either by death, or removal from office, or by resignation the body shall fill the vacancy either by proxy, or by election of officer to the vacancy at any regular session of the body, and a proxy may be appointed by the body to fill any absentee's place who does not attend the sessions.



Section IV. Election years shall be odd years, Thus the regular elections shall take place on odd years of the calander.

Section V. This body shall have and does reserve the right to deal with any officer, or board member who does not conduct his, or her office in a Christian and business like manner according to rules of Christian conduct laid down in the teaching of the New Testament. Thus the right to discipline in this body is confined to this body, but a charge against a member of this body in the members of local churches shall conduct a charge against said member in this body, and the body shall abide accordingly thereby.

### AMENDMENTS

This Constitution and these By-Laws shall not be changed or altered except by two-third vote of the members present in a regular session. All amendments shall lie on the table at least from morning session until evening session or from evening session until morning session prior to adoption and shall during that be read at least twice in open session.

Additions of boards, or officers may be added as there is an occasion for same.
