Proceedings

The Eleventh Annual Session of the Georgia State Association of the Original Free Will Baptist convened with Ozias Church, Pearson, Georgia, Monday evening, November 10, 1947, at 7:30 o'clock.

After several songs by congregation devotional was rendered by Rev. Riley Giddens, followed by a prayer. Sermon was then delivered by the Rev. J. B. Harris, whose subject was "Missions". After the sermon arrangements were made by the host pastor, Rev. J. D. Little, and the Association was adjourned until Tuesday morning.

TUESDAY MORNING

The Association assembled at the appointed time and after singing several hymns of praise, devotional was led by Rev. Ralph Lightsey, reading I King 1: 38-39.

Welcome address by Rev. J. D. Little and response by C. J. Faison.

Moderator's message was on the subject "Union and Uction" which was given very timely and inspirationally. Prayer by Rev. J. D. Little.

The hour for the associational sermon arrived after singing and a prayer by Rev. R. W. Crawford. The Rev. E. C. Morris presented for the occasion, reading Exodus 14:15, subject "Go Forward", which was very powerful.

After sermon offering was taken in the amount of \$80.10 which was for the promotion of education. Immediately following the host pastor announced arrangements for lunch and G. W. Cloud dismissed.

Song service was opened with the song "There's Power in the Blood" and devotional was rendered by Rev. L. A. Norris which was very brief and timely.

REPORT OF CAMP COMMITTEE

We your camp committee make the following report:

We have made some surveys in regard to a camp site, and we submit here a proposition, offered by our Brother G. C. King, a tract of land containing seven acres, more or less, bounded on one side by a large creek, on another side by a small running stream suitable for a lake, with a road frontage of a thousand to fifteen hundred feet of hard surface road. Located four miles North of Ashburn on the Ashburn-Cordele Highway. This property will be a gift as stated above to the State Association for the purpose of a camp site.

We recommend that a permanent board of trustees be elected by this body whose duty it shall be to hold property deed and have charge of all administration of the work coming under this head. That this board be elected and governed in the manner provided for in the Constitution.

REPORT OF PLANNING BOARD

The following recommendations are offered by the Planning Board:

1. That a revisive committee be appointed by this session to study the Constitution of this body and offer any changes that it may deem necessary at the next session for adoption.

2. That this body decide which invitation shall be accepted for the next session, namely, Midway, Colquitt County or Belview, Miller County.

3. That the officers of this body be nominated from the floor and voted on by ballot.

4. That the Planning Board be abolished and that the body provide for the work as has been involved upon the board.

5. That a member of this body be appointed or elected to serve on the revision committee of the treatise as provided for by the National Association.

6. That this body decide whether or not we shall invite the National Association to convene in our bounds in 1949 and that plans be made for the entertainment.

7. That we render a standing vote of thanks to Ozias Church and community for the generous way in which they have entertained this session:

8. That our clerk be authorized to figure manuscript of minutes and have 800 copies printed and distributed in usual way, and that he and the moderator be allowed the usual remuneration for their labors.

REPORT OF MISSION BOARD

To the State Association convening with Ozias Church, Pearson, Georgia.

Owing to the fact that our joint board meeting at Pleasant Hill Church on December 5th has already been reported we omit that much of our activities.

On May 30, 1947 this board held a special session under a call of our chairman, Rev. H. L. Knighton. At this session we had an agreement with Rev. Ralph Lightsey that he take his tent to Colquitt, Ga., and conduct a revival meeting there for a period of four weeks or until he had organized a church.

The results were a church organized during the last week with 29 members.

At New Salem Church, Colquitt, in an annual joint board meeting on September 10 we voted Brother Knighton should go to Albany and conduct a tent meeting there. However, we failed to complete the arrangements for that meeting but we hope to start a campaign there early next spring.

It was also voted that Brother Knighton take charge of our mimeograph machine.

We appreciate the support of our people given the board this year and we humbly ask that you continue and increase your support that we may be able to increase our efforts to organize Free Will Baptist churches over Georgia.
