Song service conducted by Rev. Louis H. Moulton. Devotion by Rev. H. J. Kelly, reading verses 1-7 from 33rd chapter of Psalms. Sermon by Rev. S. T. Shutes, using John 19:5 as basis for a timely and interesting message.

At the close of the message the body entered into short business session.

#### CONSTITUTION

#### Preamble

We, the Original Free Will Baptists of the State of Georgia, do ordain this constitution for the purpose of advancing, promoting and increasing all phases of the cause of Christ.

#### Article I

Section 1. The assembly shall be known as the Georgia State Association of the Original Free Will Baptists.

#### Article II

Section 1. The Officers of this Association shall be Moderator, an Assistant Moderator, A Secretary, an Assistant Secretary and a Promotional Secretary-Treasurer.

Section 2. All regular officers and the Chairman of each standing board shall compose the Executive Board.

Section 3. This Association shall be composed of all active ministers who are members of an affiliated body, one delegate for every 500 members or fraction thereof of each affiliated union meeting, and one delegate for every 100 members or a fraction thereof of every affiliated local Free Will Baptist Church. Any union or local church shall have the privilege of affiliating with the State body independent of the District Association.

Section 4. All delegates from associations, union meetings and local churches shall be elected from the laity of the body sending them.

Section 5. Funds to meet the current and benevolent of allocations shall be paid in on a voluntary basis to the Treasurer of this Association; however, it is suggested that each affiliated body contribute as a minimum in the following order; Each district association three-fourths of one percent per capita of their respective membership and \$5.00 in addition for the National Association dues; each union meeting one-half of one per cent per capita of their respective membership, and each local church five cents per capita of their respective membership.

#### Article III

Section 1. It shall be the privilege of each affiliated district association to furnish a member for each standing board, with terms of office rotating which will necessitate one member of each board being elected annually, the number of each board shall not be less than five except the board of auditors which shall consist of two members who shall be elected at the same time of the general officers.

Section 2. There shall be a board of missions composed of members who are noted for missionary zeal and they shall have the supervision of all mission interest sponsored by this body. All undesignated mission funds shall be equally divided between home and foreign.

Section 3. There shall be a board of Christian Education whose duty it shall be to keep the body informed of all Christian education sponsored by the body and make such recommendations as they shall deem proper to the body from time to time.

Section 4. There shall be a board of superannuation whose duty it shall be to make plans and rules which shall be in harmony with the National Superannuation Board. And shall be authorized to formulate plans whereby necessary funds for superannuation may be raised.

Section 5. There shall be a board of trustees whose duty it shall be to hold titles of all property belonging to this body.

Section 6. A Board of Auditors, whose duties it shall be to audit the books of the Associational Treasurer and the Treasurers of all Boards.

#### Article IV

Section 1. All officers except board members shall be elected to serve a term of two years.

Section 2. Any officers may be reelected as the body shall see fit. Section 3. When vacancies occur for any cause they shall be filled by the Executive Board, or by any of the standing boards, subject to the approval of the Executive Board, until the convening of the annual session of the body.

Section 4. Election years shall take place on the odd years of the calendar.

Section 5. Any member who fails in the function of his or her duties without a reason, the board to which the delinquent member has been elected, shall declare the office vacant. Further, the body shall have and does reserve the right to deal with any officer or board member who does not conduct his or her office in a Christian and business like manner according to the rules of Christian conduct laid down in the New Testament. Thus the right to discipline in this body is confined to this body, but a charge against a member of this body and the member of a local Church shall constitute a charge against said member in this body and the body shall abide accordingly.

Section 6. The duties of officers so defined shall be the same as those for any deliberative assembly.

Section 7. All boards may be called in session only by the Chairman of the Executive Board and any standing board may be called

in session only by the Chairman of said board, unless said chairman becomes uncapacitated, in which case the assistant assumes the authority of said incapacitated chairman.

#### **AMENDMENTS**

This Constitution shall not be changed or altered except by a majority vote of all members present to regular session. All amendments shall lie on the table at least from the morning session prior to adoption and shall during that time be read at least twice in open session. Additions of boards or officers may be added as there is need.

#### SUPERANNUATION BOARD

The Board of Superannuation met with Glennville Church, Glennville, Georgia, November 12, 1951.

First item of business was reading the Secretary and Treasurer's report.

This board recommends that the Promotional Secretary-Treasurer furnish the board with information relative to the State Superannuation fund.

We recommend that Bro. R. B. Pyle be placed on the board as secretary-treasurer, also that W. H. Lane be elected to replace W. H. Ellis of Martin Association, and that some one be elected to replace Bro. W. H. Nobles.

We recommend that if possible, Brother Morris send each church clerk a by-law of our National Association and ask that it be read in church often.

## REPORT OF PROMOTIONAL SECRETARY E. C. Morris

The promotional work is being rendered for the fifth year of its activities. During this time much progress has been observed. We only have to view the records for the verification of this. In some fields of endeavors, the past year has not been marked with any great, or rapid growth, yet greater increases have been obtained in other fields. While there have been no grounds lost in any phase of the work that will probably give cause for alarm, there should be some consideration given to certain efforts. May we be thinking of the weak places while considering this report and then seek for the remedy. On the other hand,

there are gains for which we should be very grateful. May they be noted as we proceed, then seek ways and means of promoting them still further until all shall be brought under the banner of full co-operation and fellowship.

For the first time since working under the budget system, the State Association has, not only raised the budget, but gone some over two thousand beyond. If all the funds had been raised for the unified system all phases of the budget would have been met, however, since special efforts have been launched for certain funds, it causes some phases to be oversubscribed while others go lacking. Even though we have made wonderful progress in our unified effort, there are still some grounds to be gained before we can properly take care of all the various needs.

The churches which have supported the Unified Program with monthly offerings follow:

St. John and St. James in the Chattahoochee Association. Elders H. J. Kelly and H. L. Knighton are the pastors respectively. New Ebenezer in the Georgia Union Association, Eld. Emmett McDuffie, pastor. Ozias in the Little River Association, Eld. E. C. Morris, pastor. Midway in the Union Association, Eld. L. S. Anthony, pastor. Patmos, Travelers Rest, Live Oak, Blakely and Cedar Springs in the Midway Association. Elders C. R. Houston, H. L. Roberts, E. C. Morris and Ralph Lightsey, pastors. Harmony, Unity, Marietta and Glennville in the South Georgia Association. Elders J. O. Fort, C. J. Pitts, I. J. Blackwelder and Louis H. Moulton, pastors.

The total number of churches on the Grand Honor Roll of the year is fourteen.

The St. John Church in the Chattahoochee Association stands at the head of the list of Honor Roll churces for giving more per capita member on the Unified Program by sending in \$535.66. Harmony in the South Georgia Association holds second place by sending in \$415.41.

There are twelve churches placed on the Junior Honor Roll for having sent in six or more offerings during the year on the Unified Program. They are as follows:

Christian Hill and Double Branch ten and eight offerings respectively. Greenwood, ten offerings; Colquitt, seven; Bellview and New Salem, eleven each. Ebenezer, ten; Alabama, ten; Metter, eight; Lower Corinth, six. Macedonia, eight; White Pond, eleven.

Beside the honor roll churches, thirty-five more have sent in from one to five offerings, which make a total of sixty-one churches supporting Unified Program. Then, in addition to the churches supporting the Unified Program, there are nineteen more which have sent in offerings for one or more of the various phases of the work, which makes a grand total of eighty churches which have co-operated in the Promotional Program. This is the greatest number of any previous year.

For the first time, two district associations have the distinction of every church on their list co-operating with the Promotional Program by making one or more offerings for one or more of the causes sponsored. These are the Midway and the Georgia Union. The South Georgia only lacked one of making this honor.

We are glad to report that four new churches have been organized this year, namely, Cairo and Pelham in the Union Association, River Turn in the Martin Association, and Albany in the Midway Association. We have been informed of some mission points that are favorable for organizing soon.

Our needs for the coming year can be summed up as follows:

Camp buildings \$5,000.00. Bible College \$100,000.00. Foreign Missions \$2,500.00. Superannuation \$1,000.00. Several thousands for the purpose of erecting buildings for the newly organized churches. Ample support for the Alabama Children's Home. Other needs, but these especially. The needs are great but the opportunities are equally great. We have a great Saviour and with Him, we can do great things. May we all work together for a greater place in the Kingdom of our God.
