



Song Service conducted by Rev. I. J. Blackwelder. Devotional by Rev. H. J. Kelly, reading from Matthew 11:28-30, using 29th verse for theme (Humility). Song, "Love Lifted Me." Prayer by Rev. Manse Cason. The message of the evening was delivered by Rev. Louis H. Moulton, reading Mark 16:17-18. The message was very timely and enlightening. Prayer by Bro. Moulton. The Moderator then declared the body in order for a short business session. Moderator appointed Credentials Committee as fol-

Moderator made a report, naming some of the progress that had been made in the State work, also expressed to all his appreciation for the cooperation that had been given him during his tenure of four years as Moderator.

Report of Committee on Committees called for by Moderator. Report read. (See report.) Motion that report be accepted and Committee released.

Words of Welcome were extended to all by Mayor of Thomaston, a deacon of the First Baptist Church of Thomaston, Marvin Adams, a member of City council, and Rev. Oliver, Pastor of Methodist Church and Chairman of Ministerial Association.

Response to words of welcome was given by Rev. H. L. Knighton.

Report of Woman's Auxiliary Convention was given by Mrs. Edith Shiver, President. Song service conducted by Rev. S. T. Shutes. A worshipful offering was taken for the Unified Program. Special music was arranged by Rev. S. T. Shutes. The morning message was

Rev. K. V. Shutes, a member of College board of Trustees, extended greetings from the college, also made a report relative to the growth and conditions of the Bible College. Rev. T. G. Hamilton, Mrs. T. G. Hamilton and Rev. C. B. Dowdney, Bible College students, also spoke of the College.

Rev. E. C. Morris, State Promotional Secretary-Treasurer, made his annual report. Motion that report be received. (See report.) Motion that a rising vote of thanks be extended to Bro. Morris for his great work as Promotional Secretary-Treasurer.

Greetings from the National Association were extended by Rev. Damon C. Dodd. Telegram from Dr. L. C. Johnson, President Bible College, was read, expressing his regrets not being able to attend this session. Dr. Johnson's idea and plan for raising funds to liquidate the indebtedness of the College was given to the body.

All ministers present gave a rising vote of thanks to all laymen of the state for their support of the Unified Program.

Song service conducted by Rev. S. T. Shutes. Prayer by Rev. A. J. Lambert. Devotion by Rev. W. S. Driggers, reading Psalms 23. The message was interesting and inspiring. Greetings were extended by Rev. A. J. Lambert, Moderator Alabama State Association.

Report of Board of Trustees was read and received. (See report.)

Final report of Credential Committee was read. Motion that report be accepted and Committee released. (See report.) Report of Resolutions Committee was read. Motion that report be accepted and Committee released, provided it is amended to provide for a rising vote of thanks to the Chattahoochee Association and the City of Thomaston for the great hospitality during this session, and further that we have 1500 copies of minutes printed and the Clerk and Moderator be paid an honorary fee of \$25.00 and \$15.00 respectively. Motion that clerk and Moderator be paid \$25.00 and \$15.00 respectively for all future sessions, unless otherwise established by this body.

Constitutional Committee re-read report relative to proposed changes of Article IV, Section 5. Motion that proposed change be adopted. Report of Auditors was made. Motion that report be accepted. 

COMMITTEE ON CONSTITUTIONAL AMENDMENTS

We, your committee on Constitutional Amendments, appointed by the Moderator in a meeting of the Executive Board, wish to offer for your consideration, the following:

Section 5 of Article IV be changed to read as follows:

A member of any board who fails in the function of his or her duties without a reason, the board to which the delinquent member has been elected, shall declare the office vacant. Further, the body shall have and does reserve the right to deal with any officer or board nember who does not conduct his or her office in a Christian and business like manner, according to the rules of Christian conduct laid down in the New Testament. Should such board fail to have a sufficient number of its members present to constitute a quorum, it shall then become the duty of the Executive Board to deal with any delinquent member. 

1. Boards making reports were as follows: Christian Education, Superannuation, and Mission.

Motion that C. J. Faison and Ernest J. Barker be recommended to nominating Committee to become additional members of Camp Building Committee, making a total of five (5).

Motion that the names of G. C. King and Rev. T. B. Melette be recommended to Nomination Committee for Camp Committee.

Rev. H. L. Knighton requested that the Camp Committee make plans and arrangements for a care taker at the camp. The same later be made as a motion.

Motion to adjourn. Prayer by Rev. H. L. Knighton.

MISSION BOARD

Blakely, Ga., November 10, 1952.

The Mission Board met in joint session with all boards on this date and after some matters were brought to our attention, we met in regular session to consider anything that should properly come before us.

First, we had the minutes read of the year's work, and after considering same, accepted them as read.

The matter of the possibility of the ronting the Mission Tent was discussed as there was some question of it being used when we are not using same and after a motion which carried the handling of the tent was left in the hands of Bro. Harvey and Cloud for them to use their discretion and look out for same.

Bro. Harvey then made the finance report for the year, which we accepted and are ordering same to be placed before the State Association in session for their reception, etc. Motion carried that we create a revolving loan fund from the funds which come into our board for the purpose of aiding worthy churches in their building programs. This fund to be administered in the following manner: We are setting aside in this fund now, two hundred dollars (\$200.00) as the starter to build to in the following manner: Fifty per cent of all incoming funds, and the loans are to be made to churches when they have good and sufficient titles to their property to satisfy the State body, and a charge of five percent, per annum (5%) be charged on all loans after thirty days. The loans to be repaid in thirty, sixty and ninety and six months and yearly basis. Same to be agreed upon by the church and board representatives. The Board was authorized to proceed with the securing the proper legal aid and papers to enter into this program. Also the treasurer is to be bonded in the full amount that five dollars (\$5.00) will pay for in security bond.

CONSTITUTION

Preamble

We, the Original Free Will Baptists of the State of Georgia, do ordain this constitution for the purpose of advancing, promoting and increasing all phases of the cause of Christ.

Article I

Section 1. The assembly shall be known as the Georgia State Association of the Original Free Will Baptists.

Article II

Section 1. 'The Officers of this Association shall be Moderator, an Assistant Moderator, a Secretary, an assistant Secretary and a Proriotional Secretary-Treasurer.

Section 2. All regular officers and the Chairman of each standing board shall compose the Executive Board.

Section 3. This Association shall be composed of all active ministers who are members of an affiliated body, one delegate for every 500 members or fraction thereof of each affiliated union meeting, and one delegate for every 100 members or fraction thereof of every affiliated local Free Will Baptist Church. Any Union or local church shall have the privilege of affiliating with the State body independent of the District Association.

Section 4. All delegates from Associations, Union meetings and local churches shall be elected from the laity of the body sending them.

Section 5. Funds to meet the current and benevelent of allocations shall be paid in on a voluntary basis to the Treasurer of this Association; however, it is suggested that each affiliated body contribute as minimum in the following order: Each district Association three-fourths of one per cent per capita of their respective membership and \$5.00 in addition for the National Association dues; each Union meeting one-half of one per cent per capita of their respective membership, and each local church five cents per capita of their re-



Article III

Section 1. It shall be the privilege of each affiliate district Association to furnish a member for each standing board, with terms of office rotating which will necessitate one member of each board being elected annually, the number of each board shall not be less than five except the board of auditors which shall consist of two members who shall be elected at the same time of the general officers.

Section 2. There shall be a board of missions composed of memters who are noted for missionary zeal and they shall have the supervision of all mission interest sponsored by this body. All undesignated mission funds shall be equally divided between home and foreign.

Section 3. There shall be a board of Christian Education whose duty it shall be to keep the body informed of all christian education sponsored by the body and make such recommendations as they shall deem proper to the body from time to time.

Section 4. There shall be a board of superannuation whose duty it shall be to make plans and rules which shall be in harmony with the National Superannuation Board. And shall be authorized to formulate plans whereby necessary funds for superannuation may be raised.

Section 5. There shall be a board of trustees whose duty it shall be to hold titles of all property belonging to this body.

Section 6. A Board of Auditors, whose duties it shall be to audit the books of the Associational Treasurer and the Treasurers of all Boards.

Article IV

Section 1. All officers except board members shall be elected to serve a term of two years.

Section 2. Any officers may be re-elected as the body shall see fit.

Section 3. When vacancies occur for any cause they shall be filled by the Executive Board, or by any of the standing boards, subject to the approval of the Executive Board, until the convening of the annual session of the body.

4. Election years shall take place on the odd years of the calendar.

Section 5. A member of any board who fails in the function of his or her duties without a reason, the board to which the delinquent member has been elected, shall declare the office vacant. Further, the body shall have and does reserve the right to deal with any officer or board member who does not conduct his or her office in a Christian and business-like manner, according to the rules of Christian conduct laid down in the New Testament. Should such board fail to have a sufficient number of its members present to constitute a quorum, it shall then become the duty of the Executive Board to deal with any delinquent member. Also, a charge against a member of this body and a member of a local church shall constitute a charge against said member in this body and the body shall abide accordingly.

Section 6. The duties of officers so defined shall be the same as those for any deliberative assembly.

Section 7. All boards may be called in session only by the Chairman of the Executive Board and any standing board may be called in session only by the Chairman of said board, unless said chairman be-



comes uncapacited in which case the assistant assumes the authority of said uncapacited chairman.

AMENDMENTS

This Constitution shall not be changed or altered except by a majority vote of all members present to regular session. All amendments shall lie on the table at least from the morning session until evening session or from evening session until morning prior to adoption and shall during that time be read at least twice in open session. Additions of boards or officers may be added as there is need.

CONSTITUTION OF GEORGIA STATE LEAGUE CONVENTION

PREAMBLE

We, the Original Free Will Baptists of the State of Georgia, do ordain and establish this Constitution for the purpose of advancing and promoting Free Will Baptist Leagues in the State of Georgia.

Article I

NAME: The name of this organization shall be the Orighnal Free Will Baptist State League Convention of Georgia.

Article II

OFFICERS: The Officers of this State League Convention shall be a President, Vice-President, Recording Secretary, Corresponding Secretary, Treasurer, Chorister, Pianist, and Bible Quiz Leader. All of whom shall be elected annually by this Convention.

Article III

MEMBERSHIP: Section I. Each District League Convention shall be entitled to send five (5) delegates to this Convention. Each individual League shall be entitled to one (1) delegate to represent in this body. All Ordained Ministers shall be considered members of this State League Convention and shall be privileged to vote.

DUES: Section II. The Dues for this State League Convention shall be as follows: (1) District League Convention \$5.00. (2) Each individual League Convention representing \$3.00.

Article IV

COMMITTEES: The Committees of this State League Convention shall be as follows:

1. The Program Planning Committee, whose duty shall be to plan the program for each State League Convention, and shall be composed of the officers of the Convention.

2. The Resolutions Committee, shail consist of three members appointed by the President of the League Convention, or elected from the floor.

3. The Digest Committee, shall consist of three members appointed by the Chair, or elected from the floor.

The duty of the Digest Committee shall be to receive the reports from the various leagues representing (District and Individuals), along with the dues from each, and furnish a digest of the reports to the Convention.

4. The Nominating Committee, shall consist of five members elected from the floor. Whose duty it shall be to furnish the Convention with the names of persons nominated for the various offices of the State League Convention.

Article V

MEETINGS: The Original Free Will Baptist State League Convention of Georgia, shall convene annually on the day after Thanks-

giving.

AMENDMENTS

This Constitution shall not be changed or altered except by a twoinitids majority vote of all members present. All amendments shall lie on the table at least from the morning session prior to adoption and shall, during that time be read at least twice in open session.



As a promotional Board for the educational activities of the Georgia State Association of Free Will Baptists we propose the following:


1. That all churches promote Christian Education because our youth of today to be our leaders of tomorrow.

There was a motion made and sustained by the Board to make a monthly loan to Bro. Kenneth Faison in the amount of \$30.00 per month for nine (9) months that he might attend the college at Nashville to prepare himself for the ministry. We would recommend to any of our churches who may have young people desiring to attend our Bible College and are not financially able, that the church makes loans to them which may become a revolving fund and that this board



REPORT OF PROMOTIONAL SECRETARY

(E. C. Morris)

"Time speeds on wings," is an old saying that seems to be true. Here we are, having reached another mile post on our onward march to the boundless eternity. The year just closing in our Promotional activities is one that has been marked with splendid success. What has been done is not only encouraging but inspiring. The State Association has been an agent in promoting all denominational endeavors from the very beginning of its existence and for some years seed were sown in faith and watered with prayers and devotions and now we have the plants growing which we will soon be gathering the harvest of God's bounties. Many pages could be used in writing the report of Promotional effort and results, but time and space forbids a full detail here, therefore, we will submit factual figures as we have them for your consideration. This is the first report of actual full time service being rendered by your Promotional Secretay. That which has been accomplished will determine whether or not the results justify the efforts. As your Promotional Secretary, we feel humbly grateful for the gracious manner in which we have been received and the splendid cooperation given. We, therefore, must attribute what success has been obtained to the Free Will Baptists of Georgia and adjoining states.

Two new churches have been organized during the year, namely, White Oaks in Macon and the First Church of Savannah. Two

churches have changed their affiliations from us to the Florida Association. This leaves us with the same number of churches as that of last year. The net gain in membership, while not so great, yet show that we are still gaining ground. There are nine more Sunday Schools reported this year, five more Leagues and five more Woman's Auxiliaries with the total enrollments showing quite a considerable gain over that of last report. The number of weekly prayer servicees remain the same which is just a few over half of the churches. This should be made better.

We are glad to report that every church in the State Association can claim having a part in the support of one or more of some phase of the Unified Program and one hundred sixteen supported the entire program with one or more offerings during the year. This nearly doubles any previous number on the Unified list of contributors.

A summary of activities follows:

In the office, we have issued 4,200 mimeographed copies of the monthly Bulletins, kept up with quite a volume of correspondnece in which vital contacts have been made. On the field, ninety four churches were visited, six revivals conducted, attended all the district associations, eight unlon and quarterly meetings. two Sunday School Conventions, the State League Convention, two Missionary conferences, the semi annual session of the National Home Mission Board and the National Association, beside several boards and committee meetings. There have been 187 sermons and forty/ five special lectures delivered. Conducted one funeral and taught nine Sunday School classes and in two weeks study courses. Asssisted in organizing one Church and two dedication services. Visited 185 homes and 31 sick. Received thirty into Church membership.





A motion was made that the delegates be seated who had paid their dues and that the compiling committee report on it at noon hour.


The ministers who were present were recognized at this time. and the minutes of the last session were read and approved.




