

# Constitution

· (ARANA)

#### PREAMBLE

We, the Original Free Will Baptists of the state of Georgia, do ordain this constitution for the purpose of advancing, promoting and increasing all phases of the cause of Christ.

#### Article I

Section 1. The assembly shall be known as the Georgia State Association of the Original Free Will Baptists.

#### Article II

Section 1. The officers of this association shall be moderator, an assistant moderator, a secretary, an assistant secretary and a promotional secretary-treasurer.

Section 2. All regular officers and the chairman of each standing board shall compose the executive board.

Section 3. This association shall be composed of all active ministers, deacons and missionaries who are members of any affiliated bodies. One delegate for every 500 members, or a fraction thereof, of each district association or union meeting, and one delegate for every 100 members or a fraction thereof of all local affiliated churches.

Section 4. All delegates from associations, union meetings and local churches shall be elected from the laity of the body sending them.

Section 5. Funds to meet current needs of the body shall be paid in on a voluntary basis to the treasurer of the association, however, it is suggested that each association give as shall be allocated to them each year by a committee, and that each union meeting give five dollars and each local church give five cents per capita for their respective membership.

#### Article III

Section 1. It shall be the privilege of each affiliated association to furnish a member of each standing board with terms of office rotating which will necessitate the election of four members at one election year and three members at the next election year, giving each member a term of office of four years each. The exception will be the board of auditors which shall consist of two members who shall be elected at the same time as the general officers.

Section 2. There shall be a board of missions composed of members who are noted for missionary zeal and they shall have the supervision of all mission interest sponsored by this body. All undesignated mission funds shall be equally divided between home and foreign.

Section 3. There shall be a board of Christian education whose duty it shall be to keep the body informed of all Christian education sponsored by the body and make such recommendations as they shall deem proper to the body from time to time.

Section 4. There shall be a board of superannuation whose duty it shall

be to make plans and rules which shall be in harmony with the National

Superannuation Board. And shall be authorized to formulate plans whereby necessary funds for superannuation may be raised.

Section 5. There shall be a board of trustees whose duty it shall be to hold titles of all property belonging to this body.

Section 6. A board of auditors, whose duties it shall be to audit the books of the association treasurer and the treasurers of all boards.

Section 7. There shall be a camp board whose duties shall be to supervise the entire activities of the camp; arranging the time of sessions, electing all faculty members, forming all the study courses, especially those leadings to a completion with the issue of certificates.

#### Article IV

Section 1. All officers, except board members, shall be elected to serve a term of two years.

Section 2. Any officers may be re-elected as the body shall see fit.

Section 3. When vacancies occur for any cause they shall be filled by the executive board, or by any of the standing boards, subject to the approval of the executive board, until the convening of the annual session of the body.

Section 4. Election years shall take place on the odd years of the calendar.

Section 5. A member of any board who fails in the function of his or her duties without a reason, the board to which the delinquent members has been elected, shall declare the office vacant. Further, the body shall have and does reserve the right to deal with any officer or board member who does not conduct his or her office in a Christian and businesslike manner, according to the rules of Christian conduct laid down in the New Testament. Should such board fail to have a sufficient number of its members present to constitute a quorum, it shall become the duty of the executive board to deal with any delinquent member. Also, a charge against a member of this body and a member of a local church shall constitute a charge against said member in this body and the body shall abide accordingly.

Section 6. The duties of officers so defined shall be the same as those for any deliberative assembly.

Section 7. All boards may be called in session only by the chairman of the executive board and any standing board may be called in session only by the chairman of said board, unless said chairman becomes uncapacited in which case the assistant assumes the authority of said uncapacited chairman.

#### Amendments

This constitution shall not be changed or altered except by a majority of all members present to regular session. All amendments shall lie on the table at least from the morning session until evening session or from evening session until morning prior to adoption and shall, during the time be read at least twice in open session. Additions of boards or officers may be added as there is need.

### PROCEEDINGS

The State Association of Original Free Will Baptists of Georgia met with Mt. Olive Free Will Baptist Church near Reynolds, Georgia, on Tuesday evening, November 14, 1961. This was the twenty-fifth, or silver anniversary session.

Service began at 7:00 o'clock with singing led by the Rev. James E. Ursrey, music director for the session. The clerk called the body to order and presided for the evening, the moderator and the assistant moderator being absent.

Motion made and carried to adopt the prepared program, giving the moderator the privilege to make any necessary changes.

The association was given a cordial welcome to Mt. Olive Church and the Chattahoochee Association by Rev. Frank Willis, host pastor, and Rev. J. W. Childree, past moderator of the Chattahoochee Association.

At this time the presiding officer, Rev. S. T. Shutes, recognized those

attending from the various districts, asking each group to stand. Then the ministers, deacons, and auxiliary members were also recognized.

The moderator having been called away because of a funeral, his message was postponed until Wednesday morning.

After a song by the congregation, Revs. James Ursrey and Bill Gardner sang a duet: the song, "Face to Face." Prayer led by Rev. Louis H. Moulton. Rev. Shutes presented Rev. Irvin Hyman who brought the opening message. His subject was, "That We May Know Him," and the text was Philippians 3:10a. It was an informative message.

Brother Shutes presented the moderator, Rev. C. R. Houston, who had arrived from attending a funeral and the moderator then appointed the committee on committees. Committee: Rev. E. C. Morris, Bro. J. W. Franks, Bro. W. J. Starr.

Rev. T. B. Mellette gave a partial report of the credential committee. Moved and carried to accept report.

The host pastor assigned those who were away from home to homes in the community and the association was recessed until 9:30 Wednesday morning.

#### WEDNESDAY A. M.

To begin the service the music director led in singing, "Standing on the Promises" and "Higher Ground." After the prayer, the moderator gave his message. He pointed out some of the accomplishments of the State Association during the twenty-five years of her history, naming some of those who had led in the movement.

We were led in our devotional meditations by Rev. Richard H. Sample. He gave some very timely remarks on "A Praying Church," based on Acts 12:5.

The clerk read the report of the executive board and the minutes of the

#### Tuesday evening session of the association. Motion carried to adopt report.

A partial report of the credential was given by Rev. T. B. Mellette and accepted by the body.

The association accepted the report of the committee on committees as read by Rev. E. C. Morris. (See report.)

The clerk read a resolution of respect to the Rev. and Mrs. E. C. Morris for fourteen years of faithful service in the promotional office of the State Association. The resolution was written by the assistant moderator and clerk and adopted by the association. (See resolution.)

The congregation sang "Love Lifted Me," and then the assistant moderator, Rev. Damon C. Dodd, extended a hand of welcome to those visiting with us.

Rev. Carlton Lambert, superintendent of the Children's Home at Eldridge, Alabama, gave an encouraging report of the home.

Motion carried that this body accept this report from Brother Lambert relative to the gifts from Georgia and the general report; further that we accept their challenge for placing a trustee from each district association in Georgia to the Board of Trustees of the Free Will Baptist Children's Home in Eldridge, Alabama.

A brief but timely report of the Free Will Baptist Press of Ayden, North Carolina, was given by the business manager, Rev. N. Bruce Barrow.

The moderator appointed ushers to receive an offering while the congregation sang, "'Tis So Sweet to Trust in Jesus."

Rev. W. M. Gardner sang "Amazing Grace" while the congregation hummed. It was sweet and uplifting.

The clerk, Rev. S. T. Shutes, introduced Rev. James Pelt to bring the morning message. His subject was, "That We May Follow Him." He read from Philippians 2:1-12, and the message was taken from Verses 5-11. In this sermon Brother Pelt exalted Christ and pointed men to His humility and example as our pattern for life.

We were dismissed for lunch by Rev. Odell Harris.

#### WEDNESDAY P. M.

After singing, led by the music director, Rev. Emmitt McDuffie gave the devotional thoughts on "A Witnessing Church," using Acts 1:8 as a Scripture text. It was inspiring.

Mrs. J. W. Clower gave a report of the Woman's Auxiliary Convention.

Report of the promotional secretary was read and adopted. It was a good report, but sorrowful because it was the last to be given by the present secretary, Bro. Morris.

Dr. L. C. Johnson, president of Free Will Baptist Bible College, gave a brief report of the college.

Moved and carried that the State Association of Georgia put its approbation on the twenty dollar gift project to the college in Nashville, Tennessee, for the purpose of paying off the debt and expanding the college.

The camp board report was given by the secretary-treasurer, Wallace Franks. Motion carried to adopt the report.

Someone from the congregation called for a report of the spiritual side of the youth camp. This was given by Brothers Bill Gardner, Paul Irvin, James Ursrey, T. B. Mellette, and S. T. Shutes.

Superannuation report was given and adopted by motion and second.

Rev. Louis H. Moulton read the report of the temperance committee. Motion carried to adopt the report.

The allocations committee report was read by Mrs. L. E. Sheffield. Adopted as read. (See report.)

The report of the board of Christian education was read by the secretary, Rev. Charles Clark. Motion carried to adopt report.

Recessed for supper.

#### WEDNESDAY EVENING

The Mission Board of the State Association had charge of the service

Wednesday evening. After singing and prayer the chairman of the board, Rev. W. M. Gardner, introduced the members of the board who were present. Then he called for Rev. Mance Cason, secretary, to give the report. Motion carried to adopt the report.

Since Brother Gardner was leaving the state, he gave the association his resignation which was accepted. By motion and second the association extended to Brother Gardner a rising vote of thanks for his services to the cause of missions in the state.

An offering was received for the cause of missions. The ministers present sang "The Old Rugged Cross," and then the music director sang a solo.

The sermon was preached by Rev. W. M. Gardner. He used for a subject, "The High Calling of God," with Philippians 3:14b as a text. His message was full of true gospel facts.

Rev. Frank Willis, the host pastor, assigned those who had arrived during the day to homes and we were recessed until 9:15 on Thursday morning.

#### THURSDAY A. M.

The service was begun by singing "All Hail the Power," and prayer by Rev. Mance R. Cason. We were then favored by a solo by Rev. Bill Gardner, "Ship Ahoy."

Rev. J. E. Wood gave the devotional message on "An Approved Church," from 2 Timothy 2:15. The message was good.

The committee on resolutions was read and adopted. (See report.)

The moderator called for a report of the Sunday School and League Conventions. The reports were to be sent to the clerk.

Rev. T. B. Mellette read the final report of the credentials committee.

#### The report was adopted.

The auditing committee reported that all books were correct and in order. Motion carried to adopt the report.

The minutes of the previous day, and up until this time were read and adopted.

The report of the nominating committee was read by Rev. T. G. Hamilton. Motion carried to receive the report. Since there were no other nominations, a motion was made and carried to elect the slate of officers as nominated by the committee. (See report.)

Bro. Billy Hatcher was nominated and elected to the mission board to fill the place left vacant by the election of Rev. Mance R. Cason to the office of promotional secretary.

Motion made and carried to accept an invitation to meet with the Georgia Union Association at Pine Level Church near Chester, Georgia, in 1962.

Motion to amend the report of the credential committee to include Atlanta Church. Carried.

Moved and carried that we request Rev. W. J. Childree to release the manuscript he is preparing for the local paper to the Associated Press for publication. The following delegates were appointed to the National Association: O. B. Everson, Ernest J. Barker, Hermon Watson, Mrs. E. C. Morris, Mrs. T. B. Mellette, Mrs. Effie Kimbrel, Mrs. B. W. Clenny, Mrs. W. J. Starr, Mrs. Irvin Hyman and Mrs. J. B. Rice Sr. Motion carried that the state moderator be authorized to appoint other delegates to the National Association when it convenes as might be necessary.

Motion made and carried to extend a rising vote of appreciation to the retiring officers.

Motion that we adjourn to meet with Pine Level Church of the Georgia Union Association in November, 1962. Carried.

We were dismissed for a brief recess before the closing message.

For the closing service the congregation sang one song and we favored with a solo by Rev. James Pelt. He sang, "Others." Then the moderator introduced Rev. Ralph Lightsey, director of public relations for Mt. Olive College, Mt. Olive, North Carolina.

Brother Lightsey spoke briefly, but very convincingly of the progress and the advantages of the college, and then brought the closing message. Reading Philippians 3:14 and Colossians 1:18, 19; he brought a stirring message on the subject "That We May Crown Him."

We were dismissed and all enjoyed another sumptous dinner together.


#### AUDITING COMMITTEE REPORT

#### REPORT OF THE GEORGIA STATE MISSION BOARD

to the

#### GEORGIA STATE ASSOCIATION OF FREE WILL BAPTISTS

Inasmuch as a real, noble servant of our Lord's, Brother B. W. Clenny, who served on your mission board for several years, and also had served as chairman for sometime was promoted into the eternal realms of glory on November 26, 1960; we, the members of the said board, acknowledge with a deep feeling of love and devotion the passing of one whom we esteem highly as a brother and fellow-board member.

This year the board was called together for two board meetings. Resulting from the meetings plans were made to continue a forward push with our churches in Atlanta and Tifton, Georgia. Also a committee was appointed to draw up a constitution to govern the work of the mission board.

By mutual agreement of the board and the Atlanta Church, the Rev. Irvin Hyman of Jacksonville, Florida, was secured to succeed the Rev. J. R. Davidson as pastor. Brother Davidson served the church for little more than two years and did an outstanding job, for which we are truly thankful. We feel sure that the church of Atlanta is continuing to move forward by faith. They are now assuming all of their financial responsibility with exception of one hundred dollars per month with a possible twenty-five dollars a month expense account which they receive from the board.

One of the three churches making monthly payment to the board for money loaned to them while in their building program, paid out this year. The one liquidating their indebtedness to the board is the church of West Bainbridge.

This is a brief resume of the activities of this department for this year, with the proposal of the following items to this association for approval.

1. The accepting of the proposed constitution.


2. That the operating and loan account be consolidated into one account.

3. Because of the present need for new churches in new areas of the state, we hereby ask that the association approve a quota of \$3,000,000 which will be a supplement to the funds received through the unified program. The suggested amount fo reach district is as follows: South Georgia, \$750.00; Chattahoochee, \$350.00; Georgia Union, \$350.00; Little River, \$250.00; Martin, \$250.00; Union, \$300.00; and Midway, \$750.00.

#### CONSTITUTION OF THE GEORGIA STATE BOARD OF MISSIONS OF THE ORIGINAL FREE WILL BAPTISTS

#### PREAMBLE

We, the Board of Missions of the State of Georgia of the Original Free Will Baptists, do ordain this constitution and bylaws for the purpose of



#### Article I Name: This organization shall be known as the Georgia State Board of Missions of the Original Free Will Baptists.

#### Article II

Members: This board shall be composed of one member from each district association composing the Georgia State Association. If any member is employed by the board or is called to work with or pastor a mission or mission-church supported by the board, he will make this known to his district association and relinquish his position on the mission board.

#### Article III

Officers: Officers of this board shall be chairman, vice-chairman, secretary and treasurer elected annually.

#### Article IV

Meetings: This board shall hold two regular meetings a year, to be decided by the board and meetings when necessary to be called by the chairman.

#### Article V

Committees: Committees shall be appointed by the board or its chairman as needs arise which would demand the work of a committee.

#### Article VI

Reports: Section I—This board should report annually to the State Association, giving account of all funds received and disbursed, and activities of the board during the year, and state objectives for the following year or any future plans. Section II—The secretary and treasurer serving the mission board shall submit written reports to the board members as often as the board may deem it necessary. Also that supports be submitted through our state publications as often as may be deemed necessary by the board.

#### Article VII

Finance: This board shall be supported by the quota of finances allotted to them by the State Association and any other raised by special offering in promoting missions and personal gifts.

#### Article VIII

Section I: Missions—Missions receiving financial help from this board must either be established or accepted by the board, and the board reserves the right to determine how much and how long financial assistance be granted to any mission. All missions will be under the supervision of the board as long as financial aid is given.

Section II: Churches—(A) Any church receiving financial aid must accept such as a loan on conditions agreed upon by the board and the church. (B) Any church finding itself unable to operate as such, may request mission status, or mission church status.

#### BYLAWS

Duties of the Officers: Section I-Chairman: He shall preside over each

#### session, preserve order, govern the body according to established parliamentary

usage and appoint all temporary committees. He shall have the right to call meetings when it is necessary and where.

Section II—Vice-Chairman: It shall be the duty of the vice-chairman to serve in the full capacity of the chairman when the chairman is absent.

Section III—Secretary and Treasurer: The secretary shall keep an accurate record of all transactions and the board meetings and preserve the same, keep all valuable documents and surrender same to his successor in office. Send out a report of the work of the board as often as the board requires. All funds shall be held and disbursed by the treasurer at the approval of the board.

Section IV—Ex Officio Member: The chairman shall be ex officio member of all committees.

Article I: Voting is restricted to members or their proxies. Quorum— Four members will compose a quorum.

Article II: Amendments—This constitution and bylaws may be amended by two thirds of the membership of the board voting favorable for the amendment.

#### EXECUTIVE BOARD MEETING

At 10:00 a. m., September 16, 1961, the executive board of the Georgia State Association convened at White Oaks Free Will Baptist Church, Macon, Georgia. Members present were: Revs. C. R. Houston, moderator, E. C. Morris, promotional secretary, Paul Irvin, Bill Gardner, J. B. Lovering, and S. T. Shutes, clerk. 

We, your board on superannuation, submit the following recommendations:


The state superannuation board met in a called session at Corinth Church on October 7, 1961, for the purpose of drawing up rules and regulations to govern the actions of the superannuation board. The following were present for the meeting: Bro. L. E. Wynn, Bro. Shermon Jones, Rev. E. C. Morris, as proxy, and Bro. J. W. Clower.

#### Rules as Follows

1. This board, consisting of seven members, elected by the State Association, shall be governed by the standard rules of the State Association of Free Will Baptists, and such rules as may be adopted by the board in cooperation with the state.

2. To qualify for superannuation the minister shall have served one or more churches for a reasonable period of time; and during his ministry he must have shown good faith in the welfare of his church and the denomination, and a willingness to co-operate in all denominational enterprises.

3. The widow of a deceased superannuate shall receive the same consideration as that of her husband so long as she remains a widow and in good standing with the denomination.

5. The board shall have an annual session just prior to the convening of the State Association, and at the same place. #### REPORT OF THE PROMOTIONAL SECRETARY-TREASURER E. C. Morris

Fourteen years ago, I was asked to assume the task of promoting all the causes being sponsored by the State Association of Free Will Baptists of Georgia on a full-time basis. Eight months before, the late Rev. H. L. Catrett of Colquitt, had been employed by the Executive Board to devote half time to such endeavors. He visited many of the districts and churches over the state and edited a monthly mimeographed periodical. Through these mediums a foundation was carefully laid upon which the promotional efforts were to take permanent form. Upon the resignation of Bro. Catrett, your present promotional secretary was elected to the office and has remained on the job since.

It was readily seen that this was a vast field of pioneering, since Georgia

#### Free Will Baptists were the first to launch such a movement. It was with

much fear and trembling that the approach was made, but with a faltering faith in God and Free Will Baptists, we set our face toward the dim horizon of what was hoped to be a brighter and happier day. It is needless to say, that God has provided grace for every trial and supplied every need. These fourteen years have been happy ones, even though storm clouds have gathered at times, but every cloud had a silver lining and the sun of progress would eventually shine through. As we view the record of these years, encouraging facts are revealing. There have been 31 churches established, and even though some have failed, there are 23 more churches on the list at the present. The total membership has grown from 7,903 to 11,479. All the auxiliaries have made great advancéments. The total number of Sunday schools have increased from 59 to 110 with the enrollment more than doubling. The leagues have made astounding improvements numbers gaining from 16 to 74 with an enrollment making more than 300% increase. The woman's auxiliaries growing from 18 to 54. The midweek prayer services have advanced from 19 to 81. Fifteen years ago, there was hardly a full-time church, at least, not one with a full-time pastoral care and at least 85% of the churches were operating on quarter-time basis with a few having half time. The report for this year show only six quarter-time churches and 47 on a full-time schedule. When we consider the stewardship of giving the results have been almost phenomenal. Pastor's salaries have increased from \$19,835.77 to \$126,515.00. During this period, the building boom has surpassed any comparable time in history. The reported value of church property in 1945 was \$152,059.00 and now it stands at \$1,717,366.00. Fourteen years ago there were only two parsonages known in the state with a total value of probably \$6,000.00. Today, there are 18 reported with a combined value of \$163,000 with others under construction or being planned. There has been a mighty surge in giving to the world-wide ministry. The first year of the promotional program all gifts for denominational enterprises amounted to \$2,882.87, this year it probably runs beyond \$30.000.00. Progress has been made along other lines in proportion, but these few items show the trend. As we leave the office to another, the Lord forbid that we should boast save in the cross. No, the results have been achieved through co-operation and most of all by divine power. As we look to the future, may we continue to co-operate and stand with the one upon whose shoulders may rest the responsibilities of the promotional office and may even greater results be obtained through the leadership of the Holy Spirit.

With a deep sense of appreciation for the privilege granted to serve you these years, I now submit the statistical and financial report for the year.



# Constitution

#### PREAMBLE

The Sunday school of the Free Will Baptist churches of Georgia, do hereby ordain this constitution for the purpose of advancing every phase of the Sunday school endeavors as set for herein.

Article 1. The name of this convention shall be known as the State Sunday School Convention of Georgia Free Will Baptists.

Article II. The purpose of this convention shall be to secure co-operation and unity of action and to promote every phase of the Sunday school work as represented by the Sunday school cause of the denomination.

Article III. The convention shall be composed by delegates and ministers from the district and local Sunday schools. Delegates to be worked out as may be provided for in the bylaws which may be drafted by this body.

Article IV. The officers of this body shall be a president, vice-president, recording secretary and treasurer and such other officers as may be provided for from time to time. Standing, temporary or session committees may be considered officers of the body which serving.

Article V. The executive committee may consist of all the standing officers with the addition of others as the body may deem wise and proper.

Article VI. The convention may be financed by means which may be worked out from time to time and included in the bylaws.

Article VII. All standing officers shall be elected annually at the close of the convention session, and the installation of newly elected officers to be the last item on the program each year.

Article VIII. The convention shall convene on second Saturday in June each year, unless otherwise arranged.

Article IX. The program of the convention will consist of items as may be arranged by a program committee, and the usual order of business as of any deliberate body.

#### BYLAWS

#### ARTICLE 1, DUTIES OF OFFICERS:

Section 1, President: It shall be the duty of the president to preside over each session, preserve order, govern the body according to established parliamentary usage, and appoint all temporary committees and substitute officers. The president shall also be a member of any chairman of the executive committee.

Section 2, Vice-President: It shall be the duty of the vice-president to serve in the full capacity of the president when the president is absent. The vice-president shall be a member of the executive committee.

Section 3, Secretary-Treasurer: It shall be the duty of the secretary-treasurer to take minutes of all proceedings, and read them for approval, and

#### to record and to keep all money and pay for whatever the convention elects

to pay; also the secretary-treasurer shall deliver to his or her successor all records and money. The secretary-treasurer shall be a member of the executive committee and shall serve as clerk of the executive committee.

Section 4, Assistant Secretary-Treasurer: It shall be the duty of the assistant secretary-treasurer to take the place of the secretary-treasurer when he or she is absent. The assistant secretary-treasurer shall be a member of the executive committee.

Section 5, Ex-Officio Members: The president shall be an ex-officio member of all committees of the convention.

ARTICLE 2, VOTING:

Section 1: All questions coming before the convention shall be decided by a majority vote, in case of a tie, the president shall vote.

Section 2: Voting shall be restricted to all officers of the convention-Ministers, superintendents and delegates from each district convention, also each Sunday school.

Section 3: Each district convention shall be entitled to five delegates. Each Sunday school two delegates.

ARTICLE 3, DUES:

Each district convention shall send \$5.00 to the convention. Each Sunday school shall send \$1.00 to the convention.

ARTICLE 4, AMENDMENTS:

Any amendments to this constitution and bylaws may be secured by twothirds majority vote, provided such an amendment has been presented to the executive committee 90 days before the date of the convention, and has been approved by the executive committee.
