ALLOCATION COMMITTEE REPORT

We, your allocation committee, make the following report. We recommend \$25,000.00 for the Unified budget and suggest the following quotas: South Georgia, \$7,500.00; Chattahoochee, \$3,000.00; Georgia Union \$2,000.00; Little River, \$2,000.00; Union \$2,000.00; Martin, \$2,000.00; Midway, \$6,500.00.

We also suggest a designated quota of \$10.000.00 as follows: South Georgia, \$3,000.00; Chattahoochee, \$1,300.00; Georgia Union, \$800.00; Little River \$800.00; Union \$800.00; Martin, \$800.00; Midway \$2,500.00.

We also suggest we pay the expenses of the Promotional Department at the rate of \$450.00 per month and the remaining money as follows: 35% to National Co-Operative Program of the National Association and the remaining 65% stay in the State as follows: State Superannuation 25%; State Mission 38%; Children's Home, 6%; Camp Mt. Bethel 25%; State Education 6%.

We recommend each church give more consideration to support

of the unified program and if each association will raise its unified quota the Promotional Secretary could be more adequately serviced.

REPORT OF THE GEORGIA STATE MISSION BOARD TO THE GEORGIA STATE ASSOCIATION OF FREE WILL BAPTISTS

The Georgia State Mission Board held three meetings this past year for the purpose of transacting necessary business.

After investigation, the Eastman Church was granted a loan of \$1,000.00 to be paid as follows: One-hundred and fifty dollars in February, seventy-five dollars per month for ten months beginning March 1962, one-hundred dollars in January. 1963.

Motion, second, and carried in view of request to return title to property owned by Calvary Free Will Baptist of Albany, Georgia, and in view of fact that title is intrusted in the board of trustees of Georgia State Association of Free Will Baptists. This request was hereby referred to said board of trustees for action on their part.

The Tifton Church made final payment on their loan from the Mission Board in May, and the deeds were sent to the church.

The Donalsonville Church is making small payments monthly on their loan. The contract between the Mission Board and the Atlanta Church was terminated with the September, 1962 payment and the Church was notified by the chairman. Bro. J. R. Davidson gave some facts concerning the Atlanta Church in the October meeting and asked that the board be much in prayer for the work there, also that the needs be reconsidered by the Missien Board.

A representative from the board was appointed to visit the Atlanta Church and see what assistance could be rendered and report findings to said board. It was moved and adopted that the chairman Vice-chairman. Secretary and Treasurer serve as trustees of the Georgia State Mission Board.

CONSTITUTION OF THE GEORGIA STATE BOARD OF MISSIONS OF THE ORIGINAL FREE WILL BAPTISTS PREAMBLE

We, the Board of Missions of the State of Georgia of the Original Free Will Baptists, do ordain this Constitution and By-Laws for the purpose of promoting all mission endeavors of the Georgia State Association.

ARTICLE I

Name: This organization shall be known as the Georgia State Board of Missions of the Original Free Will Baptists.

ARTICLE II

Members: This board shall be composed of one memebr from each district Association composing the Georgia State Association. If any member is employed by the board or is called to work with or pastor a mission or mission-church supported by the board, he will make this known to his district association and relinquish his position on the mission board.

ARTICLE III

Officers: Officers of this board shall be chairman, vice-chairman, secretary and treasurer elected annually.

ARTICLE IV

Meetings: This board shall hold two regular meetings a year, to be decided by the board and meetings when necessary to be called by the chairman.

ARTICLE V

Committees: Committees shall be appointed by the board or its chairman as needs arise which would demand the work of a committee.

ARTICLE VI

Reports: Section 1. This board should report annually to the State Association, giving account of all funds received and disbursed, and activities of the board during the year. and state objectives for the following year or any future plans.

Section II. The secretary and treasurer serving the mission board shall submit written reports to the board members as often as the board may deem it necessary. Also that supports be submitted through our state publications as often as may be deemed necessary by the board.

ARTICLE VII

Finance: This board shall be supported by the quota of finances allotted to them by the State Association and any other raised by special offering in promoting missions and personal gifts.

ARTICLE VIII

Section 1. Missions: Missions receiving financial help from this board must either be established or accepted by the board, and the board reserves the right to determine how much and how long financial assistance be granted to any mission. All missions will be under the supervision of the board as long as financial aid is given.

Section II. Churches: (A) Any church receiving financial aid must accept such as a loan on conditions agreed upon by the board and the church. (B) Any church finding itself unable to operate as such, may request mission status, or mission church status.

BY-LAWS

Duties of the Officers. Section 1. Chairman. He shall preside over each session, preserve orde,r govern the body accordingly to

established parliamentary usage and appoint all temporary committees. He shall have the right to call meetings when it is neccessary and where.

Section II. Vice Chairman: It shall be the duty of the vice-chairman to serve in the full capacity of the chairman when the chairman is absent.

Section III. Secretary and Treasurer: The secretary shall keep an accurate record of all transactions and the board meetings and preserve the same,, keep all valuable documents and surrender same to his successor in office. Send out a report of the work of the board as often as the board requires. All funds shall be held and disbursed by the treasurer at the approval of the board

Section IV. Ex-Officio Member: The chairman shall be exofficio member of all committees.

Article 1. Voting is restricted to members or their proxies. Quorum: Four members will compose a quorum.

Article II. Amendments: This constitution and by-lays may be amended by two-thirds of the membership of the board voting favorable for the amendment.

EXECUTIVE BOARD MEETING

The Executive Board of the Georgia State Association of Free Will Baptists is happy to present the following report of its activities for the year beginning Nov. 15, 1961 and ending Nov. 13, 1962. We submit this account of our activities with thanksgiving and gratitude to God and the members of this Georgia State Association for the privilege of serving in this capacity. We have done our best to follow the leadership of the Holy Spirit, keeping our hearts and minds open to the opportunities and needs of the Kingdom Work in general and the Free Will Baptists cause in particular. Our aim has been to keep our program Christ-centered and to so regulate our activities as to make the salvation of men and women everywhere our first motive and concern.

The Board held a brief meeting Nov. 15, 1961 for the purpose of arranging the changeover in the State Promotional office with Brother Mance Cason, the newly elected Promotional Secretary. Satisfactory plans were set up and adopted and the Board adjourned.

On January 19, 1962, the Board met in session at Camp Mt. Bethel. near Ashburn, Georgia. After disposing of routine matters, the question of living quarters for the Promotional Secretary was taken up. First attention was given to using the house located on the Camp premises and the members of the Board examined the house to determine the necessary repairs and additions to make it suitable for this purpose. Following this inspection a discussion was entered into relative to buying property in town, inasmuch as the state office was to be located in the residence of the Pormotional Secretary. It was the opinion of all present in the meeting that this would be the course of wisdom. On motion and second, which was followed by a unanimous vote, a committee was appointed and given six months in which to locate suitable property. The committee consisted of Revs. Tom Hamilton, Paul Irvin, James Pelt, with the Moderator and Promotional Secretary to assist as ex-offficio members.

The Board met in called session on Feb. 10, 1962 at Midway Church, Moultrie, Georgia.

After prayer, led by Bro. Curtis Ray, the business was taken up.

The report of the committee on investigating and locating property for the Promotional Secretary's living quarters and office was given as follows: In light of the responsibility developing upon the special committee designated by the Executive Board of the Georgia State Association to investigate housing facilities for our Promotional Secretary and his office, we have made investigation in three of our towns and as a result we wish to recommend the purchase of a piece of which is \$7,950.00. The down payment required is \$350.00 with monthly payments of approximately \$50.00, over a period of 30 years.

Said property is in the hands of Spooner Real Estate and Insurance Company.

By motion and second, followed by unanimous vote, this report

was adopted.

We then recessed for the purpose of going in a body to look the property over again.

Following lunch which was served by the Midway Church, we

resumed the meeting.

The following item was adopted in connection with the property deal:

"Whereas, it has come to our attention that \$300.00 has been found in the Promotional Fund previously designated as an emergency fund for use by the Promotional office, and

"Whereas, an emergency has arisen in connection with the purchase of a home and office for the Promotional Secretary, it is hereby agreed that the Promotional Secretary be authorized to use the \$300.00 in the transaction for purchasing the house."

Moved, seconded and carried by unanimous vote, "that in order to get a better type loan, Brother Mance Cason be authorized to purchase the house in his own name and that as soon as feasible, the deeds to said property be transferred to the State Association of Free Will Baptists through its Board of Trustees."

"In order to protect the State Association in the interin period between actual purchase and the signing of the deeds over to the State Association, Revs. D. C. Dodd and James Pelt were appointed to draw up such protective provisions as to safeguard both parties concerned in this thansaction."

As the final word concerning this matter, in the Executive Board meeting at Camp Mt. Bethel, Ashburn, Georgia on July 31, 1962, photostatic copies of the deeds to the property in Moultrie were presented by Brother Mance Cason which presented indisputable evidence that the property had been transferred from Brother Mance Cason to the Georgia State Association of Free Will Baptists and that said Body is the sole owner of the property.

On the basis of the facts presented herewith in connection with the home and office for the Promotional Secretary, the Executive Board recommends that the Georgia State Association, in session November 13-15, 1962, concur in the action of its Executive Board and approve the transaction as it was carried out.

We further recommend:

No. 1. That an allocaiton of \$450.00 per mon	th be made for the
promotional department, to be broken down as fol	llows:
Salary for Promotional Secretary	\$250.00 per month

SUPERANNUATION BOARD

We. your board on superannuation, submit rules as follows:

- 1. This board, consisting of seven members elected by the State Association, shall be governed by the standard rules of the State Association of Free Will Baptist, and such rules as may be adopted by the Beard in cooperation with the State.
- 2. To qualify for superannuation the minister shall have served one or more churches for a reasonable period of time; and during his ministry he must have shown good faith in the welfare of his church and the denomination, and willingness to cooperate in all denominational enterprises.
- 3. The widow of a deceased superannuate shall receive the same consideration as that of her husband so long as she remains a widow and in good standing with the denomination.
- 4. For the consideration of this board the applicant should be recommended by the church where he holds membership, and the association of which affiliated; and further his local church must be in good fellowship with an affiliated association which is a member of the State Association.
- 5. The board shall have an annual session just prior to the convening of the State Association, and at the same place. And upon the call of the chairman, or his authorization, or any other time as

may be necessary. In called sessions of the board, milage fees shall be paid as agreed upon by the board.

The folloowing board members: M. M. Franks, C. D. Rentz, J. W. Clower, Sherman Jones meet with Rev. Chester A. Huckaby, a representative from the National superannuation board. The discussion consisted of the new plan of insurance for ministers.

OUR STATE ASSOCIATION BETWEEN ITS 1961 AND 1962 SESSIONS BY ITS MODREATOR

During the 1961 Session of the Georgia Association of Free Will Baptists almost an entirely new staff of officers was chosen. Decisions made by that body called for special arrangements to be made, which could not be made short of some wise investigations. With desire to perpetuate the cause for which the group was chosen,

its chairman called the Executive Committee into session for the nineteenth day of January, 1962 at Camp Mt. Bethel. It was suggested that members of your camp board be asked to associate in this meeting, which they graciously did. Study from every angle revealed the fact that the status was considerably different than it had been assumed relative to plans for housing the state office, the Promotional Secretary and his family, in the Caretaker's building. This brought the group face to face with unforeseen problems—matters relating to housing, salary, Secretary's Aid, supplies, travel and mailing; along with responsibility for protection of denominational interests and assets. There was also the problem as to provisions for the spiritual life of the Promotional Secretary's family, with no church within reach of their walking ability from the Camp. Too, we were confronted with the fact that we had no law protection for money assets flowing into the office from day to day.

Finally, we were informed that during encampments in the previous summer all facilities at the camp were overtaxed, including the house we had loosly thought of setting up our headquarters in. Further information was brought to our attention as to the purpose for which the house was built; that of a caretaker, and no doubt all will agree that our Promotional Secretary cannot do the job assigned him and serve as a caretaker too. Finally, we were faced with considerable outlay financially in converting and construction were the denomination to set up its office at the Camp.

Out of such honest investigations, and findings, it was moved that there be an investigation committee appointed, which resulted in the designation of Brothers Hamilton, Pelt and Irvin as committeemen, with Davidson to advise in his ex-officio capacity and Cason to be added for wisdom's sake. This committee was to investigate possibilities of a rental proposition with option to buy in one of our representative towns, fairly located for convenience to our people. Such investigations were made in a number of towns, but no rental possibilities showed up. However, a prospect in a good location in Moultrie was presented, which showed to be good economy in light of possible rentals. The offer was made in such a way that unanimous consent was given for negotiation, hence the opening of such. It turned out that by following directions of men who were well versed in the real estate business we could have this property with monthly payments a bit minus \$50.00. It is true that a small down paymnet of \$300.00 associated the agreement. The title to this property is duly made (under direction of business authorities) to the Georgia State Association of Free Will Baptists.

Almost continuous alerted activity has been an order of members of the Executive Committee, which you democratically chose a year ago, in order to find best ways and means for promotion of our cause. Two regular meeting times have been arranged for January

and September, aside from the session just before the State Body is called for dealing with final matters. Quite a bit of work has been done through the effort of chosen committeemen within our group, and, the Moderator, the Assistant Moderator and the Promotional Secretary have been in constant contact with each other for the best interest of our common cause. One mass prayer meeting was called to convene just before the September meeting of the Executive Committee, the purpose of which was experiencing a knitting of our hearts together with the Lord's and one another. Reports of misunderstandings of the purpose came in, but, we were very keenly conscious of its blessings as we met in our September session of the committee the day following the night prayer session.

Not everything we might have purposed has been realized through our unrelenting efforts, however, I wish personally to vouch for my faith in the good purpose in the hearts of the brethren whom you chose as your Executive Committee. We plead for a bit of confidence in expression, for fervent prayers to ascend to our heavenly Father, for unity in Christian fellowship and dedication in concerted efforts that we may get on with the greatest task ever assigned to mankind.

CONSTITUTION

The Sunday School of the Free Will Baptist Churches of Georgia do hereby ordain this constitution for the purpose of advancing every phase of the Sunday School endeavors set forth herein.

Article 1. The name of this convnetion shall be known as the State Sunday School Convention of Georgia Free Will Baptists.

Article II. The purpose of this convention shall be to secure cooperation and unity of action and to promote every phase of the Sunday school work. as represented by the Sunday school cause of the denomination.

Article III. The convention shall be composed by delegates and ministers from the district and local Sunday schools. Delegates to be worked out may be provided for in the By-Laws which may be drafted by this body.

Article IV. The officers of this body shall be a president, vicepresident, recording secretary, and treasurer and such other officers as may be provided for from time to time. Standing, temporary or session committee may be considered officers of the body which serving.

Article V. The executive committee may consist of all the standing officers with the addition of others as the body may deem wise and proper.

Article VI. The convention may be financed by means which may be worked out from time to time and included in the By-Laws.

Article VII. All standing officers shall be elected annually at the close of the convention session, and the installation of newly elected officers to be the last item on the program each year.

Article VIII. The convention shall convene on second Saturday in June each year, unless otherwise arranged.

Article IX. The program of the convention will consist of items as may be arranged by a program committee, and the usual order of business as of any deliberate body.

BY-LAWS

ARTICLE 1—DUTIES OF OFFICERS

Section 1. President: It shall be the duty of the president to preside over each session, preserve order, govern the body according to established parliamentary usage, and appoint all temporary committees and substitute officers. The president shall also be a member of any chairman of the executive committee.

Section 2. Vice-President: It shall be the duty of the vice-president to serve in the full capacity of the president when the president is absent. The vice president shall be a member of the executive committee.

Section 3. Secretary-Treasurer: It shall be the duty of the secretary-treasurer to take minutes of all proceedings, and read them for approval, and to record and keep all money and pay for what ever

the convention elects to pay; also the secretary-treasurer shall deliver to his or her successor all records and money. The secretary-treasurer shall be a member of the executive committee and shall serve as clerk of the executive committee.

Section 4. Assistant Secretary-Treasurer: It shall be the duty of the assistant treasurer to take the place of the secretary-treasurer when he or she is absent. The assistant secretary shall be a member of the executive committee.

Section 5. Ex-Officio Members: The president shall be an exofficio member of all committees of the convention.

ARTICLE 2—VOTING

- Section 1. All questions coming before the convention shall be decided by a majority vote, in case of a tie, the president shall vote.
- Section 2. Voting shall be restricted to all officers of the convention—Ministers, superintendents and delegates from each district convention, also each Sunday School.
- Section 3. Each district convention shall be entitled to ifve delegates. Each Sunday School two delegates.

ARTICLE 3—DUES

Each district convention shall send \$5.00 to the convention. Each Sunday Schoool shall send \$1.00 to the convention.

ARTICLE 4-AMENDMENTS

Any amendments to this constitution and by-lays may be secured by two-thirds majority vote, provided such an amendment has been presented to the executive committee 90 days before the date of the convention, and has been approved by the executive committee.

CONSTITUTION

PREAMBLE

We, the Original Free Will Baptists of the State of Georgia, do ordain this Constitution for the purpose of advancing, promoting and increasing all phases of the cause of Christ.

ARTICLE I

Section 1. The assembly shall be known as the Georgia State Association of the Original Free Will Baptists.

ARTICLE II

Section 1. The officers of this Association shall be Moderator, an assistant Moderator, a Secretary, an assistant Secretary and a promotional Secretary-Treasurer.

Section 2. All regular officers and the chairman of each standing board shall compose the Executvie Board.

Section 3. This Association shall be composed of all active Ministers, Deacons and Missionaries who are members of any affiliated bodies. One delegate for every 500 members, or a fraction thereof of each district Association or Union Meeting, and one delegate for every 100 members or a fraction thereof of all local affiliated churches.

Section 4. All delegates from Associations, Union meetings and local churches shall be elected from the laity of the body sending them.

Section 5. Funds to meet current needs of the body shall be paid in on a voluntary basis to the Treasurer of the Association, however, it is suggested that each Association give as shall be allocated to them each year by a committee, and that each Union meeting give five dollars and each local church give five cents per capita for their respective membership.

ARTICLE III

Section 1. It shall be the privilege of each affiliated Association to furnish a member of each standing board with terms of office rotating which will necessitate the election of four members at one election year and three members at the next election year, giving each member a term of office of four years each. The exception will be the board of auditors which shall consist of two members who shall be elected at the same time as the general officers.

Section 2. There shall be a board of missions composed of members who are noted for missionary zeal and they shall have the supervision of all mission interest sponsored by this body. All undesignated mission funds shall be equally divided between home and foreign.

Section 3. There shall be a board of Christian education whose duty it shall be to keep the body informed of all Christian education sponsored by the body and make such recommendations as they shall deem proper to the body from time to time.

Section 4. There shall be a board of superannuation whose duty it shall be to make plans and rules which shall be in harmony with the National Superannuation Board. And shall be authorized to formulate plans whereby necessary funds for superannuation may be raised.

Section 5. There shall be a board of trustees whose duty it shall be to hold titles of all property belonging to this body.

Section 6. A board of auditors, whose duties it shall be to audit the books of the Association Treasurer and the Treasurers of all boards.

Section 7. There shall be a camp board arranging the time of sessions, electing all faculty members, forming all the study courses, especially those leading to a completion with the issue of certificates.

ARTICLE IV

Section 1. All officers, except board members, shall be elected to serve a term of two years.

Section 2. Any officers may be re-elected as the body shall see fit.

Section 3. When vacancies occur for any cause they shall be filled by the Execuitve Board, or by any of the standing boards, subject to the approval of the Executive Board, until the convening of the annual session of the body.

Section 4. Election years shall take place on the odd years of the calendar.

Section 5. A member of any board who fails in the function of his or her duties without a reason, the board to which the delinquent members has been elected, shall declare the office vacant. Further the body shall have and does reseve the right to deal with any officer or board member who does not conduct his or her office in a Christian and businesslike manner, according to the rules of Christian conduct laid down in the New Testament. Should such board fail to have a sufficient number of its members present to constitute a quorum, it shall become the duty of the Executive Board to deal with any delinquent member. Also, a charge against a member of this body and a member of a local church shall constitute a charge against said member in this body and the body shall abide accordingly.

Section 6. The duties of officers defined shall be the same as these for any deliberative assembly.

Section 7. All boards may be called in session only by the chairman of the Executive Board and any standing board may be called in session only by the chairman of said board, unless said chairman becomes incapacitated in which case the assistant assumes the authority of said incapacitated chairman.

AMENDMENTS

This Constitution shall not be changed or altered except by a majority of all members present to regular session. All amendments shall lie on the table from the morning session until evening session or from evening session until morning prior to adoption and shall. during the time be read at least twice in open session. Additions of boards or officers may be added as there is need.

REVEREND T. B. MELLETTE
