PROCEEDINGS

SECTION I

The Georgia State Association of Free Will Baptists met with the Midway Association at Damascus, Georgia in the Damascus High School Auditorium on Tuesday evening, November 15, 1966.

TUESDAY EVENING—NOVEMBER 15, 1966—7:30

The 30th Annual Session of the Georgia State Association was officially called to order by the clerk, Rev. A. C. Truluck. The officers of the Association were introduced. Rev. Jake Creech led the evening song service and the pledge to the Christian and American flag and the Bible. Rev. James Roland gave the devotion scripture reading and led in prayer.

Rev. C. R. Houston, Moderator of the Midway Association gave the welcome address. The program presented by the program committee was adopted with authority given the moderator to make changes as necessary during the proceedings.

Visitors were recognized by the moderator. Visitors were: Dr. L. C. Johnson, president of Free Will Baptist Bible College, Nashville, Tenn., and Rev. Mark Vandivort representative of the National Home Missions Board.

The committee on committees was appointed: J. R. Davidson, Billy Hatcher, Riley Giddens, Robert Lizenby, Edward Kimball, George Foskey. Rev. Luther Burns was recognized as a new minister in the Georgia Association, now pastoring the Okefenokee church at Waycross, Ga.

Special song was given by Mrs. Shirley Kimball.

The evening message was delivered by Dr. L. C. Johnson. The message: "We Preach Christ Virgin Born." Scripture reading: Isaiah 7:14. Following a most inspiring message the Association adjourned until Wednesday morning November 16, at 9:30.

WEDNESDAY MORNING—NOVEMBER 16, 1966—9:30

Song and prayer service led by Rev. Kenneth Fason. Prayer made by Rev. Gilbert O'String. The moderator's message was given using the thought, "Lord what would you have me do"? A challenge was given to let everything done in this associational meeting be based upon this thought.

A partial report of the credentials committee was given and a motion adopted to receive the report and seat the represented delegates and to receive other delegates as they report and represent. The committee on committees reported the following appointments, which was adopted. NOMINATING COMMITTEE: Rev. Damon Dodd, Mr. Jack Faison, Mrs. Opal Hatcher. RESOLUTIONS COMMITTEE: Mr. Curtis Gay, Mr. Whit Mercer, Mrs. B. W. Clenney.

A report from the Free Will Baptists Bible College was given by Dr. L. C. Johnson and received as information. Dr. Johnson reported an enrolment of 338 regular students and 60 part time students for a total enrolment of 398. The college campus expansion program has gotten off to a very successful start with total to date of \$218.00 cash and commitments.

Report of the Woman's Auxiliary was given by Mrs. G. E. Lee, received and adopted for inclusion in the minutes.

A report of the Church Training Service State Convention was given by Rev. Wilburn Beasley. Report received and adopted.

The business session was deferred until after the morning worship hour. Song and prayer service led by Rev. Ken Faison. An offering for the general fund was received in the amount of \$72.23. The morning message was delivered by Rev. T. G. Hamilton. Subject: "We Preach Christ Alive Forevermore." Scripture: Rev. 1:18. Following the worship service the host Association furnished lunch and a period of relaxation and fellowship was enjoyed.

WEDNESDAY AFTERNOON—NOVEMBER 16, 1966—1:15

Song and prayer service was led by Rev. Jake Creech. Rev. H. L. Knighton brought the devotional thought.

The National Sunday School Departement was represented by Rev. Harold Harrison. The report was received as information. Items of interest reported were: The extension of Free Will Baptist written and edited quarterlies based on our own selected scripture lessons to include those through the Hi-Teen, beginning with the 1st quarter 1967, also the availability of a new attendance pin.

The State Promotional Secretary gave the report of the state ministries and the promotional department. The report was received and adopted. A prayer of thanksgiving was offered in behalf of God's blessings upon our promotional work.

The nominating committee gave its report which was received and adopted. Nominating committee report: Resignations accepted from: Rev. Harris Nix, assistant moderator; Rev. A. C. Truluck, clerk and Rev. A. G. Windham, board member. Thsoe elected were: Rev. Harris Nix, as moderator; Rev. Kenneth Faison, as clerk; Rev. Odell Harris, as assistant moderator; Mr. Rodney Tarrer, board of trustees.

The National Church Training Service Department was represented by Mr. Sam Johnson. The report was received as information. Items of interest were: Quarterlies are now available for 8 departments, revised record system, (5 point system in lieu of old 7 point system) new manuals now available for all departments.

The National Superannuation Department was represented by Rev. C. A. Huckaby. Report received as information. Items of interest were: Now available to our ministers an endowment insurance plan and a retirement plan.

The report of the State Superannuation Department was given by Mr. Leron Clower. Report was received and adopted. A motion was adopted to request the state superannuation board to submit a plan to this session of the association to raise the amount of monies needed to equal the amount given by the national board in support of those individuals enrolled in the national superannuation program.

Report from the State Camp Board was given by Mr. Wallace Franks. Report was received and adopted as amended. See reports section. Upon recommendation of the camp board Rev. Kenneth Faison was elected for a 2 year term as camp director.

Report of the State Sunday School Convention was given by Mrs.

Harris Nix. Report was received and adopted.

Business session was adjourned until the evening service at 7:30.

WEDNESDAY EVENING—NOVEMBER 16, 1966—7:30

Song and prayer service directed by Rev. Jake Creech. Prayer offered by Rev. T. G. Hamilton.

An inspiring and challenging report from the State Home Missions Board was given by Rev. J. E. Blanton. Report and recommendations received and adopted. See reports section. A report from the National Home Missions Department was given by Rev. Mark Vandivort. Report received as information. Report from the National Foreign Missions Department was given by Rev. Reford Wilson, general director of Foreign Missions.

The evening message was delivered by Rev. Reford Wilson. Subject: "We Preach Christ Crucified." After a very challenging and inspiring message many responded to an invitation to re-dedicate themselves to missionary zeal. An offering was received in the amount of \$183.70 for missions.

A partial report was received from the resolutions committee and adopted. Item adopted requested the clerk to forward a telegram to Senator Everett Dirksen expressing appreciation for his support in attempting to pass legislation to allow voluntary bible reading and prayer in our public schools, and pledge our continued support of his endeavors in the area. Note: Telegram was forwarded during this session at 8:45 A. M. November 17, 1966.

The session was adjourned until Thursday morning, November 17, at 9:00 o'clock. Rev. Irvin Hyman rendered the benediction.

THURSDAY MORNING—NOVEMBER 17, 1966 9:00 O'CLOCK

Song and prayer service led by Rev. Jake Creech. Devotion presented by Mr. Ernest Barker. Devotional thought taken from Matt. 28:18. "The Power of Christ."

Report for the Alabama Childrens' Home was given by Rev. Carlton Lambert. Rev. Lambert expressed appreciation for the liberal giving of the Georgia Churches and individuals in support of the Children's Home. The report was received as information.

The following reports were given and adopted as they appear in the reports section. 1. Board of Christian Education; 2. Resolutions Committee; 3. Credentials Committee; 4. State Ministers Association; 5. Auditing Committee; 6. Budgeting Committee.

Delegates appointed to the National Association were: Delegates, G. C. King, J. W. Clower, M. M. Franks, Herman Watson, Leron Clower; Alternate Delegates: Mrs. William Travis, Curtis Gay, Mrs. H. H. Watson, John Grant. A motion was adopted to authorize the state moderator to make substitution of delegates if the regular delegates do not represent.

Motion adopted to give a standing vote of appreciation to the Damascus community and those individuals who contributed to the entertainment of this State Associational Meeting.

Motion adopted to meet with the South Georgia Association in 1967.

The study committee appointed as a result of the adoption of the reso-

lution committee report consists of the following members: Rev. J. E. Blanton, as chairman; J. W. Clower, Curtis Gay, Ernest Barker, William Travis, Damon Dodd, Vernon Maggart, S. E. Newberry and Mance Cason as ex-officio member.

The morning worship service began with Rev. Jake Creech leading the song service. A special song was rendered by Rev. Carlton Lambert. The morning message was delivered by Rev. I. J. Blackwelder. Subject: "We Preach Christ Coming Again." A very inspirational message was delivered. Scripture text: 1st Thess. 4:16.

The annual session was concluded with a prayer of benediction for God's continued blessings and guidance upon the work of Free Will Baptists in this great state. Announcements and final adjournment.

SECTION II REPORTS

1. WOMAN'S AUXILIARY REPORT:

The Georgia State Woman's Auxiliary Convention met on November 15, 1966. There were 440 members paying a representation fee for this session. Attending the convention this year were: 43 delegates from 7 districts and 20 local auxiliaries, 53 visitors, 20 ministers, and 9 state officers for a total attendance of 125.

During the past year our Auxiliaries have raised approximately \$2850. for the Estenio Garcia account. Our project adopted for 1966-67 is \$2000. for a Volkswagon bus for the Larry Powells to take to the Virgin Islands and \$600 to furnish one room for our new Bible College dormitory making a total of \$2600.

From our Dot Harvey loan fund two \$300 loans have been made to a worthy student from Georgia to attend our Bible College. Other gifts given during the year have been excellent. Among these are the following:

Bobby Parker led us in singing, "To The Work" and prayer was given by Rev. Wilburn Beasley. An offering was received for the expense of the convention.

REPORT OF STATE BOARDS

1. State Mission Board:

Since the purpose of our Association is to band together for the purpose of missionary work, we are happy to see this being accomplished in our state. We have met 4 times this year and at the present are assisting with the work in Warner Robins, Ga. and will be assisting with the new work in Douglas, Ga., which was started by the South Georgia Association. At the present time we have many towns and cities that are ready for a Church and sensing this need we offer for your consideration the 2 following resolutions:

- a. That Project, "Target City" be adopted by our state as a plan of starting new churches in our cities.
- b. That the church building club plan be recommended to each district as a means of furthering our missionary outreach in our local asso-

ciations.

Project Target City would be a simultaneous state wide revival conducted in each local church by local pastors with the proceeds of the revival going to state mission work. The time for this effort will be worked out by the board and each church notified in advance. The Church club plan would be presented to encourage individuals to pledge not more than \$10.00 per month to state missions. This project is to be promoted by the local district board member in cooperation with local pastors.

The Mission Board voted in our last meeting to work in harmony with the district association mission boards and offer to match money with any association wishing to start a work within their association. This offer would be effective June 1, 1967, and the limitations to be \$200.00 per month and as long as our funds permit.

2. Camp Board Report:

The Camp Board met November 12, 1966, and made the following recommendations to the state Association.

a. That Rev. Kenneth Faison be elected as Camp Director for the next two years.

b. That the Camp Board be authorized to run a soil test at the Camp and if the report indicates that a lake could be built that the board be authorized to secure the services of Mr. Billy Hatcher and Mr. Jack Faison and build a lake at Camp Mt. Bethel. Motion carried to authorize the Camp Board to run soil tests and build lake if the amount of money required to do so does not exceed \$1000.00. Financial report in Section III of minutes.

3. Christian Education Board Report:

The Board of Christian Education submits the following recommendations:

a. That we sponsor another Bible Institute on a state wide basis with the Classes held Monday through Friday followed by the State Ministers Retreat on Friday night and Saturday. Date of this institute will be worked out with the Bible College instructors and churches notified by the Board in advance.

b. That during the above mentioned institute we offer a clinical course in supervision and teaching in the local Sunday School and Church Training Service.

c. That pastors encourage their S. S. and CTS teachers and directors to attend this clinic.

d. That the camp director work with the board of education in selection of the staff of instructors for this institute and clinic.

Items of information from the Christian Education Board. A study course in the Union District will be conducted at Bay Church Dec. 5—8.

A Bible Institute was conducted in Jan. 1966 at Camp Mt. Bethel with Rev. Ralph Hampton as the instructor, for one week and Rev. Leroy Forlines for another week. We are encouraged by the reports from individuals who attended this institute and believe that study courses held in the local associations have been prompted by these institutes. NOTE: See Section III for financial report.

4. Report of Board of Trustees:

We, your Board of Trustees, by the grace of God have had a successful year. We have been able to complete the office building project in Moultrie, Ga., for less than the \$6000 limit. We have also purchased needed furnishings and equipment, and plans are to completely furnish the office. We have requested the next joint board meeting to be held at the office building and we would like for each Free Will Baptist to visit your State Office Building. We plan to purchase a safe for the safe keeping of records and valuable papers. We, as a Board, wish to go on record as commending the building committee, namely, Mr. Curtis Gay, J. M. Hartsfield and Mance Cason for their whole-hearted effort and interest which has made this project a success. A complete report of the building fund and regular treasury is furnished for the minutes. NOTE: See section III for report.

5. Board of Superannuation Report:

We, your Board of Superannuation, recommend that the 2nd Sunday of May, (Mothers' Day) continue as the State Superannuation day, and we further recommend that each pastor help promote this worthy cause.

We further recommend that the National Superannuation Day which is the 2nd Sunday in June be supported by all the churches in the State and an offering be taken and sent to the promotional secretary ear-marked for national superannuation.

Your superannuation board is made up of members from each association in the State. Your board member should work each church in his association to promote State and National Superannuation Day. We covet your prayers for this work and also ask each church to take this program before each and every Free Will Baptist in the State of Georgia. See Section III for financial statement.

COMMITTEE REPORTS

1. Auditing Committee:

We, your Auditing Committee, have examined the Treasurer's books of the Georgia State Association of Free Will Baptists. In our opinion the statement of cash receipts and disbursements present fairly the financial position of all treasurers' books.

4. Executive Committee Report:

The Executive Committee held 3 meetings: Dec. 10, 1965; Nov. 12, 1966 and Nov. 16, 1966. With the exception of the last meeting the committee met with the joint boards at Camp Mt. Bethel. Dec. 10, 1965, Rev.

Louis Moulton presided over the meetings and Rev. Harris Nix presided over the other meetings of the committee. Items of business brought before the committee and passed and presented to the association for consideration were:

a. That the promotional secretary revise the present report blank for the Church to the annual association in order to have a more uniform system of reporting.

b. That a complete statistical report of each church be included in the State Minutes.

c. Inasmuch as the suggested quotas for the cooperative giving were in error by approximately \$1000.00, based on per capita giving, the promotional secretary was authorized to recompute the suggested overall quota and allocate them, based on per capita membership.

d. Accept the recommendation of Wesley Mitchell as a replacement on the board of trustees from the Liberty District.

e. That the general officers of the Association serve as program committee for the 1966 session of the Association.

f. Authorize the promotional secretary to revise the mailing list of the state paper.

g. Authorize the purchase of a multilith offset duplicating machine and typewriter which is now available at less than one half the original cost. The equipment to be used in the promotional office.

h. Authorize payment of the afore mentioned equipment in item g. be made by pledges from churches and individuals and if the pledges do not meet the required amount of \$70.00 per month allocation for the state office addition be utilized until loan is negotiated.

i. Recommend that the promotional secretary be authorized to secure a fire proof office safe to be used in the promotional office in the interest of maintaining historical records of the state work.

j. Accept as information a report from the promotional secretary to the effect that the office equipment authorized to be purchased at the previous meeting, has been secured and paid for without having to utilize the special funds authorized at that meeting.

k. Approved the sale of the old mimeograph machine used in the promotional office to Rev. J. C. Hubert Carter for the price agreed upon of \$40.00.

l. Approved the use of the \$40.00 from sale of the mimeograph machine for the purchase of the office safe.

m. Approve the giving of the old benches removed from the tabernacle at Camp Mt. Bethel to churches requesting them, namely Arlington Mission, Spring Hill Church, and the rest to be retained by the camp for use there as needed.

n. Inasmuch as the chairs for Mt. Bethel campaign resulted in an excess of \$93.93 and 16 additional chairs too many approve the giving of the money to the camp board and the chairs to be used in the promotional office.

o. Set the time and place for the next board meeting to be held at the state promotional office beginning at 9:30 A. M. Dec. 17, 1966.

5 Resolutions Committee Report:

We, your Resolutions Committee, submit the following report:

Item 1. Adopted forwarding of telegram to Senator Dirksen as appears in Section I.

Item 2. With the purchasing of the new office equipment which means that we are in a better position to publish a state paper, and since this has met with favorable response from our people, therefore be it resolved that the promotional secretary as editor, be given the privilege to arrange his schedule in a way that will give adequate time to get the publication in the mail on a regular date each month. We further feel that he should be given the privilege to limit his work on the field so as to take care of the growing demand for the service offered by the state office.

a. We recommend that the books close by the 1st of each month and that all news items be submitted for publication by the 10th of each month thus enabling the printing of the bulletins and mailing by the 20th each month.

b. In regards to limiting field activities in order to take care of the work of the office, be it resolved that the secretary accept no more than 4 revivals per year, however in this connection we strongly urge our pastors and churches to open their doors so that our state ministry may be presented to our people. This might be done by week end services or a special service arranged in the interest of our state work.

Item 3. Inasmuch as we are living in a day of compromise and modernism be it resolved we as Free Will Baptists take an uncompromising stand for righteous, holy separated living. That we walk a separated life that distinguishes us from the world; that we abstain from all appearances of evil and that all we do shall glorify the name of Christ. II Cor. 6:17, I Thess. 5:22, I Cor. 10:31. That our churches study and observe our church covenant. That our members give themselves to daily Bible reading and prayer, faithful attendance to the house of God for all services including Sunday night, business meetings, associational meetings, and supporting the work for a world-wide outreach of souls with their tithes and offerings. We further recommend that our ministers and laity re-evaluate their stand or position in regard to communism, we further recommend that all Free Will Baptists consider this a spiritual problem instead of a political problem inasmuch as they are atheistic and anti-God. Also we recommend that each pastor and minister inform their people of the danger and evils of communism. We recommend that each pastor inform their people of the motives, intentions and objectives of the National Council of Churches and the Ecumenical Movement.

Item 4. Be it resolved that a form from our Clerk be mailed to each church 30 days prior to our State Association in order that each church may send back to this body the names of delegates and representation fee.

Item 5. Be it resolved that a committee be appointed from this body to make a study of the activities of the State Board of Education and The Camp Board and report back to the body at the next annual meeting. This resolution is prompted, due to the area of responsibility of these 2

boards seeming to be overlapping in certain areas and it seems better results from a promotional and economical standpoint can be derived as a result of this action. NOTE: Item amended to include in this committee's study the duties of the promotional secretary.

Item 6. Be it resolved that our clerk write a letter of appreciation to the Midway Association Moderator for entertaining this session of the State Association. The Moderator will express to those responsible for this entertainment our deep appreciation for their hospitality.

PROMOTIONAL DEPARTMENT REPORT

REPORT OF THE PROMOTIONAL SECRETARY

"O bless our God, . . . and make the voice of His praise to be heard." Psalms 66:8. No words could be more fitting than these, as we bring this report to the 30th Annual Session of the Georgia State Association of Free Will Baptists. To Almighty God is praise given for His blessings upon our State ministry this year. Our heart is filled with gratitude as we review our work for the past twelve months.

The addition on to the State property in Moultrie has been completed which now provides us with adequate office space. Needed office equip-

ment has been bought. This might well be called the year of adjustment since the purchasing of new office equipment required many hours of learning how to carry on the new operation. However, we are deeply grateful to you for making these facilities available, and we have found them very helpful in discharging our responsibilities. With the added office space and new facilities we will be able to carry on our State ministry with much greater efficiency.

PROMOTION: Again this year, we have traveled many miles in the interest of our State Association. Several churches were visited with preaching assignments filled, and attended all State meetings. As much as possible, we attended the various meetings of each of the district associations. It is encouraging to see the progress being made in each of the districts, relative to our total denominational ministries and especially the increasing interest toward the establishing of other Free Will Baptist Churches. Also we attended the Christian Camp and Conference Association that was held at Eatonton, Ga., a meeting for State Promotional Secretaries and Directors of the different departments of the National Association that was held in Nashville, Tenn., and the National Association which met in Little Rock, Arkansas.

Other areas of promotion included itinerates for both home and foreign missionaries. Workshops were conducted in the interest of Sunday School and C. T. S. Such services always prove to be a real challenge to our churches in extending our witness for Christ here at home and around the world. During the year three weeks were spent as an instructor in youth camp work. Also a considerable amount of supply work was done due to pastors being ill and for churches without pastors.

PROMOTIONAL BULLETIN: Our State publication is now going into nearly 1200 homes each month. This is an increase of about 400 over our list last year. During the year, we were able to meet all regulations required by the United States Post Office Department and now have the Promotional Bulletin registered as the official publication of the Georgia State Association of Free Will Baptists, thus entitling us to second class mailing privileges which does have several advantages over our previous mailing permit.

OUR STEWARDSHIP: Denominational giving for the year was \$49,904.78 for all state and national causes. Of the total denominational giving \$14,184.25 was given through the Cooperative Plan of Support. We are grateful for the increase in Cooperative Receipts. A five year Comparison follows:

Of the 116 churches affiliated with the State Association 96 gave support to a world-wide ministry through the Cooperative Plan of Support.

My sincere appreciation is expressed to every individual, pastor and church who has shared with us in this ministry; God bless each of you for your prayers and support this year. SECTION IV

CONSTITUTION AND BY-LAWS

CONSTITUTION

PREAMBLE

We, the Original Free Will Baptists of the State of Georgia, do ordain this Constitution for the purpose of advancing, promoting and increasing all phases of the cause of Christ.

ARTICLE I

Section I. The assembly shall be known as the Georgia State Association of the Original Free Will Baptists.

ARTICLE II

Section 1. The officers of this Association shall be Moderator, an Assistant Moderator, a Secretary, an Assistant Secretary and a Promotional Secretary-Treasurer.

Section 2. All regular officers and the chairman of each standing board shall compose the Executive Board.

Section 3. This Association shall be composed of all active Ministers, Deacons, and Missionaries who are members of any affiliated bodies. One delegate for every 500 members, or a fraction thereof, of each district Association or Union Meeting, and one delegate for every 100 members or a fraction thereof of all local affiliated churches.

Section 4. All delegates from Associations, Union Meetings, and local churches shall be elected from the laity of the body sending them.

Section 5. Funds to meet current needs of the body shall be paid in on a voluntary basis to the Treasurer of the Association, however it is suggested that each Association give as shall be allocated to them each year by a committee, and that each Union meeting give five dollars and each local church give five cents per capita for their respective membership.

ARTICLE III

Section 1. It shall be the privilege of each affiliated Association to furnish a member of each standing board with terms of office rotating which will necessitate the election of four members every two years giving each member a term of office of four years each. The exception will be the board of auditors which shall consist of two members who shall be elected at the time as the general officers.

Section 2. There shall be a board of missions composed of members who are noted for missionary zeal and they shall have the supervision of all mission interest sponsored by this body. All undesignated mission funds shall be equally divided between home and foreign.

Section 3. There shall be a board of Christian Education whose duty it shall be to keep the body informed of all Christian Education sponsored by the body and make such recommendations as they shall deem proper to the body from time to time.

Section 4. There shall be a board of superannuation whose duty it shall be to make plans and rules which shall be in harmony with the National Superannuation Board and shall be authorized to formulate plans whereby necessary funds for superannuation may be raised.

Section 5. There shall be a board of trustees whose duty it shall be to hold titles of all property belonging to this body.

Section 6. A board of auditors, whose duty it shall be to audit the books of the Association Treasurer and the Treasurers of all boards.

Section 7. There shall be a camp board arranging the time of sessions, electing all faculty members, forming all the study courses, especially those leading to a completion with the issue of certificates.

ARTICLE IV

Section 1. All officers, except board members, shall be elected to serve a term of two years.

Section 2. Any officer may be re-elected as the body shall see fit.

Section 3. When vacancies occur for any cause they shall be filled by the Executive Board, or by any of the standing boards, subject to the approval of the Executive Board, until the convening of the annual session

of the body.

Section 4. Election years shall take place on the odd years of the calendar.

Section 5. A member of any board who fails in the function of his or her duties without a reason, the board to which the delinquent members has been elected, shall declare the office vacant. Further, the body shall have and does reserve the right to deal with any officer or board member who does not conduct his or her office in a Christian and businesslike manner according to the rules of Christian conduct laid down in the New Testament. Should such board fail to have sufficient number of its members present to constitute a quorum, it shall become the duty of the Executive Board to deal with any delinquent members. Also, a charge against a member of this body and a member of a local church shall constitute a charge against said member in this body and the body abide accordingly.

Section 6. The duties of officers defined shall be the same as these for any deliberative assembly.

Section 7. All boards may be called in session only by the chairman of the Executive Board and any standing board may be called in session only by the chairman of said board, unless said chairman becomes incapacitated, in which case the assistant assumes the authority of said incapacitated chairman.

AMENDMENTS

This Constitution shall not be changed or altered except by a majority of all members present to regular session. All amendments shall lie on the table from the morning session until evening session or from evening session until morning prior to adoption and shall during the time be read at least twice in open session. Additions of boards or officers may be added as there is need.

CONSTITUTION AND BY-LAWS OF MINISTER'S ASSOCIATION

Article 1.

This Minister's Association shall be called The Georgia State Free Will Baptist Minister's Association, and shall be composed of Ordained Free Will Baptist Ministers who are regular members of the Georgia State Association of Free Will Baptists.

The purpose of this Association shall be to edify one another through the preaching of the Word, and discussion of methods and to receive a general understanding of one another and to promote the work of our Lord as we see fit.

Article 2.

The officers of this Association shall be President, Vice-President, Clerk, Treasurer, and assistant Clerk-Treasurer, who shall be elected annually.

Article 3.

This Association shall have no disciplinary action.

Article 4.

Every ordained minister in the State of Georgia should be a member of this Association and should represent in each session in person or by letter. Every member shall carry on his person a card of recommendation from this Association. A new card shall be issued or renewed annually.

Article 5.

This Association shall meet annually. Offerings shall be received to carry out its goals and purposes. In addition this Association shall set an annual membership fee.

Article 6.

This constitution may be amended by a two-thirds vote of the members present at any regular session.

BY-LAWS**Article 1.**

The clerk or assistant clerk, or in their absence the senior minister in years, shall call the ministers into session. If a quorum is present the President or in his absence the Vice-President shall moderate the meeting. If neither are present, the senior minister in years shall be in charge. Twenty percent of active membership shall constitute a quorum for the transaction of business.

Article 2.

It shall be the duty of the clerk to enroll the ministers of the Association. Ministers shall present themselves with proper evidence of their rights to seats therein, and those enrolled by the clerk shall compose the Association. In case of questionable representation the case under question shall be referred to the credentials committee.

Article 3.

It shall be the duty of each minister belonging to this association to be active in pastoral, evangelistic, administrative, or promotional work (disabled and retired ministers excepted). Any minister belonging to this association shall represent to each session in person or by letter and failure to do so shall result in having his name taken from the list of members.

Article 4.

Each association shall be opened by reading a portion of God's Word and prayer and each session shall be closed with prayer.

Article 5.

By a two-third vote of the members present a ruling of the president may be overruled.

Article 6.

This association shall sit with open doors, except when it shall go into a committee as a whole.

Article 7.

No member shall absent himself from the association during its meetings without permission from the president.

Article 8.

No person shall be allowed to nominate more than one member, unless the person nominated is not elected.

Article 9.

The president shall not allow discussions when not carried on in a Christian Spirit, or when he thinks it will cause discord.

Article 10.

Anyone desiring to speak shall rise and address the president by the

appellation, "Brother President" but shall not speak further until recognized.

Article 11.

No member of this association shall be allowed to speak more than five minutes nor more than twice on the same subject without permission from the President.

Article 12.

These By-Laws may be altered or amended at any regular or adjourned session of this association by a two-thirds vote of the members present.
